1.1. Synopsis of SMOKE

The environmental community has developed advanced numerical air quality models (AQMs) to understand the interactions among meteorology, emissions (both manmade and biogenic), and pollutant chemistry and dynamics. Emissions data from emissions models and regulatory inventories are one of the most important inputs for these air quality models. Scientists use air quality modeling for a number of purposes: for state and federal implementation plan development, for research on improved modeling methods, and most recently for air quality forecasting. In all of these cases, the trend has been to model larger regions, at a finer grid resolution, with more emissions sources, and for more purposes (e.g., ozone, particulates, toxics). These needs require a computationally efficient, user-friendly, and flexible emissions data processing system.

The MCNC Environmental Modeling Center (EMC) created the Sparse Matrix Operator Kernel Emissions (SMOKE) Modeling System to allow emissions data processing methods to integrate high-performance-computing (HPC) sparse-matrix algorithms. The SMOKE system is a significant addition to the available resources for decision-making about emissions controls for both urban and regional applications. It provides a mechanism for preparing specialized inputs for air quality modeling research, and it makes air quality forecasting possible. The SMOKE system continues to develop and improve at the University of North Carolina at Chapel Hill's Institute for the Environment (IE).

The SMOKE prototype, available since 1996, was an effective tool for emissions processing in a number of regional air quality modeling applications. In 1998 and 1999, SMOKE was redesigned and improved with the support of the U.S. Environmental Protection Agency (EPA). The primary purposes of the first SMOKE redesign were support of (1) emissions processing with user-selected chemical mechanisms (described in more detail in Section 2.10, "Chemical speciation processing" [63]) and (2) emissions processing for reactivity assessments (described in Section 2.13.3, "Creating the reactivity control matrix" [75]). In 2002, SMOKE was enhanced to support driving the MOBILE6 model used to create on-road mobile emission factors and to support on-road and nonroad mobile toxics inventories, resulting in SMOKE v1.5. In 2003, SMOKE v2.0 was created to include all toxic inventories, including point and nonpoint (stationary sources reported at the county level) sources. SMOKE v2.1, released in 2004, included updated versions of the BEIS3 and MOBILE6.2 models, the ability to use humidity data when processing on-road mobile sources with MOBILE6, and support for polar stereographic output grids. In 2009, SMOKE v2.6 enhanced the processing of fire data, streamlined the processing for CAMx and UAM models, and added a new approach to processing CEM data. Version 2.7, SMOKE was enhanced to support processing the MOVES (MOter Vehicle Emission Simulator) emission rates output through the SMOKE system to model on-roadway and off-network mobile sources. As of version 4.0 SMOKE is enhanced to support hemispheric modeling by enabling the processing of global gridded emission inventories, such as EDGAR, for input to chemistry-transport models.

SMOKE can process criteria gaseous pollutants such as carbon monoxide (CO), nitrogen oxides (NO_x), volatile organic compounds (VOC), ammonia (NH₃), sulfur dioxide (SO₂); particulate matter (PM) pollutants such as PM 2.5 microns or less (PM_{2.5}) and PM less than 10 microns (PM₁₀); as well as a large array of

toxic pollutants, such as mercury, cadmium, benzene, and formaldehyde. In fact, SMOKE has no limitation regarding the number or types of pollutants it can process.

The purpose of SMOKE (or any emissions processor) is to convert the resolution of the emission inventory data to the resolution needed by an air quality model. Emission inventories are typically available with an annual-total emissions value for each emissions source, or perhaps with an average-day emissions value. The AQMs, however, typically require emissions data on an hourly basis, for each model grid cell (and perhaps model layer), and for each model species. (Refer to Appendix A. Glossary [411] for definitions of these terms.) Consequently, emissions processing involves transforming an emission inventory through temporal allocation, chemical speciation, and spatial allocation, to achieve the input requirements of the AQM.

1.2. SMOKE Users

Possible SMOKE users are individuals who need to prepare emission input files for one of the following air quality models:

- Community Multiscale Air Quality (CMAQ) modeling system
- Comprehensive Air Quality Model, with Extensions (CAM_x)
- Urban Airshed Model, version 4 (UAM-IV)
- Urban Airshed Model, Variable grid (UAM-V)

We anticipate that the typical SMOKE user will have some combination of the following experience and needs:

1. Those knowledgeable about emission inventories.
2. Those with UNIX experience (including Linux).
3. Those with little or no emissions modeling background.
4. Those who are somewhat familiar with grid-based air quality models and their emissions input needs.
5. Persons with emission inventories in hand who need to process the data for input to an AQM.
6. EPA personnel who want to create emission inputs for research or regulatory efforts with AQMs.
7. State environmental personnel who want to create emission inputs to AQMs for regulatory efforts, including State Implementation Plans (SIPs).
8. Those wishing to generate an on-road mobile inventory using MOVES and either the Weather Research and Forecasting (WRF) modeling system or the Pennsylvania State University/National Center for Atmospheric Research fifth-generation Mesoscale Model (MM5) gridded, hourly meteorology data.

SMOKE users who have previous UNIX experience can expect to run SMOKE more easily than users who must learn both UNIX and SMOKE. This is because the standard way to run SMOKE is from UNIX scripts.

2.1. Introduction

The purpose of SMOKE is to convert the resolution of the data in an emission inventory to the resolution needed by an air quality model. Emission inventories typically have an annual-total emissions value for each emissions source, or perhaps an average-day emissions value. The AQMs, however, typically require emissions data on an hourly basis, for each model grid cell (and perhaps model layer), and for each model species. Consequently, to achieve the input requirements of the AQM, emissions processing must (at a minimum) transform inventory data by temporal allocation, chemical speciation, spatial allocation, and perhaps layer assignment.

In addition to changing the resolution of the data, SMOKE must also provide the AQM input files in the correct file format. SMOKE can create the Input/Output Applications Programming Interface (I/O API) Network Common Data Form (NetCDF) output format needed by the CMAQ model. It can also create the Fortran binary format for the 2-D emissions needed by UAM, and CAM_x, and the ASCII elevated-point-source format used by the Ptsrce preprocessor to these models. File format is also important for the input files used by SMOKE, most of which are ASCII files, but some of which are I/O API NetCDF or CF-compliant NetCDF format files.

In this chapter, we introduce you to various concepts that are critical to understanding the technical description of emissions processing, as well as provide more detail about the processing capabilities of SMOKE. (Later, Chapter 3, *SMOKE Utility Tools* [91], Chapter 4, *SMOKE Core Programs* [127], Chapter 5, *SMOKE Quality Assurance* [229], Chapter 6, *SMOKE Input Files* [261], Chapter 7, *SMOKE Intermediate Files* [379], and Chapter 8, *SMOKE Output Files* [403] give more specifics about each program's capabilities and each file's format.) This chapter provides the context and framework for the rest of the user's manual. To assist you in reading and using this chapter, we provide Appendix A. Glossary [411] for definitions of emissions inventory and emissions modeling terminology.

2.2. Emission inventories

Emission inventories are the key input files to SMOKE and emissions modeling. The data types that these inventories contain are called inventory pollutants (e.g., carbon monoxide, ammonia, mercury). By itself, SMOKE does not require specific data types in the inventory files it reads. However, the AQMs that SMOKE supports do require certain input data, called model species, which in turn requires SMOKE to use certain inventory pollutants.

In this section, we focus on the inventory files that SMOKE uses. Section 2.2.1, “Inventory data types” [4] describes the major inventory types useable by SMOKE. In Section 2.2.2, “Inventory source categories” [4], we describe the inventory source categories, and in Section 2.2.3, “Inventory file formats” [10] we discuss the inventory file formats. The remaining sections describe the various codes used in specific inventory sources: Section 2.2.4, “Country, state, and county codes” [10], Section 2.2.5, “Source Classification Codes” [11], Section 2.2.6, “Standard Industrial Classification codes” [12], Section 2.2.8, “Maximum Achievable Control Technology codes” [13], Section 2.2.9, “Source types: major and section-112 area sources” [13] and Section 2.2.10, “Source types: nonroad and onroad mobile sources” [14].

2.2.1. Inventory data types

SMOKE processes criteria, particulate, toxics, and activity data inventories. Activity data will be discussed along with on-road mobile sources in the next section. By criteria inventories, we mean inventories containing EPA’s criteria pollutants: carbon monoxide (CO), nitrogen oxides (NO_x), and volatile organic compounds (VOC) or total organic gases (TOG). Particulate inventories contain ammonia (NH₃), sulfur dioxide (SO₂), particulate matter (PM) of size 10 microns or less (PM₁₀), and PM of size 2.5 microns or less (PM_{2.5}).

Additionally, SMOKE can process inventories with pre-specified criteria and/or particulate emissions. For example, elemental carbon of size 2.5 microns or less can be provided as input to SMOKE directly, instead of letting SMOKE’s speciation step compute it from the PM_{2.5} total emissions. To ensure that SMOKE correctly processes the data when you are using pre-specified emissions, other input files must be configured in specific ways.

The toxics inventories that SMOKE can process are data from the National Emission Inventory (NEI) for Hazardous Air Pollutants (HAPs). This inventory contains hundreds of specific compounds representing the 188 HAPs defined by the Clean Air Act. The original list of 189 HAPs and modifications representing the current list are available from the EPA’s web site [<http://www.epa.gov/ttn/atw/orig189.html>]. The reason the inventory contains many more pollutants than 188 is because several on the list of 188 are pollutant groups, such as polycyclic organic matter, cyanide compounds and numerous metal compounds including chromium compounds, cadmium compounds, manganese compounds, and others. Note that because of these groups, specific compounds in the inventory in one inventory year may not exactly match the compounds in another inventory year. For example, one may have lead oxide reported one year but not in a subsequent year. However, those compounds not belonging to compound groups are likely to be in the inventory year after year, particularly the common gaseous HAPs emitted by mobile sources such as benzene, 1,3-butadiene, acrolein, formaldehyde, and acetaldehyde.

2.2.2. Inventory source categories

2.2.2.1. Overview

Emission inventories are divided into several source categories. These divisions stem from both differing methods for preparing the inventories and from different characteristics and attributes of the categories (more on these terms later). Generally, emission inventories are divided into the following source categories:

- **Stationary area/Nonpoint sources:** Sources that are treated as being spread over a spatial extent (usually a county or air district) and that are not moveable (as compared to nonroad mobile and on-road mobile sources). Because it is not possible to collect the emissions at each point of emission, they are estimated over larger regions. The EPA introduced the term “nonpoint” to replace “stationary area” in order to avoid confusion with the term “area source”, which is used as a regulatory term in the toxics realm. However, “nonpoint” has not gained acceptance (thus far) by the criteria inventory/modeling community. Thus, in this manual we will use the term “stationary area” to refer to these sources when they are in criteria inventories, while we use the term “nonpoint” to refer to these sources when they are in toxics inventories. Examples of nonpoint or stationary area sources are residential heating and architectural coatings. Numerous sources, such as dry cleaning facilities, may be treated either as stationary area/nonpoint sources or as point sources; in particular, the toxics inventory contains numerous small sources (based on emissions) that are not inventoried as nonpoint sources because their locations are known and are provided.
- **Nonroad mobile sources:** Vehicular and otherwise movable sources that do not include vehicles that travel on roadways. These sources are also computed as being spread over a spatial extent (again, a county or air district). Examples of nonroad mobile sources include locomotives, lawn and garden equipment, construction vehicles, and boating emissions. These sources are included in both criteria and toxics inventories.
- **On-road mobile sources:** Vehicular sources that travel on roadways. These sources can be computed either as being spread over a spatial extent or as being assigned to a line location (called a link). Data in on-road inventories can be either emissions or activity data. Activity data consists of vehicle miles traveled (VMT) and, optionally, vehicle speed. Activity data are used when SMOKE will be computing emission factors via another model such as MOVES. Examples of on-road mobile sources include light-duty gasoline vehicles and heavy-duty diesel vehicles. On-road mobile sources are included in both criteria and toxics inventories.
- **Point sources:** These are sources that are identified by point locations, typically because they are regulated and their locations are available in regulatory reports. Point sources are often further subdivided into electric generating utilities (EGUs) and non-EGU sources, particularly in criteria inventories in which EGUs are a primary source of NO_x and SO_2 . Examples of non-EGU point sources include chemical manufacturers and furniture refinishers. Point sources are included in both the criteria and toxics inventories.
- **Wildfire sources:** Traditionally, wildfire emissions have been treated as stationary area sources. More recently, data have also been developed for point locations, with day-specific emissions and hour-specific plume rise (vertical distribution of emissions). In this case, the wildfire emissions are processed by SMOKE as point sources.
- **Biogenic land use data:** Biogenic land use data characterize the type of vegetation that exists in either county total or grid cell values. The biogenic land use data in North America is available using two different sets of land use categories: the Biogenic Emissions Landcover Database (BELD) version 2 (BELD2), and the BELD version 3 (BELD3).

Emission processing in SMOKE is divided into four processing categories: area, biogenic, mobile, and point. The definitions of these categories that SMOKE uses are different than those used for defining emission inventories. Table 2.1, “Inventory source categories and SMOKE processing capabilities and categories” [6] lists the inventory source categories, the types of inventories (activity data, criteria, particulates, and toxics) that SMOKE can process, the temporal resolution that is acceptable to SMOKE, and the SMOKE processing category that should be used for processing the inventory.

2.2.2.2. Detailed source category descriptions

Each inventory source category has source characteristics, source attributes, data values, and data attributes. *Source characteristics* are unique to each inventory source category and also distinguish one source in the inventory from another. *Source attributes* further describe the sources with other information that is useful for emissions processing, such as point-source flue gas exit height and temperature. The *data values* are either emissions values or activity values. The *data attributes* are additional information about the data values, such as the percentage reduction in emission from controls already applied to the source. In the following subsections, we summarize the source characteristics and attributes and the data values and attributes that are used by SMOKE for each of the inventory categories.

2.2.2.2.1. Nonpoint/stationary area and nonroad mobile (SMOKE category: area)

- **Source characteristics:** For all typical inventories, the source characteristics that identify these sources are country/state/county code, SCC and/or GEOCODE_LEVEL[1-4]. See Section 2.2.4, “Country, state, and county codes” [10] and Section 2.2.5, “Source Classification Codes” [11] and Section 2.2.7, “Geographical Code (GEOCODE_LEVEL[1-4])” [12] for further information.
- **Optional source characteristics:** SMOKE can also use pregridded data from the same modeling domain as a SMOKE area source; this is described in more detail in Section 2.7.2.2, “Pre-gridded Emissions” [28]. In this case, the source characteristics and attributes, (country/state/county code and SCC) are *not* used in SMOKE. SMOKE can also use pregridded data from a different modeling domain along with geographical codes (GEOCODE_LEVEL[1-4]) and source information from the ARINV file to specify the source characteristics and associated source attributes for each grid cell.
- **Source attributes:** The inventory year is associated with all sources in the inventory input files. In addition, SMOKE assigns a time zone (see Section 2.8.14, “Assign country codes, years, and time zones” [54]) and an approach for normalization of temporal profiles (see Section 2.8.13, “Set the weekday averaging approach” [54]). In the nonpoint toxics inventory only, Standard Industrial Classification (SIC) codes, Maximum Achievable Control Technology (MACT) codes, and North American

Industrial Classification System (NAICS) codes are optional source attributes; the NAICS code is read by SMOKE but not otherwise used at this time. Additionally, a “source type” field is available in the nonpoint inventory to identify major and Clean Air Act (CAA) section 112 area sources. See Section 2.2.6, “Standard Industrial Classification codes” [12] for a description of SIC codes, Section 2.2.8, “Maximum Achievable Control Technology codes” [13] for more about MACT codes, and Section 2.2.9, “Source types: major and section-112 area sources” [13] for more about source types. We will refer to the CAA section 112 area sources as simply “section-112 area sources”.

- **Data:** SMOKE can read emissions data for criteria, particulate, and toxics pollutants for nonpoint/stationary area and nonroad inventories. The SMOKE system is not constrained with regard to the pollutants read (although typical examples were given in Section 2.2.1, “Inventory data types” [4]). SMOKE accepts annual emissions data, average-day emissions data, or both (though not all input formats support all types). An emission factor value can also be read by SMOKE, but SMOKE does nothing with it.
- **Data attributes:** Inventories for nonpoint/stationary area and nonroad mobile sources can contain control efficiency, rule penetration, and rule effectiveness information for each pollutant. SMOKE will use these data if provided; otherwise it will set default values that indicate that no control-based adjustments have been applied to the inventory pollutant data. The defaults are listed in the file formats in Chapter 6, *SMOKE Input Files* [261].

2.2.2.2.2. On-road mobile (SMOKE category: mobile)

- **Source characteristics:** For on-road mobile inventories, the minimum source characteristics that identify these sources are country/state/county code and either SCC *or* road class and vehicle type codes. When the SCC is provided, it must follow a specific pattern in order to contain the road class and vehicle type codes (see Section 2.7.4.1, “Special approach for on-road mobile MOVES SCCs” [33]). When road class and vehicle type codes are provided to SMOKE directly, SMOKE translates these to SCC values.
- **Optional source characteristics:** A link code may also identify on-road sources. This code must be unique within each county and SCC (or road class/vehicle type combination).
- **Source attributes:** The inventory year is associated with all sources in the inventory input files. In addition, SMOKE assigns a time zone (see Section 2.8.14, “Assign country codes, years, and time zones” [54]) and an approach for normalization of temporal profiles (see Section 2.8.13, “Set the weekday averaging approach” [54]). For sources with link codes, SMOKE will use the starting and ending coordinates of the link, using either latitude-longitude (lat-lon) values or coordinates in the Universal Transverse Mercator (UTM) coordinate system.
- **Data:** Emissions data for criteria, particulate, and toxics pollutants can be read for on-road mobile inventories. SMOKE is not constrained with regard to the pollutants read (although typical examples were given in Section 2.2.1, “Inventory data types” [4]). SMOKE accepts annual emissions data, average-day emissions data, or both (though not all input formats support all types).

Additionally, on-road mobile inventories can contain VMT and average speed activity data, which are needed when users would like SMOKE to run MOVES to compute emissions. A combination of pre-computed emissions and VMT data is also acceptable for input to SMOKE, but you are responsible for preventing duplication of emissions. Duplication could occur if you input precomputed emissions for the same sources that you use SMOKE to compute the emissions on the fly, by multiplying the on-road emissions factors from MOVES by hourly VMT, and the off-network emission factors from MOVES by annual vehicle populations.

- **Data attributes:** No data attributes are associated with on-road mobile sources.

2.2.2.2.3. Point sources (SMOKE category: point)

- **Source characteristics:** The source characteristics for point sources depend on the inventory input format. The SMOKE one-record-per-line (ORL) and Flat File 10 Format (FF10) formats identify sources by country/state/county code, plant code, point code, stack code, segment code, and SCC. 95.
- **Optional source characteristics:** SMOKE can support up to five location identifiers within a plant, although the most used in any currently implemented input file format is four.
- **Source attributes:** As with other source categories, inventory year is associated with all sources in the inventory input files. SMOKE also assigns a time zone (see Section 2.8.14, “Assign country codes, years, and time zones” [54]) and an approach for normalization of temporal profiles (see Section 2.8.13, “Set the weekday averaging approach” [54]). In addition, point sources have the following required source attributes not associated with other source categories: latitude, longitude, stack height, stack diameter (at the exit location), flue gas exit velocity, and flue gas exit temperature. Finally, the following optional source attributes are also used by SMOKE: SIC codes, MACT codes, plant descriptions, emissions release type point (e.g., horizontal stack, fugitive), source type (major or section-112 area), Office of Regulatory Information Systems (ORIS) identification codes, and boiler identification codes. Also, the MACT code and source types are supported only by the ORL format. See Section 2.2.6, “Standard Industrial Classification codes” [12], Section 2.2.8, “Maximum Achievable Control Technology codes” [13], and Section 2.2.9, “Source types: major and section-112 area sources” [13] for more information.
- **Data:** Emissions data for criteria, particulate, and toxics pollutants can be read for point inventories. SMOKE is not constrained with regard to the pollutants read (although typical examples were given in Section 2.2.1, “Inventory data types” [4]). SMOKE accepts annual emissions data, average-day emissions data, or both.

Optionally, point-source emissions data can be provided using day-specific or hour-specific records. The formats for these data are described in Section 6.2.6, “PTDAY: Point source day-specific emissions” [278] and Section 6.2.7, “PTHOUR: Point source hour-specific emissions” [280].

- **Data attributes:** EGU and non-EGU point sources can contain control efficiency and rule effectiveness information for each pollutant. SMOKE will use these data if provided; otherwise it will set default values that indicate that no control-based adjustments have been applied to the inventory pollutant data. The defaults are listed in the file formats in Chapter 6, *SMOKE Input Files* [261].

2.2.2.2.4. Wildfire with precomputed plume rise (SMOKE category: point)

- **Source characteristics:** Wildfires with precomputed plumes are identified by the country/state/county code and the fire name.
- **Optional source characteristics:** There are no optional source characteristics for wildfire sources.
- **Source attributes:** Like other source categories, inventory year is associated with all sources in the inventory input files. SMOKE also assigns a time zone (see Section 2.8.14, “Assign country codes, years, and time zones” [54]) and an approach for normalization of temporal profiles (see Section 2.8.13, “Set the weekday averaging approach” [54]). In addition, wildfire sources require the latitude and longitude source attributes. Finally, additional hour-specific source attributes for wildfire sources *must* be provided for the fraction of emissions in the surface layer, the height of the bottom of the plume, and the height of the top of the plume. These hour-specific attributes are provided to SMOKE using the point source hour-specific formats described in Section 6.2.7, “PTHOUR: Point source hour-specific emissions” [280].

- **Data:** Wildfire source inventories can contain criteria and particulate pollutants. SMOKE is not constrained with regard to the pollutants read (although typical examples were given in Section 2.2.1, “Inventory data types” [4]). These data must be provided as day-specific or hour-specific emissions values using point source formats specified in Section 6.2.6, “PTDAY: Point source day-specific emissions” [278] and Section 6.2.7, “PTHOUR: Point source hour-specific emissions” [280].
- **Data attributes:** No data attributes are associated with wildfire sources.

2.2.2.2.5. Wildfires with internal plume rise calculation (SMOKE category: point)

- **Source characteristics:** Wildfires with internal plume rise calculation are identified by the country/state/county code, fire identification, fire name, location identification, and SCC.
- **Optional source characteristics:** There are optional source characteristics for fire sources, such as material burned, vegetation types, size of area burned, fuel loading, and fire start/end hour. The size of area burned and fuel loading are used for computing the fire-specific plume rise. Fire starting and ending hours are needed to adjust the hourly temporal profiles for the emissions.
- **Source attributes:** Like other source categories, inventory year is associated with all sources in the inventory input files. SMOKE also assigns a time zone (see Section 2.8.14, “Assign country codes, years, and time zones” [54]) and will re-normalize temporal profiles based on the starting and ending hours of the fire. In addition, wildfire sources require the latitude and longitude source attributes to locate the fire. Note that all emissions for a fire will be assumed to come from the single grid cell that contains the latitude and longitude of the fire. Finally, additional day-specific source attributes listed above for fire sources *must* be provided for calculating the heat flux of each fire, which is used to estimate the fraction of emissions in the surface layer, the height of the bottom of the plume, and the height of the top of the plume.
- **Data:** Fire source inventories can contain criteria and particulate pollutants. SMOKE is not constrained with regard to the pollutants read (although typical examples were given in Section 6.2.8.3, “ORL FIRE Format” [294]). These data must be provided as day-specific emissions values using point source formats specified in Section 6.2.6.2, “ORL FIREEMIS Emission Format” [279].
- **Data attributes:** No data attributes are associated with wildfire sources.

2.2.2.2.6. Biogenic land use (SMOKE category: biogenic)

- **Source characteristics:** Biogenic emission data does not fit as neatly into the source-characteristic paradigm as the previously described source types. Emissions for biogenic sources are estimated starting with land use data, which are available for both BELD2 and BELD3 processing. The BELD2 data are available either by U.S. state/county and BELD2 land use category or by grid cell and BELD2 land use category. BELD3 land use data are available by 1-km grid cell over North and Central America and by BELD3 land use category.
- **Optional source characteristics:** Biogenic land use data do not include optional source characteristics. The data are either by state/county or by grid cell.
- **Source attributes:** There are no source attributes for biogenic land use data.
- **Data:** The biogenic land use data consist of fractions associated with each land use type within a county or grid cell.
- **Data attributes:** There are no data attributes for biogenic land use data.

2.2.3. Inventory file formats

SMOKE supports a variety of inventory formats for criteria, particulate, toxics, and activity data inventories, which are described in detail in Section 6.2, “Inventory Files” [262]. Here, we provide a brief introduction to these formats, which will be helpful as you read more about SMOKE in the remainder of this chapter and the chapters before Chapter 6, *SMOKE Input Files* [261]. All formats described here are text files. To convert your data to these formats, the best approach is to use a database or spreadsheet program to reformat and output the data in the requested format. There is not a standard format-conversion method that comes with SMOKE.

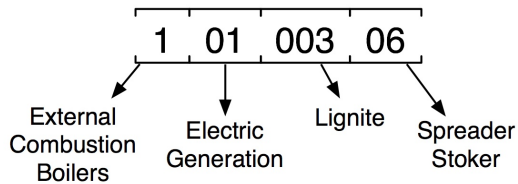
In the following paragraphs, we describe the formats available for nonpoint/stationary area, nonroad mobile, on-road mobile, point, and point-wildfire sources.

- **Nonpoint/stationary area sources:** SMOKE supports two formats for nonpoint/stationary area sources. The ORL and FF10 (Flat File 10) format are list directed (comma or semicolon delimited) and these file formats may be used to represent many different sources. The header of the file indicates what source data are in the file.
- **Nonroad mobile sources:** There are three available inventory formats for nonroad mobile sources. The FF10 (Flat File 10) format is list directed (comma or semicolon delimited) and the header of the file is used to indicate the nonroad mobile source data is within the file.
- **On-road mobile sources:** The Flat File 10 (FF10) format is list directed (comma or semicolon delimited) and contains activity inventory such as VMT, speed, and vehicle population data. This format requires VMT, SPEED, and VPOP inventory data.
- **Point sources:** SMOKE has formats for annual or average-day inventories, for day-specific inventories, and for hour-specific inventories. For annual or average-day inventories, the ORL and FF10 formats can be used for criteria, particulate, and toxics inventories. Finally, the CEM data format can be used for day-specific or hour-specific data : SMOKE uses the ORIS codes and boiler codes in the annual inventory files to match sources from the CEM data files.
- **Wildfire sources:** There are two approaches available that you can provide wildfire data that are being treated as point sources to SMOKE using the ORL and FF10 point-source formats.
 - **Precomputed plume rise approach:** Certain fields must be left blank (such as stack parameters) because they do not apply to wildfire sources. When using wildfire data provided as point sources, you must also provide day-specific or hour-specific wildfire emissions and hour-specific precomputed plume rise using the FF10 day-specific and hour-specific formats.
 - **Internal plume rise calculation approach:** Requires two separate inventory files that are provided in a modified ORL format: (1) a list of fires with fire-specific characteristics including country/state/county, fire identification, location coordinate, fire name, SCC and others, as described in Section 6.2.8.3, “ORL FIRE Format” [294], and (2) a day-specific fire data including size of area burned, fuel loading, and star/end hour of fire (Section 6.2.6.2, “ORL FIREEMIS Emission Format” [279]). Unlike the approach listed above, this approach internally estimates the plume rise using the size of the area burned and fuel loading, and it adjusts temporal profiles using the start and end hours of the fire.

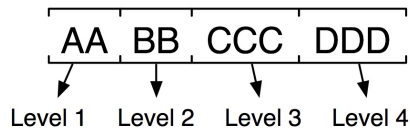
2.2.4. Country, state, and county codes

SMOKE uses a 6-digit integer code to identify a country, state (or province), and county (or other region) for a particular source. Most U.S. inventories input to SMOKE have the 5-digit U.S. Federal Implementation Planning Standards (FIPS) state and county codes. All inventory input formats have been adapted to include a special header record with which you can specify the country, effectively allowing the inventories to be provided with the 6-digit code that SMOKE uses. The 6-digit system was designed for use in the United

is represented by 10100306. Below we have mapped the levels of this description with the levels of the SCC:



Similarly, the code structure for the 10-digit area- and mobile-source codes is:

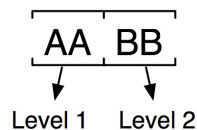


SMOKE treats SCCs as character strings, though in practice the values in the inventories and cross-reference files are usually numeric. In Section 2.3, “Cross-referencing and profiles” [14] on cross-references and profiles, we explain how these hierarchies are used by SMOKE and how you should use them in preparing SMOKE input files.

For on-road mobile sources, SCCs are treated somewhat differently than for other source categories. We explain more about this in Section 2.7.4.1, “Special approach for on-road mobile MOVES SCCs” [33].

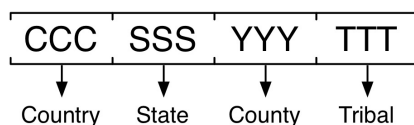
2.2.6. Standard Industrial Classification codes

Although SIC codes are being replaced by NAICS codes in building emission inventories at EPA, SIC codes are still used in emissions processing. As of SMOKE v4.0, the SIC codes may be up to 20 characters in length, but for SIC codes greater than 4-digits, the hierarchical system is not used. For SICs of size 4-digits, a 2-level hierarchical system is recognized by SMOKE for application of growth, control, and chemical speciation factors. The two code levels are illustrated below.



2.2.7. Geographical Code (GEOCODE_LEVEL[1-4])

Geographical codes may be specified to the user’s desired level of detail using the GEOCODE_LEVEL[1-4] files. GEOCODE_LEVEL1 contains three character codes for each country in the inventory (CCC). GEOCODE_LEVEL2 contains six character codes for each state that the user would like to track in the inventory (CCSSS). GEOCODE_LEVEL3 contains nine character codes for each county that the user would like to track in the inventory (CCSSSYYY). GEOCODE_LEVEL4 contains twelve character codes for each tribal region that the user would like to track in the inventory (CCSSSYYT).



2.2.8. Maximum Achievable Control Technology codes

The following quote explaining MACT codes was taken from EPA to explain what MACT codes are and why they are used in some inventories and not others:

To evaluate EPA's progress in reducing air toxic emissions through the Maximum Achievable Control Technology (MACT) standards and to identify sources that may be modeled as part of residual risk assessments, operations within facilities that are subject to MACT standards are identified in the NTI by 4-digit MACT codes. *[note that the term NTI (National Toxics Inventory) has since been replaced with NEI and that the codes are now 6 digits]*

A MACT category is one for which emissions limitations have been or are being developed under section 112(d) of the Clean Air Act (National Emissions Standards for Hazardous Air Pollutants). EPA sets source category, technology based standards through its MACT program that sharply reduce emissions of HAPs. EPA's ATW web site includes information on the MACT source categories and the MACT program (www.epa.gov/ttn/atw/eparules.html). The tagging of data with MACT codes allows EPA to determine reductions attributable to the MACT program. The NTI associates MACT codes corresponding to MACT source categories with stationary major and [section-112] area source data. MACT codes are assigned at the process level or at the site level in the point source data, e.g., the MACT code for municipal waste combustors (MWCs) is assigned at the site level whereas the MACT code for petroleum refinery catalytic cracking is assigned at the process level. MACT codes are also assigned to source categories in the nonpoint source file.

In SMOKE, MACT codes are treated as 6-character strings, with no internal hierarchy associated with the number.

2.2.9. Source types: major and section-112 area sources

For point and nonpoint toxics inventories, each source can be labeled as "major" or "section-112 area" for input to SMOKE (the following paragraph explains how the term "area" can be applied to a point-source inventory). The Clean Air Act defines major sources as those stationary facilities that emit or have the potential to emit 10 tons per year or more of any one toxic air pollutant or 25 tons per year or more of any combination of toxic air pollutants. section-112 area sources include facilities that have air toxics emissions below the major source threshold as defined in section 112 of the Clean Air Act and thus emit less than 10 tons per year of a single toxics air pollutant or less than 25 tons per year combined of multiple toxics air pollutants. Another source type exists in principle for nonpoint sources: the "other" source type; an example of this source type is wildfires. However, these source types are not labeled differently from the section-112 area sources in the nonpoint toxics inventories, so the "other" source type has not been included in SMOKE to date.

A note about the confusing use of "area" terminology to describe point sources: The designation of sources in the point inventories as section-112 area sources has no relationship whatsoever to SMOKE's area

processing category. The point sources that are section-112 area sources are still processed by SMOKE as point sources using a lat-lon location and stack parameters.

In practice, all “major” sources should appear only in the point toxics inventory, but in some cases, “major” sources have shown up in the nonpoint inventory (specifically in inventory year 1996, in the July 2001 version of that inventory). Thus, the source type designation is provided in both the point and nonpoint toxics input formats.

The major and section-112 area designations are used when applying MACT-based control factors. These control factors are assigned based on a source’s MACT code and may be applied to major sources only, to section-112 area sources only, or to both types of sources regardless of designation.

2.2.10. Source types: nonroad and onroad mobile sources

The nonroad and onroad mobile source type designations are used when applying MACT-based control factors. These control factors are assigned based on a source’s MACT code.

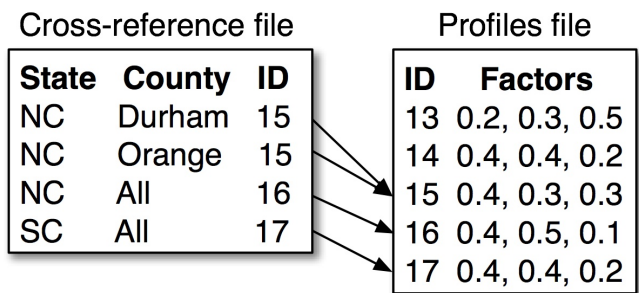
2.3. Cross-referencing and profiles

The emission inventories described in Section 2.2, “Emission inventories” [4] can contain hundreds of thousands or even millions of sources. Collecting specific information for each source about its temporal allocation, chemical speciation, and spatial allocation is not practical. Therefore, a part of emissions processing involves assuming that many sources share the same factors for these major processing steps. For example, we apply monthly, day-of-week, and hourly temporal factors (called profiles) to convert from an annual emissions value to an hour-specific emissions value. A limited set of monthly, day-of-week, and hourly diurnal profiles are available from various studies, and these profiles each have their own unique profile number (also called profile code or profile ID). This limited set of profiles is assigned to the much more numerous inventory sources using an approach called cross-referencing, which is implemented using cross-reference files.

The cross-reference files assign the profiles based on source characteristics such as country, state, and county codes and/or SCCs, using the profile numbers to associate source characteristics with the profiles. While the profile numbers are unique in the profile files, they will appear many times in the cross-reference; this is how SMOKE is able to group the sources to treat them in the same manner. This approach is used for temporal allocation profiles, chemical speciation profiles and the spatial “profiles”, which are called spatial (or gridding) surrogates.

The cross-reference tables are applied to the sources in a stepwise manner, such that the most specific entry available is always applied. For example, if a cross-reference entry were available that matched a source by state, county, and SCC, SMOKE would apply that entry instead of a different cross-reference entry that matched that source only by SCC. The hierarchy that describes how each cross-reference file is applied to the inventory is described for each program in Chapter 4, *SMOKE Core Programs* [127].

Figure 2.1, “Generic example of how cross-reference files and profiles work together” [15] provides a generic example of how cross-reference files and profile files work together. In the example, the profile to be used for most of North Carolina is profile ID 16. Durham and Orange counties, however, are assigned profile 15, which would be preferentially applied to all sources in Durham and Orange counties, instead of using the general North Carolina profile. South Carolina sources would be assigned profile 17.

Figure 2.1. Generic example of how cross-reference files and profiles work together

This example does not correspond to a particular processing step (i.e., temporal allocation, chemical speciation, or spatial allocation), but rather assigns generic “factors” from profiles 15, 16, and 17 based on the state and county information in the cross-reference file. (Note that we have used the state and county names in this example, whereas real cross-reference files would use the country, state, and county codes according to the file format of the actual cross-reference files.)

SMOKE handles cross-references and profile application in a very efficient manner. In reading a cross-reference file, SMOKE first sorts the cross-reference entries using the same sort criteria as are used for the inventory sources (e.g. by country/state/county code, then by SCC, then by remaining source characteristics if any). Next, the cross-reference entries are grouped according to the “level” of matching of each of the entries. For example, all entries that could match to the inventory using only state and county codes would be in one group, while entries that could match to the inventory using only SCCs would be in another group. Once the cross-reference entries are grouped, SMOKE processes each sources in the inventory, and attempts to find a matching entry in one of the cross-reference groups. The most specific groups are searched first, and when a match is found for a particular source, the other groups are not searched. This helps increase efficiency. In addition, because the cross-reference entries are sorted within each group, an efficient searching algorithm can be used for each individual search. When a match to one of the cross-reference groups has been found, SMOKE continues to the next source in the inventory until all sources have been processed.

Cross-references and profiles are used in the following SMOKE processing steps. These steps and their associated programs (listed in parentheses) will be described in the sections to come.

- Inventory import (**Smkinven**)
 - cross-references: NHAPEXCLUDE, VMTMIX, PSTK, ARTOPNT
 - profiles: none (factors are included in the cross-reference files when needed)
- Temporal allocation (**Temporal**)
 - cross-references: ATREF, MTREF, PTREF
 - profiles: ATPRO, MTPRO, PTPRO
- Chemical speciation (**Spcmat**)
 - cross-references: GSREF, GSCNV
 - profiles: GSPRO
- Spatial allocation (**Grdmat**)
 - cross-references: AGREF, MGREF
 - profiles: AGPRO, MGPRO (* **Note**)
- Growth and controls (**Cntlmat**)
 - cross-references: GCNTL
 - profiles: none (factors are included in the cross-reference files)
- Mobile-source speed assignment (**Movesmrg**)
 - cross-references: MCXREF, MFMREF
 - profiles: SPDPRO

The hierarchies that each SMOKE program uses to assign cross-reference entries to sources are provided in Chapter 4, *SMOKE Core Programs* [127], where the programs are described at length. The file contents and formats are described in more detail in Chapter 6, *SMOKE Input Files* [261].

Note: The use of the Environment variable AGPRO (Area spatial surrogate file) and MGPRO (Mobile spatial surrogate file) have been discontinued. Two new Environment variables have been introduced to SMOKE; SRGPRO_PATH (spatial surrogate profile file location) and SRGDESC (description file with the specific list of available surrogates located in SRGPRO_PATH) See Figure 4.4, “**Grdmat** input and output files” [146]. The surrogate files located in SRGPRO_PATH are refinements of the old [A|M]GPRO files. They are of the same format as the old files, however, there now may be one or more surrogate files. **Grdmat** now process each surrogate separately. On domains with large cell counts, this approach limits the memory usage at the expense of slightly longer run times.

2.4. Input and output file types

Before we describe more about the SMOKE processing, we first need to explain the types of files you will encounter in this documentation. SMOKE primarily uses two types of file formats: ASCII files and I/O API files. In addition, the output file format for the UAM-based air quality model is a Fortran binary file format. Chapter 6, *SMOKE Input Files* [261], Chapter 7, *SMOKE Intermediate Files* [379], and Chapter 8, *SMOKE Output Files* [403] describe all input, intermediate, and output files, including the file format for each one. Input files are files that are read by at least one core SMOKE program (listed in Chapter 4, *SMOKE Core Programs* [127]), but are not written by a core program. Intermediate files are files that are written by a core program and read by at least one other core program. Output files are files output by a SMOKE core program but not read by any of them; these files include reports, log files, and the model-ready files to be input to an air quality model. (Exception: one intermediate file [used by a core program] is also an output file [used by an AQM]: the STACK_GROUPS file, described in Section 7.3.2, “STACK_GROUPS” [382].) In this section, we further describe the ASCII and I/O API files, and then provide information about the two approaches for formatting the model-ready output files produced by SMOKE (the CMAQ/Models-3 approach and the UAM-based approach).

SMOKE’s input files are primarily ASCII files, although a few I/O API files are used. The intermediate files in SMOKE are primarily I/O API files, although there are several important ASCII files as well. The output files from SMOKE are primarily I/O API files and Fortran binary files for model-ready emissions files, and ASCII files for reports and logs.

2.4.1. ASCII files

ASCII files are simply the text files with which most computer users are familiar. The ASCII files input by SMOKE come in two structures: *column-specific* and *list-directed*.

2.4.1.1. Column-specific ASCII files

In column-specific files, the fields in the files must appear in certain columns in the file. Each character on a line represents a single column. The lines below represent a column-specific ASCII data file:

2.4.1.2. List-directed ASCII files

In list-directed files, the exact positioning of the fields on a line is not important, but the order of the fields on that line is crucial. The fields must be delimited (separated) by special characters called delimiters; in SMOKE, valid delimiters are **spaces**, **commas**, or **semicolons**. If a particular field happens to contain any of these delimiters within it, then that field must be surrounded by single or double quotes in the input file.

2.4.2. I/O API files

I/O API files are read and written by the I/O API library used by SMOKE and other Models-3 programs. A library is a set of routines that have been created and compiled for use by multiple programs. The I/O API library, in turn, is built upon yet another library called the NetCDF library. For this reason, I/O API files are also referred to as I/O API NetCDF files. More information on both of these libraries is available at the I/O API web site [<http://www.baronams.com/products/ioapi/>].

The I/O API files cannot be viewed with a text editor because they are binary files. These binary files use less disk space than ASCII files containing the same data. They also allow much more efficient input and output of the data, and the I/O API library provides many quality assurance (QA) features useful for all input and output (I/O), including I/O for emissions processing.

The basic I/O API file has a limitation of 120 variables per file. To overcome this, SMOKE uses a wrapper called the FileSetAPI that creates and manages multiple I/O API files when more than 120 variables are needed in a single I/O API dataset in SMOKE. For example, if the SMOKE speciation matrix requires 140 pollutant-to-species variables, SMOKE will open by default two standard I/O API files: one with 120 variables and one with 20 variables. This resulting “file set” will be treated by other SMOKE programs as a single file, which enables processing of any number of pollutants and species in a single run, despite the I/O API variable limitation.

Some I/O API files can be viewed by the Visualization Environment for Rich Data Interpretation [<http://www.verdi-tool.org>] (VERDI). In SMOKE, any gridded output file from the **Smkmerge**, **Mrggrid**, or **Smk2emis** programs can be viewed by VERDI.

In some cases, it can be helpful to directly view the contents of the I/O API files in text form. This provides a quick way to check grid settings, time period, or species names in the model-ready output files. By viewing the text version of the model-ready output files produced by SMOKE, you can easily confirm that the correct species have been created or that the emission units are correct. To convert the I/O API files to text, one can use a combination of the NetCDF-provided **ncdump** utility and UNIX commands. The **ncdump** utility is created when you compile the NetCDF library, or you can download it from the NetCDF web site [<http://www.unidata.ucar.edu/packages/netcdf/>]. The command to convert the files to text format is:

```
ncdump <infile> | cut -c1-80 > <outfile>
```

Replace *<infile>* in the command above with your input I/O API file name, and *<outfile>* with your desired ASCII output file name. The output file contains all the applicable data stored in the I/O API file including grid information, time period, variable names, etc.

2.4.3. Model-ready files

SMOKE supports two major approaches for formatting its output files that are used as inputs to air quality models (i.e., model-ready files): the CMAQ/Models-3 approach and the UAM-based approach. The CMAQ/Models-3 approach is used for the CMAQ model, and the UAM-based approach is used for the UAM models, and CAM_x.

The CMAQ/Models-3 approach uses one required 3-D I/O API file that contains the gridded, hourly, speciated, and vertically distributed emissions. In SMOKE, it is called the `EGTS3D_L` file. To create the 3-D model-ready emissions file, SMOKE computes plume rise for some or all point sources. For CMAQ, two additional optional files can be provided for plume-in-grid (PinG) processing. The first must contain locations and stack parameters for PinG sources and is called the `STACK_GROUPS` file. The second must contain the hourly, speciated emissions for the same PinG sources in a file called the `PINGTS_L` file.

The UAM-based approach has two required files: (1) a 2-D emissions Fortran binary file with all sources other than point sources and all low-level point sources, and (2) an elevated-point-source Fortran binary file. The SMOKE program **Smk2emis** can create the 2-D emissions Fortran binary file (called the `UAM_EGTS` file) by converting a 2-D `EGTS_L` file from an I/O API format. To obtain the elevated-point-source Fortran binary file, the SMOKE program **Smkmerge** can create an ASCII elevated-point-source file, which can then be converted to the required binary format using the UAM preprocessor `Ptsrce` [<http://www.remsad.com/ptsrce.htm>].

2.5. Modeling parameters

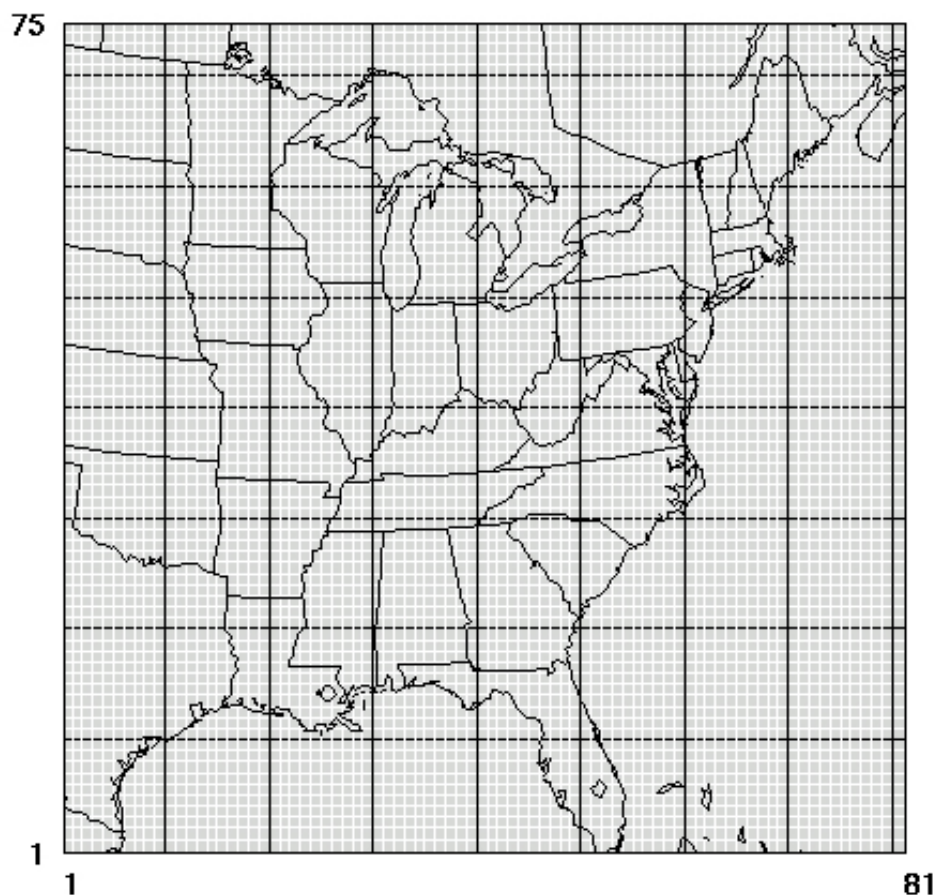
Emissions modeling requires information about the subsequent air quality modeling that will be done. For example, to produce appropriate model-ready files using SMOKE, you must know which AQM will be used, the model grid and map projection, the episode dates, and the chemical mechanism to be used. In this manual, we refer to these settings collectively as “modeling parameters”. In this section, we provide information on what these modeling parameters are and SMOKE’s capabilities to support them.

SMOKE reads in the modeling parameters from both script settings (environment variables) and input files. In the subsections below, we provide the relevant settings and files that control the modeling parameters; how the settings affect the programs is described in Chapter 3, *SMOKE Utility Tools* [91] and Chapter 4, *SMOKE Core Programs* [127].

2.5.1. Map projections and model grids

A map projection is the mathematical representation of the spherical surface of the earth on a 2-D plane. SMOKE supports Lambert conformal, lat-lon, UTM, and polar stereographic map projections. There are many different settings that you may use to define your Lambert conformal, UTM, and polar stereographic projections, to make these projections match the one being used by your meteorology model and AQM. (Lat-lon is a fixed projection and cannot be changed.)

A model grid is a two-dimensional region overlaid on a map projection. It is defined by the starting *x-y* coordinates, the number of grid cells in each direction, and the physical size of the grid cells. Figure 2.2, “Example model grid” [19] shows an example of a model grid that includes most of the eastern U.S. This example has 81 grid cells in the *x*-direction, 75 grid cells in the *y*-direction, and each grid cell is 36 by 36 kilometers. Each set of 10 cells by 10 cells (counting from the starting coordinates) is enclosed in black grid lines.

Figure 2.2. Example model grid

The model grid is set in SMOKE using the `IOAPI_GRIDNAME_1` setting to select a grid and map projection from among those defined in the `GRIDDESC` input file. The name of the grid set with the `IOAPI_GRIDNAME_1` setting must match a grid name in the `GRIDDESC` file to allow SMOKE to obtain the grid and map projection parameters from the `GRIDDESC` file.

2.5.2. Base year and past/future years

For any modeling effort, the emissions base year and future year are key modeling parameters needed for performing emissions processing. The base year is usually the year for which the air quality model is being run in order to compare modeling results with observed air quality data. Such comparisons allow modelers to tune the emissions data and air quality model, to ensure that the AQM is performing adequately during the modeling episode.

The base year is most often a year for which an emission inventory is available. This is usually the same year for which the meteorology model has been run to prepare input to SMOKE and an AQM and for which air quality observations are available. Of course there are exceptions to this principle, but generally that is how one establishes a base year.

Several different files and settings are used to set the base year in SMOKE, each of which should be consistent with each other for ideal results.

- The `YEAR` setting in the `SMOKE Assigns` file is the reference point used by the scripts to determine the base year and set the names of various year-specific input files.
- The episode and run settings (see Section 2.5.3, “Modeling episodes” [20]) determine the base year that will be used in the model-ready output files. This base year must match the `YEAR` setting so that the correct input files are used.
- The input emissions files should ideally contain data for the same base year, and the `#YEAR` header setting in those files should be consistent with the `YEAR` environment variable in the `Assigns` file. If the years in the annual inventory files are not consistent with each other, `SMOKE` will determine the year used by the most sources and set that as the base year. If day-specific or hour-specific data are used, all years in those files must be consistent with the base year of the annual emissions.
- The `MOVES` input data, if they are being used, should also be consistent with the base year. `SMOKE` is capable of running `MOVES` with inputs from a different year, but certain inputs may not be correct.
- Finally, the dates in the I/O API meteorology data from the Meteorology-Chemistry Interface Processor (MCIP) must be consistent with both the base year and the episode and run settings.

The future (or past) year is a chosen year in the future (or past) for which a modeler needs to run an air quality model; for example, to model the future effects of particular emission control strategies. To model a future year with `SMOKE`, you must have either an inventory that has been computed for a future year, or growth and control factors to project the base-year inventory to the future year. The settings and files that must be considered are as follows:

- The setting `FYEAR` is set in the run script and is used by the script to automatically assign the name of the **Cntlmat** input file `GCNTL`, which contains the growth factors. `FYEAR` must be set to the future year even if a future-year inventory is not being created because it has already been provided to you.
- If you already have a future-year inventory and so do not need to use `SMOKE` to project one from the base year inventory, then the emissions data year must match the future year, and the `#YEAR` header in the inventory file must match that year as well. In this case, the `SMK_BASEYR_OVERRIDE` setting must also be used to indicate what the base year is (which will be the same as the year of the meteorology data).
- The `MOVES` input data, if they are being used, must also include the correct settings for the future year of interest.
- The episode and run settings, meteorology files, and day- or hour-specific inventories should *not* match the future year, but rather should use the base-year episode dates.

2.5.3. Modeling episodes

The modeling episode is the total time period for which you will run `SMOKE` and your `AQM`. Unless the episode is just a few days long, users typically set up `SMOKE` to create emissions files of a shorter duration than their modeling episode, often creating one-day files for each day of their episode. Though `SMOKE` can create a single file for an entire episode, the file often becomes too large for some computers to handle (the limit for 32-bit operating systems is 2 GB files), so necessity rather than preference dictates that smaller files (usually one-day files) be created by `SMOKE`. We use the term “run period” to distinguish between these shorter durations and the full modeling episode; unless otherwise noted, we will assume that the run period is one day. For example, a typical `SMOKE` episode might cover July 1, 1996 through July 31, 1996. There will be 31 run periods (days) within this episode, the first starting on July 1, 1996 and the last starting on July 31, 1996.

- The episode start date (EPI_STDATE), episode start time (EPI_STTIME), episode duration in hours (EPI_RUNLEN), and the episode number of days (EPI_NDAY) all must be set to cover the modeling episode. Note that SMOKE can only be run for periods contained within a single calendar year. It cannot, for example, start in December of 1996 and run through January of 1997. Two separate episodes would need to be set up in this case, with the first ending on December 31, 1996, and the second starting on January 1, 1997.
- The start date of the first run period needs to be set using the G_STDATE and ESDATE settings. The G_STDATE is the year and Julian day setting used by the SMOKE programs; in our example above, G_STDATE would be set to 1996183, since July 1 is the 183rd day of 1996. The ESDATE is the Gregorian date used in naming the SMOKE intermediate and output files; for our example, ESDATE would be 19960701. The SMOKE scripts will use the EPI_NDAY setting to automatically loop through the number of run periods in the episode, starting with the first G_STDATE value in the Assigns file. The G_STDATE and ESDATE settings are changed for each run period.
- The run period start time (G_STTIME) and duration (G_RUNLEN) must also be set to indicate the start time and length of each run period. Both values are provided as a number of hours, using a HHMMSS (hours, minutes, seconds) format.

The run period duration (G_RUNLEN) is usually not the same as the episode duration (EPI_RUNLEN). For example, if the episode length is 30 days (720 hours), the run period duration setting could be just 1 day (25 hours), 2 days (49 hours), or three days (73 hours) (the reason for the extra hour in each case is explained below). In the first case, SMOKE would create thirty 25-hourfiles; in the second case, fifteen 49-hour files; and in the third case, SMOKE would create ten 73-hour files.

- The NDAYS, MSDATE, and MDAYS settings are used for naming files. The NDAYS setting should be set to the number of days in each run period, and is used by default for naming time-based files. The NDAYS setting is also used along with the EPI_NDAY setting to loop through the run periods in the episode. The MSDATE and MDAYS settings can be used for naming the meteorology input files, but are not being used by the default Assigns file provided with SMOKE.

There are a few key things to remember when you are verifying that you have the correct episode settings:

- SMOKE cannot process emissions over a calendar-year break. Thus, the longest run that can be done is for 365 days, with the episode start date being January 1. If a modeling episode spans multiple years, then a different Assigns file, script, and sets of input files must be created for each year.
- The AQMs supported by SMOKE always need one extra hour in each emissions input file due to how they calculate boundary conditions. Therefore, if you are inputting emissions to run a 24-hour period, the G_RUNLEN setting should be 250000 for 25 hours.
- The CMAQ and CAM_x models can accept emissions files for multiple days, but the UAM must have 25-hour files only. As stated earlier, however, all of these models are often run using 25-hour files, with one file for each day of the episode.
- All times are associated with a time zone, including the episode and run period start time settings. These settings must be consistent with the time zone of the meteorology files. If the meteorology data were created using MM5, the time zone is most likely Greenwich Mean Time (GMT); therefore, the EPI_STDATE, EPI_STTIME, G_STDATE, and G_STTIME settings would have to be provided in that same time zone. Whatever time zone is inherent in the meteorology files and these date settings will also be the time zone of the dates and times in the output emissions files from SMOKE. This ensures that the dates and times of the emissions and meteorology files are consistent for input to the AQM.

2.5.4. Chemical mechanisms

SMOKE can accommodate a variety of chemical mechanisms for the models it supports. From the emissions processing perspective, the chemical mechanism is the mapping of the pollutants provided in the emissions inventory to the species needed by the AQM of interest. For example, the input files for five chemical mechanisms for the CMAQ model are available for download from the EPA; these mechanisms are Carbon Bond 6 (CB6), CB6 with particulates, Regional Acid Deposition Model, 2 (RADM2), RADM2 with particulates, and a research version of CB6 with toxics.

SMOKE users must know what chemical mechanism will be used in the AQM for which the SMOKE output emissions are intended. Once that has been determined, the following files must be configured to be consistent with the inventory being used and the chemical mechanism: the inventory table (INVTABLE), speciation profiles (GSPRO), speciation cross-reference (GSREF), and the mobile processes file (MEPROC) when creating on-road mobile emissions with MOVES through SMOKE.

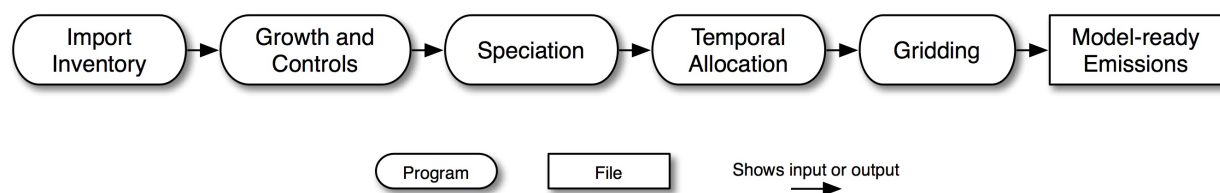
2.5.5. Layer structures

SMOKE needs information on layer structures for processing elevated point sources' plume rise in the **Laypoint** program and creating the ASCII elevated-point-source file (ELEVTS_L or ELEVTS_S) with the **Smkmerge** program. The way SMOKE obtains the layer information differs depending on whether you are creating emissions using a CMAQ-based or UAM-based approach (see Section 2.4.3, "Model-ready files" [18]). For the CMAQ-based approach, SMOKE determines the layer structure from the structure included in the header of the GRID_CRO_3D meteorology file. For the UAM-based approach, SMOKE does not really need to know the layer structure, except to output it to the ASCII elevated-point-source file. In this case, there are many settings obtained by **Smkmerge** from environment variable names starting with UAM_.

2.6. Sparse matrix approach to emissions modeling

The paradigm for atmospheric emissions models prior to SMOKE was a network of pipes and filters. This means that at any given stage in the processing, an emissions file includes self-contained records describing each source and *all* of the attributes acquired from previous processing stages. Each processing stage acts as a filter that inputs a stream of these fully-defined records, combines it with data from one or more support files, and produces a new stream of these records. Redundant data are passed down the pipe at the cost of extra I/O, storage, data processing, and program complexity. Using this method, all processing is performed one record at a time, without necessarily a structure or order to the records.

This old paradigm came about as a way to avoid repeatedly searching through data files for needed information, which would be very inefficient. It is admirably suited to older computer architectures with very small available memories and tape-only storage, but is not suitable for current desktop machines or high-performance computers. SMOKE developers demonstrated this when the Emissions Preprocessor System (EPS) 2.0 was run on a Cray Y-MP. It ran four times slower on the Cray machine (a much faster computer) than on a desktop 150 MHz DEC Alphastation 3000/300. This paradigm also fostered a serial approach to the emissions processing steps, as shown in Figure 2.3, "Serial approach to emissions processing" [23].

The new paradigm implemented in SMOKE came about from analyses indicating that emissions computations should be quite adaptable to high-performance computing if the paradigm were appropriately changed. For each SMOKE processing category (i.e., area, biogenic, mobile, and point sources), the following tasks are performed:

- read emissions inventory data files
- optionally grow emissions from the base year to the (future or past) modeled year (except biogenic sources)
- transform inventory species into chemical mechanism species defined by an AQM
- optionally apply emissions controls (except for biogenic sources)
- model the temporal distribution of the emissions, including any meteorology effects
- model the spatial distribution of the emissions;
- merge the various source categories of emissions to form input files for the AQM
- at every step of the processing, perform quality assurance on the input data and the results

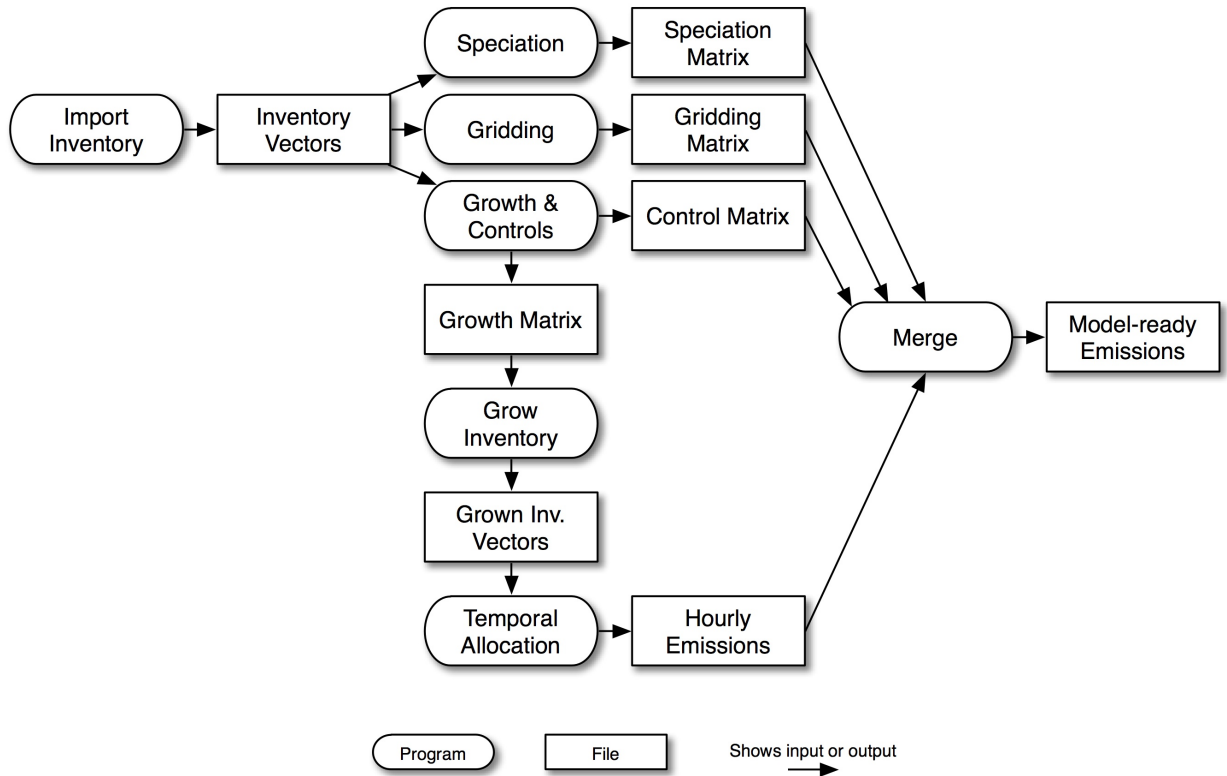
Each processing category has its particular complexities and deviations from the above list; these are described in Section 2.7, “Area, biogenic, mobile, and point processing summaries” [26]. For all categories, however, most of the needed processing steps are *factor-based*; they are linear operations that can be represented as multiplication by matrices. Further, some of the matrices are *sparse* matrices (i.e., most of their entries are zeros).

SMOKE is designed to take advantage of these facts by formulating emissions modeling in terms of sparse matrix operations, which can be performed by optimized sparse matrix libraries. Specifically, the inventory emissions are arranged as a vector of emissions sorted in a particular order, with associated vectors that include characteristics about the sources such as the state/county and SCCs. SMOKE then creates matrices that apply the control, gridding, and speciation factors to the vector of emissions. In many cases, these matrices are independent from one another, and can therefore be generated in parallel and applied to the inventory in a final “merge” step, which combines the inventory emissions vector (now an hourly inventory file) with the control, speciation, and gridding matrices to create model-ready emissions. Figure 2.4, “Parallel approach to emissions processing” [24] shows how the matrix approach allows for a more parallel approach to emissions processing, in which fewer steps depend on other needed steps.

Note that in Figure 2.4, “Parallel approach to emissions processing” [24], temporal allocation outputs hourly emissions instead of a temporal matrix. This is because of some peculiarities with temporal modeling for point sources, which can use hourly emissions as input data. To be able to overwrite the inventory emissions with these hourly emissions, the temporal allocation step must output the emissions data. The matrix approach is used internally in the temporal allocation step.

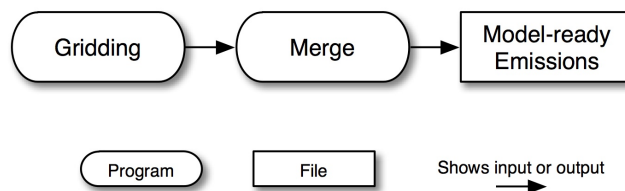
The growth and controls steps shown in Figure 2.4, “Parallel approach to emissions processing” [24] are optional. If the inventory is not grown to a future or past year, then the temporal allocation step uses the original inventory vectors to calculate the hourly emissions.

Figure 2.4. Parallel approach to emissions processing

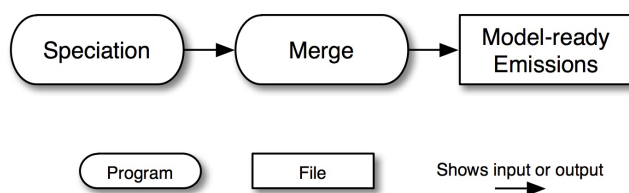

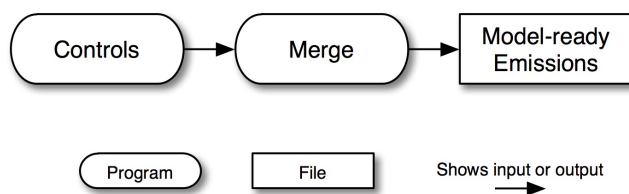
Figure 2.5. Processing steps for running an additional grid in SMOKE

Several benefits can be realized from this more parallel approach. For example, given a single emissions inventory, temporal modeling is performed only once per inventory and episode (though in practice, this step is often performed once per episode day). Also, gridding matrices typically need only be calculated once per inventory and model grid definition, without having to reprocess other steps. As shown in Figure 2.5, “Processing steps for running an additional grid in SMOKE” [24], SMOKE usually needs to rerun only the gridding and merge steps to process a different grid for the same inventory. The merge step in the figure will read the previously created results from the temporal allocation, chemical speciation, and control processing steps.

In addition, speciation matrices need only be calculated once per inventory and chemical mechanism. Similar to the gridding example, Figure 2.6, “Processing steps for running an additional chemical mechanism in SMOKE” [25] shows the SMOKE steps that generally need to be rerun for running an additional chemical mechanism.

A final example of how this approach is beneficial is processing with a control strategy. Because of SMOKE's parallel processing, changing a control strategy requires only the control and merge steps to be processed again (Figure 2.7, "Processing steps for running a control scenario in SMOKE" [25]). In serial processing, on the other hand, the growth and controls step occurs as the second processing step, which requires that all downstream steps be redone. In Figure 2.7, "Processing steps for running a control scenario in SMOKE" [25], the speciation, temporal allocation, and gridding steps have already been run, and can be fed to the merge step without being altered or regenerated.

Although SMOKE processing generally follows the structure shown in Figure 2.4, "Parallel approach to emissions processing" [24], there are some exceptions. In the list below, we summarize these exceptions and provide references to the sections of this chapter where these exceptions are explained and shown through diagrams. These exceptions are also described in more detail in Section 2.7.2, "Area-source processing" [26], Section 2.7.3, "Biogenic-source processing" [29], Section 2.7.4, "Mobile-source processing using MOVES" [30], and Section 2.7.5, "Point-source processing" [41].

- On-road mobile processing with MOVES:** One way of processing on-road mobile-source emissions is to have SMOKE run the MOVES model based on hourly, gridded meteorology data. To run a different grid or control strategy using this approach, users usually need to run a number of additional processing steps that we have not yet discussed. These differences from the standard processing approach are described in Section 2.7.4, "Mobile-source processing using MOVES" [30].
- Biogenics processing:** Biogenics processing uses different processors than those for anthropogenic sources. The emissions from biogenic sources are based on land use data and meteorology data instead of on actual emission inventories. For more information, please see Section 2.7.3, "Biogenic-source processing" [29].
- Toxics processing for different chemical speciation mechanisms:** Toxics processing may require some special processing steps during import of the inventory data when integrating the criteria and toxics inventories. This step depends on which chemical speciation approach is going to be used. Therefore, when changing the toxics speciation mechanism, it is sometimes necessary to rerun the data import step. See Section 2.8.5, "Combine toxics and criteria inventories" [49] for more information.
- Point-source processing for CMAQ versus UAM, or CAM_x:** Point-source processing for CMAQ uses some different programs than processing for UAM or CAM_x. In some cases, it may be necessary to rerun several programs in order to run for one model rather than another. Further details on this additional processing can be found in Section 2.7.5, "Point-source processing" [41].

- **Adding hour-specific or day-specific point-source data:** If you want to add hour-specific or day-specific point-source data after a point source run has already been performed, several processing steps must be rerun. Further details on this additional processing can be found in Section 2.7.5, “Point-source processing” [41].

2.7. Area, biogenic, mobile, and point processing summaries

2.7.1. Summary of SMOKE processing categories

Each SMOKE processing category is defined by its source *characteristics*, which correspond to the identifiers used in creating the emission inventory (e.g., state/county FIPS code and SCC). The processing categories also have source *attributes*, which are the other useful data in the emission inventories that SMOKE uses; examples are point-source flue gas exit height and temperature. Source characteristics *define* the sources as area, biogenic, mobile, or point sources and also distinguish one source in the inventory from another. Source attributes are additional data about the source that do not contribute to the source’s uniqueness in SMOKE. We have previously described in Section 2.2.1, “Inventory data types” [4] the data types and the data attributes that are contained in the inventories that SMOKE uses. In the subsections below, we summarize the source characteristics of area, biogenics, mobile, and point sources. Please refer to Table 2.1, “Inventory source categories and SMOKE processing capabilities and categories” [6] for more information about how SMOKE processing categories map to the inventory source categories.

In SMOKE, each processing category is defined by source characteristics as follows:

- **Area sources** are defined by (1) country, state, and county codes, (2) SCCs, and (3) optionally, grid cell.
- **Biogenic sources** are defined differently depending on the type of processing you are using. They can be defined either by (1) country, state, and county codes and (2) land use code, or by (1) grid cell and (2) land use code.
- **Mobile sources** are defined by (1) country, state, and county codes, (2) SCCs, and (3) optionally link codes.
- **Point sources** are defined by (1) country, state, and county codes, (2) plant/facility codes, and (3) characteristics 1 through 5, one of which must be the SCC.

2.7.2. Area-source processing

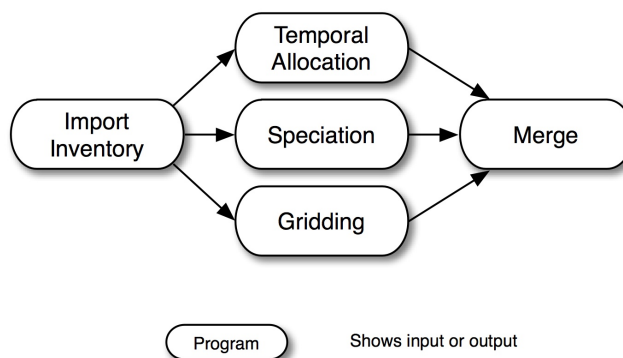
In SMOKE, there are two major processing routes that you can take for area sources: the typical route and the pregridded data route. (Recall that by “area sources” in SMOKE we mean stationary area/nonpoint sources and nonroad mobile sources.)

2.7.2.1. Typical route

The typical route involves processing data identified by country/state/county codes and SCCs. The processing steps vary depending on whether you are doing base-case processing or future- or past-year processing. The steps for base-year processing are shown in Figure 2.8, “Base case area-source processing steps” [27]. In Figure 2.4, “Parallel approach to emissions processing” [24], we also included the major intermediate vectors and matrices; please refer to that diagram for those details. The inventory import step reads the raw emissions data, screens them, processes them, and converts the raw data to the SMOKE intermediate

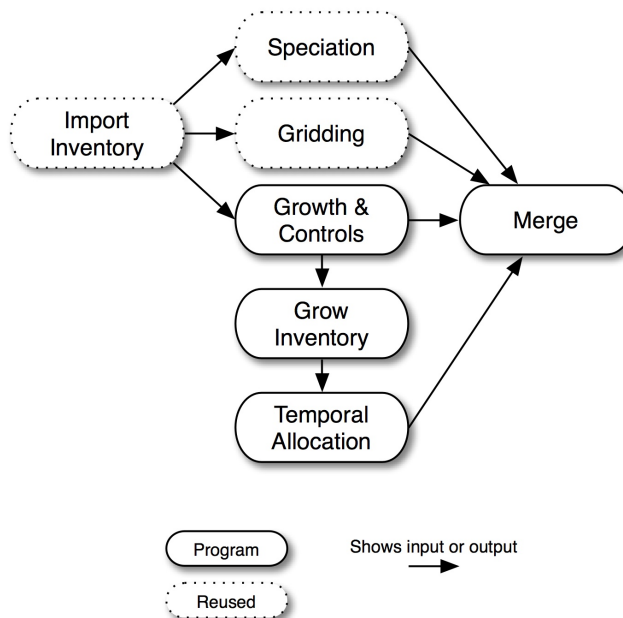
inventory file (inventory vectors in Figure 2.4, “Parallel approach to emissions processing” [24]). The emissions in the inventory file are subdivided to hourly emissions during temporal allocation; assigned chemical speciation factors during speciation, and assigned spatial allocation factors during gridding. The merge step combines the hourly emissions, speciation matrix, and gridding matrix to create model-ready emissions.

Figure 2.8. Base case area-source processing steps

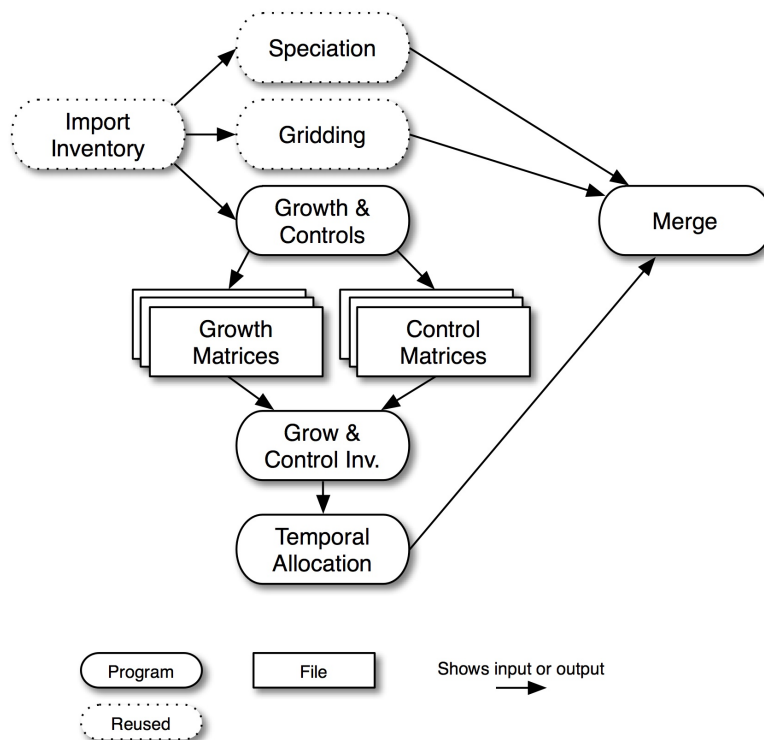
Figure 2.9. Future- or past-year growth and optional control area-processing steps

In Figure 2.9, “Future- or past-year growth and optional control area-processing steps” [27], we show the area-source processing steps for future- or past-year processing. This processing is similar to the base-year processing flow, except the growth and controls step is added to create the growth matrix and optionally one or more control matrices. The grow inventory step applies the growth matrix to convert the base-year inventory to a future or past year. Also, the control matrix can optionally be used in the merge step to apply control factors to the future- or past-year emissions. The steps shown with dotted lines represent steps that can be reused from the base-year processing because they do not depend on any of the new steps.

Finally, inventory controls as well as growth can be applied at the front end of processing if such a scheme is needed (Figure 2.10, “Alternative future- or past-year growth and control area-processing steps” [28]).

This method permits up to 80 growth and/or control matrices to be applied to an inventory, whereas the method shown in Figure 2.9, “Future- or past-year growth and optional control area-processing steps” [27] allows only one control matrix in the merge step, although any number of growth matrices on the front end. The processing scheme shown in Figure 2.10, “Alternative future- or past-year growth and control area-processing steps” [28] can therefore be useful when mixing and matching many control strategies for simulations.

- Section 2.19, “Quality assurance” [88]

2.7.2.2. Pre-gridded Emissions

2.7.2.2.1. Pregridded data route for same modeling domain

The second processing approach for area sources involves using pregridded data. As indicated in Section 2.7.1, “Summary of SMOKE processing categories” [26], area sources can be specified by grid cell instead of by country/state/county code and SCC. This optional approach to modeling area sources requires

the inventory emissions data to be gridded prior to inventory import. The gridded area sources do *not* have country/state/county codes or SCCs, and can be provided via an I/O API time-independent gridded data file. The flow diagrams that describe this type of processing are identical to those in Figure 2.8, “Base case area-source processing steps” [27], Figure 2.9, “Future- or past-year growth and optional control area-processing steps” [27], and Figure 2.10, “Alternative future- or past-year growth and control area-processing steps” [28]. Although the gridding step is quite trivial when the grid cell numbers are already specified, the gridding step must still be run to create a gridding matrix required for the merge step.

The disadvantage of using pregridded emissions for area-source processing is that there are no country/state/county codes and SCCs to use in the cross-referencing of any processing step. Therefore, temporal profiles, speciation profiles, growth factors, and control factors must be applied uniformly across the model grid by pollutant.

2.7.2.2.2. Pregridded data route for a different modeling domain

The sequence for processing global emissions data (e.g., EDGAR, RCP and HTAP) for hemispheric CMAQ involves projecting the data from latitude-longitude projection to polar stereographic projection, converting the inventory species to the terms required by the CMAQ chemical mechanism, and extrapolating the annual emissions to hourly estimates.

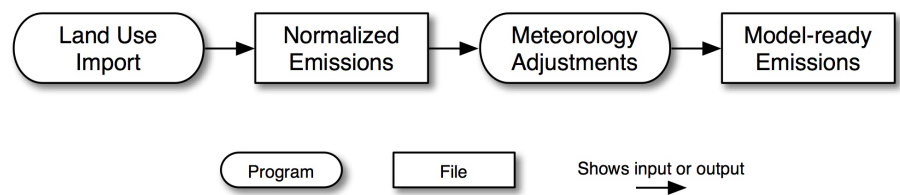
2.7.2.3. Day-specific and Hour-specific Emissions

Emissions from area sources are sometimes available as day- or hour-specific values. **Smkinven** can import the day- and hour-specific data, and it can also convert the hour-specific data to hour-specific temporal profiles. When these data are available, the **Temporal** program overrides the annual or daily emissions with the most specific data available. If day-specific data are available, **Temporal** uses them to overwrite the annual or average-day emissions during the time periods that these data are available. If hour-specific data are available, **Temporal** uses them to overwrite the annual, average-day emissions, or day-specific emissions data.

2.7.3. Biogenic-source processing

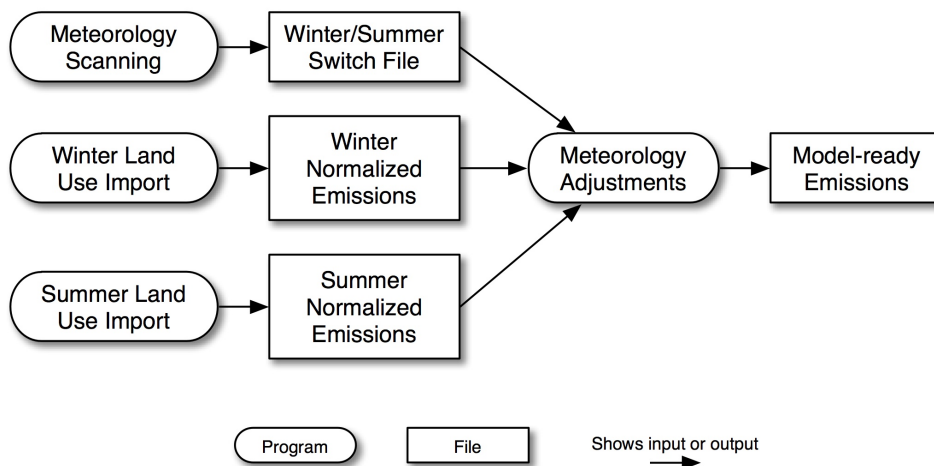
Figure 2.11. Biogenic-source processing steps and intermediate files

SMOKE biogenic emissions modeling can be accomplished with the Biogenic Emissions Inventory System, version 4 (BEIS4) approach using the processing scheme (Figure 2.11, “Biogenic-source processing steps and intermediate files” [29]). The raw land use inventory data are imported and output as normalized emissions. Meteorology adjustments are then applied to the normalized emissions to create hourly model-ready emissions estimates.

The land use import can start with gridded BELD6 inputs along with summer and winter emission factors. In Section 2.16, “Biogenic processing” [85], we provide additional details about the SMOKE programs used for BEIS4 processing and its capabilities.

A variation can be run on the processing steps shown in Figure 2.11, “Biogenic-source processing steps and intermediate files” [29] (see Figure 2.12, “Biogenic-source processing steps and intermediate files using both winter and summer emission factors” [30]). In this variation, some grid cells use summer emission factors and some use winter emission factors. This is useful during the changes of seasons. Based on guidance from EPA, the summer emissions factors should be used for time periods after the last frost of the spring until the first frost of the fall, and winter emission factors should be used at other times of the year. To make such assignments by grid cell, the SMOKE utility **Metscan** analyzes the meteorology data for the entire year (or the period of interest) to establish which days each grid cell should use winter and summer emission factors. **Metscan** creates a winter/summer switch file that indicates the appropriate season for each grid cell for each day. More information on **Metscan** is available in Section 3.3.10, “**Metscan**” [117]. The results of the meteorology analysis can then be used in the Figure 2.12, “Biogenic-source processing steps and intermediate files using both winter and summer emission factors” [30] processing approach, in which both the summer and winter normalized emissions are provided to the meteorology adjustments step, along with the winter/summer switch file. The resulting model-ready emissions data have used the winter emission factors for all grid cells of the domain that have experienced the first freeze date of the year but not the last (within a calendar year, this is the time periods January through March and November through December in many regions), and the summer emission factors for all grid cells between the last and first freeze dates.

In Section 2.16, “Biogenic processing” [85] we describe the SMOKE programs that are needed for each of these processing types for BEIS4 processing, and additional details about what activities are accomplished during each step.

2.7.4. Mobile-source processing using MOVES

SMOKE provides two ways of processing mobile sources using MOVES. (Recall that by “mobile sources” in SMOKE we mean on-road mobile sources.) The first approach is to compute mobile emissions values prior to running SMOKE and provide them to SMOKE as input; we call this the precomputed-emissions approach. The second approach is to provide SMOKE with VMT data, Vehicle population (VPOP) data, meteorology data, and MOVES outputs, and have SMOKE compute the mobile emissions based on these

data; this is called the MOVES approach. These approaches are not mutually exclusive, so it is possible to provide both precomputed emissions and VMT and VPOP data to SMOKE and have the system compute only some of the emissions using MOVES outputs. Both processing approaches can produce criteria, particulate, and toxics emissions results.

The precomputed-emissions approach is quite similar to the processing method for area sources. In fact, Figure 2.8, “Base case area-source processing steps” [27], Figure 2.9, “Future- or past-year growth and optional control area-processing steps” [27], and Figure 2.10, “Alternative future- or past-year growth and control area-processing steps” [28] from Section 2.7.2, “Area-source processing” [26] show exactly the processing steps needed for processing mobile sources using SMOKE and the precomputed-emissions approach. As in base-case processing for area sources, emissions in the inventory file are subdivided to hourly emissions during temporal allocation, assigned chemical speciation factors during speciation, and assigned spatial allocation factors during gridding. The merge step combines the hourly emissions, speciation matrix, and gridding matrix to create model-ready emissions. For future- or past-year processing, the growth and controls step is added to create the growth and control matrices, while the grow inventory step converts the inventory from the base year to a future or past year. The control matrix can be optionally used in the merge step to apply control factors to the future- or past-year emissions. Note that, unlike the VMT approach, in the precomputed-emissions approach SMOKE will not model the variations in emissions caused by temperature, humidity, or other meteorological settings.

The MOVES approach is much different from the precomputed-emissions approach. Figure 2.13, “MOVES mobile RatePerDistance processing steps” [32] and Figure 2.14, “MOVES mobile RatePerVehicle and RatPereProfile (off-network) processing steps” [32] summarize the MOVES approach. First, county total activity inventory VMT data by road class and vehicle type or county total activity inventory VPOP by vehicle type are input to SMOKE. The chemical speciation step computes the chemical speciation factors for each county, road class, vehicle type, emissions process (e.g., exhaust start, exhaust running, evaporative processes, extended idle, and crankcase), and pollutant and stores the necessary factors for this transformation. The gridding step allocates the sources to grid cells and uses spatial surrogates to allocate county-total emissions to grid cells, storing the emission rates needed for these allocations based on hourly gridded ambient temperature meteorology.

The approach for running MOVES for SMOKE relies on the concept of representative counties and fuel months. The concept of representative county refers to running MOVES for a single county, which is the representative county, to represent itself and other counties that share the same MOVES input parameters and thus have the same emission rates for any given speed, temperature and humidity. A reference fuel month similarly refers to a reference fuel month's MOVES run that contains the temperatures that occur in neighboring months as well as the representative month. The mapping of calendar months to a representative month should be assigned on the basis of shared fuel parameters, because it is the interaction of fuel and temperature that is important. For example, an average-hourly temperature of 70°F may occur in some hour of any day in each of four months: May, June, July and August. If those four months share the same fuel properties (i.e. summer fuel) then an emission factor will be determined for just the representative month, reducing by a factor of four the number of calculations that MOVES needs to perform.

Unlike MOBILE6, MOVES differentiates between on-roadway emission processes and off-network emission processes. Figure 2.13, “MOVES mobile RatePerDistance processing steps” [32] summarizes the approach used by MOVES for on-roadway mobile sources. The on-roadway emission process includes county-total VMT and average speed inventory as input. The off-network emission processes use the county-total vehicle population by vehicle type as input. Figure 2.14, “MOVES mobile RatePerVehicle and RatPereProfile (off-network) processing steps” [32] summarizes the approach used by MOVES for off-network mobile sources. Both on-roadway and off-network emission processes do require real gridded meteorology data from MCIP files to estimate temperature-dependent emission rates.

Figure 2.13. MOVES mobile RatePerDistance processing steps

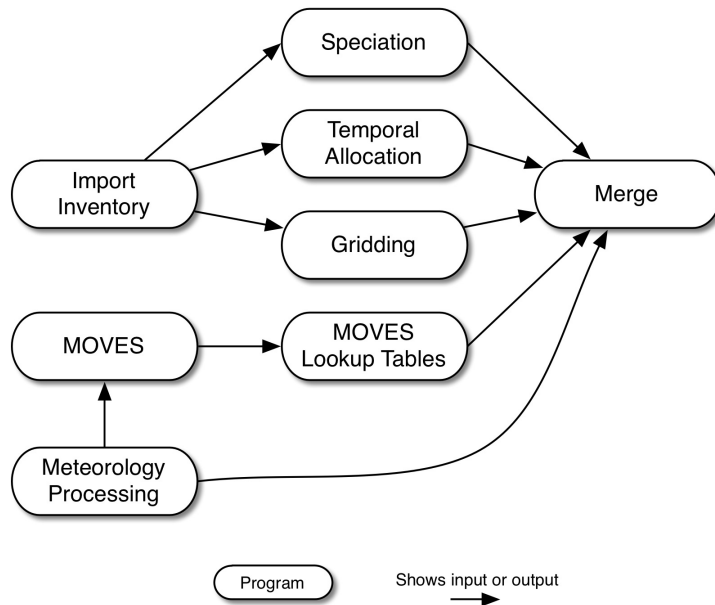
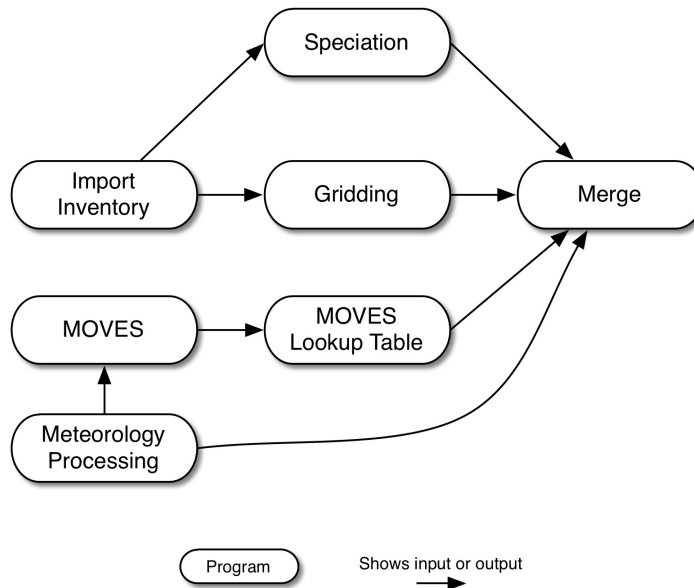


Figure 2.14. MOVES mobile RatePerVehicle and RatPereProfile (off-network) processing steps



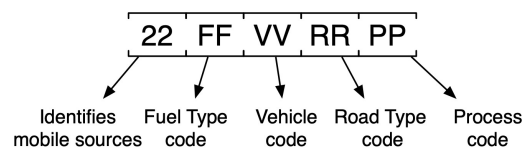

Processing mobile sources involves a number of concepts that are unique to mobile sources. These include a special classification of road types in MOVES, SMOKE and MOVES vehicle types, emissions processes, MOVES emission factors, representative counties, reference fuel months, and meteorological processing using **Met4moves**. The following subsections explain these topics in more detail.

2.7.4.1. Special approach for on-road mobile MOVES SCCs

SMOKE handles SCCs differently for on-road mobile sources compared with all other source categories. SMOKE programs assume that on-road mobile SCCs have the following form:



2.7.4.2. Fuel types in MOVES

MOVES can model six different fuel types: Gasoline, Diesel, Compressed Natural Gas (CNG), Liquefied Petroleum Gas (LPG), Ethanol, and Electricity. Table 2.2, “MOVES Fuel Type” [33] indicates a list of original MOVES fuel types.

2.7.4.6. Representative Counties

The approach for running MOVES for SMOKE relies on the concept of representative counties. These are counties that are used during the creation and use of emission rates to represent a set of similar counties (i.e., inventory counties) called a county group. The purpose of the representative county approach is to reduce the computational burden of running MOVES on every county in your modeling domain. By using a representative county, the user generates key emission rates for the single county in MOVES and then utilizes these factors to estimate emissions for all counties in the county group through SMOKE. The representative county is modeled at a range of speeds and temperatures to produce emission rate lookup tables (grams/mile or grams/vehicle/hour, depending on mobile emission process). The variables that are assumed to be constant across the county group members (and the representative county) are fuel parameters, fleet age distribution and inspection/maintenance (I/M) programs. The variables that can vary within the county group are vehicle miles traveled (VMT), source type vehicle population, roadway speed, and grid cell temperatures. Determining the representative counties and their respective county groups is a key aspect of utilizing the SMOKE-MOVES tool. It is ideal for the user to create each county group based on the similarity between the county characteristics (e.g., urban and rural) and the meteorological conditions (e.g., temperature and relative humidity). The user should avoid grouping counties that have significantly different meteorological conditions.

2.7.4.7. Reference Fuel month

Along with the concept of representative county approach, the concept of a fuel month is very important. It is used to indicate when a particular set of fuel properties should be used in a MOVES simulation. Similar to the representative county, the fuel month reduces the computational time of MOVES by using a single month to represent a set of months. To determine the fuel month and which months it corresponds to, the user should review the State-provided fuel supply data in the MOVES database for each representative county. If the fuel supply data change throughout the year, then group the months by fuel parameters. For example, if the grams/mile exhaust emission rates in January are identical to February's rates for a

given representative county, then use a single fuel month to represent January and February. In other words, only one of the months needs to be modeled through MOVES.

2.7.4.8. Meteorological Data Processing

The meteorological data processor program **Met4moves** prepares spatially and temporally averaged temperatures and relative humidity data to set up the meteorological input conditions for MOVES and SMOKE using the Meteorology-Chemistry Interface Processor (MCIP) output files.

Met4moves must be run after MCIP and before the MOVES Driver script “**Runspec_generator.pl**” and SMOKE modeling system.

The following are the major processing steps that **Met4moves** performs:

- Read the representative county cross-reference file M CXREF that contains a list of representative counties and the county groups that map to those representative counties.
- Read the surrogate description file SRGDESC and a list of associated spatial surrogate(s) chosen for use in selecting grid cells.
- Determine a list of grid cells for each county. Only the selected grid cells are used to estimate the min/max temperatures, 24-hour temperature profiles, and RH over the user-specified modeling period.
- Set the dates of the modeling episode in local time using the flags STDATE and ENDATE
- Determine the fuel month for the representative county using the MFMREF input file.
- Read the country/state/county COSTCY or GEOCODE_LEVEL [1 - 4] (if USE_EXP_GEOCODES Y) file to define the time zones for county groups.
- Read the meteorology data that have been processed by MCIP.
- Calculate the min/max temperatures hourly and over the modeling period.
- Calculate average RH for the specified hour range over the modeling period.
- Once min/max temperatures and averaged RH are estimated for all representative counties and all inventory counties in the county groups, estimate diurnal 24-hour temperature profiles for use by the MOVES Driver script. The result is a normalized 24-hour shape profile over the user-specified period or fuel month.

2.7.4.9. MOVES Emission Processes by Emission Rate Tables

When the MOVES model runs for SMOKE, it runs for all emissions processes (or modes), including on-roadway and off-network emissions processes, for the selected pollutants. Off-network emission processes (e.g., parked engine-off, engine starts, and idling, and fuel vapor venting) in MOVES are hour-dependent due to vehicle activity assumptions built into the MOVES model; the emission rate depends on both hour of the day and temperature. On-roadway emission processes (e.g., running exhaust, crankcase running exhaust, brake wear, tire wear, and on-road evaporative), on the other hand, do not depend on hour. In MOVES, these emission processes are categorized into three major groups:

- **RatePerDistance (RPD)** - The emission rate of on-roadway vehicles (e.g., driving) from MOVES. The rate is expressed in grams/mile traveled.
- **RatePerVehicle (RPV)** - The emission rate of off-network vehicles (e.g., idling, refueling, parked) from MOVES. The rate is given in grams/vehicle/hour.

- **RatePerProfile (RPP)** - The emission rate of off-network vehicles specifically, the evaporation from parked vehicles (vapor-venting emissions) from MOVES. The rate is expressed in grams/vehicle/hour.
- **RatePerHour (RPH)** - The emission rate of extended idle exhaust from on-roadway vehicle. The rate is expressed in grams/hour traveled.
- **RatePerStart (RPS)** - The emission rate of off-network vehicles from engine start exhaust and crankcase start exhaust processes. The rate is expressed in grams/no of engine starts.
- **Off-Network Idling (RPHO or ONI)** - The emission rate of off-network vehicles from idling process from parking lots, distribution centers et al., The rate is expressed in grams/hours of vehicle idling.

MOVES emission rates are organized into four lookup tables (RPD, RPV, RPP, RPH, RPS and RPHO), depending on emission process and whether the vehicle is parked or in motion. The approach to running MOVES for SMOKE is unique for each emission rate table listed in Table 2.6, “MOVES Emission Processes by Emission Rate Tables” [37]. A complete inventory must use the emission rates from all three tables. Note that refueling emission process is not a subject to MOVES emission rate table approach yet.

The RPD lookup table is used to provide estimates of on-roadway emissions processes from mobile sources, using a separate file for each representative county. The on-road running processes that appear in this table include running exhaust, crankcase running exhaust, brake wear, tire wear, on-road evaporative permeation, on-road evaporative fuel leaks, and on-road evaporative vapor venting. The units of the emission rates in this table are grams/mile. The lookup fields for the factors are temperature and average speed. There are 16 set speed bins defined in Table 2.7, “MOVES Default Speed Bins” [39] (i.e., avgSpeedBinID 1=2.5mph, 2=5mph, 3=10mph, ...16=75mph). The avgBinSpeed is used for interpolation in the RPD table.

The RPV, RPH, and RPS lookup table is used to provide estimates of off-network emission processes (parked engine-off, engine starts, and idling), except for the evaporative off-network vapor venting emissions process. A separate file is provided for each representative county. The off-network emission processes include start exhaust, crankcase start exhaust, off-network evaporative permeation, off-network evaporative fuel leaks, extended idle exhaust, and crankcase extended idle exhaust. Fuel month, temperature, and local hour are the lookup fields in this table, and hours are in the local time of the modeling county. The units of the emission rates are grams/vehicle/hour. Note: Although the units are grams/vehicle/hour, the number of vehicles (i.e., population) should not be temporally allocated to hours in SMOKE. Instead, a county total of vehicle population should be multiplied by emission rates at any given hour. The number of starts per vehicle by hour is already accounted for in the MOVES lookup table.

The RPP table is used only to estimate emissions for off-network fuel vapor venting when the vehicle is parked. This process type includes diurnal (when the vehicle is parked during the day) and hot soak (immediately after a trip when the vehicle parks) emissions types. The process depends on the rate of rise in temperature and the maximum temperature achieved during the day for the diurnal emissions type, and on the hourly temperatures for the hot soak emission type. The lookup fields for this table are reference fuel month and hour of day. As with the RPV table, the units of the emission rates are grams/vehicle/hour. The estimated emissions rates need to be multiplied by the county vehicle population. The representative county lookup tables contain 24-hour emission rates per hour per vehicle using a representative county temperature profile with different minimum and maximum temperatures. The average day county emissions are determined by interpolating between the minimum and maximum temperatures for the modeling county generated by **Met4moves**. Section 2.7.4.8, “Meteorological Data Processing” [36] summarizes how **Met4moves** processes meteorological data for both MOVES and SMOKE.

The RPH table is used only to estimate emissions for on-roadway extended idle exhaust process from mobile sources, using a separate file for each representative county.

:

The RPS table is used only to estimate emissions for off-network engine start and crankcase start exhaust when the vehicle engines get ignited. Number of vehicle starts activity inventory will be used to compute the emissions multiplying to RPS grams/start emission rate.

The RPHO (ONI) table is used only to estimate emissions for off-network vehicle idling process during especially heavy duty vehicle engines are in idling mode in the parking lot and distribution. Number of vehicle idling hours activity inventory will be used to compute the emissions multiplying to RPHO (ONI) grams/hour emission rate.

2.7.4.10. MOVES Pollutant Groups

The following Table 2.8, “MOVES Pollutant Groups” [40] provides a list of available MOVES pollutant groups that the user can specify to model within MOVES. The choice of pollutant groups(s) determines what pollutants are included in the three emission rate lookup tables (RPD, RPV, and RPP) output by MOVES. The letter 'X' marks the key pollutants for inclusion, and a letter 'd' signifies that the pollutant is included as a default in the MOVES run because a key pollutant depends on it. The user modifies the control.in input file to specify the pollutant group.

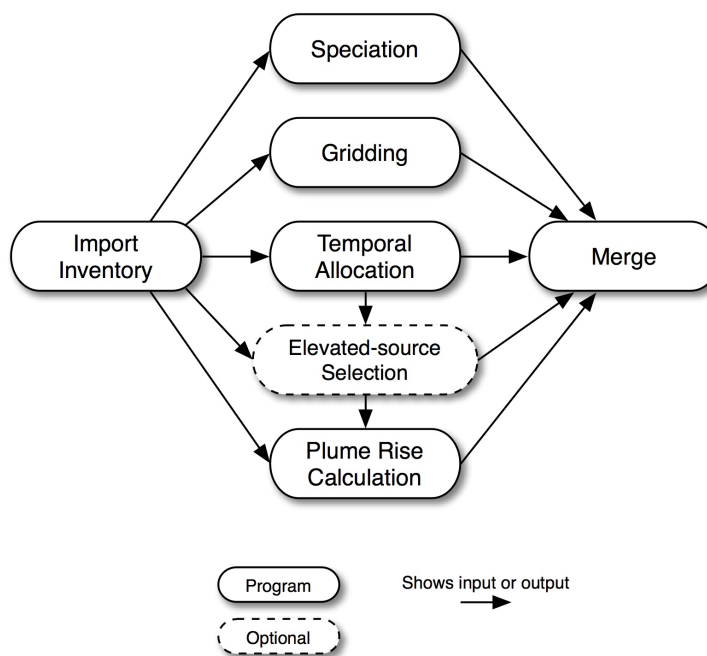

2.7.5. Point-source processing

Point-source emissions processing in SMOKE focuses on converting annual, daily, or hourly emissions to hourly, gridded model-ready emissions of the chemical species used by an AQM. Recall that by “point sources” in SMOKE we mean point sources in the usual sense plus wildfires with/without precomputed plumes. SMOKE processing may be performed either with or without growth and control of emissions. SMOKE can process both criteria and toxics inventories for point sources and combine consistent criteria and toxics inventories in one run (as explained in more detail in Section 2.8.5, “Combine toxics and criteria inventories” [49]).

Point-source processing can be performed using a CMAQ-based approach or a UAM-based approach, as previously described in Section 2.4.3, “Model-ready files” [18]. The processing steps for CMAQ base-year processing are shown in Figure 2.15, “Base case point-source processing steps for the CMAQ-based approach” [41]. In Figure 2.4, “Parallel approach to emissions processing” [24], we also included the major intermediate vectors and matrices; please refer to that diagram for those details.

Figure 2.15. Base case point-source processing steps for the CMAQ-based approach

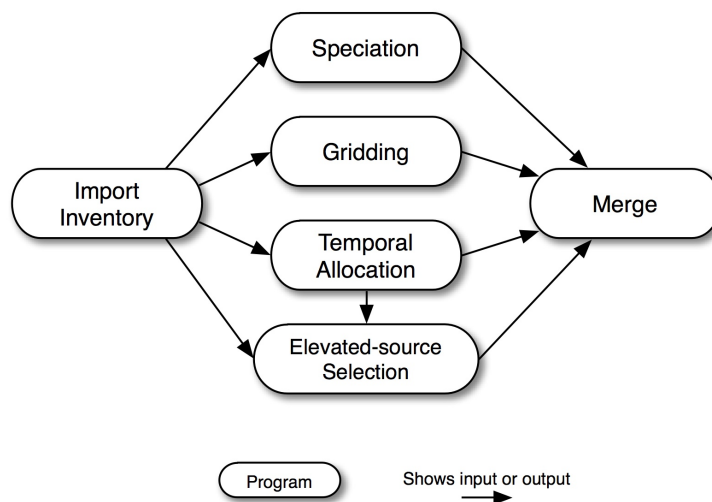


The inventory import step reads the raw emissions data, screens them, processes them, and converts the data to the SMOKE intermediate inventory file (inventory vectors in Figure 2.4, “Parallel approach to emissions processing” [24]). The import can optionally include day-specific and hour-specific data. The emissions in the inventory file are subdivided to hourly emissions during temporal allocation; assigned chemical speciation factors during speciation, and assigned spatial allocation factors during gridding. The plume-rise computation estimates vertical plume rise of emissions sources and computes the fraction of emissions from the sources to go into the model layers. The results of these steps are combined in a merge step, which creates model-ready files for CMAQ.

Users may optionally choose to select specific sources to be elevated sources and/or PinG sources. If this approach is taken, the selection process can depend on daily-total emissions summed from the **Temporal** output files. Hence, Figure 2.15, “Base case point-source processing steps for the CMAQ-based approach” [41] shows that the elevated-source selection may optionally depend on the output from the **Temporal** program. If elevated-source selection is being included, the plume-rise computation uses that information to skip the point sources that have not been selected as elevated. Thus, plume rise is only computed for the elevated sources. The elevated-source selection also provides its results to the merge step, which is where the special PinG data files for CMAQ are created in addition to the 3-D model-ready file.

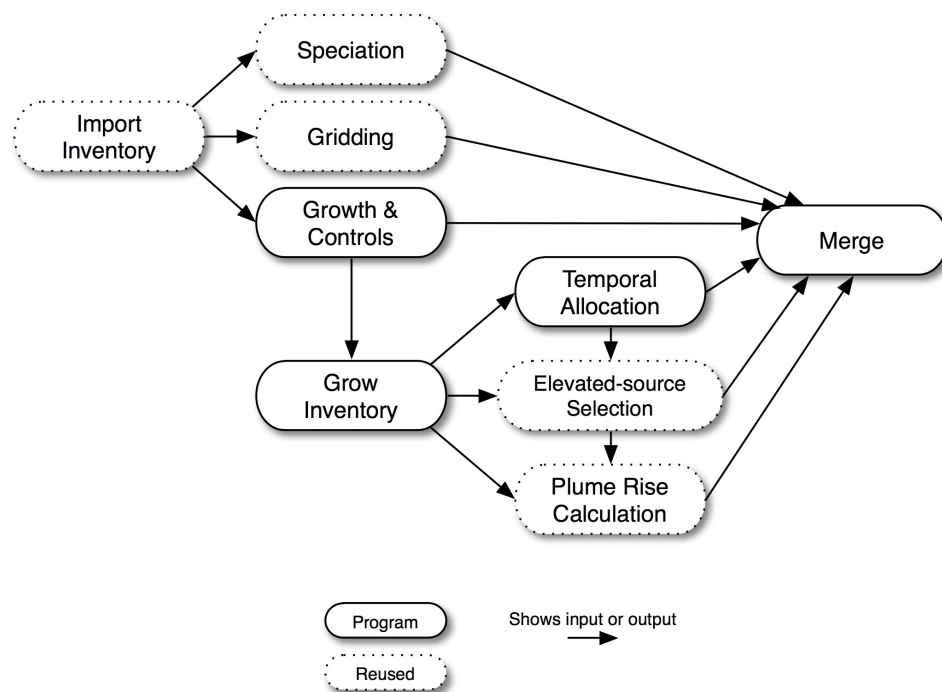
Figure 2.16, “Base case point-source processing steps for the UAM-based approach” [42] describes base-case processing for the UAM-based approach. For this type of modeling, the elevated-source selection step is required, and the plume rise computation is not performed. Otherwise, the major processing steps are the same as for the CMAQ-based approach.

Figure 2.16. Base case point-source processing steps for the UAM-based approach



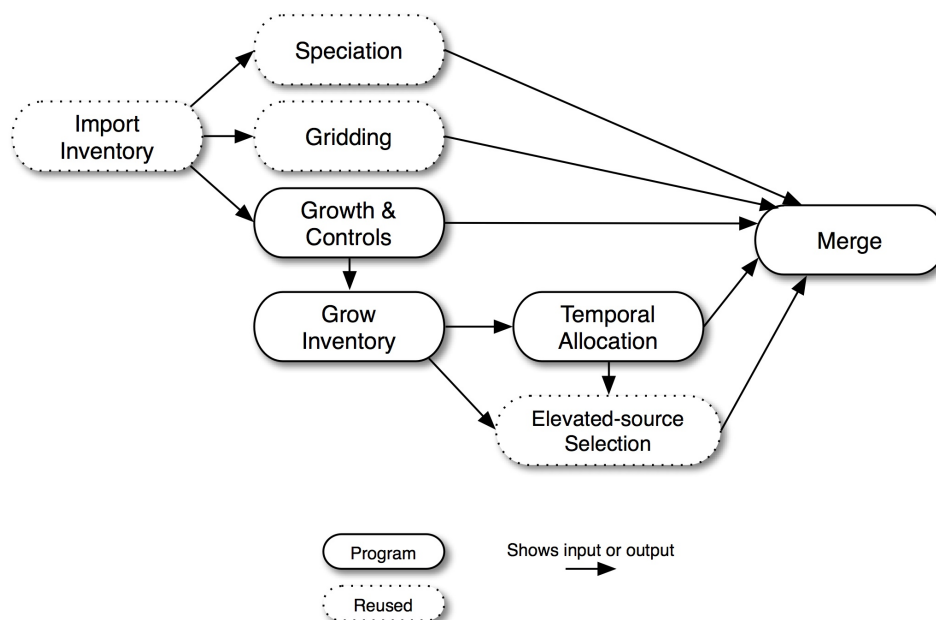
In Figure 2.17, “Future- or past-year growth and control point-source processing steps for the CMAQ-based approach” [43], we show the point-source CMAQ-based processing steps for future- or past-year processing. This processing is similar to the base-year processing flow, except the growth and controls step is added to calculate the growth and control matrices. The grow inventory step is added to convert the inventory from the base year to a future or past year. The control matrix can optionally be merged to apply control factors to the future- or past-year emissions. The steps shown with dotted lines represent steps that can be reused from the base-year processing because they do not necessarily depend on any of the new steps. However, if the elevated-source selection is to be performed based on the grown emissions, then the elevated-source selection and plume rise computation steps would need to be redone. Note that usually the same elevated-source list is used in both the base- and future-year modeling.

Figure 2.17. Future- or past-year growth and control point-source processing steps for the CMAQ-based approach



Growth and control can also be used for UAM-based processing (Figure 2.18, “Future- or past-year growth and control point-source processing steps for the UAM-based approach” [44]). As with the other figures, the dotted lines indicate steps that may be reused from the base-case processing. If the elevated-source selection depends on the grown emissions then you will need to regenerate the elevated-source list, though it is the usual practice in modeling to use the same elevated-source list in both the base- and future-year modeling. This allows the air quality modeling results to be more comparable.

As with area sources, you may apply many growth and control matrices at the front end of processing. The area-source diagram for this approach was provided as Figure 2.10, “Alternative future- or past-year growth and control area-processing steps” [28], and the point-source approach is quite similar, with the addition of the elevated-source selection and plume rise computation steps.

In sections later in this chapter, we describe the SMOKE programs that are needed for each of the processing steps just discussed and additional details about what activities are accomplished during each step. These sections are:

- Section 2.8, “Inventory import” [47]
- Section 2.9, “Temporal processing” [57]
- Section 2.10, “Chemical speciation processing” [63]
- Section 2.11, “Spatial processing” [67]
- Section 2.12, “Growth processing” [71]
- Section 2.13, “Control processing” [74]
- Section 2.14, “Elevated-source processing” [77]
- Section 2.17, “Creating model-ready emissions” [86]
- Section 2.19, “Quality assurance” [88]

Point-source processing includes a number of additional features that are not applicable for other SMOKE source categories:

1. Flexible source definitions
2. Stack parameters
3. Day- and hour-specific emissions
4. Different approaches for elevated sources for different AQMs, including the use of PinG sources
5. Elevated-source selection
6. Wild and prescribed fires point sources

2.7.5.1. Flexible source definitions

Depending on the input format of the point-source emissions (e.g., FF10, ORL), the set of characteristics that are used to uniquely identify a point source can be different. For example, the ORL-formatted inventories define a point source using a country, state, and county code, an SCC, a plant identifier, a stack number, a point identifier, and a segment number. The FF10 format, however, identifies a source using a FIPS state/county code, a plant code, a unit ID, a segment ID, and SCC. To better support the formats and be adaptable if new formats are created in the future, SMOKE uses a flexible definition of point sources. This definition consists of the following source characteristics to uniquely define the sources:

- Country, state, and county code
- Plant ID (15 characters or less)
- Characteristics 1 through 5 (each 15 characters or less)

Depending on the input format, SMOKE assigns different variables from the input format to the parts of the SMOKE point-source definition. The assignments for the remaining characteristics are as follows:

ORL format:

- Char 1: Point ID
- Char 2: Stack ID
- Char 3: Segment ID
- Char 4: SCC
- Char 5: unused

FF10 format:

- Char 1: Stack ID
- Char 2: Unit ID
- Char 3: Segment ID
- Char 4: SCC
- Char 5: unused

The meaning of these source characteristics for a given inventory type needs to be considered when cross-reference files are created, if cross-reference entries other than state/county and SCC-specific entries are provided.

2.7.5.1.1. Point definition header row in cross-reference files

As just described, SMOKE uses a flexible definition of point sources. This definition may or may not include the SCC (although SCC is always at least a source attribute). Cross-reference files for point sources can contain source-specific records, and they usually use the SCC to perform the needed assignments during emissions processing. For the files to be self-describing, they use a header that indicates the number of characteristics in addition to the plant ID that are being used in the cross-reference file. This number needs to be consistent with the number of point-source characteristics used in the inventory files. In addition, the header indicates which, if any, of the point-source characteristics is the SCC. This header starts with the characters `/POINT DEFN/`, and the files that use it describe it as part of the file format definition in Chapter 6, *SMOKE Input Files* [261].

2.7.5.2. Stack parameters

Several of the source attributes for point sources are stack parameters - specifically, the stack height, stack diameter, and the stack flue gas exit temperature, velocity, and flow rate. SMOKE can use hourly data for

the stack flue gas exit temperature, velocity, and flow rate when using the CMAQ-based approach to modeling with SMOKE computing hourly plume rise. The hourly stack parameters cannot be used when modeling using a UAM-based elevated-point-source approach.

During the **Smkinven** program's import of the stack parameters from the annual or average-day inventory file (i.e., not the hourly stack parameters), SMOKE needs to read or assign stack parameters for all point sources. Section 2.8.9, "Fill in and check point-source stack parameters" [52] explains in greater detail what the **Smkinven** program does with stack parameters. The hourly stack parameters are read in without modification or adjustment.

2.7.5.3. Day-specific and hour-specific emissions

Emissions from point sources are sometimes available as day- or hour-specific values. **Smkinven** can import the day- and hour-specific data, and it can also convert the hour-specific data to hour-specific temporal profiles. When these data are available, the **Temporal** program overrides the annual or daily emissions with the most specific data available. If day-specific data are available, **Temporal** uses them to overwrite the annual or average-day emissions during the time periods that these data are available. If hour-specific data are available, **Temporal** uses them to overwrite the annual, average-day emissions, or day-specific emissions data.

2.7.5.4. Different approaches for elevated sources for different AQMs

As introduced in Section 2.4.3, "Model-ready files" [18], there are two different major approaches for creating emissions inputs to AQMs: the CMAQ-based approach and the UAM-based approach. The two approaches differ only on how point sources are being treated. In the CMAQ-based approach, SMOKE calculates the plume rise using an algorithm based on a Briggs plume rise formulation. SMOKE then includes the vertical distribution of the point-source emissions in the 3-D model-ready file for CMAQ. For the CMAQ model only, SMOKE can also create two special PinG files: one to identify the sources, their locations, and their stack parameters, and the other to provide the hour-specific emissions for just these sources. In the UAM-based approach, SMOKE creates a special elevated-point-source file that both identifies the elevated and PinG sources and includes the hourly emissions values for those sources.

PinG sources are those sources that will be treated in greater detail by the AQM. In simple terms, the AQMs preprocess the chemistry of the plume emissions before those emissions are provided to the AQM grid cells and layers. The intent of the PinG approach is to provide more accurate modeling at and around very large point sources.

Section 2.14, "Elevated-source processing" [77] describes in greater detail the steps taken by SMOKE in the layer fraction processing using a Briggs formulation and the elevated and PinG source selection.

2.7.5.5. Wild and prescribed fires point sources

You may also either provide either precomputed point-source plume rise to SMOKE or internally compute plume rise using acres burned and fuel loading of fires with both the CMAQ-based and UAM-based approaches to modeling point sources. Precomputed plume rise point sources are called explicit plume sources. This capability was implemented for modeling wildfire sources as point sources in SMOKE using plume rise computed with a different approach from the Briggs-based approach used for stack-based plumes. The input data for this approach are the fraction of emissions in layer 1, the bottom of the plume, and the top of the plume. SMOKE distributes the emissions across the layers by weighting the emissions by the pressure difference in each layer over the total pressure difference between the top and bottom of the plume.

For the UAM-based modeling approach, the file format does not readily allow you to provide precomputed plume rise; in fact, the entire premise of the format is that the AQM will compute the plume rise. To enable you to provide precomputed rise for the UAM-based modeling approach, the **Smkmerge** program creates

an ASCII elevated-point-source file with an imaginary stack for each layer of each source (e.g., each wildfire). The stack parameters of the imaginary stack are set to values that will ensure a zero plume rise will be computed for the stack, and the x-y location of the stacks are the same for all imaginary stacks representing the same source. The emissions associated with the imaginary stacks are provided based on the emissions values that are to be entered in each layer for the source. The emissions for layer 1 are written in the point-source file to the imaginary stack associated with layer 1, and the same is done for all of the other layers. SMOKE uses a zero value for the imaginary stack when the emissions from a given source are not in a layer for an hour or when the source stops (e.g., once a wildfire ends). While not particularly elegant, this approach permits providing precomputed plume rise to the UAM-based models without having to change those models.

2.8. Inventory import

The importing of emission inventory and related data is the first processing step needed for any emissions processing effort. The **Smkinven** program imports data for anthropogenic sources, and the **Normbeis4** program imports BEIS4 land use data for biogenic sources. In this section, we focus on the import of the anthropogenic inventories using **Smkinven**. The biogenic import is further described in Section 2.16, “Biogenic processing” [85].

Smkinven performs many types of activities during import of the anthropogenic inventories. Though the primary purpose is reading the data from ASCII formats and outputting and I/O API SMOKE intermediate inventory, there are many other actions that need to be performed during the inventory import stage of processing. These actions are the following:

1. Check that the formats of the input files are correct and consistent, and ensure that all data can be read properly.
2. Assign pollutant names to data input by code numbers.
3. Select pollutants from the input files to keep for further SMOKE processing.
4. When multiple files are provided, combine all annual and/or average-day data into a consistent inventory. This includes checking for duplicates and possibly aborting, depending on program options set by the user.
5. Combine toxics and criteria inventories, and eliminate duplicate mass using either an integrate or no-integrate approach.
6. Sort the inventory records into the order expected by other SMOKE programs.
7. Aggregate or disaggregate toxics emissions data as specified by user inputs.
8. Assign point-source locations to area sources, when available.
9. Fill in and check point-source stack parameters.
10. Convert stack locations from UTM to lat-lon.
11. Optionally ensure that lat-lon coordinates are in the Western Hemisphere.
12. Convert units of emissions and activities to the units used in the SMOKE intermediate inventory.
13. Set the weekday averaging approach.
14. Assign country codes and/or geographic codes (GEOCODE_LEVEL[1-4]), years, and time zones.

15. Handle inventories that have data for multiple years.
16. Set the base year.
17. Report results of import including pollutant totals for toxics data and other information needed for quality assurance.
18. Import day-specific and hour-specific data, if available, and ensure that records in these files match inventory records provided in the annual or average-day inputs.

In the following subsections, we describe what SMOKE does for each of these activities.

2.8.1. Check the correctness and consistency of input file formats

Smkinven can read the following ASCII formats for annual and average-day inventory data:

- **ORL format:** This set of input formats is used for inputting point, nonpoint, on-road, and nonroad HAP emissions inventories, also called toxics emission inventories. There is a different ORL format for nonpoint, point, nonroad mobile, and on-road mobile sources.
- **List format:** This is the input format used to provide multiple files to **Smkinven** in a single run. This format is simply an ASCII file that contains a list of other files.
- **List GRID format:** This is the input format used to provide multiple global gridded emission inventory files to **Smkinven** in a single run. This format is simply an ASCII file that contains a list of other files. To support input of multiple pre-gridded NetCDF files, the keyword #LIST GRID in the header of this file will switch SMOKE into gridded inventory processing mode. This approach is described more in Section 2.7.2.2, “Pre-gridded Emissions” [28]
- **Gridded I/O API format:** This format is a gridded I/O API file for allowing the import of pregridded data from the same modeling domain. This approach is described more in Section 2.7.2.2, “Pre-gridded Emissions” [28].

Smkinven ensures that all file formats provided to SMOKE are correct and include the required data fields. The formats and their required fields are provided in Chapter 6, *SMOKE Input Files* [261].

2.8.2. Assign pollutant names to data input by code numbers

The ORL format use code numbers (usually Chemical Abstracts Service [CAS] numbers) to distinguish which chemical compound or inventory pollutant is provided on each line of the file. **Smkinven** matches these numbers with the CAS numbers from an inventory table (INVTABLE) file, described in Section 6.10.4, “INVTABLE: Inventory table” [368]. The CAS number does not necessarily have to be a valid CAS number; it can be any number as long as there is a match between the numbers in the ORL file and the inventory table. The inventory table provides the inventory data names, such as the pollutant names that SMOKE uses in the remaining processing steps. Note that the SMOKE inventory pollutants may not be identical to the pollutants in the inventory fed to SMOKE because of the aggregation/disaggregation that is performed by **Smkinven** (see Section 2.8.7, “Aggregate or disaggregate toxics emissions” [51] for more information).

For toxics processing, if multiple inventory data names apply for the same CAS number, the Factor column of INVTABLE will contain the split factor used by **Smkinven** to disaggregate the emissions from that CAS number to multiple inventory data values. If multiple CAS numbers apply for the same pollutant name,

then **Smkinven** will sum these emissions, but will not report duplicate records unless there are indeed duplicates in the inventory file. This is described more fully in Section 2.8.7, “Aggregate or disaggregate toxics emissions” [51]. Duplicate reporting is described more in Section 2.8.4, “Check for duplicate records” [49].

The use of the inventory data name as the unique pollutant identifier in SMOKE differs from the approach of EMS-HAP, in which the SAROAD code is the unique identifier for the pollutants to be modeled. Because we anticipated that some toxics pollutants that do not have unique SAROAD codes (e.g., divalent particulate mercury) would need to be modeled explicitly, we did not want to take this approach. If we had, the user would have been required to create fake and unique SAROAD codes to be able to model these emissions explicitly.

2.8.3. Select pollutants from the input files for further SMOKE processing

In version 1.5 and higher of SMOKE, users can specify the valid data (pollutants and activities) using the inventory table discussed in Section 6.10.4, “INVTABLE: Inventory table” [368], as described in Section 2.8.2, “Assign pollutant names to data input by code numbers” [48]. **Smkinven** will read only those entries that have a “Y” (for “Yes”) in the Keep column of the inventory table. If a pollutant has an “N” (for “No”) in the Keep column, it will not be output to the SMOKE intermediate files, but will be included in the inventory reports that **Smkinven** creates. If the pollutant is not listed at all in the inventory table, it will be dropped as well; **Smkinven** will also write a warning message and will not include the pollutant in any reporting. It is a good work practice for users to put all pollutants in the input inventory in the inventory table even if it the pollutant will not be used for the AQM. Use of the INVTABLE file replaces the use of the SIPOLS and ACTVNAMS files from previous versions of SMOKE.

2.8.4. Check for duplicate records

In Section 2.8.1, “Check the correctness and consistency of input file formats” [48], we explained that **Smkinven** ensures that the input files are correct and that the same format is used. In addition, **Smkinven** checks for duplicate records across the entire set of inventory input files. A duplicate record is one that has the same source characteristics (defined in Section 2.7.1, “Summary of SMOKE processing categories” [26]) and pollutants as another record in the inventory. **Smkinven** provides an option that allows you to instruct **Smkinven** whether duplicates should cause a warning message or an error. In some cases, you may not expect duplicates in your inventory, in which case you can have **Smkinven** abort after reporting all duplicates. In other cases, you can instruct **Smkinven** to sum the emissions across all duplicate records. See Section 4.14, “**Smkinven**” [179] for more information on the different approaches.

2.8.5. Combine toxics and criteria inventories

For point, nonpoint, on-road mobile, and nonroad-mobile sources, the toxics inventory contains emissions for VOC pollutants that are provided as explicit chemical compounds (for example, benzene). These same VOC emissions are also included as an aggregated VOC value in the criteria emissions inventory. To use these inventories together, **Smkinven** provides the necessary options to ensure that double counting of VOC emissions will not occur. These two options are the “integrate” and “no-integrate” options.

The “integrate” option involves subtracting toxic VOC emissions from the criteria VOC emissions to avoid double counting of VOC when the emissions are speciated. With this option the user must ensure that the sources in the toxics and criteria inventories match up one-to-one, so that **Smkinven** can properly compute the emissions.

Note that in any discussion of the toxics inventory we have assumed that all emissions are annual total emissions, because the toxics inventory that is currently available does not include average-day emissions. We have also assumed that the inventory contains VOC emissions, but the same approach can be used to process TOG emissions.

During import of both toxics and criteria emission inventories, SMOKE matches the area/nonpoint, on-road mobile, and nonroad mobile emission inventories by country/state/county code and SCC. SMOKE also matches the toxics and criteria records for the point sources, provided that the point sources in the two inventories use identical fields for their source characteristics. You are required to ensure that the source characteristics for all source categories match between the two inventories for any sources that you wish to have matched. Once they are matched, SMOKE will have both a criteria VOC emissions value and toxics emission values for individual VOC chemical compounds.

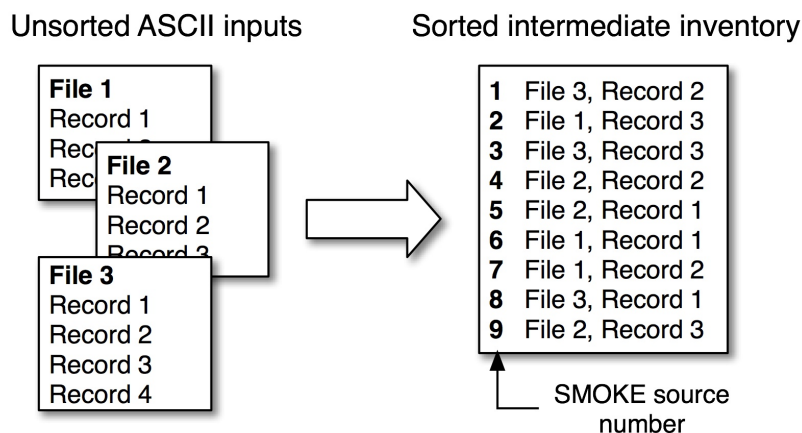
SMOKE can optionally compute a NONHAPVOC value by subtracting the sum of toxics VOC from the criteria VOC value. This same approach can be used to create a NONHAPTOG value if the inventory or MOVES (when processing on-road mobile emissions using VMT data) uses a TOG value instead of a VOC value. (We will not mention NONHAPTOG again, but it could be used to replace NONHAPVOC throughout this section).

The case of computing NONHAPVOC is called the “integrate” case because it involves integration of the VOC mass between the criteria and toxics inventories. Likewise, the case of not computing NONHAPVOC is called the “no-integrate” case. With the “integrate” approach, the NONHAPVOC mass and the toxics VOC mass are independent from one another and will not double count emissions. The calculation must be performed for each source, and **Smkinven** will set the criteria VOC value to zero when it computes the NONHAPVOC value. **Smkinven** determines which pollutants should be subtracted from VOC using the “VOC or TOG” column in the inventory table (INVTABLE) file.

2.8.6. Sort the inventory

When **Smkinven** reads an inventory, it also puts its sources into a special sorted order prior to outputting the SMOKE intermediate inventory files. All programs that read **Smkinven** outputs, which includes most of the SMOKE programs, expect this order. The order is determined by sorting the source characteristics listed in Section 2.7.1, “Summary of SMOKE processing categories” [26] in ascending order. For example, area sources will be sorted in order of increasing country/state/county code, and within a single country/state/county code will be sorted in order of increasing SCC. In Figure 2.19, “Combining and sorting ASCII inputs to create sorted I/O API outputs” [51], we show how the sorted order may be completely different from the order of the files and records provided to **Smkinven**. The figure shows the unsorted ASCII input files at left (provided to **Smkinven** by logical files ARINV, MBINV, or PTINV) and how the records can be rearranged by **Smkinven** to create the sorted I/O API output files (output from **Smkinven** as AREA, MOBL, or PNTS). Each record in this diagram represents a complete inventory record with all source characteristics, source attributes, and emissions.

Figure 2.19. Combining and sorting ASCII inputs to create sorted I/O API outputs



Having this sorted order is important because the programs that depend on **Smkinven** outputs also store their outputs in the same order. However, these other programs (such as **Temporal** for temporal allocation, **Spcmat** for chemical speciation, and **Grdmat** for spatial allocation) store their records using the record numbers to match their outputs with the **Smkinven** outputs. This means that the source characteristics that are stored in the **Smkinven** outputs are not also included in the outputs from **Temporal**, **Spcmat**, **Grdmat** and other programs; these programs rely on the sorted order in the **Smkinven** outputs not changing. This approach allows minimal redundant data storage, thus reducing disk space needs.

As explained previously, the records output from **Smkinven** are vectors of emissions and source characteristics that make up the SMOKE intermediate inventory files. Each record number in the file identifies an element of the vector. The outputs from **Temporal** are also vectors of hourly emissions. The record number in each hourly vector will match the record number in the intermediate inventory files. The outputs from **Spcmat** are a matrix of speciation factors, in which the record numbers (rows of the matrix) will match the record numbers of the intermediate inventory files. The columns of the matrix are each valid pollutant-to-species transformations. The outputs from **Grdmat** are a sparse matrix, but again the rows of the matrix match the rows of the intermediate inventory file. Therefore, assignment of factors is a simple matter of selecting the same record number from the **Smkinven** output files; this is in fact one part of the vector-matrix multiplication used by SMOKE.

It is important to remember this sorted-order approach when you have run an inventory through all of the programs once, and then want to change your inventory and re-import the data with **Smkinven**. For the re-importing and subsequent rerun, if any source characteristics in the inventory change, or if any sources are added or removed, then the number and/or order of the output sources in the new **Smkinven** outputs will be different. This means that the outputs from all processing steps that depend on the **Smkinven** outputs will need to be rerun.

2.8.7. Aggregate or disaggregate toxics emissions

Smkinven also supports aggregation and disaggregation of toxics inventory pollutants to match the input needs for AQMs. There are two components of this aggregation and disaggregation. The first involves what to do during inventory import to resolve discrepancies between the inventory content and what data are most useful for further processing through SMOKE; this topic is addressed in this subsection. The second issue is conversion of the toxics inventory to the species needed by the AQM, which is handled by the **Spcmat** program in SMOKE, as described in Section 2.10, “Chemical speciation processing” [63].

Smkinven uses the inventory table (INVTABLE) file to determine what aggregation and disaggregation are needed. The INVTABLE file can have both multiple pollutant names per CAS number and multiple CAS numbers per pollutant name. In the first case, **Smkinven** disaggregates the emissions to two or more pollutants using the number provided in the “Factor” column of the INVTABLE file. In the second case, **Smkinven** combines the separate records in the inventory into the same pollutant. Depending on the relationship between the “Keep” column, the “Pollutant Name,” and the “CAS Number” in the inventory table file, the reader routines ensure that they will keep emissions only for pollutants (not CAS numbers) with a “Y” in the “Keep” column. **Smkinven** can also tell the difference between two CAS numbers that are being aggregated for the same source and a duplicate record (two records for the same source with emissions for the same pollutant).

2.8.8. Assign point-source locations to area sources

Some area/nonpoint and nonroad mobile sources can be assigned point-source locations instead of being assigned spatial surrogates. At this time, the only allowable cases of this are for toxics processing for nonroad mobile and stationary area/nonpoint sources related to airport emissions processes. **Smkinven** has the capability to make such assignments for any area source from both the toxics and criteria inventories.

Because airport location data are readily available, this feature gives users the ability to model airport-related area-source emissions at airport locations, as opposed to spatially allocating them to grid cells using spatial surrogates. Although spatial surrogates could be (and have been) developed to reproduce the same or similar results as the point-source assignments for models such as CMAQ, other models that SMOKE may eventually support (namely ISCST3) require that point-source inputs include the location coordinates. The area-to-point assignment feature in SMOKE will support such a need. Note that for large airports and a small grid, one may want to have the airport emissions gridded using surrogate data since the airport can be large enough to encompass multiple grid cells. Thus, the user should decide whether and when to use this area-to-point feature as opposed to gridding using an airport surrogate.

In SMOKE version 1.5 and higher, SMOKE can assign an area source to one or more locations in a county. For example, when multiple airports are in a county, SMOKE adds sources to the inventory and splits the county-total emissions among the locations based on a factor provided in the ARTOPNT file. All sources remain with the area-source inventory in which they started; they are not moved to a point-source inventory. Any area sources that are assigned point locations are spatially allocated using those locations, as described in Section 2.11, “Spatial processing” [67]. Sources that are not assigned point-source locations are allocated in the standard way using spatial surrogates.

2.8.9. Fill in and check point-source stack parameters

An additional action taken by the **Smkinven** program for point sources only is to check stack parameters and fill them in with valid values if they are missing. **Smkinven** performs the following steps on stack parameters from the annual or average-day inventory files, but not the hour-specific stack parameters file.

- If the stack parameters are zero, **Smkinven** treats them as missing values and writes the warning messages.
- If the exit velocity is missing or zero and the exit flow is not, or if the VELOC_RECALC option is Y in the run script, **Smkinven** automatically calculates the exit velocity using the formula:

$$\text{velocity} = \text{flow} / (\pi * \text{diameter}^2/4)$$

- If the stack parameters are not missing or zero, **Smkinven** ensures that their values are within the allowed ranges. The range for each stack parameter is as follows:
 - Height: 0.5 to 2100 meters
 - Diameter: 0.01 to 100 meters

- Exit temperature: 260 to 2000 K
- Exit velocity: 0.0001 to 500 m/s

When a stack parameter falls outside of its associated range, **Smkinven** sets it to the top or bottom of the range, depending on whether it is higher than the upper end of the range or lower than the lower end. Note that a zero value is not treated as an out-of-range parameter, but is treated as a missing value.

- If the stack parameters are missing or zero, **Smkinven** uses the PSTK file to assign new stack parameters using country/state/county and SCC assignments. The format of PSTK file is described in Section 6.9.3.2, “PSTK: Point source stack replacement parameters file” [361].

2.8.10. Convert coordinates from UTM to lat-lon

The ORL and FF10 point-source formats permit stack coordinates to be provided in UTM or lat-lon coordinates, and the SMOKE intermediate inventory stores the coordinates as lat-lon values. **Smkinven** converts the UTM coordinates to lat-lon coordinates using the I/O API routine UTM2LL [<http://www.baronams.com/products/ioapi/LL2UTM.html>]. Lat-lon coordinates must be provided in decimal degrees, while UTM coordinates must be provided in meters.

2.8.11. Optionally ensure that lat-lon coordinates are in the Western Hemisphere

For any lat-lon coordinates input to **Smkinven** (point-source locations, link coordinates, and area-to-point coordinates), SMOKE can optionally ensure that the longitude values are in the Western Hemisphere. In some cases, the data prepared for input to SMOKE do not contain the negative sign on the longitude value that indicates the Western Hemisphere. If the modeling domain is in the Western Hemisphere, then **Smkinven** will convert all positive longitudes to negative ones when the WEST_HSPHERE option is set to Y.

2.8.12. Convert units of emissions and activities

Different input formats in SMOKE have different emissions units. The SMOKE intermediate inventory file stores all annual and average-day emissions values from the ORL format in tons/year. These two formats also support average-day emissions values, which are stored separately in the SMOKE intermediate inventory in tons/day. The average-weekday emissions values input are also stored in tons/year, but SMOKE sets an internal variable called TPFLAG so that later SMOKE processing steps can properly treat the computed “annual” value as an average-day value. The annual VMT data are stored as miles/year. In all cases, **Smkinven** converts the units of the input emissions to the units used in the SMOKE intermediate inventory. When this conversion involves a day-to-year conversion, **Smkinven** considers leap years by using 366 instead of 365 days in the year. See Section 6.2, “Inventory Files” [262] for information about the units required for each inventory format.

When emissions are provided as average-day values from the ORL and FF10 formats and these emissions are then used in later processing steps, SMOKE does not further adjust the emissions using the monthly profiles. SMOKE assumes that the average-day emissions from these two formats have been adjusted to a specific month already. In addition, when **Smkinven** is configured using the FILL_ANNUAL option to fill in missing annual values using average-day values, **Smkinven** sets the TPFLAG internal variable to indicate that monthly adjustments should not be applied and that the “annual” emissions should just be divided by the number of days of the year before being used. **Smkinven** makes this setting on a source-by-source basis.

2.8.13. Set the weekday averaging approach

There are two approaches for processing weekly temporal profiles: weekly normalization and weekday normalization. Although the actual normalization happens during temporal allocation, **Smkinven** sets the approach to use for each source. In the weekly approach, the **Temporal** program normalizes the weekly temporal profiles over every day of the week. This approach is appropriate for annual-total inventories or average-day inventories. Weekday normalization normalizes over just the weekdays (i.e., Monday through Friday) in the profile, or if the profile indicates no emissions on weekdays, then over just the weekend days in the profile. This approach is appropriate only for average-weekday inventories. Section 2.9, “Temporal processing” [57] describes the two forms of weekly profile normalization in more detail.

The default normalization setting for ORL and FF10 formats in **Smkinven** is weekly normalization. The default settings can be changed using the `WKDAY_NORMALIZE` option in the SMOKE run scripts. When this option is set to Y, the sources will be set to instruct **Temporal** to use weekday normalization, and when this option is set to N, the sources will be set to cause weekly normalization. **Smkinven** gives a warning when an approach is being used that is inconsistent with the expected approach for the inventory format being used.

2.8.14. Assign country codes, years, and time zones

For all source categories, **Smkinven** assigns country codes, years, and time zones to inventory files that do not contain this information in the inventory records.

Since most inventory formats do not include a column for country or year, the country code and year must be provided in header fields in the inventory. Because most inventory formats do not include a column for country or year. Users can provide data for up to 10 countries using as many separate files, or separate headers within a single file, as needed. The inventory file formats listed in Section 6.2, “Inventory Files” [262] provide a further description of these country-setting headers and the valid country codes.

Users can also provide multiple inventory years in a single **Smkinven** run. This is necessary in some cases when an inventory for one region (e.g., Canada or Mexico) is unavailable for the same year as the majority of the inventory region (e.g., the U.S.). **Smkinven** stores the inventory year as part of the source attributes.

In addition to country codes and years, **Smkinven** assigns a time zone to each source based on the county associated with the source. **Smkinven** uses the `COSTCY` or the `GEOCODE_LEVEL4` (if `USE_EXP_GEOCODES Y`) file to get this information. It matches the county code from the inventory to the county code in this file. If a county code included in the inventory is missing from this file, or if the time zone is not provided in the `COSTCY` or `GEOCODE_LEVEL4` file, **Smkinven** uses the `SMK_DEFAULT_TZONE` setting to obtain a default time zone for sources in such a county. In some cases, the time zone set in the `COSTCY` or `GEOCODE_LEVEL4` file is an approximation, since counties that are bisected by two time zones have only the predominant zone represented in this file.

2.8.15. Handle inventories that have data for multiple years

In some cases, inventories may use data from multiple years; this can occur when inventory data are not available for the modeling year of interest, but data from another year are available. SMOKE can handle this case. Unless growth factors are available to grow the available data to the desired year, the SMOKE intermediate inventory may include data from two years. Usually, using data from a nearby year is preferable to not performing the modeling at all.

2.8.16. Set the base year

Smkinven imports all data and then sets the inventory base year in the file as the year that has the most data values. The year of the inventories is set using the #YEAR header for ORL and FF10 inputs, (see Section 6.2, “Inventory Files” [262] for more information on this header and packet). Usually, the year of the data is the same for all sources, so you will know what **Smkinven** will assume is the base year. However, if multiple inventory years are provided, **Smkinven** will set it using the year that is associated with the largest number of sources.

If you provide a future-year inventory to SMOKE, you must override the base-year setting obtained from the values given by the #YEAR header or the /INVYEAR/ packet. This is accomplished with the SMK_BASEYR_OVERRIDE setting. This is necessary so that later SMOKE steps will be able to verify that the episode year is consistent with the base year.

2.8.17. Report results of import step

The **Smkinven** program writes several reports to help you determine what it has done.

1. A summary by CAS number of the emissions in tons/year. This includes the number of inventory records; whether all, some, or none of the pollutants associated with that CAS code are kept; and the CAS description. This report is written to a special report file (REPINVEN).
2. A summary of emissions by CAS number and pollutant before and after the application of disaggregation factors based on the inventory table. This report shows, for instance, how chromium emissions get split out into different pollutants. The report is written to the REPINVEN file.
3. A listing of the first 10 nonheader records in each inventory file. This information is written to the program log file.
4. For area-to-point conversions (from Section 2.8.8, “Assign point-source locations to area sources” [52]), a list of the SCCs that were converted, and the section number of the ARTOPNT input file used to assign the point locations. This information is written to the program log file.
5. For area-to-point conversions, a list of any SCCs included in the ARTOPNT input file that do not also appear in the inventory. This report is written to the REPINVEN file.
6. For area-to-point conversions, a summary of emissions totals by SCC and pollutant before and after the factors are applied, and the total number of country/state/county codes affected. A separate summary is provided that reports emissions by state, SCC, and pollutant, but otherwise has the same information. These reports are written to the REPINVEN file.
7. For area-to-point conversions, a summary by SCC of the number of country/state/county codes being assigned area-to-point factors, and the number not being assigned those factors. This report is written to the REPINVEN file.
8. For import of CEM data, a summary of ORIS IDs and boiler IDs from the CEM data that have been matched to the inventory. SMOKE allows for multiple plant descriptions and country/state/county codes for a single ORIS ID that may be identical in their characteristics but different boiler IDs. They are treated as separate sources by matching boiler IDs. This report is written to the REPINVEN file.

More information about these reports can be found in Section 8.5.1, “REPINVEN” [407].

2.8.18. Import day-specific and hour-specific data

Another function of **Smkinven** that only applies to point sources is importing day- and hour-specific data. It can read three input ASCII formats:

- **CEM data format:** The CEM data format provides standard local time hourly emissions by ORIS identification code and boiler number. It was developed in conjunction with the Market Trading Division of EPA, and that division now provides this ASCII file format when the data are released.
- **FF10 format:** The FF10 day- and hour-specific format can be input to SMOKE using either the FF10 annual or average-day inventories.

In addition to reading the files, **Smkinven** ensures that the records listed in day- and hour-specific files match records provided in the annual inventory inputs. This is necessary because SMOKE builds its list of all point sources based on the annual and/or average-day inventory files, and these are the only sources that will be listed in the SMOKE intermediate inventory file. **Smkinven** requires that the year associated with the date of the day-specific and hour-specific emissions is the same as the base year. **Smkinven** generates an error message when it cannot match a day- or hour-specific source with an inventory source. Please refer to Section 4.14, “**Smkinven**” [179] for more information about how **Smkinven** can be used to import these data.

Smkinven also can process the hourly CEM data in a more sophisticated way. Hourly heat input from the CEM data are used to allocate annual emissions to hourly emission data. First of all, the utility program **CEMScan** must be run before **Smkinven**, see more information at (Section 3.3.3, “**CEMScan**” [104]).

2.8.19. Processing hour-specific CEM data

Smkinven can allocate annual emissions to hourly data using the hourly heat input from the standard local time CEM data. **Smkinven** must match the ORIS/boiler combinations that appear in the standard local time CEM data to sources in the annual emissions inventory. **Smkinven** will first skip any ORIS/boiler combinations in the input CEM data that do not appear in the summary list (**CEMSUM**) created by **CEMScan**; it is important that users ensure that their input CEM data and CEM summary file remain consistent. **Smkinven** will also skip any CEM ORIS IDs that are not in the inventory and also any ORIS and boiler combinations that are not in the inventory. Note that the inventory may contain sources with valid ORIS IDs but blank boiler codes; none of these sources will be matched to the CEM data. The format of the CEM hour-specific data is shown in Table 6.22, “CEM Format for individual hour-specific data files” [281].

Data Check : Before calculating the hourly emissions, **Smkinven** first checks if the hourly NO_x emissions from the CEM data are zero or null. If so, **Smkinven** checks if the hourly heat input, gross load, and steam load values are zero or null before all output values will be set to zero. In this case a warning will be written to the **Smkinven** log file.

Special handling is needed when processing SO₂ and NO_x emissions. If the summed annual CEM SO₂ and NO_x emissions for a particular ORIS/boiler combination are zero or null, **Smkinven** will calculate hourly emissions based on the SO₂ and NO_x emissions in the annual inventory rather than using the hourly CEM data. If the summed annual SO₂ and NO_x emissions are valid but a particular hour is missing the hourly SO₂ and NO_x emissions, **Smkinven** will set the hourly SO₂ and NO_x emissions to zero and write a warning to the log file.

Calculation: When calculating hourly emissions, **Smkinven** must use data from the annual inventory. If any of the matching inventory sources are missing the annual emissions value, the program will exit with an error. **Smkinven** will start with the hourly emissions from the CEM data and then disaggregate the emissions to the matching inventory sources like so:

*Hourly NOx emissions for source i = (annual NOx emissions for source i / summed annual NOx emissions for all matching sources) * hourly CEM NOx emissions * pounds to tons conversion*

If the summed annual emissions for all matching sources is zero, the hourly CEM emissions will be distributed evenly to the matching inventory sources. For all other pollutants, the hourly emissions are calculated as;

*Hourly emissions for source i = annual factor * annual emissions for source i*

The annual factor in the above calculation will preferentially be:

Annual factor = hourly heat input for ORIS/boiler / annual summed heat input for ORIS/boiler

If heat input data are not available, **Smkinven** will fallback to steam load followed by gross load. The heat input values do not need to be disaggregated to the matching inventory sources because the same disaggregation factor would be used for both the hourly heat input and summed heat input.

Used to calculate hourly flow rates from hourly heat input when reading CEM data. If FLOW_RATE_FACTOR is set to zero or unset, then **Smkinven** will not calculate hourly flow rates.

*Hourly flow rate (m³/s) = [FLOW_RATE_FACTOR (ft³/MMBTU) * hourly heat input (MMBTU/hr) * 0.02831 m³/ft³] / 3600 s/hr*

Smkinven then needs to assign the ORIS/boiler-level hourly flow rate to the matching inventory sources. To do this, it sums the flow rate for sources with the same stack. **Smkinven** uses the plant ID and stack ID to determine which sources feed into the same stack. Script setting information is available at Section 4.14.3.2, “Input Environment Variables” [184].

NOTE: It is not recommended to run **Smkinven** for an entire year's worth of CEM data since the memory requirements are large. Instead, users should process only the CEM data for their episode of interest. This may require multiple runs of **Smkinven** to break up large episodes.

2.9. Temporal processing

The temporal allocation of emission inventory data always occurs after the inventory import processing previously described in Section 2.8, “Inventory import” [47]. The **Temporal** program processes data for anthropogenic sources, while the **Tmpbeis3** or **Tmpbeis4** program allocates biogenic emissions. In this section, we focus on the temporal allocation of the anthropogenic inventories using **Temporal**. The biogenic processing is further described in Section 2.16, “Biogenic processing” [85].

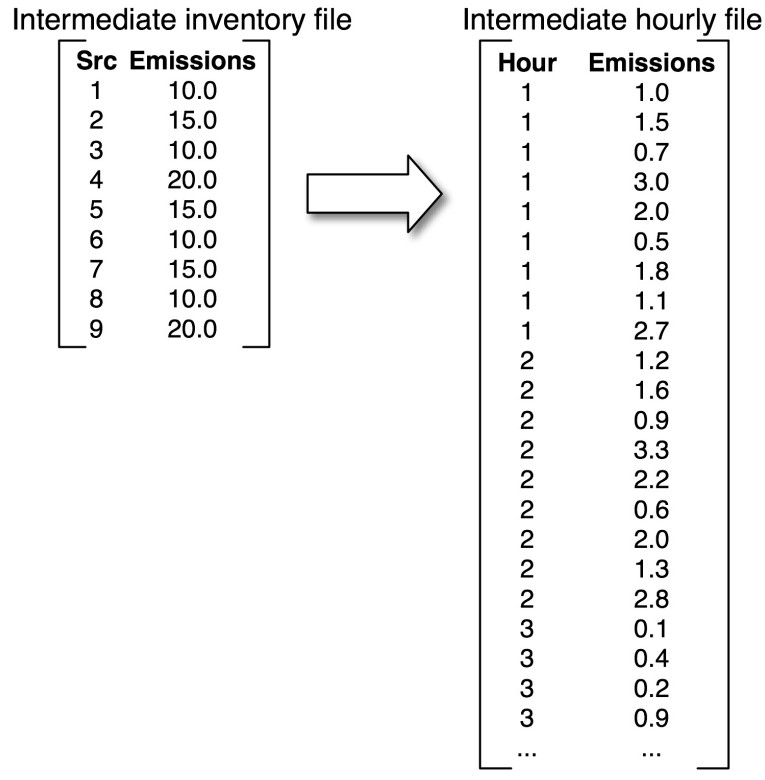
The primary purpose of the **Temporal** program is to create an intermediate hourly emissions file (ATMP, MTMP, or PTMP). It also creates a supplementary intermediate file that indicates which monthly, weekly (day-of-week), and diurnal (hourly) profiles were assigned to each source (ATSUP, MTSUP, or PTSUP). Since the **Temporal** dynamically create names for the output files, two new environment variables [A|M|P]TMPNAME and [A|M|P]TSUPNAME are used to set the directory and file prefix for naming the output files [A|M|P]TMP and [A|M|P]TSUP. The files are named using the starting date of each time period. For example, if ATMPNAME is set to /data/ntmp.nctox., then the ATMP file for a given time period will be put in the data directory and named ntmp.nctox.[start date].ncf.

The temporal processing operation applies factors based on the source characteristics to the emissions data from the SMOKE inventory files. These factors can include monthly, weekly, and diurnal temporal profiles. The resulting emissions data vectors (not a matrix) contain hourly emissions for the inventory species. SMOKE assumes an hourly time step (Even though the time step is an input setting to SMOKE, it currently cannot be changed.). Most of the calculations are implemented as sparse-matrix algebra based upon temporal cross-references and profiles, augmented by the substitution of values from day- and hour-specific

emissions data sets. For mobile sources, hourly emissions values also depend on meteorology (e.g., the temperature dependence of evaporative emissions).

Figure 2.20, “Transformation of inventory data to hourly data” [58] shows how data from the intermediate inventory are stored in the hourly file. The arrow represents the temporal processing steps which convert the annual, average-day, or day- and hour-specific data to hourly data. After the temporal processing, the hourly emissions are stored in the intermediate hourly file, by hour and source number. The emissions are stored in the same order as the sources in the sorted intermediate inventory file.

Temporal processing also addresses the following issues that need to be considered during emissions processing:

1. Using annual or average-day data when both are available in the inventory
2. Applying monthly, weekly, and diurnal profiles
3. Using day- and hour-specific emissions
4. Time zone adjustments
5. Holiday processing
6. Monday-weekday-Saturday-Sunday (MWSS) processing
7. Processing non-sequential dates
8. Creating the intermediate files

In the subsections below, we address each of these issues in the same order as the list above.

2.9.1. Using annual or average-day data

When using the ORL or FF10 inventory format, you may choose to use either the annual or the average-day emissions values when running the **Temporal** program. The default is to use the annual data. To apply average-day data instead, the `SMK_AVEDAY` setting is used (this setting is relevant only for ORL or FF10 inventories). These emissions are then used in the merge-processing step, resulting in model-ready emissions that depend on the data type selected. If part of your inventory is available as average-day data and part is available as annual data, you have used **Smkinven** to fill in annual values based on the average-day values. The **Temporal** program is then run using annual values. **Temporal** ensures that for those sources for which “annual” values were created, only day-of-week and hourly adjustments (not monthly profiles) are applied. **Temporal** assumes that any average-day data provided has already been adjusted for a specific month, and therefore does not apply the monthly profiles to them.

2.9.2. Applying monthly, weekly, and diurnal profiles

The **Temporal** program uses a cross-reference file and a temporal profiles file to assign the temporal profiles to the inventory sources. The cross-reference file can assign the profiles using a hierarchy that is based on the source characteristics. A detailed list of valid assignments is given in Section 4.17, “**Temporal**” [211] with the detailed description of the **Temporal** program. The cross-reference assigns a monthly, weekly, and diurnal profile to each source, and can also assign default profiles to sources that don’t have more specific matches in the cross-reference file. When default assignments are made by the **Temporal** program, you can optionally choose to have warnings given for all of these assignments, using the `REPORT_DEFAULTS` option.

The temporal profiles file has different sections that contain the monthly, weekly, and diurnal profiles. Additionally, you may provide different weekend (Saturday, Sunday) and weekday (Monday through Friday) diurnal profiles, or you may provide a different set of diurnal profiles for each day of the week.

When using multiple diurnal profiles, a given source must use a diurnal profile with the same profile code for each day. For example, if a source uses diurnal profile 1 for Monday, it will also use profile 1 for Tuesday, but Monday’s profile 1 can be different than Tuesday’s profile 1.

For weekly profiles, **Temporal** evaluates the `TPFLAG` setting (set by **Smkinven** as explained in Section 2.8.13, “Set the weekday averaging approach” [54]) and uses the weekly-normalized weekly profiles or weekday-normalized weekly profiles, depending on the setting.

One limitation of using monthly, weekly, and diurnal profiles is that there is no week-to-week variation within a month. For example, all Tuesdays in a month use the same emissions profile (unless one happens to be a holiday, see Section 2.9.5, “Holiday processing” [61]). This limitation can be overcome by using day-specific emissions data (only for point sources).

2.9.3. Using day- and hour-specific emissions

SMOKE uses the most specific data available for any given source. For point sources, **Temporal** will read in the day-specific and hour-specific emissions and use these instead of the annual or average-day emissions that have been adjusted to hourly values. If both day-specific and hour-specific data are available for the same source, **Temporal** will use the hour-specific data. The settings that control the use of these emissions are `HOUR_SPECIFIC_YN` and `DAY_SPECIFIC_YN`.

2.9.4. Time zone adjustments

You can use the `OUTZONE` setting to control the output time zone that defines the hours in the output files. The one constraint on this setting is that it must be consistent with the time zone of the meteorology files. These files are used only when processing on-road mobile sources with `MOVES/MOBILE6` (optional), processing elevated point sources for the CMAQ-based approach (required), or processing biogenic emissions with `SMOKE BEIS3` (required). The time zones must be consistent among all source categories processed, so if one source category depends on the meteorology file, then all source categories must be processed with the same `OUTZONE` setting.

Temporal compares the `OUTZONE` value with the time zone of the source, which was set in **Smkinven** (see Section 2.8.14, “Assign country codes, years, and time zones” [54]) based on the county. Additionally, it assesses and accounts for whether the date being processed falls within the range of Daylight Savings Time, and whether the county of the source uses Daylight Savings Time. **Temporal** uses the `COSTCY` or the `GEOCODE_LEVEL4` (if `USE_EXP_GEOCODES Y`) file to determine which counties use Daylight Savings Time and which do not; for example, the state of Arizona does not use it. Using these pieces of information, **Temporal** interprets the diurnal profiles assuming that they are local profiles in order to map the correct adjustment to the correct output hour in the output time zone. **Temporal** also uses the time zone of the source and the output time zone to determine the correct hour for switching from one month to the next and from one day of the week to the next.

Table 2.9, “Example `OUTZONE` settings and their associated time zones” [61] lists a sampling of `OUTZONE` settings and the time zones that they represent. Note that `SMOKE` expects `OUTZONE` to be set as a positive number for time zones in the Western Hemisphere, although standard notation would list these as negative values. For example, Eastern Standard Time is listed in this table as -5:00 hours from GMT, but `OUTZONE` for EST in `SMOKE` is 5. One result of this implementation is that `SMOKE` does not work perfectly for time zones east of GMT.

2.9.5. Holiday processing

Holidays that fall on weekdays can have different activity patterns than regular weekdays because commercial and commuting activities are altered. **Temporal** uses the HOLIDAYS file to identify which user-defined dates should be processed as holidays and to determine which day of the week (Saturday or Sunday) to use to model the holiday. Usually, holidays are modeled as if they were a Sunday; this attempts to account for things like plants being closed and traffic patterns being different. Of course, you can also set up specific temporal profile inputs for a specific holiday and model that day separately, but this is not automated in SMOKE. Users therefore simply pick Saturday or Sunday as an alternative date treatment in the hope that it will somewhat better represent the emissions than using a weekday.

Holidays processing happens automatically if you are running the **Temporal** program for every day of your episode. If you are using the Monday-weekday-Saturday-Sunday approach described in Section 2.9.6, “Monday, weekday, Saturday, Sunday processing” [62], then additional scripting steps must be taken to ensure that the holidays are modeled properly. In particular, for inventories that span multiple time zones and/or when the output time zone is not the same as at least one time zone in the inventory, the scripts must be configured to model the holiday and the next day, so that the final hours in the holiday that are west of the output time zone will be included in the next day’s file.

2.9.6. Monday, weekday, Saturday, Sunday processing

The temporal variation of the days in a week is the same from week to week within a month because SMOKE uses weekly profiles. Also, it is common that the weekly profiles do not vary on Monday through Friday. Consequently, it is often desirable for long (e.g., annual) simulations to use a Monday-weekday-Saturday-Sunday (MWSS) approach. With this approach, SMOKE computes emissions for a representative Monday, weekday, Saturday, and Sunday within each month. The representative days cannot be the first day of the month (to prevent effects from the previous month from being included in the emissions data), a holiday (as set in the HOLIDAYS file), or the day after the holiday. Monday is distinguished from other weekdays because in multi-time zone cases in the Western Hemisphere with OUTZONE set to 0 (i.e. GMT), a few late-night Sunday hours are included in the hours at the start of the Monday file. In addition, one must specifically process the holidays and the day after holidays as separate runs for all holidays set by the HOLIDAYS file. During merging of emissions, the Monday, weekday, Saturday, and Sunday files are reused to create model-ready emissions for every day and hour needed. The holiday and day-after files are used for the holiday and day-after dates only.

This approach relies heavily on scripting to select dates for each month’s representative days and to ensure that the days that are run are consistent with the dates in the HOLIDAYS file. Scripting is also responsible for ensuring that the correct files are merged together by **Smkmerge** to create the model-ready files for all days of the episode.

There are some situations in which you cannot use the MWSS approach. In particular, on-road processing with MOVES must be run for all days of the episode, although some steps can be sped up by using the meteorology averaging approach. Additionally, biogenic emissions processing obtains all of its temporal variation from the meteorology data, and therefore must be run for all days. Fortunately, biogenic emissions processing is very fast compared to processing for other source categories.

2.9.7. Processing Non-sequential Dates

Previously, **Temporal** processed a single continuous time period during each execution of the program producing one output file. Typically, only representative Monday, weekday, Saturday and Sunday, plus any holidays are processed for a single month. This type of processing can require complex scripting and **Temporal** would need to be run several times.

SMOKE now provides the capability for optionally setting non-sequential date processing during a single execution of **Temporal** using a new input file PROCDATES to indicate a list of dates which **Temporal** should process. The format for PROCDATES is described in Section 6.3.4, “PROCDATES: Procdates date list” [300]. The format allows for blank lines, comment lines (any lines that start with a pound sign, and trailing comments (any characters after an exclamation point).

G_TSTEP will be used to set the time step for all time periods. The output data for each time period will be written to an individual file.

An example of PROCDATES file is shown below. In this case, we are processing the first day of each month in 2005. Twelve output files will be produced. Each file will contain 25 time steps.

Temporal produces two output files [A|M|P]TMP and [A|M|P]TSUP. Since **Temporal** will need to dynamically create names for the output files, we will use two new environment variables [A|M|P]TMPNAME and [A|M|P]TSUPNAME to set the directory and file prefix used to name the output files. The files will be named using the starting date of each time period. For example, if ATMPNAME is set to /data/ntmp.nctox., (note the period at the end of the file string) the ATMP file for a given time period will be put in the *STATIC* directory and named "ntmp.nctox.<start date>.ncf".

2.9.8. Creating the intermediate files

Finally, the **Temporal** program must output intermediate files. The hourly emissions are written to the ATMP, MTMP, and PTMP I/O API files. Unlike the other major SMOKE intermediate files (e.g., the matrices), the actual emissions (not just factors) are written to this file. This is because day-specific and hour-specific emissions can be impossible to convert into factors since the annual inventory emissions for the day- or hour-specific sources could be zero and factors would not be able to change that.

If **Temporal** has more than 120 variables to output (the limit for the number of variables in an I/O API file), **Temporal** opens as many files (using the FileSetAPI wrapper) as are needed to store the data. SMOKE also estimates how large the output files will be using 120 variables per file and automatically lowers the number of variables that will be put in each I/O API output file to ensure that the files use less than 2 GB of disk space. In addition, **Temporal** writes the supplementary files ATSUP, MTSUP, or PTSUP, which contain the temporal profiles assigned to each source. The structures of the SMOKE intermediate files output by **Temporal** are provided in Section 7.15, "**Temporal**" [401].

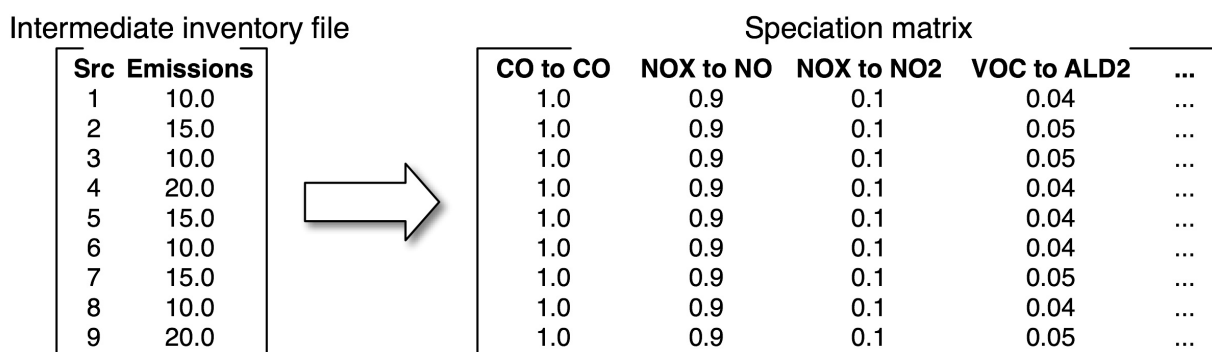
2.10. Chemical speciation processing

An emission inventory is built and reported for a variety of pollutants, such as CO, NO_x, VOC, PM₁₀, and SO₂. However, AQM chemical mechanisms (e.g., CB6) contain a simplified set of equations that use "model species" to represent atmospheric chemistry. Therefore, emissions processing requires speciation profiles to convert the emissions in terms of pollutant values to the species used in the photochemical

mechanism. The purpose of the chemical speciation processing program **Spcmat** is to produce matrices that contain the factors for converting the input emissions pollutants to the model species used in the AQM. These species include organics, PM species, and toxics species.

The speciation matrices that **Spcmat** creates are used transform column vectors of inventory-pollutant emissions into column vectors of model-species emissions. As shown in Figure 2.21, “Relationship of inventory sources to speciation matrix” [64], the speciation matrix consists of columns for each required pollutant-to-species transformation and includes an entry for each source. The entries are the factors needed to convert the inventory pollutants into the model species. Note that speciation matrices depend only upon the chemical mechanism and the inventory, and they are therefore independent of the other factor-based operations for emissions processing.

Chemical speciation processing addresses the following issues during emissions processing:

1. Splitting inventory pollutants into chemical species
2. Pollutant-to-pollutant conversions
3. Checking the consistency of the speciation profiles with the inventory
4. Setting the order of the output species
5. Creating speciation intermediate files

In the subsections below, we provide additional detail about each of these steps, in the order in which they are listed above.

2.10.1. Splitting inventory pollutants into chemical species

SMOKE supports run-time, user-selected inventory pollutants and chemical mechanisms. Before running the chemical speciation step, the only relevant information that SMOKE has is information about the inventory pollutants. After **Spcmat** runs, SMOKE then has the instructions for supporting a specific chemical mechanism, and through the speciation matrices, SMOKE will be able to generate model-ready emissions for the specific chemical mechanism set by the user. The inventory pollutants relate to the chemical mechanism because certain pollutants are needed to create certain species, but the pollutants do not dictate the chemical mechanism. As a SMOKE user, you must be aware of what pollutants are required to generate the model species needed by a chemical mechanism, so that all needed model species are created.

As we just mentioned, SMOKE learns of the species being created for a given run through the **Spcmat** program. The chemical speciation profiles input file (*GSPRO*) is the data file that controls the chemical

species SMOKE will create. It contains the chemical speciation profile code, the pollutant-to-species relationships, and both mole-based and mass-based conversion factors. The format and contents of this file are described in detail in Section 6.5.2, “GSPRO: Speciation profile file” [304]. Several GSPRO files to support many chemical mechanisms are available for download.

Spcmat uses a cross-reference file to assign the chemical speciation profiles to the inventory sources and pollutants. The cross-reference file can assign the profiles using a hierarchy that is based on the source characteristics; a detailed list of valid assignments is given in Section 4.16, “**Spcmat**” [206]. All assignments are pollutant-specific, such that each pollutant for a source can (and often should) use a different speciation profile. The cross-reference file can also assign a default profile, and some pollutants that have only one way of being speciated (e.g., mapping the CO pollutant to the CO species) receive a default profile for every source. When **Spcmat** makes default assignments, you can optionally choose to have warnings given for all of these assignments using the REPORT_DEFAULTS option. **Spcmat** will also produce a warning about any inventory pollutants that are not assigned a speciation profile, because this will result in the emissions for that pollutant being dropped by SMOKE.

Spcmat creates two speciation matrices during each run: a mole-based matrix and a mass-based matrix. The speciation profile file (GSPRO) has different factors for mass- and mole-based conversions. It is not trivial to convert between mass- and mole-based factors for some chemical mechanisms like CB6, which use aggregates of chemical compounds or parts of compounds to define the model species. One cannot simply use a molecular weight to convert accurately, because the molecular weight of the chemical species is different for every speciation profile. This is because different proportions of chemical compounds are present in each speciation profile, so even though the species are the same, their molecular weights are different from profile to profile. This is why SMOKE has the two speciation matrices. The mole-based matrices are used to create the model-ready files, and the mass-based matrices are used only to create the reports that require tons, kilograms, grams, or other mass units. One peculiarity of the mole-based matrix is that particulate species emissions cannot be expressed in moles, so the units are still grams in the mole-based matrices for particulate species.

Chemical speciation has both similarities and differences from the aggregation and disaggregation that is performed during inventory import (see Section 2.8.7, “Aggregate or disaggregate toxics emissions” [51]). It is similar in that it involves separating one data value into more than one data value. For example, inventory disaggregation can split Mercury & Compounds (CAS=199) into elemental mercury, divalent gaseous mercury, and divalent particulate mercury during inventory import of nonroad mobile sources. Similarly, NO_x can be split into nitrogen oxide (NO) and nitrogen dioxide (NO₂) during chemical speciation. Aggregation is also similar to speciation because it can map multiple pollutants or parts of pollutants into the same chemical compound, just as speciation can map parts of the different pollutants (e.g., HGSUM and HG) to the same model species (e.g., HG). On the other hand, the two concepts are different for three reasons. First, the pollutants aggregated and disaggregated by **Smkinven** are still considered by SMOKE to be pollutants, not species, to pass to later processing steps. Second, chemical speciation allows multiple split factors to be used for the same pollutant-to-species conversion, whereas inventory aggregation/disaggregation uses just one factor across the whole inventory for each pollutant-to-pollutant conversion. Third, chemical speciation also converts the units of the pollutants (tons) to the units of the species (moles for gaseous species and grams for particulate species).

Speciation profiles do not necessarily conserve mass. For example, it is possible to input 100 tons of VOC into the **Spcmat** program and have it output factors that will produce 70 tons of VOC-based species or 110 tons of VOC-based species. The reduced mass occurs when some of the pollutant’s mass does not map to chemically reactive species in the inventory. In some cases, the nonreactive (NR) species is included in the speciation profiles so that the speciation profiles do sum to 1. Increased mass happens because some compounds that are part of VOC may have chemical reactivity associated with two model species. Since this one part of the VOC is mapped to two model species, its mass appears to be double-counted when summing the model-species mass. This is merely an artifact of how the model species are defined and

implemented in the AQM, and the AQM is responsible for accounting for such issues in its chemical mechanism.

2.10.2. Pollutant-to-pollutant conversions

In some cases, the pollutant available in the inventory is not the same as the pollutant for which speciation profiles have been developed. At this time, the only known case of this situation is when the inventory is collected for VOC (or for reactive organic gases [ROG]) but the speciation profiles are available for TOG. For this situation, VOC-to-TOG factors have been developed that **Spcmat** assigns to the inventory sources based on the sources' SCCs. The factors are input using the GSCNV file, which can support multiple pollutant-to-pollutant conversions in the same file.

2.10.3. Checking the consistency of the speciation profiles with the inventory table

The **Spcmat** program checks to be sure that the two definitions of the NONHAPVOC pollutant - one from the speciation profiles (GSPRO) file and the other from the inventory table (INVTABLE) file - are consistent. When you are modeling with both criteria and toxics inventories and using toxics VOC (i.e., "integrating" toxics VOC), you must ensure that the definition of toxics VOC used in the INVTABLE file is consistent with the definition in the GSPRO file. **Spcmat** cannot assure that these files are consistent with each other, but does ensure that the information provided by the user is consistent; it is up to you to make sure that the information provided is correct and consistent with what is actually in the files.

These files need to be consistent because the same pollutants that SMOKE subtracts out of the VOC to create NONHAPVOC must also be removed when the speciation profiles are being computed. This assures that there will be no double-counting of mass when calculating model species from both toxics VOC and from the criteria aggregated VOC value. The GSPRO file format includes a header that allows you to define the toxics VOC that were removed when creating the NONHAPVOC speciation profiles. This is intended to help you ensure that the NONHAPVOC definition in the GSPRO file is consistent with the inventory table file. One important detail of how this is implemented is that **Spcmat** will not include inventory pollutants that are not actually in the inventory in the consistency check, even if the pollutant is listed in the NONHAPVOC definition in the GSPRO file.

2.10.4. Setting the order of the output species

The **Spcmat** program controls the order of the species in the output files. The order does not matter to any of the AQMs that SMOKE supports, so there is not very much user control of the order. **Spcmat** arranges the output species first by the order in which their associated pollutants appear in the inventory table (INVTABLE) file, and next in alphabetical order. For example, if an inventory included CO, NO_x, and VOC, the CO species from the CO pollutant would be first, followed by the NO and NO₂ species for NO_x. After that, all of the VOC species would be output in alphabetical order (e.g., ALD2, ETH, FORM, ISOP, NR, OLE, PAR, TOL, XYL). If two pollutants create the same species, the first pollutant in the INVTABLE file with which the species is associated will determine its output order.

2.10.5. Creating speciation intermediate files

The last task for the chemical speciation processing is creating the speciation intermediate files. The **Spcmat** program creates a mole-based speciation matrix (ASMAT_L, MSMAT_L, or PSMAT_L) and a mass-based speciation matrix (ASMAT_S, MSMAT_S, or PSMAT_S), as previously mentioned. These matrices can have any number of pollutant-to-species conversions; the **Spcmat** program will open multiple speciation matrix output files if the number of pollutant-to-species conversions is greater than 120 (the limit for the

number of variables in an I/O API file). **Spmat** opens and writes as many files with 120 variables (using the FileSetAPI wrapper) as are needed to store the data. In addition, the **Spmat** program writes a supplementary speciation file (ASSUP, MSSUP, or PSSUP) that contains the speciation profile assignments for each source. The structures of the SMOKE intermediate files output by **Spmat** are provided in Section 7.14, “**Spmat**” [400].

2.11. Spatial processing

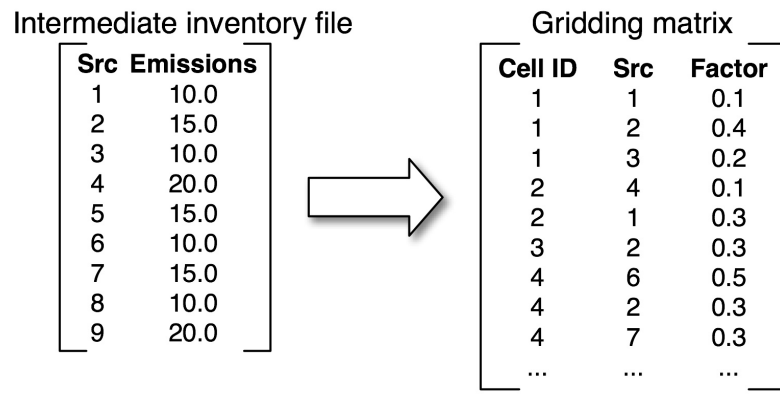
The spatial processing operation, or *gridding*, combines the grid specification for the air-quality modeling domain with source locations from the SMOKE inventory file. The resulting gridding matrix is a sparse matrix that describes in which grid cells the emissions for each source occur within the modeling domain. The gridding matrix is applied to the inventory emissions to transform source-based inventory emissions to gridded emissions.

The SMOKE **Grdmat** program creates the gridding matrix for area, mobile, and point sources. The gridding step is different depending on the type of source being processed.

- For area sources, county-total emissions are spread among the cells intersecting the county through the use of gridding surrogates.
- For mobile sources, the data can be provided by county (as area sources are), or the data can be provided as line sources (“links”). County-based mobile emissions are apportioned with gridding surrogates, preferably with surrogates based on the different road types for which the mobile emissions are provided. The line-source emissions are apportioned depending on the length of the link in each cell.
- For point sources, emissions are apportioned to the grid cell intersecting the point.

As shown in Figure 2.22, “Relationship between inventory and gridding matrix” [67], the gridding matrix contains the SMOKE source IDs that intersect each grid cell, and the source-to-cell factors for each. The gridding matrix is a sparse matrix because each source intersects only a small number of cells relative to the total number of cells in the domain, and the storage format shown in the figure reflects a sparse storage format. In the example in Figure 2.22, “Relationship between inventory and gridding matrix” [67], source 1 intersects cells 1 and 2, with 10% of the emissions in cell 1 and 30% of the emissions in cell 2. The remainder of the source’s emissions (60%) are either outside the grid or in other cells not shown in this example. Source 2 is completely inside the domain; 40% of its emissions are in cell 1, 30% are in cell 2, and 30% are in cell 4. If this were a point-source speciation matrix, there would be only one cell associated with each source because each point source exists in only one cell.

Note that the gridding matrix depends only upon the source locations, the grid definition, and in some cases gridding surrogates and cross-references. It is therefore independent of the other steps of emissions processing.

Spatial processing addresses the following issues during emissions processing:

1. Defining the gridded region to output from SMOKE
2. Assigning sources to grid cells
3. Creating the spatial allocation intermediate files

2.11.1. Defining the gridded region to output from SMOKE

The grid for which the spatial allocation step outputs the gridding matrix depends upon the `IOAPI_GRIDNAME_1` environment variable setting and the `GRIDDESC` input file. The file contains all of the settings needed by the I/O API to define each grid (together, these settings are called a grid definition), and it contains many such grid definitions. The `IOAPI_GRIDNAME_1` setting selects the specific grid to use during a specific run, and it must match the grid name provided in the `GRIDDESC` file. The settings used by the I/O API to define a grid are documented as part of the I/O API web site [<http://www.baronams.com/products/ioapi/GRIDDESC.html>].

There is another file format, called the `G_GRIDPATH` file, that can be provided to **Grdmat** instead of the `GRIDDESC` file. However, the `G_GRIDPATH` format allows only one grid per file. It is included as an acceptable input to SMOKE to allow SMOKE to be backwardly compatible with previous versions. All new users are advised to use a single `GRIDDESC` file to store all of their modeling grids, instead of using multiple `G_GRIDPATH` files, one for each grid. The `IOAPI_GRIDNAME_1` setting is not used by **Grdmat** when the `G_GRIDPATH` format is used.

The gridded region selected at run time does not need to cover all of the counties in the inventory. If the gridded region is smaller than the inventory, this processing step will still include the counties or parts of counties that do not overlap the grid. This allows users who are performing emissions processing using nested grids to import the inventory once and apply gridding matrices for each grid to the same inventory, creating gridded emissions for all nested grids without having to adjust the inventory files. The downside of this approach is that SMOKE does not give a warning if a county that is in the inventory is not in the spatial surrogates, or if a lat-lon coordinate is not inside the grid. It assumes that these sources are intended to be dropped and proceeds without comment. Thus, you must ensure that your surrogate files contain the counties in your inventory that are inside the grid and that your lat-lon coordinates for point and link sources are correct.

2.11.2. Assigning sources to grid cells

SMOKE takes a different approach to assigning sources to grid cells for each SMOKE source category and some special cases. In the following subsections, we describe the concepts of spatial allocation of (1) area/nonpoint, nonroad, mobile, and on-road mobile nonlink sources; (2) area-to-point sources; (3) pregridded area sources, (4) on-road mobile link sources, and (5) point sources.

2.11.2.1. Spatial allocation of area/nonpoint, nonroad mobile, and on-road mobile nonlink sources

The area/nonpoint, nonroad mobile, and on-road mobile nonlink sources all have emissions in the inventory with county-total values. To spatially allocate these emissions, factors must be assigned to each source to

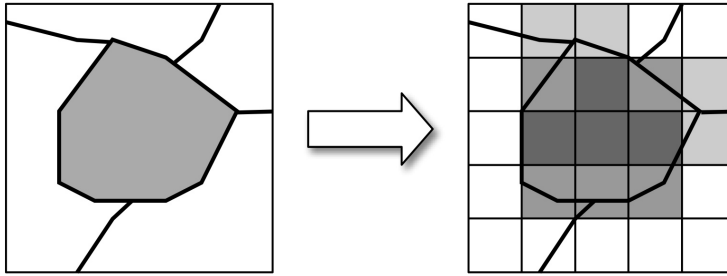
distribute the county-total emissions across the grid cells that intersect the county. This is accomplished using a cross-referencing approach that assigns a spatial surrogate to each source in the inventory.

The spatial surrogates files, located in `SRGPRO_PATH` contain factors for allocating emissions from a county-total to a gridded value, and there are usually many sets of factors available for each county. The data in this file are used to estimate the spatial distribution of county-total emissions inside the county. These sets of factors are calculated from other data that are available at a finer resolution than the county data, such as census tracts. Examples of commonly available surrogates are population, housing, urban area, rural area, agriculture, water, railroads, major highways, airports, ports, and forest. To ensure correct emissions processing, it is essential that all counties within the inventory and domain be included in the spatial surrogates file. If any counties inside the domain are left out of the file, then **SMOKE** will not be able to detect this; instead, it will act as though the county is outside of the domain and drop the emissions.

The general case of cross-referencing and profiles was described in Section 2.3, “Cross-referencing and profiles” [14]. During spatial allocation with the **Grdmat** program, the spatial cross-reference file (`AGREF` or `MGREF`) assigns spatial surrogates for area/nonpoint, nonroad mobile, and on-road mobile nonlink sources. The spatial cross-reference file associates SCCs with a spatial surrogate code, which is an arbitrary positive integer code that also appears in the spatial surrogates file along with the spatial surrogate data. It is important to ensure (if possible) that the spatial surrogate codes assigned to each SCC are actually available in the surrogate file for all counties in the inventory with that SCC. For example, if the water surrogate is assigned to motorboat sources in a given county, the spatial surrogate file should have values for the water surrogate in that county. If this is not the case, **SMOKE** will be forced to use a “fallback” surrogate, defined with the `SMK_DEFAULT_SRGRID` environment variable setting, which assigns a surrogate that is defined for every county in the domain. `SMK_DEFAULT_SRGRID` is mandatory and must be set to the population surrogate code listed in the `SRGDESC` file. The population surrogate in this case serves two purposes; 1) It defines all the FIPS codes contained within the gridded domain which reduces I/O in the gridding process and 2) this fallback approach prevents the emissions for that county and source category from being dropped from the emissions processing. **Grdmat** produces warnings in the log file whenever the fallback surrogate is used. If the fallback surrogate also causes the emissions to go to zero, an additional warning that indicates the emissions are being dropped is also written to the **Grdmat** log file. It is to the users discretion to use the fallback described in purpose 2. This is set by the `SMK_USE_FALLBACK` environment variable either set as [Y/N].

The surrogate codes are defined, described and a reference to the spatial surrogate files listed in the surrogate description file `SRGDESC` which is likewise set as the environment variable `SRGDESC`. Because the surrogate codes are arbitrarily assigned, you need to make sure that the spatial cross-reference is developed in conjunction with the spatial surrogates so that the surrogate codes used in each are consistent. It is not generally wise to develop surrogates without a cross-reference, unless the surrogate codes used in the surrogates file are set to the same values that are in a spatial cross-reference file that is already available. In other words, the surrogate codes in `SRGDESC`, `AMGREF` and `AMGPRO` should be in agreement.

Figure 2.23, “Spatial allocation of county-total emissions” [70] illustrates spatial allocation of all county-based emissions sources. The box at the left represents a grid with a single county, shaded in gray to represent an emissions value in that county. The arrow represents the spatial allocation steps. The box at right shows that all grid cells that intersect the county have emissions contributed by the county. Cells that intersect more of the county are shown in darker colors, simulating the effect of using area surrogates. The darker cells could also represent cells in which a large city causes the population surrogate to concentrate the emissions in those cells, while the surrounding regions within the county have lower emissions.

2.11.2.2. Spatial allocation of area-to-point sources

In some cases, the inventory import processing (by the **Smkinven** program) will have assigned point locations to some of the county-based inventory sources such as airports. Spatial allocation for these sources ignores the assigned surrogate, sets the surrogate assignment to 0, and uses the point-source locations and assigned fractions to determine the cells and associated magnitudes of the emissions from the county-total source.

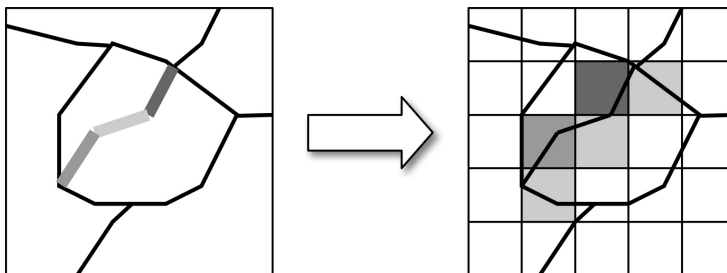
2.11.2.3. Spatial allocation of pregridded sources

When pregridded data are provided to SMOKE, the spatial allocation step must still be run. In this case, **Grdmat** just maps the pregridded emissions to the correct cells and outputs a simple gridding matrix that is used in later processing steps to maintain the pregridded nature of the inventory.

2.11.2.4. Spatial allocation of on-road mobile link sources

On-road mobile link sources are straight line segments within a county that have emissions and/or VMT data associated with them as well as the latitudes and longitudes of the starting and ending positions of the link. SMOKE determines the fraction of each link within each grid cell, and then assigns the emissions or VMT from the link to those grid cells that the link intersects, by weighting the emissions according to the length of the link within a grid cell divided by the total length of the link.

As shown in Figure 2.24, “Spatial allocation of on-road mobile link sources” [70], three link sources in the left-hand diagram are joined at their ends to represent a road cutting through the county. As shown in the figure, link sources do not bisect county boundaries (new link sources would be used to continue the road into an adjoining county). The three portions of the link have different VMT values, as represented by the three different shades of gray that highlight the link. The arrow represents the spatial allocation step. In the right-hand diagram, the cells that intersect the link sources are shaded, with darker shading used in cells in which the link intersects the cell more and the link has higher VMT.

2.11.2.5. Spatial allocation of point sources

Spatial allocation of point sources in **Grdmat** is very straightforward. The **Grdmat** program simply determines which cell the lat-lon coordinates are in and assigns all emissions from that source to a single grid cell. Except for (1) plume-in-grid sources for all models and (2) elevated sources for UAM-based models (both addressed in Section 2.14, “Elevated-source processing” [77], this means that the AQMs do not have information about where in the grid cell the point source is located.

2.11.3. Creating the spatial allocation intermediate files

The last task for the spatial allocation processing is creating the gridding intermediate files. The **Grdmat** program creates a gridding matrix (**AGMAT**, **MGMAT**, or **PGMAT**) and for on-road mobile sources an ungridding matrix (**MUMAT**). These matrices contain all of the factors needed to calculate gridded emissions from a source-based inventory. In addition, the **Grdmat** program writes a supplementary output file (**AGSUP** or **MGSUP**) that contains the spatial surrogates assigned for each source, indicates whether the assignment was a primary or a fallback, and identifies area-to-point sources. The structures of the SMOKE intermediate files output by **Grdmat** are provided in Section 7.4, “**Grdmat**” [382].

2.12. Growth processing

Growth processing creates emission data sets for years other than a year for which an emissions inventory is available. For example, if an inventory is available for 1996, but the modeling effort involves predicting ozone levels in 2007, then the emissions inventory must be grown to the year 2007. Previous versions of this document used the term “projection” for this function; in this version, however, “projection” refers to both growth of emissions (which is covered in this subsection) and control of emissions (addressed in Section 2.13, “Control processing” [74]). The **Cntlmat** program performs both growth and control functions. For growth processing, **Cntlmat** creates a growth matrix that contains the growth factors for each source and pollutant in the inventory. The **Grwinven** program then combines the growth matrix with the emission inventory to create a grown emission inventory.

If no new sources are being added when moving from the inventory year to the future year, then **Grwinven** can be used with the base case inventory and the growth matrix based on it. If new sources must be added, then the data structuring step (performed by **Smkinven**) must be rerun for the new number of sources, followed by running **Cntlmat** to create the growth matrix; then **Grwinven** applies the matrix to the new inventory file. Alternatively, users may elect to prepare a future-year inventory outside of SMOKE and import it directly with **Smkinven**, which skips the **Cntlmat** and **Grwinven** steps.

Figure 2.25, “Relationship between inventory sources and growth matrix” [72] shows the relationship between the inventory and the growth matrix created by **Cntlmat**, which consists of columns for each pollutant being grown from one year to another. The entries in the matrix are the growth factors needed to grow the inventory to a future or past year; note that these entries can be greater than, equal to, or less than 1 depending on if the emissions should increase, stay the same, or decrease after the inventory is grown. If the growth factors are the same for every pollutant in the inventory, then only one column, called “pfac”, is included in the growth matrix, rather than using duplicate columns for every pollutant. The growth matrix depends only upon the growth factors and the inventory, so it is therefore independent of other factor-based operations for emissions processing; however, growth of the inventory (using the **Grwinven** program) must occur before the temporal allocation step when creating model-ready emissions using inventories grown with SMOKE.

Grwinven combines the intermediate inventory files with one or more growth matrices to create a new intermediate inventory file with the same structure as the original file but with a future (or past) year stored in the header of this file.

In growth processing, the **Cntlmat** program addresses the following emissions processing needs when creating the growth matrix:

1. Assigning growth factors
2. Reporting on the factors assigned to each source in the inventory
3. Creating the growth matrix

The **Grwinven** program addresses the remaining needs to create a grown inventory:

4. Applying the growth matrix
5. Creating a grown inventory file

Each of the issues in the list above is addressed in the following subsections, in the order in which they appear in the list.

2.12.1. Assigning growth factors

The **Cntlmat** program assigns growth factors using a cross-reference approach similar to the approaches used for chemical speciation and gridding. **Cntlmat** reads the information about the growth factors from the /PROJECTION/ packet in the control input file (GCNTL). As described in detail in Section 4.2, “**Cntlmat**” [129], GCNTL can assign growth factors by state/county FIPS code, SCC, SIC, MACT, pollutant, and various combinations of these. The most specific entry is selected by **Cntlmat** based on the hierarchy described in Section 4.2, “**Cntlmat**” [129]. Since the /PROJECTION/ packet includes both the cross-referencing information and the growth factors, there is no need for a profile file (like those used for chemical speciation). The growth factors may include both positive growth (factors greater than 1) or negative growth (factors less than 1) or no growth (factors equal to 1).

The /REACTIVITY/ packet can also be used to grow emissions to a future or past year, but a different approach is used that includes a “phase-in” period and other differences. We describe this packet in Section 2.13, “Control processing” [74].

2.12.2. Reporting on the factors assigned to each source in the inventory

In addition to actually applying the growth factors, the growth processing reports the factors that were applied to each source. **Cntlmat** writes a report that includes the source characteristics and the factor from the /PROJECTION/ packet assigned to the source. For example, the area-source report would include the state, county, and SCCs along with the factor assigned to the source. Only those sources that have growth factors applied are included in the report. This report permits you to verify that the assignments you intended were in fact made by the program. The report is called the APROJREP, MPROJREP, or PPROJREP file for SMOKE area, mobile, and point sources, respectively.

2.12.3. Creating the growth matrix

The growth matrix created by **Cntlmat** contains the growth factors for each source and pollutant. If pollutant-specific growth factors are used, the growth matrix contains one column for each pollutant that is grown. The names of the columns are the same as the names of the pollutants from the SMOKE inventory file, so that the **Grwinven** program knows which column to apply to which inventory pollutant. If the growth factors are applied uniformly to all pollutants in the inventory, then **Cntlmat** does not output a separate but identical factor for each pollutant. Instead, it writes only one column in the matrix, with the name “pfac”.

2.12.4. Applying the growth matrix

The **Grwinven** program applies the growth factors to the inventory pollutants by simply multiplying the growth matrices for the pollutants with the annual and average-day emission values. It reads in the SMOKE intermediate inventory file and up to 80 growth matrices, then applies the growth factors from all growth matrices to the appropriate pollutants. If a growth matrix has the “pfac” variable, **Grwinven** applies the factors to all pollutants in the inventory; if instead the matrix has pollutant-specific entries, the factors are applied by matching the pollutants between the matrix and the inventory.

As is further described in Section 2.13, “Control processing” [74], **Grwinven** can also apply the control matrix at the same time it applies the growth matrix, and the total number of growth and control matrices that can be applied in one run is 80. The **Grwinven** program’s growth processing features cannot be applied to a SMOKE intermediate file that **Grwinven** has created, because of the /FYEAR/ header element described in the next section.

2.12.5. Creating a grown inventory file

After applying the growth factors to the SMOKE intermediate inventory file, the **Grwinven** program writes a new SMOKE intermediate inventory file that contains the new, grown emissions. **Grwinven** only writes the I/O API part of the inventory and not the ASCII part, because the ASCII part that contains the state/county codes, SCCs, and other character strings does not change between the base and future or past year. All of the sources in the base and grown inventory files are the same; the difference is in their emissions values.

Grwinven adds a header element to the I/O API part of the inventory file that indicates the file was created using **Grwinven** and a growth matrix. The header element is /FYEAR/, which is followed by the date of the future year (for example, /FYEAR/ 2018). Other programs (such as **Temporal**) will recognize the /FYEAR/ header element and alter its messages to indicate that a future year is being processed.

2.13. Control processing

The control processing operation applies control factors from a control input file (GCNTL) based on source characteristics in the inventory. A control scenario involves changing the values of emissions based on regulations affecting industrial activities or personal behaviors. The resulting control matrix, created by the **Cntlmat** program, takes the form of the matrix shown in Figure 2.25, “Relationship between inventory sources and growth matrix” [72]. The control matrix depends only upon the source characteristics in the SMOKE inventory and the set of controls chosen, so control processing can therefore be decoupled from the rest of the processing steps. The **Cntlmat** program performs control processing for SMOKE area, mobile, and point sources; however, much more complex controls for on-road mobile sources can also be implemented when using MOVES through SMOKE to calculate emission factors and apply them to VMT.

The emissions control factors can be applied in addition to the emissions growth factors (described in Section 2.12, “Growth processing” [71]), and the net effect of this growth and control is called “projection”. SMOKE control processing can create two types of control matrices during a given run: a multiplicative control matrix and a reactivity control matrix.

The **Cntlmat** program performs the following emissions processing steps in creating the control matrices:

1. Assigning control factors from six control packets to the sources
2. Creating the multiplicative control matrix
3. Creating the reactivity control matrix
4. Reporting on factors assigned to each source in the inventory

The **Grwinven** program addresses the following control processing steps:

5. Applying the multiplicative control matrices to the inventory
6. Creating a controlled intermediate inventory file

Finally, the **Smkmerge** program can be used to perform the following control processing step:

7. Applying the multiplicative and/or reactivity control matrices to the inventory to create model-ready inputs

The next seven subsections explain the concepts involved with these processing steps in more detail.

2.13.1. Assigning control factors from six control packets to the sources

SMOKE provides six control packets with which users can control emissions:

- **/MACT/** contains MACT-based assignments for toxics inventories and can be used to apply general MACT controls to sources affected by MACT regulations. This packet contributes to the multiplicative control matrix.
- **/CONTROL/** contains settings for control efficiency, rule effectiveness, and rule penetration that can be applied by nearly any combination of source characteristics, even targeting a specific source. This packet contributes to the multiplicative control matrix. This packet cannot appear in the same input file with an **/EMS_CONTROL/** packet.

- `/EMS_CONTROL/` contains settings for control efficiency, rule effectiveness, and rule penetration for both the base year *and* a future year. It also contains a point-source conversion factor and an aggregated control factor that can override everything else in the packet. This packet contributes to the multiplicative control matrix. This packet cannot appear in the same input file with a `/CONTROL/` packet, and it can be used for point sources only.
- `/CTG/` contains settings for control technology guideline (CTG) controls, MACT controls, and reasonably available control technology (RACT) controls. It contributes to the multiplicative control matrix.
- `/ALLOWABLE/` contains county-specific, SIC-specific, SCC-specific controls, caps, and replacement emissions. It contributes to the multiplicative control matrix.
- `/REACTIVITY/` contains settings needed for reactivity-based controls and its use results in the reactivity control matrix.

Section 4.2, “**Cntlmat**” [129] describes the **Cntlmat** program in more detail, including the cross-reference hierarchy of these packets and how they relate to one another. All packets can be included in a single **Cntlmat** run, with the exception of the `/CONTROL/` and `/EMS_CONTROL/` packets (either one or the other of these can be included, but not both). In general, these packets can assign control factors by state/county FIPS code, SCC, SIC, MACT, pollutant, other plant-specific source characteristics, and various combinations of these.

2.13.2. Creating the multiplicative control matrix

Cntlmat creates the multiplicative control matrix based on the information contained in the `/MACT/`, `/CONTROL/`, `/EMS_CONTROL/`, `/CTG/`, and `/ALLOWABLE/` packets. The specific details of how these packets interact and how the control factors are calculated is described in the **Cntlmat** section of Section 4.2, “**Cntlmat**” [129]. Once the control factors have been calculated, **Cntlmat** writes a multiplicative control matrix file that contains one column of control factors for each pollutant; each row in the matrix represents a source. The names of the columns are the same as the names of the pollutants from the SMOKE inventory file, so that either the **Grwinven** or the **Smkmerge** program knows which control column to apply to which inventory pollutant.

2.13.3. Creating the reactivity control matrix

Reactivity controls have been included in SMOKE to allow users to examine what happens to the air quality modeling results when the chemical mixture of the emissions is changed to reduce its ozone-forming potential. Examining the effect of reactivity controls is known as “reactivity assessment”. The implementation of this type of control includes permitting users to reset the base-year emissions, reset the SCC, and reset the chemical speciation profile. The controls can be applied to all sources that match an SCC or a specific facility or process within a facility.

Several issues are important when addressing emissions processing requirements for reactivity assessments. Reactivity assessment involves replacing one compound in the inventory by another compound. This replacement can impact emission projections, the total magnitude of the inventory pollutants, and the associated SCCs. The market penetration of the replacement compound may vary in time and space, which affects the future-year emissions. Also, the replacement compound may be needed in much greater or much smaller amounts, thereby affecting the total inventory emissions. Finally, if a different process is required in order for a source to use the different compound, the SCC for that source may change.

The scale of the reactivity assessment is important; it could be local, statewide, or national. A local case could involve investigating reactivity for one source. A statewide case could be implementing a change in compound based on reactivity considerations for a State Implementation Plan (SIP), and this would affect

sources across the state. A national case could involve an EPA investigation of the formulation of nationally distributed consumer products.

In addition, exemptions from controls for certain sources must be permitted as part of an emissions control strategy. These exemptions can occur when a reactivity assessment determines that certain compounds and/or processes do not significantly affect pollution formation.

To address these issues, SMOKE is able to target changes in a VOC for specific classes of VOC emissions, and address the spatial and temporal considerations implied by market penetration issues. Furthermore, when replacement options are being investigated, the correct replacement operations are facilitated by SMOKE. These operations include selecting sources, changing underlying pollutant emissions, changing SCCs, correctly projecting future-year emissions based in part on market penetration issues, and appropriately speciating emissions for the new compound.

For a single run of **Cntlmat**, reactivity controls can be applied to only one pollutant, typically a VOC pollutant. Therefore, if you have more than one VOC pollutant in the inventory (e.g., a toxics VOC and a particulate pollutant), then separate reactivity matrices will need to be created for each pollutant that receives reactivity controls, and these controls will need to be applied in separate SMOKE runs (see Section 2.13.7, “Using **Smkmerge** to apply the multiplicative and/or reactivity control matrices” [77] for more information).

2.13.4. Reporting on factors assigned to each source in the inventory

In addition to assigning the control factors, **Cntlmat** also creates reports detailing the factors applied to each source. These reports include the source characteristics and the factors assigned to the sources. The reports are:

- **ACREP, MCREP, or PCREP:** For area and mobile sources, this report includes emissions before and after all multiplicative controls have been applied by state, county, and SCC. For point sources, the report includes emissions before and after all multiplicative controls by facility.
- **AREACREP, MREACREP, or PREACREP:** For pollutants controlled with reactivity controls (usually VOC), this report includes source number, base-year emissions, replacement base-year emissions, projection factor, future-year SCC, future-year speciation profile number, and market penetration rate of reactivity control. This report is the only reactivity report that can be generated by SMOKE since the **Smkreport** program cannot yet import and apply the reactivity matrix to generate reports.
- **ACSUMREP, MCSUMREP, or PCSUMREP:** For each source, this report includes the specific multiplicative controls that were applied to each source. It includes the emissions before and after each control, as well as the control factor that was applied. The control packet from which each control came is included in the report. The reactivity controls are not included in this report.

2.13.5. Using Grwinven to apply the multiplicative control matrices

The **Grwinven** program applies the multiplicative control matrices to the inventory pollutants by multiplying the control factors for the pollutants with the annual and average-day emission values. (Reactivity matrices cannot be applied by **Grwinven**; only the **Smkmerge** program can apply those, as discussed in Section 2.13.7, “Using **Smkmerge** to apply the multiplicative and/or reactivity control matrices” [77].)

Grwinven reads in the SMOKE intermediate inventory file and up to 80 control matrices and then applies the control factors from all matrices to the appropriate pollutants.

As discussed in Section 2.12.4, “Applying the growth matrix” [73], the **Grwinven** program can also apply growth matrices at the same time it applies control matrices, and the total number of growth and control matrices that can be applied in one run is 80. If desired, the control processing features of **Grwinven** can be used on a SMOKE intermediate file that has been created by **Grwinven** with grown and/or controlled emissions, as long as no *growth* processing features are included in that second pass. (See section Section 2.12.4, “Applying the growth matrix” [73] for discussion of this restriction on applying growth matrices, caused by **Grwinven**’s addition of the /FYEAR/ header element.)

2.13.6. Creating a controlled intermediate inventory file

After applying the control factors to the SMOKE intermediate inventory file, the **Grwinven** program writes a new SMOKE intermediate inventory file that contains the new, controlled emissions. **Grwinven** writes only the I/O API part of the inventory and not the ASCII part, because the ASCII part that contains the state/county codes, SCCs, and other character strings does not change between the base and future or past year. All of the sources in the base and controlled inventory files are the same; the difference is in their emissions values.

Grwinven can also output the ORL inventory format (in addition to I/O API format), which is also a SMOKE input format.

2.13.7. Using Smkmerge to apply the multiplicative and/or reactivity control matrices

The **Smkmerge** program is a second option for applying control matrices. **Smkmerge** can apply both multiplicative control matrices and reactivity control matrices; it is the only program that can do the latter. Because the overall purpose of **Smkmerge** is to create the model-ready input files for an AQM (as discussed in Section 2.17, “Creating model-ready emissions” [86]), the result of using **Smkmerge** to apply control matrices is a controlled, model-ready file, as opposed to the controlled intermediate inventory file output by **Grwinven**.

Smkmerge is limited to applying one control matrix and one reactivity matrix for each SMOKE source category (area, mobile, or point). Therefore, if multiple reactivity control matrices need to be applied to create a single set of model-ready emission inputs, then the processing must be done as multiple SMOKE runs. This includes separating the sources that need different controls into separate inventory files and performing all SMOKE processing steps separately on the runs, using different reactivity controls for each. The resulting two or more sets of model-ready emissions should not have duplicate sources if the inventories were separated correctly at the start, and the model-ready files are combined using the **Mrggrid** program, as discussed in Section 2.17, “Creating model-ready emissions” [86].

2.14. Elevated-source processing

As introduced in Section 2.4.3, “Model-ready files” [18] and further explained in Section 2.7.5, “Point-source processing” [41], there are two major approaches to processing elevated point sources for air quality modeling. The first approach is to have SMOKE compute the layer assignments for the point sources; this method is used for the CMAQ model. The second approach, which is used for the UAM models and CAM_X, is to select specific sources as elevated and then create a special elevated-point-source file that contains the information needed so that the AQM can compute the plume rise. In both cases, users can select elevated sources specifically (in the second approach, that selection is mandatory). Also, PinG sources can be selected in both cases.

The two approaches have some steps that are the same and some that are different. The rest of this section is split into the following two subsections, one for each elevated-point-source processing approach:

1. Computing layer fractions for CMAQ
2. Creating an elevated-source file for UAM and CAM_x

Each subsection first overviews the steps in the approach, then gives more details on some of them.

2.14.1. Computing layer fractions for CMAQ

The CMAQ model requires the layer fractions for elevated point sources to be computed by SMOKE. To do this, SMOKE performs the following steps:

- Uses the **Smkinven** program to import the annual, average-day, day-specific, and/or hour-specific emissions.
- Optionally uses the **Temporal** program to calculate hourly emissions if emissions will be used as a criterion for selecting elevated sources or PinG sources. For example, you may wish to select facilities with NO_x emissions greater than 100 tons/day.
- Uses the **Elevpoint** program to select elevated and/or PinG sources. This step is required if modeling with PinG sources, but optional otherwise.
- Uses the **Elevpoint** program to create the `STACK_GROUPS` file, which is needed for processing PinG sources with CMAQ.
- Uses the **Laypoint** program to compute elevated plume rise for all elevated sources, and store the layer fractions for each source. This step can optionally read the output file from **Elevpoint** to identify the elevated sources, but otherwise will compute plume rise for *all* sources.
- Uses the **Smkmerge** program to combine the layer fractions with the hourly emissions to generate the model-ready output files and optionally generate the PinG hourly emissions file for CMAQ.
- Optionally uses the **Smkreport** program to report on elevated or PinG sources

2.14.1.1. Using Elevpoint

Elevpoint can select elevated and PinG sources using multiple criteria based on emissions values, emissions rank, stack parameters, plant numbers, and an analytical plume rise calculation. The elevated criteria and PinG criteria are provided to **Elevpoint** using a file called `PELVCONFIG`. You must configure this file to contain the criteria needed to select elevated and PinG source (if these selection are needed at all). If emissions values is one of the criteria, the **Elevpoint** program reads all of the hourly point-source files using the `PTMPLIST` file. This file is a list of all `PTMP` files that will be evaluated to determine which sources have maximum daily emissions that exceed the specified selection criteria or to determine the emissions rank. Only the maximum daily facility-total emissions can be used by **Elevpoint** to select sources based on emissions.

The elevated sources and PinG sources can each be selected using different criteria. In general, there are many more elevated sources than PinG sources for typical applications of SMOKE and AQMs. **Elevpoint** also permits you to group PinG sources and creates the `STACK_GROUPS` file so that the sources are treated as a single source in the PinG rise calculation by CMAQ. Grouping is useful to reduce the total number of PinG stacks processed by CMAQ (PinG processing is a computationally expensive calculation). Using grouping makes sense when several stacks at the same plant have the same, or nearly the same, stack parameters. When that is true, the emissions from the multiple stacks can be grouped and treated as a single PinG stack. Finally, there are two SMOKE settings (`SMK_ELEV_METHOD` and `SMK_PING_METHOD`) that instruct **Elevpoint** and other SMOKE programs to actually use these criteria to select the elevated and

PinG sources. If these settings are not set to “1” the elevated and PinG selections will not be made, and so will not affect any further processing steps.

2.14.1.2. Using Laypoint

In this CMAQ approach, **Laypoint** uses gridded, hourly meteorological data and stack parameters to calculate the plume rise for all point-source emissions. The program’s approach is based on the Briggs algorithm, as explained in detail in Section 4.3.1.1, “Plume rise calculation” [140], and provides the top and bottom heights of the plume. **Laypoint** uses these heights to compute the plumes’ distributions into the vertical layers that the plumes intersect, using the pressure difference across each layer over the pressure difference across the entire plume as a weighting factor to make this calculation. This approach gives plume fractions by layer and source. Only these fractions are stored in the output file (PLAY) from the **Laypoint** program (not the emissions in each layer).

If explicit plume rise sources (e.g., wildfires with precomputed hourly plume rise) are included in the inventory, **Laypoint** will skip the plume rise calculation for these sources. Instead, it will use the hourly data from the SMOKE PHOUR intermediate file, which describe the fraction of emissions in layer 1 and the top and bottom of the plume. **Laypoint** will combine these data with the pressure weights used for all elevated point sources to compute the fraction of emissions to go into each layer.

2.14.1.3. Using Smkmerge

Smkmerge applies the layer fractions from **Laypoint** to the elevated sources to compute the emissions in each layer. This approach has the advantage of allowing you to avoid repeating the plume rise calculations for each control strategy or grid. If the SMK_PING_METHOD setting (discussed above) indicates that the special CMAQ PinG file should be created, the **Smkmerge** program will also output this special file, called the PINGTS_L file. It contains the hourly, speciated emissions for each PinG source (which could be a stack group, as explained above).

2.14.1.4. Optional use of Smkreport

If desired, **Smkreport** can apply the layer fractions and elevated or PinG statuses to the inventory to generate reports that include layer information and/or the elevated or PinG status. This reporting could be used, for example, to create a list of all PinG sources in the inventory, or to determine the elevated versus layer-1 emissions by state or SCC.

2.14.2. Creating an elevated-source file for UAM and CAM_x

The other approach to modeling elevated sources is to create an elevated-point-source input file for one of the UAM models or CAM_x. To do this, SMOKE performs the following steps:

- Uses the **Smkinven** program to import the annual, average-day, day-specific, and/or hour-specific emissions.
- Optionally uses the **Temporal** program to calculate hourly emissions if emissions will be used as a criterion for selecting elevated sources or PinG sources. For example, you may wish to select facilities with NO_x emissions greater than 100 tons/day.
- Uses the **Elevpoint** program to select elevated and optionally PinG sources. Unlike processing for CMAQ, this step is always required.
- Uses the **Elevpoint** program to create the STACK_GROUPS file, which is needed for creating the elevated-point-source file with **Smkmerge**.

- Uses the **Laypoint** program to compute elevated plume rise for explicit plume rise sources, and store the layer fractions for the explicit sources only.
- Uses the **Smkmerge** program to combine the `STACK_GROUPS` information, optional explicit plume rise information, and the hourly emissions to generate an ASCII elevated-point-source file with optional PinG flags.

2.14.2.1. Using Elevpoint

The primary difference between this approach is that the **Elevpoint** processing step is required. Traditionally, elevated point sources have been selected for the UAM or CAM_X models using the analytical plume rise calculation. While **Elevpoint** can perform this calculation and use it exclusively to determine the elevated sources, you can also use the other selection criteria if desired: emissions values, emissions rank, stack parameters, and plant numbers. As described in Section 2.14.1, “Computing layer fractions for CMAQ” [78], if the selection criteria include emissions, then the `PTMPLIST` file will be used to input all hourly emissions files for the entire modeling episode.

2.14.2.2. Using Laypoint

If explicit plume rise sources (e.g., wildfires with precomputed hourly plume rise) are included in the inventory, you must run the **Laypoint** program to compute the layer fractions for these sources only. This is the *only* reason **Laypoint** would be run in the UAM/CAM_X processing approach, and it requires that the `EXPLICIT_PLUMES_YN` and the `HOURL_PLUMEDATA_YN` settings be set to Y. These settings cause **Laypoint** to write the layer fractions to the `PLAY_EX` file instead of to the usual `PLAY` file. For these explicit sources, **Laypoint** will skip the plume rise calculation. Instead, it will use the hourly data from the `SMOKE PHOUR` intermediate file containing the fraction of emissions in layer 1 and the top and bottom of the plume. **Laypoint** will combine these data with the pressure weights used for all elevated point sources to compute the fraction of emissions to go into each layer.

2.14.2.3. Using Smkmerge

The **Smkmerge** program looks for the `SMK_ASCII_ELEV_YN` setting to determine whether the ASCII output file should be created. When this is set to Y, the output files from **Elevpoint** (`PELV` and `STACK_GROUPS`) are read to determine which sources should not be included in the 2-D emissions output file for point sources. The emissions from these sources are instead output to an ASCII elevated file along with stack parameters and locations so that the AQM can compute the plume rise.

If `EXPLICIT_PLUMES_YN` is also set to Y, **Smkmerge** will read the `PLAY_EX` file for the explicit plume sources. Since the UAM-based approach assumes that the AQM will compute the plume rise, `SMOKE` must manipulate the input file to trick the model into using precomputed plume rise. This is done by inserting fake stacks into the ASCII elevated file that extend to the center of each of the model layers and setting the stack parameters so that the plume rise calculation will keep the emissions associated with the fake stacks in the layer of the stack. As the emissions move from layer to layer, **Smkmerge** moves the reported emissions in the ASCII elevated file from fake stack to fake stack to represent the same behavior.

2.15. Mobile-source processing with MOVES

MOVES is the U.S. Environmental Protection Agency's (EPA) Motor Vehicle Emission Simulator. In the modeling process, the user specifies vehicle types, time periods, geographical areas, pollutants, vehicle operating characteristics, and road types to be modeled. The model then performs a series of calculations, which have been carefully developed to accurately reflect vehicle operating processes (such as cold start or extended idle) and provide estimates of bulk emissions or emission rates.

An important feature of MOVES is that it allows users to choose between (1) the Inventory calculation type, which provides emission rates in terms of total quantity of emissions for a given time period; and (2) Emission Rate calculation type, which gives emission rates in terms of grams/mile or grams/vehicle/hour. For large-scale emissions modeling such as that needed for regional- and national-scale air quality modeling projects, it is desirable to use the Emission Rate calculation type, which populates emission rate lookup tables that can then be applied to many times and places, thus reducing the total number of MOVES runs required.

To reduce the time and effort and to help the user obtain more accurate modeling results, users need to prepare and post-process MOVES runs for a representative county (See Section 2.7.4.6, “Representative Counties” [35]) and reference fuel month (See Section 2.7.4.7, “Reference Fuel month” [35]) This approach consists of a set of scripts that automate the proper use of the Emission Rate calculations for the purpose of estimating mobile-source emissions for air quality (AQ) modeling.

Integrating MOVES into SMOKE modeling system consists of three major parts:

1) Meteorological data processing

- The meteorological data preprocessor program **Met4moves** prepares spatially and temporally averaged temperatures and relative humidity data to set up the meteorological input conditions for MOVES and SMOKE using the Meteorology-Chemistry Interface Processor (MCIP) output files.

2) MOVES model processing

- The MOVES Driver script : “**Runspec_generator.pl**” creates data importer files and the MOVES input file (runspec), which specifies the characteristics of the particular scenario to be modeled.
- The MOVES postprocessing scripts : “**Moves2smkEF.pl**” formats the MOVES emission rate lookup tables for SMOKE. “**gen_8digit_scc.pl**” generates an SCC mapping file used when importing activity data.

3) SMOKE model processing

- Spatially and temporally allocate mobile onroad activity data (i.e., Vehicle Mileage Traveled and Vehicle population).
- The MOVES postprocessing program, **Movesmrg**, estimates emissions from on-road mobile sources based on MOVES-based emission rate lookup tables and meteorology data from **Met4moves**.
- Creates hourly gridded speciated air quality model-ready input files.
- Produces various types of reports for users.

2.15.1. Meteorology Data Processing

With the specified representative county and reference fuel month approach for temperature and RH calculation for MOVES and SMOKE modeling systems, **Met4moves** uses hourly min/max temperatures and averaged RH over the spatial region that includes all of the inventory counties in a county group over the user-defined modeling period. **Met4moves** supports the averaging method (monthly or daily) to create min/max temperatures and averaged RH for all inventory counties in the county group(s). **Met4moves** determines the min/max grid cell temperatures and associated RH for both SMOKE and MOVES, and computes average 24-hour temperature profiles using Meteorology-Chemistry Interface Processor (MCIP) output files for use in MOVES. These **Met4moves** program is discussed in detail in Section 4.7, “**Met4moves**” [155].

The 24-hour temperature profiles are averaged over a user-specified time period and grid cells for all representative counties. For the MOVES Driver scripts, **Met4moves** outputs monthly average RH, min/max temperatures, and 24-hour temperature profiles in local time for all representative counties into one output file. For the SMOKE model, **Met4moves** outputs county-specific min/max temperatures and averaged RH values in local time for every inventory county and averaging period in the modeling inventory.

2.15.2. MOVES Model Processing

2.15.2.1. MOVES Driver Script

The inputs to the MOVES Driver Script (**Runspec_generator.pl**) include the temperature and humidity conditions output from **Met4moves** and two additional inputs, the RunControl and RepCounty files. The RunControl file contains pollutant selections and the file path location to the **Met4moves** output. The RepCounty file contains file path locations to user-created MOVES-formatted inputs for age distribution, fuel supply and formulation, inspection and maintenance programs, county level population and annual VMT for each representative county. Precise formats of the RunControl and RepCounty files can be found in the Section 6.9.2.2.2, “Representative County File for MOVES Driver Script” [346] and Section 6.9.2.2.1, “Run Control File for MOVES Driver Script” [345].

2.15.2.2. MOVES Post-processing Script

A MOVES Driver Script to automates the MOVES run setups and prepare two kinds of batch files. When launched, the batch files instruct MOVES to:

- import data into MySQL County Scale databases
- run MOVES for each runspec file

The resulting RatePerDistance (RPD), RatePerVehicle (RPV), RatePerProfile (RPP), and RatePerHour (RPH) tables contain all the conditions needed for regional modeling using SMOKE modeling system.

Once a MOVES batch run completes, MOVES populates the four output lookup tables with formats listed in Table 2.10, “MOVES Emission Rate Lookup Table (MOVES Format)” [83]. A MOVES Post-processing Script (**Moves2smkEF.pl**) in Perl interacts with MySQL to modify the default formats shown in Table 2.10, “MOVES Emission Rate Lookup Table (MOVES Format)” [83] into a text ASCII-format readable by SMOKE, shown in Table 2.11, “MOVES Emission Rate Lookup Table (SMOKE Format)” [84].

The MOVES Post-processing Script converts the MOVES format Emission Rate Lookup Table to the SMOKE format Emission Rate Table by performing the following:

- Parses the state-county FIPS code from linkID, zoneID or TemperatureProfileID and stores it as a unique field, FIPS.
- Removes fields that are uninformative to SMOKE, including the MOVES source type, fuel type and road type, hourID in RatePerDistance, TemperatureProfileID in RatePerProfile.
- Reduces the output database table size by performing a cross-tab query on the pollutant emissions, listing each pollutant in a separate field rather than in a single column with a higher number of data records. The script also sorts the lookup tables by countyID, monthID and SCC for more efficient processing in SMOKE.
- Optionally calculates additional output pollutants or species by applying user-specified formulas to MOVES-created emission factors.
- Write out to the ASCII-formatted four processed SMOKE-ready MOVES lookup tables [RatePerDistance (RPD), RatePerVehicle (RPV), RatePerProfile (RPP), and RatePerHour (RPH)].

2.15.3. SMOKE Model Processing

Once the **Met4moves** meteorology preprocessor and the MOVES model processing that results in the SMOKE-formatted emissions factor lookup tables are completed, we address the remaining major component of the SMOKE-MOVES tool: the SMOKE model processing step. The goals of this step are (1) to estimate emissions from on-road mobile sources based on MOVES-based emissions lookup tables and meteorology data, (2) to create hourly gridded speciated air quality model-ready input files, and (3) to produce various types of reports for the user.

As some readers are aware, MOBILE6 and MOVES are both vehicle emissions modeling systems used with SMOKE. However, they differ in their approaches to calculating off-network evaporative emissions. In MOBILE6, off-network emissions processes are calculated as emission factors in grams/mile, which is related to Vehicle Mileage Travelled (VMT). MOVES, on the other hand, uses the source (vehicle) type population (VPOP) to calculate start and off-network evaporative emissions, which are assigned to off-network emissions processes; these processes are hour-dependent due to VPOP (activity) assumptions built into the MOVES model. Thus, compared to the SMOKE-MOBILE6 approach, the SMOKE-MOVES approach requires additional vehicle population inventory data as input for estimating mobile-source emissions from off-network emissions processes. This requirement is reflected in the discussion below.

When processing mobile-source emissions from MOVES, SMOKE performs the following basic steps.

- **Smkinven** imports county-total VMT and average speed, and county-total vehicle hotelling hours (HOTELLING) by SCC for On-roadway Emission Processes and county-total vehicle population (VPOP) by vehicle type for Off-network Emission Processes.
- **Spcmat** computes the chemical speciation factors for each county, fuel type, source (=vehicle) type, road type, emission process, and pollutant, and stores the necessary factors for the VMT-to-species in RatePerDistance (RPD), HOTELLING-to-species in RatePerHour (RPH), and VPOP-to-species transformations in RatePerVehicle (RPV) and RatePerProfile (RPP).
- **Grdmat** allocates the county sources to grid cells and uses spatial surrogates to allocate county-total VMT, HOTELLING, and VPOP to grid cells, storing the factors needed for these allocations.
- **Temporal** computes hourly VMT and HOTELLING activity data for On-roadway Emission Processes (RPD and RPH tables). Off-network Emission Processes (RPV and RPP tables) do not require the **Temporal** program because vehicle population does not need to be temporally allocated.

The way the MOVES-generated emissions factor lookup tables are used varies according to whether SMOKE is modeling on-roadway emission processes or off-network emissions processes.

On-roadway emission processes: When estimates of all on-roadway emission processes except for extended idle exhaust are needed, SMOKE requires county-total VMT and average hourly speed (SPEED) inventory data as inputs to a SMOKE postprocessor called **Movesmrg** which is part of the SMOKE-MOVES tool. When extended idle exhaust process is estimated, county-total HOTELLING activity data is needed for **Movesmrg**. **Movesmrg** uses the SMOKE-ready MOVES RPD and RPH lookup tables as an input to estimate on-road sources emission. The key lookup fields for RPD are gridded hourly temperature and average hourly speed from the avgSpeedBinID field for RPD. SMOKE interpolates in the emission factors lookup table (in unit of grams/mile) based on gridded hourly temperature and average speed. Figure 2.13, “MOVES mobile RatePerDistance processing steps” [32] shows processing steps for on-roadway emissions processes in the SMOKE system using VMT and SPEED activity inventory data. For RPH, the gridded hourly temperature is used to interpolate in the emission factors lookup table (in unit of grams/hour).

Off-network emission processes: When estimates are needed for off-network emissions processes, including the off-network vapor venting emissions process, SMOKE uses county-total VPOP by vehicle type as input to **Movesmrg** together with the SMOKE-ready RatePerVehicle (RPV) and RatePerProfile (RPP) lookup tables. Figure 2.14, “MOVES mobile RatePerVehicle and RatePerProfile (off-network) processing steps” [32] shows processing steps for off-network emissions processes in the SMOKE modeling system using vehicle population activity inventory data. A significant difference in the processing steps between the on-roadway emissions processes (RPD table) and the off-network emissions processes (RPV and RPP tables) is that off-network emissions processing does not require the **Temporal** program step because vehicle population (VPOP) does not need to be temporally allocated. In the RPV table, gridded hourly temperature and hour of the day are the key lookup fields SMOKE uses to estimate hourly off-network emissions in unit of grams/vehicle/hour. For the evaporative fuel off-network vapor venting emissions process only, **Movesmrg** uses the RPP lookup table to estimate the emission rates based on the minimum and maximum temperatures computed by **Met4moves**.

For all SMOKE-ready three emission rate lookup tables (RPD, RPV, RPP), SMOKE performs linear interpolation when using them.

2.16. Biogenic processing

SMOKE currently supports the Biogenic Emissions Inventory System (BEIS) 4 and previous versions for processing emissions from biogenic origin. The overall processing performed by these models is quite

different from the processing done for anthropogenic source categories. BEIS4 starts with spatial allocation of land use data as the first processing step (which is the same as importing the raw inventory data for anthropogenic sources). In the next step, the model computes normalized emissions for each grid cell and land use category. The final step is adjusting the normalized emissions based on gridded, hourly meteorology data and assigning the chemical species to output a model-ready biogenic emissions file. The following two subsections provide more detail about the most recent biogenic model implementation in SMOKE and give references to additional detail elsewhere.

2.16.1. BEIS4 processing

The concepts in BEIS4 are similar to those in BEIS3 and previous versions, except the program **Normbeis4** reads gridded land use data from a single file in I/O API input format (**BELD6**), and gridded Leaf Biomass inputs from a separate file **BIOMASS**. **Normbeis4** creates normalized biogenic emissions for both winter and summer. The **Tmpbeis4** program reads the MCIP meteorology data and makes these adjustments; these include the effects of temperature and solar radiation. **Tmpbeis4** gives the user two options for using the winter and summer normalized emissions. The recommended option is to use the gridded soil temperature from the MCIP data to determine the fraction of summer and winter normalized emissions to use for each grid cell. When gridded soil temperature is greater or equal to 290K, the summer normalized emissions will be used in the hourly emissions calculations. If gridded soil temperature is below 282K, then the winter normalized emissions will be used in calculations. Any grid cell with a soil temperature between 282K and 290K will use a certain fraction of winter and a fraction of the summer normalized emissions in hourly emissions calculations. This recommended option should provide more realistic emissions during season transition periods (e.g. winter to spring). The option for using winter and summer normalized emissions is the same approach with **Tmpbeis3** where **Metscan** is used. The winter emission factors are to be used during the "winter" period, which is defined as being after the first date of freezing ground temperature and before the last date of freezing ground temperature. The SMOKE **Metscan** program can determine this time period and create a gridded file that indicates whether each grid cell is in a winter or summer period for each day of the year. Using this file, which is optional, will cause **Tmpbeis4** to read and use both the winter and summer normalized emissions files from **Normbeis4**. Whether the winter or summer normalized emissions are used for a given grid cell and hour is set by the output from the **Metscan** program. Users can define the chemical species that are output from **Tmpbeis4** using the speciation profile file, **GSPRO**. In this file, you can set an environment variable (**BIOG_SPRO**) that indicates which speciation profile code should be used for biogenic emissions. More information on **Normbeis4** and **Tmpbeis4** is provided in Section 4.13, "**Normbeis4**" [177] and Section 4.19, "**Tmpbeis4**" [224].

2.17. Creating model-ready emissions

Creating emissions with SMOKE that are ready for input to an AQM must always include merging the hourly emissions created during temporal processing with the gridding matrices and the speciation matrices. In addition, for point sources for CMAQ, creating the model-ready emissions must also include merging with the layer fractions (see Section 2.14.1, "Computing layer fractions for CMAQ" [78]), and for UAM-based models it must include creating the ASCII elevated file (see Section 2.14.2, "Creating an elevated-source file for UAM and CAM_x" [79]). The **Smkmerge** program performs these processing steps using vector-matrix multiplication to combine the matrices and layer fractions with the hourly emissions vectors from the **Temporal** program.

If the overall SMOKE processing setup includes running the nonroad mobile category (or other source categories) as separate runs, then **Smkmerge** cannot be used to combine all source categories into a single output file. Instead, the **Mrggrid** program would combine the model-ready files from the individual source categories; for example, from separate SMOKE (including **Smkmerge**) runs for stationary area/nonpoint, nonroad mobile, windblown dust, wildfire, on-road mobile, and point sources. There is no limit to the number of model-ready files that **Mrggrid** can combine into a single model-ready file, and the input files can be 2-D or 3-D.

Smkmerge can be run for any or all SMOKE source categories, but it can use only one of each SMOKE inventory type (area, biogenic, mobile, and point source) per run. You can run it to create model-ready files for only one SMOKE source category (area, biogenic, mobile, or point), or you can run it to create both the individual and combined model-ready files. The following list indicates the modes in which **Smkmerge** can be run:

- Run for SMOKE area sources to create gridded, hourly, speciated emissions in moles/hour or moles/second. Can be used for all area sources and/or nonroad mobile sources.
- Run for SMOKE mobile sources to create gridded, hourly, speciated emissions in moles/hour or moles/second.
- Run for SMOKE point sources to create 3-D gridded, hourly, speciated emissions in moles/ second for CMAQ, *or* run to create 2-D gridded, hourly, speciated emissions in moles/hour for UAM, or CAM_X and an ASCII elevated-point-source file.
- Run to convert the units and calculate state and county totals of biogenic emissions output by the **Tmpbeis4** program.
- Run to perform any combination of the previously listed steps simultaneously and create a combined model-ready file that includes multiple source categories. In this mode, only one each of SMOKE area, mobile, point, and biogenic sources can be included. The same output units must be used for all source categories in a single run.

When creating model-ready emissions for any of the anthropogenic source categories, you may choose to apply one or more control matrices to the emissions to create controlled model-ready emissions. For each source category (area, mobile, or point), you can apply one multiplicative control matrix and one reactivity control matrix per run per source category. **Smkmerge** is the only way you can apply the reactivity control matrix to the inventory, while the multiplicative control matrix can be applied by either **Smkmerge** or the **Grwinven** program.

Many processing steps in SMOKE are independent of one another; for example, chemical speciation and temporal allocation can change without affecting one another. This independence means that when one step changes, another step does not need to be rerun in many cases. However, because **Smkmerge** combines the data from all of these processing steps to create the model-ready emissions, if one of the earlier steps changes, then the merging step must also be rerun. This includes rerunning **Smkmerge** to generate model-ready files, and if the **Mrgrid** program was used, also rerunning that to merge data from multiple source categories together.

Smkmerge also has the ability to input hourly emissions by day of the week and reuse days that are the same. For example, it can input separate hourly emissions files for Monday, a weekday, Saturday, and Sunday, and use these four files to generate model-ready emissions for every day in an entire month. This is accomplished using the MRG_BYDAY SMOKE option, described further in Section 4.15, “**Smkmerge**” [191]. Special treatment can also be given to holidays in this case, since users generally wish to model holidays differently than other days.

2.18. Creating model-ready emissions using MOVES lookup tables

Creating emissions with SMOKE using MOVES lookup tables (i.e., RatePerDistance [RPD], RatePerHour [RPH], RatePerVehicle [RPV] and RatePerProfile [RPP]) must always include merging the gridding matrices from **Grdmat** and the chemical speciation matrices from **Spemat**. In addition, for RPD emissions based on VMT data by source for CMAQ, creating the model-ready emissions must also include merging

with the hourly VMT from **Temporal**. The **Movesmrg** program performs these processing steps using vector-matrix multiplication to combine the matrices and the hourly emissions vectors to create CMAQ-ready gridded and speciated hourly emissions input data.

If the overall SMOKE processing setup includes running the nonroad mobile category (or other source categories) as separate runs, then **Movesmrg** cannot be used to combine all source categories into a single output file. Instead, the **Mrgrid** program would combine the model-ready files from the individual source categories; for example, from separate SMOKE (including **Movesmrg**) runs for RPD, RPV and RPP mobile sources. There is no limit to the number of model-ready files that **Mrgrid** can combine into a single model-ready file, and the input files can be 2-D or 3-D.

Movesmrg can be used only for MOVES-based mobile SMOKE source categories. It can use only one of each MOVES lookup table (RPD, RPH, RPV and RPP) per run. You can run it to create model-ready files for only one SMOKE source category (RPD, RPH, RPV, and RPP). The following list indicates the modes in which **Movesmrg** can be run:

- Run for MOVES RPD mobile sources based on VMT data by vehicle and road types to create gridded, hourly, speciated emissions in moles/hour or moles/second.
- Run for MOVES RPH mobile sources based on vehicle hotelling (HOTELLING) hours activity data by vehicle and road types to create gridded, hourly, speciated emissions in moles/hour or moles/second.
- Run for MOVES RPV mobile sources based on Vehicle population (VPOP) data by vehicle to create gridded, hourly, speciated emissions in moles/hour or moles/second.
- Run for MOVES RPP mobile sources based on Vehicle population (VPOP) data by vehicle to create gridded, hourly, speciated emissions in moles/hour or moles/second.
- Run to create daily total emissions report by county, by state, and by SCC in the unit of tons/day or tons/hour.

Many processing steps in SMOKE are independent of one another; for example, chemical speciation and temporal allocation can change without affecting one another. This independence means that when one step changes, another step does not need to be rerun in many cases. However, because **Movesmrg** combines the data from all of these processing steps to create the model-ready emissions, if one of the earlier steps changes, then the merging step must also be rerun. This includes rerunning **Movesmrg** to generate model-ready files, and if the **Mrgrid** program was used, also rerunning that to merge data from multiple source categories together.

Movesmrg also has the ability to input hourly emissions by day of the week and reuse days that are the same. For example, it can input separate hourly emissions files for Monday, a weekday, Saturday, and Sunday, and use these four files to generate model-ready emissions for every day in an entire month. This is accomplished using the MRG_BYDAY SMOKE option, described further in Section 4.8, “**Movesmrg**” [158]. Special treatment can also be given to holidays in this case, since users generally wish to model holidays differently than other days.

2.19. Quality assurance

Quality assuring SMOKE emissions includes a combination of (1) steps performed by SMOKE programs and (2) postprocessing steps performed by the user.

The SMOKE components that play a role in quality assurance consist of the following:

1. The various SMOKE programs perform file format checks of all input files to ensure that the files can be read. The programs write errors and warnings if files cannot be read properly.

2. SMOKE gives error and warning messages about inventory data that are not complete or are invalid, and about problems or possible problems combining the inventory data with the support files.
3. Core SMOKE programs create reports, such as the area-to-point report provided by **Smkinven** and the control reports provided by **Cntlmat**.
4. The **Smkreport** program reports emissions totals at various levels of data aggregation. This reporting capability currently allows you to generate reports of emissions by source, SCC, region (e.g., state, county, or user-defined region), road class, layer, hour, grid cell, speciation profile, gridding surrogate code, temporal profile, and elevated status. The most powerful reporting feature is that you can combine these reporting resolutions in *any* combination. In addition, reports can be created at each stage of processing (import, gridding, speciation, temporal allocation, layer assignment) or any combination of stages.

Smkreport can combine information from any SMOKE intermediate files (e.g., intermediate inventory file, speciation matrix, gridding matrix) to create emissions reports. One input file to **Smkreport**, called the `REPCONFIG` file, instructs **Smkreport** on how many and which reports to create. The `REPCONFIG` file contains a series of instructions that can be set by the user to control the contents of the reports. More details about **Smkreport** and the `REPCONFIG` are provided in Section 5.2, “**Smkreport** Program” [229] and Section 5.3, “`REPCONFIG` Input File” [232].

The second major component of quality assuring the SMOKE emissions processing involves users taking steps to evaluate the information/reports provided by SMOKE. These steps include:

1. Check that the correct settings have been selected in the run scripts, including the settings that control which SMOKE programs are run.
2. Check the log files from all SMOKE programs for errors and warnings. Errors will keep the programs from running successfully, so the source of the error must be identified and repaired. Warnings may indicate that a problem exists that needs to be addressed, or warnings can be ignored if they are not something that will impact the results for the particular inventory of interest.
3. Compare the emissions totals provided by **Smkreport** (e.g., by state and county) to totals of the emissions inventories computed outside of SMOKE. Also, compare the emissions totals from SMOKE between each of the processing stages. For example, for area sources, compare the emissions after inventory import, gridding, chemical speciation, temporal allocation, and final merge to ensure that the emissions are consistent from step to step. This involves some subjectivity because the emissions do in fact change from step to step, and the magnitude of those changes depends on the support input files SMOKE uses with the inventory.
4. Check that the correct chemical speciation profiles, temporal profiles, and gridding surrogates were applied, using reports that provide this information from **Smkreport**.
5. Perform other specific checks of **Smkreport** outputs, such as ensuring that the correct major point sources are in the inventory, comparing population-normalized emissions among the counties, and checking stack parameters from point sources.
6. Ensure that the emissions data look reasonable by viewing them in the Visualization Environment for Rich Data Interpretation (VERDI).

Chapter 5, *SMOKE Quality Assurance* [229] provides much additional detail about how to proceed with quality assuring your inventories and emissions processing.

3.1. Overview

The utility tools are divided into two sections: MOVES Utility Scripts and SMOKE Utility Programs

3.2. MOVES Utility Scripts

3.2.1. Overview

The MOVES utility scripts are designed to assist the user by automating the proper use of using MOVES emission rate calculations for the purpose of estimating mobile-source emissions for air quality modeling. The MOVES default database has over 100 different tables that store lookup/reference information, conversions/adjustment factors, emissions data, and activity data. MOVES uses MySQL databases to store user inputs, intermediate results and final outputs. The MOVES utility scripts consist of 1) MOVES Driver script and 2) MOVES Post-processing scripts. These scripts are run after the meteorological data processor program (**Met4moves**) which prepares the spatially and temporally averaged temperatures and relative humidity data used as meteorological input conditions for MOVES and SMOKE using the Meteorology-Chemistry Interface Processor (MCIP) output files.

The MOVES Driver script (**Runspec_generator.pl**) creates data importer files and importer script and the MOVES batch run script which specifies the characteristic of the particular scenario to be modeled.

The MOVES Post-processing script (**Moves2smkEF.pl**) formats the MOVES emission rate lookup tables for SMOKE. The second MOVES Post-processing script (**gen_8digit_scc.pl**) generates an SCC mapping file used when importing activity data in **Smkinven**. After the MOVES utility scripts are completed, the SMOKE postprocessing program (**Movesmrg**) estimates emissions from mobile sources using the SMOKE formatted MOVES lookup tables (RPD, RPP, RPV, and RPH) output generated by the MOVES utility scripts and meteorology data from **Met4moves**.

Movesmrg creates hourly, gridded, speciated air quality model-ready input files. Information about key concepts related to the MOVES utility scripts including Representative Counties, Fuels Months, and Emissions Processes are covered in Section 2.7.4.6, “Representative Counties” [35] and Section 2.7.4.7, “Reference Fuel month” [35] and Section 2.7.4.9, “MOVES Emission Processes by Emission Rate Tables” [36]

3.2.2. MOVES Driver Scripts

The MOVES Runspec script **Runspec_generator.pl** is written in Perl, generates the scripts and inputs needed to run MOVES for each representative county. The MOVES Model can be run at any of the three domains/scales: national, county or project. The **Runspec_generator.pl** is only applicable to the county-level because this level of model detail is required by EPA for SIP and conformity analyses. For this scale,

MOVES requires a MySQL input database containing local data for a single county. The **Runspec_generator.pl** is designed to prepare the MOVES importer and MOVES run scripts so that the fewest number of runs will produce all of the necessary emissions factors. In this approach, user can specify one or more groups of pollutants to model in the run control file.

There are a total of four types of modeling pollutant groups: 1) Ozone precursors, 2) Toxics, 3) Particulate Matters, and 4) GreenHouse Gases (GHG) based on Table 2.8, “MOVES Pollutant Groups” [40]. The choice of pollutant group(s) determines what pollutants are included in the three emission rate lookup tables (RPD, RPV, and RPP) by MOVES.

3.2.2.1. Processing Order

Runspec_generator.pl run after **Met4moves**. It assembles the instructions for MOVES to create MySQL input databases from XML files and creates the importer.csh scripts and assembles run specification XML files to run MOVES for a necessary range of conditions (for each emissions process: rate-per-distance, rate-per-vehicle, and rate-per-profile) based on the **Met4moves** output temperature list by county-specific runspec.csh.

The **Runspec_generator.pl** uses following steps:

1. Reads the representative county min/max temperature and 24-hours temperature profiles output file from **Met4moves** for RPP mode. Find detail information from Section 7.8.1, “MOVES_OUTFILE” [388]
2. Reads the representative county specific min/max temperatures and average RH output file from **Met4moves** for RPD, RPV and RPH modes. Find detail information from Section 7.8.2, “MOVES_RH_OUTFILE” [389]
3. Import the name of pollutant group to model from the run control file (contorl.in) based on Table 2.8, “MOVES Pollutant Groups” [40]
4. Reads the run control file (control.in) and representative county file (countyrep.in) created by user.
5. Assembles instructions for MOVES to create MySQL input databases from XML files (data importer).
6. Assembles runspec XML files to run MOVES for a wide range of conditions.
7. Generates the run-specific temperature and humidity comma-separated-values (CSV) format file.
8. Assembles a batch list of data importer files, runspec files, and also a list of the MySQL output database names to be postprocessed.
9. importer.csh and runspec.csh scripts are used to create the on-road operating rateperdistance table (RPD), off-network processes ratepervehicle table (RPV), and vapor venting off-network rateperprofile table (RPP).
10. Review log file of the MOVES, called runlog_*.txt.

3.2.3. Run MOVES Model

3.2.3.1. Overview

Automatically execute multiple MOVES runs based on automatically generated county-specific data importer script and the MOVES run script file by **Runspec_generator.pl**, which specifies the characteristic of the particular scenario to be modeled.

3.2.3.2. MOVES importer script

3.2.3.2.1. Description

The MOVES importer script “importer.[bat|csh]” can be written in Linux C-shell or Windows Batch script format depending on which option is chosen by the user in the **Runspec_generator.pl**. The importer script loads the county-specific data in the file and creates the MySQL input database containing local data for the representative county.

The output of the MOVES batch importer script includes:

- MySQL databases (*_in).

3.2.3.2.2. Processing Order

importer.csh should be run before runspec.csh. The importer.csh is written in Linux c-shell script format.

The importer.csh uses following steps:

1. The importer.csh contains all of the user selections needed to import data from the files into a MySQL MOVES database
2. Imports the data for each of the three different emissions processes: RPD, RPV, RPP.
3. Review log file of the MOVES, called importlog_*.txt.

3.2.3.3. MOVES Runspec batch script

3.2.3.3.1. Description

The MOVES Runspec batch script file “runspec.csh” is used to execute the MOVES runs for the representative county and reference fuel month.

The output directories are named according to the following naming convention: [CountyRep]_[monthID]_[YearID]_[PollutantID], ie. 13121_Apr_2009_ozone

The output files include:

- rateperdistance.[frm|MYD|MYI]

- ratepervehicle.[frm|MYD|MYI]
- rateperprofile.[frm|MYD|MYI]

3.2.3.3.2. Processing Order

runspec.csh is created by **Runspec_generator.pl** and should be run after importer.csh and before **moves2smkEF.pl**. The runspec.csh is written in Linux c-shell script format depending on which platform is being used (this option is specified by the user in the Runspec_generator.pl) the script is used to run MOVES for the appropriate temperature bins, source types, and pollutants.

The runspec.csh uses following steps:

1. The runspec.csh contains all of the user selections needed to run MOVES using the imported MySQL MOVES databases that were created by importer.csh
2. Creates the MOVES output in ASCII format and also provides the associated XML files for the three different emissions processes: RPD, RPV, RPP.
3. Review log file of the MOVES, called runlog_*.txt.

3.2.4. MOVES Post-processing scripts

3.2.4.1. Overview

The MOVES Post-processing scripts consist of two Perl scripts. One is called “**Moves2smkEF.pl**” which extracts the emissions factor tables from the MOVES databases and converts them into a format that can be used as SMOKE inputs. The second script, called “**gen_8digit_scc.pl**”, produces a file mapping 8-digit SCCs to 10-digit SCCs used when importing activity data in **Smkinven**.

3.2.4.2. Moves2smkEF.pl

3.2.4.2.1. Description

The MOVES post-processor script “**Moves2smkEF.pl**” extracts the emission factor tables from the MOVES databases (RPD, RPV, RPP, and RPH MOVES formatted Lookup tables) and converts them into a format that can be processed using **Movesmrg**.

1. Create a new field for 'countyID'

None of the MOVES lookup tables contain a countyID field solely dedicated to a state-county FIPS code, but SMOKE needs this information. For this reason, **Moves2smkEF.pl** creates a county field by extracting it from other fields that include county codes as part of their value. The RPD table has a linkID field that contains countyID in the leading five digits followed by more numbers to allow for future implementation of link modeling. The RPV table has a zoneID field that is countyID with a trailing zero. The RPP table has a TemperatureProfileID field, which also leads with countyID and is trailed by other numbers to indicate month and other identification. The RPH table has a linkID field the same as the RPD table. The postprocessing script parses countyID from linkID, zoneID and TemperatureProfileID and stores it as a separate field.

2. Map MOVES pollutantID to output pollutant/species name

The pollutant mapping file has columns for MOVES2014 Pollutant ID, MOVES2014 Pollutant Name, and SMOKE Pollutant/Model Species Name. **Moves2smkEF.pl** reads this list to determine which MOVES pollutants to output in the emission factor files and what name to use for each pollutant. Because MOVES2014 contains emission factors for both inventory pollutants and model species, the sample pollutant mapping file included with SMOKE uses the **_INV** suffix to distinguish inventory pollutants from model species.

3. Cross-tab pollutantID to reduce output table size

Each of the four MOVES lookup tables contains a pollutantID field, and associated emission rates for each are listed in the ratePerDistance, ratePerVehicle, or ratePerHour field (depending on lookup table). This table structure repeats the leftmost fields (e.g., MOVESRunID, yearID, monthID) for each pollutantID, which greatly increases the total number of rows. The cross-tabbing postprocessing step replaces the column for 'ratePerDistance' (or 'ratePerVehicle' or 'ratePerHour') with additional pollutant-specific columns containing values of emission rates. For example, new field headings would include 'CO_INV', 'NOX', 'BENZENE_INV', etc. Performing this cross-tab on the pollutant emission rates significantly reduces the size of the tables for use by SMOKE.

4. Aggregate emission factors by fuel type, source type, road type, and/or process type

To reduce the total number of sources to be processed in SMOKE, **Moves2smkEF.pl** supports user-specified aggregations of MOVES fuel types, source types, road types, and process types to SCCs.

5. Apply formulas to calculate additional inventory pollutants or model species

Formulas can be applied to augment the existing MOVES output pollutants. For example, speciated versions of criteria pollutants are not provided in the MOVES2014 output nor are speciated emission factors for brake and tire wear.

6. Create final emission rate lookup tables in SMOKE format

The four postprocessed tables named rateperdistance_smoke, ratepervehicle_smoke, rateperprofile_smoke, and rateperhour_smoke are exported from MySQL into ASCII files for their use in SMOKE.

3.2.4.2.2. Processing Order

Moves2smkEF.pl is run after **Runspec_generator.pl**, and before any SMOKE processing. The **Moves2smkEF.pl** is written in Perl, generates SMOKE-ready MOVES lookup tables (i.e., RPD, RPV, RPP, and RPH) by each representative county and fuel month for inputs to **Movesmrg**.

3.2.4.3.1. Description

The **gen_8digit_scc.pl** script generates a file mapping 8-digits SCCs to aggregated SCCs produced by **Moves2smkEF.pl**.

3.2.4.3.2. Processing Order

The Perl script performs the following steps:

- Connect to the first database listed in the InputDBList file
- Query the specified database table (rateperdistance, ratepervehicle, rateperprofile, or rateperhour) and generate a list of all SCCs in the MOVES2014 output
- Apply the fuel type, source type, road type, and process type mappings to generate a list of 10-digit aggregated SCCs
- Output the list of 10-digit aggregated SCCs with corresponding 8-digit SCC (first 8 digits of 10-digit SCC)

3.3. SMOKE Utility Programs

3.3.1. Overview

There are thirteen programs covered in this section:

Aggwndw is a utility program that can aggregate or window emissions from an I/O API file to a new grid.

CEMScan program calculates summed annual NO_x emissions, SO₂ emissions, heat input, gross load, and steam load from a year's worth of CEM data. The output from **CEMScan** is used by **Smkinven** to calculate hourly emissions from annual inventory data when processing CEM data.

Gentpro allows the user to use county average meteorology data to estimate temporal profiles of emissions.

Geofac adjusts SMOKE hourly, gridded, speciated emissions in based on a specified geographic region

Invsplit splits an ORL inventory into separate inventories by state, grouping the states as indicated by your inputs.

Inlineto2D merge CMAQ Inline 2D emissions with stack group emissions.

Layalloc vertically redistributes hourly, gridded, speciated pre-gridded emissions from emission sources that could emit above the surface layer (e.g. Energy and Industrial sources) based on an user-defined layer fraction input.

Metcombine combines 2-D gridded meteorology data with the 1st layer of 3-D gridded meteorology data to create input files for **Met4moves**.

Metscan reads up to one year's worth of first-layer I/O API meteorology data (whether 2-D or 3-D files) and determine the first and last freeze dates of the year, for use by **Tmpbeis3** in setting winter/summer emission factors by day and grid cell.

Pktreduc reduces the size of /PROJECTION/ packets, but keeps the same information by identifying and implementing state defaults where none already exist in the file.

SAregroup allows users to regroup existing source apportionment-ready sector-specific group ID into new SA-ready group ID.

Smk2emis converts SMOKE netCDF files into a UAM- or CAM_x-ready emissions file.

Surgtool inputs SMOKE-formatted gridding surrogates for a “fine” input grid and outputs a surrogate file for a “coarse” output grid. It produces approximate “coarse” grid surrogates, the accuracy of which depends on how fine the resolution of the input grid is relative to that of the output grid.

Uam2ncf converts UAM-ready emissions files into I/O API format.

3.3.2. Aggwndw

3.3.2.1. Description

Aggwndw aggregates and/or windows emissions from an I/O API file to a new grid. The program does not change grid projections or interpolate data; the grid boundaries of the input and output grids must be aligned and the output grid must be entirely contained within the input grid. **Aggwndw** automatically checks that the input and output emissions do not differ by more than 0.01% and also produces a report file containing summed input and output data.

3.3.2.2. Processing Order

Aggwndw can be run on any gridded I/O API file. Usually it would be used to create coarse-grid or windowed emissions from fine-grid model-ready output files created by **Smkmerge** or **Mrggrid**.

3.3.3. CEMScan

3.3.3.1. Description

CEMScan reads a year's worth of CEM data and calculates summed annual NO_x emissions, SO₂ emissions, heat input, gross load, and steam load for each unique ORIS/boiler combination in the output CEM data. While writing the output, **CEMScan** will skip any ORIS/boiler combinations where the total annual NO_x emissions are zero or null or where the total annual gross load, steam load, and heat input are zero or null. The program will write these ORIS/boiler combinations to the report file along with a flag indicating that the combination was not written to the output file. The output from **CEMScan** is used by **Smkinven** to calculate hourly emissions from annual inventory data when reading CEM data. Detail information is described in Section 2.8.19, "Processing hour-specific CEM data" [56].

3.3.3.2. Processing Order

CEMScan should be run before **Smkinven** when processing CEM data.

3.3.4. Gentpro

3.3.4.1. Description

The **Gentpro** program estimates emissions temporal profiles for residential wood combustion (RWC), agricultural ammonia (RC_NH3), livestock ammonia (BASH_NH3) or generic area sources by relating meteorology to air emission fluxes. **Gentpro** reads in hourly gridded meteorology data from the Meteorology-Chemistry Interface Processor (MCIP) and a gridded spatial surrogate (commonly used in SMOKE) to produce temporal profiles and cross-reference data in a comma separated value (CSV) format and/or a temporal data binary netCDF file. Annual MCIP input data are required to calculate temporal profiles with **Gentpro**. Spatial surrogate(s) are used to identify the grid cells for computing county averaged meteorology variables.

Gentpro provides an option to specify a profile method [PROFILE_METHOD], which can be set to generate RWC, BASH_NH3, RC_HNH3, or generic meteorology-based temporal profiles. The RWC, BASH_NH3 and RC_NH3 temporal profiles are based on algorithms described by Adelman (2009 and 2010), Mansell et al. (2000), and Bash et al. (2012) respectively, while the MET profiles can be generated from any user-selected meteorology variable. The RWC profile method produces county-specific daily temporal profiles to convert annual or monthly inventories to daily emissions estimates. Diurnal profiles must then be applied to estimate hourly RWC emissions from the daily estimates. **Gentpro** provides the option to aggregate the daily RWC profiles to month-of-year profiles as well, which can be used to compute monthly inventory estimates from annual inventory data. The BASH_NH3 and RC_NH3 profile methods produce county-specific hourly temporal profiles to convert annual, monthly, or daily inventories to hourly emissions estimates. **Gentpro** provides the option to aggregate the hourly profiles to day-of-year or month-of-year profiles as well. The MET profile method represents time series of a selected meteorology variable as a temporal profile and can be used to convert annual, monthly, or daily inventories to hourly emissions estimates. **Gentpro** also provides the option to aggregate the hourly MET profiles to day-of-year or month-of-year profiles. All of the **Gentpro** profile options create temporal cross-reference files that associate county FIPS codes in a modeling domain to the new profiles.

[1] RWC

A regression equation relating observed daily minimum temperatures and chemical tracers of wood combustion was developed using data from sites in the Pacific Northwest of the United States (Adelman, 2009; Adelman, 2010). The sites selected to develop the algorithm were screened to be representative of RWC activities. Equation (1) uses estimates of daily PM2.5 emissions to build either annual-to-daily or annual-to-monthly emission profiles for application to RWC sources. The algorithm uses county average daily or monthly minimum temperatures to estimate the percentage of RWC emissions allocated to each day or month of the year. **Gentpro** includes a temperature threshold setting to limit RWC emissions from allocated to days too warm to have much (if any) RWC emissions. A temperature threshold (T_t) variable is implemented in **Gentpro** to allow users to set a maximum temperature cutoff by either state or county. By default, **Gentpro** estimates RWC emissions at temperatures below 50°F. If the temperature threshold variable is set in the **Gentpro** script, RWC emissions will be activated below T_t . A look-up table of state/county FIPS codes and temperatures (°F) can be input to **Gentpro** to set several different temperature thresholds across a modeling domain. The purpose of using the temperature threshold override is to control when RWC emissions are activated in regions where the 50°F cutoff may not be appropriate. For example, counties in southern Florida may only experience one or two days in an entire year when the minimum temperature dips below 50°F. Without using the threshold override, all of the RWC emissions for these counties will be allocated to these one or two days, producing large emissions spikes that may not be realistic. By increasing the temperature threshold, these spikes can be avoided by activating the RWC algorithm on other days. The outputs from this algorithm are temporal profiles that convert annual or monthly RWC inventories to daily emissions for every county in the modeling domain.

Two alternative RWC temporal profile algorithms are implemented in **Gentpro**. Equation 1 below shows the algorithm developed from the Pacific Northwest Sites described by Adelman (2009; 2010).

The second RWC temporal algorithm is an ad hoc approximation of the original equation that broadens its application by removing the intercept term. By removing the intercept term, Equation 2 below will not produce negative emissions when the temperature threshold is increased above 53.3°F.

The alternate RWC algorithms can be selected using RWC_ALT_EQ_YN listed below. When RWC_ALT_EQ_YN = N, Equation 1 will be used to calculate RWC temporal profiles.

1. **Original RWC Algorithm developed by Adelman (2009;2010)**

When $T_{i,d}$ is equal or less than 50°F,

[2] NH3

Two NH3 profile methods are implemented in **Gentpro** to estimate hourly temporal allocation factors, which are output as temporal profiles to convert annual, monthly, or daily livestock ammonia inventories to hourly emissions for every county in the modeling domain. **Gentpro** can output hour-of-month and hour-of-year temporal profiles that can be input to the **Temporal**. The recommended application of the BASH_NH3 and RC_NH3 profile methods are to convert monthly agricultural ammonia inventories to hourly emissions.

1. RC_NH3 profile method: Russell and Cass (1986) developed a theoretical equation based on investigations of NH3 emissions from animal waste decomposition conducted by Muck and Steenhuis

(1982) to predict diurnal NH₃ emission variations as a function of daily meteorology. The Russell and Cass equation (a.k.a RC_METHOD) listed below is adapted for this application to use county average meteorology and implemented in **Gentpro** to estimate hourly emissions from county annual, monthly, or daily agricultural livestock NH₃ inventories.

$$E_{i,h} = [2.36^{(T_{i,h}-273)/10}] \times V_{i,h}$$

2. BASH_NH₃ profile method: Zhu, Henze, et al. (2013) developed an empirical equation based on observations from the TES instrument with the GEOS-Chem model and its adjoint to estimate diurnal NH₃ emission variations from livestock as a function of ambient temperature and aerodynamic resistance meteorological variable. The equation is listed below.

$$E_{i,h} = [161500/T_{i,h} \times e^{(-1380/T_{i,h})}] \times AR_{i,h}$$

- $PE_{i,h} = E_{i,h} / \text{Sum}(E_{i,h})$

[3] MET: Generic Meteorology Profile Algorithm

This is a simple algorithm that computes the percentage of emissions to allocate to each hour based on the hourly fractional contribution of a selected meteorology variable relative to the annual, monthly, and daily sum of all hourly values for that variable. While the fractional contribution of county-average wind speed for each hour of the year is somewhat meaningless, it does provide a way to build a time series that can be applied to an annual/monthly inventory to estimate hourly values using monthly, daily and/or hourly MET profiles.

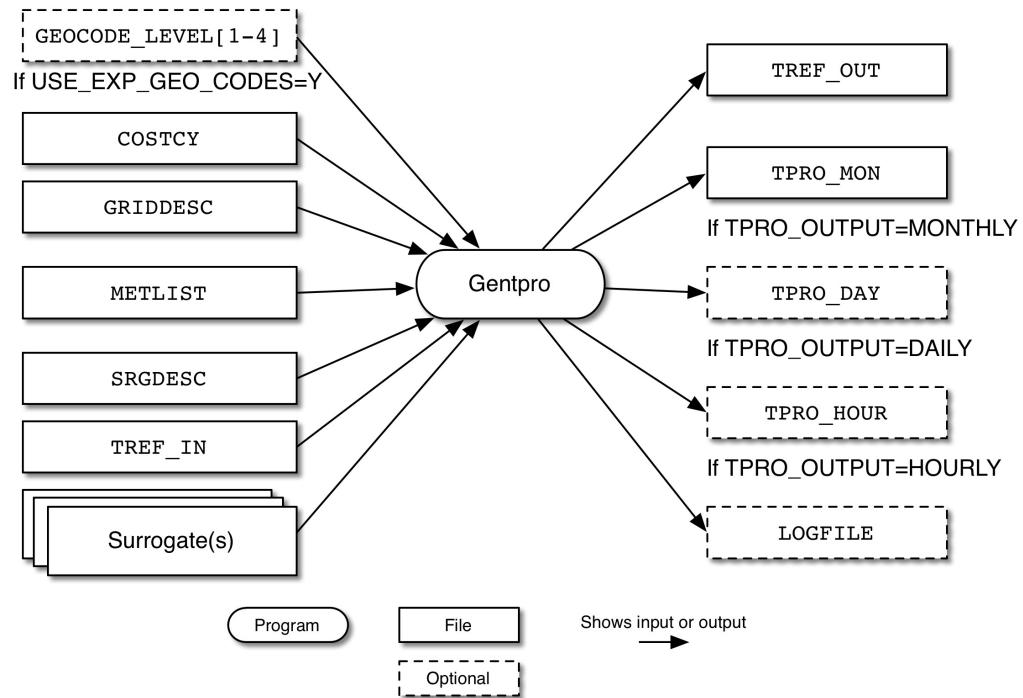

3.3.5. Geofac

3.3.5.1. Description

The **Geofac** program provides a means for adjusting emissions by grid cell after **SMOKE** has already created model-ready inputs. For example, the program could be used to zero emissions from all grid cells that intersect a certain state, which would be a rough approximation of removing that state's inventory from the model-ready files. Although it is more accurate to modify the emissions using the **Cntlmat** program, that approach takes longer and is possible only if the **SMOKE** input files used to create the model ready emissions are still available. **Geofac** is useful in situations where speed and simplicity are more important than the accuracy of the emissions, or when only the gridded model-ready inputs are available and the inventories used to create them are not.

Geofac reads in a gridded 2-D or 3-D **SMOKE** emissions file (output from the **Smkmerge** program) and multiplies the emissions with a user-supplied adjustment factor for each individual species in the emissions file. The factors are assigned by grid-cell regions, which are defined by the input "mask" file. Each grid cell either receives the factors or it does not (the mask is simply an on-off switch). The resulting hourly, gridded, speciated emissions data are output to a new I/O API file with the same spatial and temporal resolution and the same model species with different values.

3.3.7. Invsplit

The **Invsplit** program splits an ORL inventory file into multiple raw inventory files, based on the state codes. The number of output files is set at run time based on the input file that defines the splitting. Up to 80 new files can be created from a single inventory file, which is more than enough files to split a U.S. inventory into a separate file for each state. The program works on area, on-road mobile, nonroad mobile, and point inventories. Separating a single inventory file into multiple files allows the inventory data to be recombined with other data more easily.

3.3.8. Layalloc

3.3.8.1. Description

The **Layalloc** program calculates 3-D emissions from a 2-D pre-gridded emissions file. **Layalloc** is used to reallocate single layer 2-D surface layer emissions into multiple model layers. This approach is useful for processing pre-gridded or industrial area source inventories that do not contain stack information for plume rise treatment but represent elevated sources.

Layalloc reads in a gridded 2-D pre-gridded emissions file (either output from the **Smkmerge** program or from a pregridded global emission inventory (EDGAR/RCP/HTAP)) and redistributes the emissions into multiple model layers based on a user-defined vertical profile. The vertical profiles that are input to **Layalloc** consist of a layer bottom height, layer top height, and the fraction of emissions to allocate to the layer. SMOKE will interpolate from the layer heights (in meters) to the model layers (in sigma-pressure). This approach assumes that the vertical factors are uniformly applied over all horizontal grid cells. The resulting hourly, gridded, speciated 3-D emissions data are output to a new I/O API file with the same temporal resolution and the same model species as the original 2-D emissions file.

This optional program can be run after **Smkmerge** and before either **Mrggrid** (if it is being used to merge several **Smkmerge** output files together) or the AQM of interest.

3.3.9. Metcombine

3.3.9.1. Description

Metcombine combines 2-D gridded meteorology data with the 1st layer of 3-D gridded meteorology data to create custom files for on-road mobile processing with MOVES. To calculate humidity data for use in MOVES, the program **Met4moves** needs temperature, pressure, and water vapor mixing ratio data in the same meteorology file. Pressure and mixing ratio data are typically found in the MET_CRO_3D file with the variable names PRES and QV, respectively. The MET_CRO_2D file usually contains ground-level temperatures (TEMPG), 1.5 meter temperatures (TEMP1P5), 2 meter temperatures (TEMP2), and 10 meter temperatures (TEMP10). While it is possible to use air temperature data from the MET_CRO_3D file (variable named TA), it is generally recommended to use temperature data from closer to the ground, i.e. ground or 1.5 meter temperatures from MET_CRO_2D. **Metcombine** is used to create custom meteorology files that contain the variables PRES, QV, and TEMPG (or any other temperature variable).

The program takes two I/O API NetCDF gridded meteorology files as input. The files must have identical grid parameters, start dates and times, time steps, and run lengths. **Metcombine** is generally used to combine a 2-D file with a 3-D file, but the program is not restricted to that combination; it can be used to combine two 2-D files or the 1st layers of two 3-D files.

3.3.9.2. Processing Order

Metcombine can optionally be run before **Met4moves**. If used, **Metcombine** must be run for each individual meteorology file you need to create. For example, if you have five days worth of meteorology data as one-day files, you'll need to run **Metcombine** five times. If the meteorology variables you wish to use are already in the same file, then you do not need to use **Metcombine**. Example: If you decide to use ambient air temperature (TA) from the same METCRO_3D file that also contains PRES and QV, then you do not need to run Metcombine.

3.3.10. Metscan

3.3.10.1. Description

Metscan reads in a single (often annual) temperature I/O API meteorology data file (created from either the MET_CRO_2D or MET_CRO_3D files) and determines the first freeze date and last freeze date of a year, by grid cell. It outputs a gridded file with a daily (24-hour) time step that contains a single variable. For each grid cell, that variable has a value of 0 (zero) when the date being modeled indicates that the cell is experiencing winter conditions; otherwise it has a value of 1, indicating summer conditions. The program can be set to run in the Northern Hemisphere or in the Southern Hemisphere (it will not work on global meteorology datasets). In the Northern Hemisphere, the first freeze date in the fall marks the start of winter,

and the last freeze date in the spring marks the end of winter; all other days are considered summer days. The seasons are reversed in the Southern Hemisphere, and the program accommodates this accordingly.

The BEIS3 model operates using the assumption of either winter or summer emission factors. There are no spring or fall factors available, which is why this program is limited to the choice of summer or winter. The use of the freeze date to determine summer or winter emission factors is based on EPA's recommendation.

The program reads in the name of the temperature variable as an option, so that the ground temperature, 1.5-meter temperature, or 10-meter temperature can be used from the MET_CRO_2D file, or the layer-1 temperature can be used from the MET_CRO_3D file. See the TMPR_VAR option below for more information on the names of the temperature variables that are acceptable.

3.3.10.2. Processing Order

Metscan can optionally be used before **Tmpbeis3**, which does not require the output from **Metscan** to run. **Metscan** is needed only when users wish to have **Tmpbeis3** automatically switch between winter and summer emission factors by grid cell. This approach is recommended when processing time periods and modeling domains include temperatures below 32 °F either for a substantial number of days relative to the number of episode days or at critical dates in the episode.

3.3.11. Pktreduc

3.3.11.1. Description

The **Pktreduc** program reduces the size of growth packets (using the /PROJECTION/ packet in the GCNTL file), but keeps the same information. This is done by identifying and implementing state defaults where possible. This program works solely with growth packets that have state/county and SCC entries only; it will not work if the packet contains SIC, MACT, or pollutant codes.

The program identifies the most common growth factor for each state across the many counties for each SCC, and this factor is assigned as the default for the state/SCC combinations. The county/SCC-specific entries are left as is. In this way, the contents of the file are the same as far as SMOKE is concerned, but the file processes through **Cntlmat** much faster because the growth packet is much smaller. It is acceptable if state defaults are already in the file, and **Pktreduc** will leave these untouched. When state defaults are found for a state (i.e., county code is set to 000), the program skips reductions for that state and no changes are made (even if they could be).

The **Pktreduc** program is an optional preprocessor for the GCNTL input file to **Cntlmat** when processing growth packets.

The SMOKE user is responsible for preparing the I/O API inputs with the appropriate chemical species, grid structures, time steps, and units for use in whatever model will be using the results of **Smk2emis**.

The **Surgtool** program inputs SMOKE-formatted gridding surrogates for a “fine” input grid and a grid definition for a “coarse” output grid. The program requires that the input and output grids use a lat-lon, Lambert Conformal, or UTM map projection. **Surgtool** can also perform Lambert-to-Lambert and UTM zone-to-zone transformations. In addition, the program requires that the input grid resolution be much finer than the output grid resolution (at least three times finer is recommended, though no specific limitation is given by the code). **Surgtool** supports SMOKE-formatted surrogate coefficient files only.

This program is useful for converting area, nonroad mobile, on-road mobile, and biogenic UAM-ready files to the I/O API format needed for CMAQ. **Uam2ncf** can also be used with low-level point sources, but not with the elevated-point-source inputs for UAM and CAM_x.

If you wish to create CMAQ inputs from model-ready emissions for UAM or CAM_x, you must take the following steps:

1. Use **Uam2ncf** to convert individual source categories for area, biogenic, and mobile sources to I/O API format.
2. Run SMOKE for point-source inventory to create 3-D I/O API file.
3. Run **Mrgrid** to combine converted inventory for nonpoint sources with SMOKE-created inventory for point sources.

3.3.15.2. Processing Order

Because this optional program operates on model-ready files, it is run before the CMAQ air quality model.

3.3.15.3. Files and Environment Variables

3.3.15.3.1. Input Files

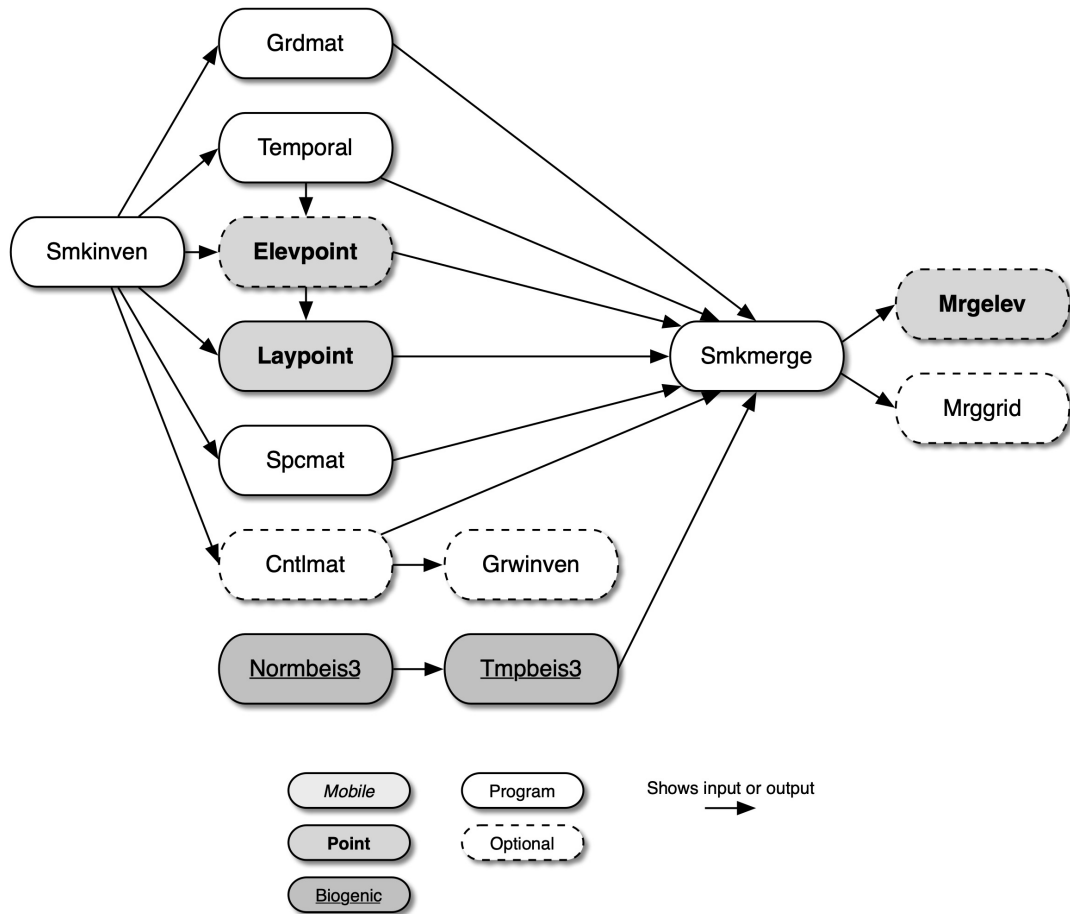

4.1. Overview

Figure 4.1, “SMOKE core programs” [128] shows the SMOKE core programs and how they relate to each other. We define the core programs as those needed for the actual emissions processing; we exclude QA and utility programs such as **Smkreport** (these programs are discussed in Chapter 5, *SMOKE Quality Assurance* [229] and Chapter 3, *SMOKE Utility Tools* [91]). The lines between the boxes represent one or more files passing between the programs, and show the dependencies among the programs. Note that we have omitted some redundant file dependencies to make the diagram easier to understand. Unless otherwise noted, the SMOKE core programs are applied for the anthropogenic source categories: area-, mobile-, and point-source processing (biogenic processing follows a separate path from the other source categories). When a program that applies to multiple source categories is used, it can be run for only one source category at a time, with the exception of **Smkmerge** and **Mrggrid**.

Figure 4.1. SMOKE core programs



The **Smkinven** program, at left in Figure 4.1, “SMOKE core programs” [128], is responsible for importing the stationary area/non-point, nonroad, on-road mobile, and point source inventory emissions data. For mobile sources, **Smkinven** can also import activity data in the form of VMT and vehicle speed for use in generating emission factors. For point sources, **Smkinven** can also import day- and hour-specific data. The output from **Smkinven** is used as input to nearly every other core SMOKE program.

Also at left, the **Normbeis3** or **Normbeis4** program imports the gridded land use data and biogenic emissions factors, and creates gridded, normalized (time-independent) biogenic emissions.

Grdmat creates the gridding matrix for the anthropogenic source categories.

Temporal program is used to create an hourly emissions file for the anthropogenic source categories. It can read in day-specific and hour-specific data, and merge this with estimated daily and hourly data created from the annual emissions data using temporal profiles.

Elevpoint preprocesses the selected PinG and major point sources. **Elevpoint** is not used when no PinG or major point sources need to be defined. In this case, SMOKE can create elevated emissions for all point sources, so there is no need to specifically indicate the major point sources.

Laypoint computes the plume rise for all point sources based on the meteorology data.

Spcmat creates the speciation matrices (both mass and molar) for the anthropogenic source categories. It uses the user-selected chemical mechanism.

Cntlmat creates the growth matrices, multiplicative control matrices, and reactivity control matrices for the anthropogenic source categories. This program is not used for base-year emissions without controls.

Grwinven is used to grow the emissions to past or future years using the growth matrix created by **Cntlmat** and the imported inventory data from **Smkinven**. It writes both SMOKE inventory format (I/O API NetCDF) and ORL format. The output from **Grwinven** is used in place of the original output from **Smkinven** when processing past or future years.

Tmpbeis3 or **Tmpbeis4** applies meteorology adjustments to the normalized emissions created by **Normbeis3** or **Normbeis4**. **Tmpbeis3** or **Tmpbeis4** also applies the speciation profiles needed for the user-selected chemical mechanism to create gridded, hourly, model-species biogenic emissions data for use in **Smkmerge** and **Mrggrid**. The **Normbeis3** and **Tmpbeis3** programs taken together are the equivalent of SMOKE-BEIS3, and **Normbeis4** and **Tmpbeis4** are SMOKE-BEIS4.

Smkmerge is used to combine all emissions and matrices to create the gridded, hourly, model-species emissions needed for an AQM. It can merge for one source category at a time or all source categories at once, and it can read in the model-ready biogenic emissions to merge with the anthropogenic source categories. It can merge the matrices with the inventory data output from **Smkinven** or the hourly emissions from **Temporal**, and it can optionally merge the speciation, gridding, or control matrices, or any combination. It also writes state and county emissions totals.

Movesmrg is only used for mobile sources to compute hourly emissions using the hourly VMT from **Temporal**, the MOVES emission rates lookup tables (i.e., RPD, RPH, RPV, RPP, RPS and RPHO), the gridded/averaged temperatures meteorology data and more. If VMT are not used, then the emissions from **Smkinven** are combined with the temporal factors, and the emission factors are not used at all.

In the remaining sections of this chapter, we provide detailed program descriptions, in alphabetic order.

Mргеlev is used to combine ASCII elevated files created by **Smkmerge**. These files contain point-source data needed by AQMs including CAMx and UAM models.

Mrggrid is used to combine gridded emission data files, which can be speciated or non-speciated, and hourly or time-independent. It can combine a 3-D point source file with any number of 2-D files from other source categories. This program is optional and provides a convenient way to merge model-ready output files outside of **Smkmerge**.

Mrgpt is used to combine multiple point sources inline-mode hourly speciated emission data and ASCII elevated files created by **Smkmerge**. This program is optional and allows the users to process multiple point sources separately in inline mode through **Smkmerge** prior to merging them for CMAQ model.

4.2. Cntlmat

4.2.1. Description

Processing categories: area, mobile, point

The **Cntlmat** program uses control packets to create a growth matrix, and/or a multiplicative control matrix, and/or a reactivity control matrix. **Cntlmat** allows seven different control packet types: /MACT/, /CONTROL/, /EMS_CONTROL/, /CTG/, /ALLOWABLE/, /REACTIVITY/, and /PROJECTION/. The format of each packet type is given in Section 6.6.1, “GCNTL: Files for controls and/or past- and future-year growth” [311].

- Growth matrix - This contains past- or future-year growth factors for all sources.
- Multiplicative control matrix - This matrix contains the combination of various types of controls typically used in emissions processing: CTG, MACT, RACT, control efficiency, rule effectiveness, rule penetration, allowable emissions, and caps. The logic used when applying this matrix is described below this bulleted list.
- Reactivity matrix - This matrix contains the information needed for applying reactivity controls.

4.2.1.1. Application Logic for the Multiplicative Control Matrix

The multiplicative matrix is built from entries in four packets: /MACT/, /CONTROL/ or /EMS_CONTROL/, /CTG/, and /ALLOWABLE/. The packets are applied in the following order:

- /MACT/
- /CONTROL/ or /EMS_CONTROL/ (cannot use both at same time)
- /CTG/
- /ALLOWABLE/

With the exception of the /CONTROL/ packet, all controls are always applied in addition to one another.

4.2.1.1.1. /MACT/ packet

The /MACT/ packet is designed to support the primary MACT controls needed for toxics processing. It is applied first, and uses the following logic. When a source is found that matches a /MACT/ packet entry (source matching is addressed in Section 4.2.1.2, “Source Matching Hierarchy” [132]), **Cntlmat** first calculates a inventory efficiency value (Eff_{inv}) for that source based on the control efficiency (C_{eff}), rule effectiveness (R_{eff}), and rule penetration (R_{pen}) provided in the inventory:

$$Eff_{inv} = C_{eff} [inventory] \times R_{eff} [inventory] \times R_{pen} [inventory]$$

Next, a control factor is calculated for existing sources (Fac_{exist}) using the control efficiency of existing sources (Eff_{exist}) and fraction of new sources ($Frac_{new}$) provided in the /MACT/ packet entry. If $Eff_{exist} > Eff_{inv}$, then Fac_{exist} is calculated as:

$$Fac_{exist} = (1 - Frac_{new}) \times ((1 - Eff_{exist}) / (1 - Eff_{inv}))$$

Otherwise,

$$Fac_{exist} = (1 - Frac_{new})$$

Cntlmat then calculates a control factor for new sources (Fac_{new}) using the control efficiency of new sources (Eff_{new}) provided in the /MACT/ packet. If $Eff_{new} > Eff_{inv}$, then

$$Fac_{new} = Frac_{new} \times ((1 - Eff_{new}) / (1 - Eff_{inv}))$$

Otherwise,

$$Fac_{new} = Frac_{new}$$

Finally, the new and existing source factors are summed to compute the final /MACT/ packet control factor (Fac_{MACT}).

$$Fac_{MACT} = Fac_{exist} + Fac_{new}$$

The /MACT/ packet is designed to be used only for sources with MACT codes, currently nonpoint and point toxic sources.

4.2.1.1.2. /CONTROL/ packet

After processing the /MACT/ packet, the /CONTROL/ packet is applied using the following logic. Each entry in the /CONTROL/ packet can be identified as “replacement” or “additive”. If set to “replace”, the /CONTROL/ entry will be used to replace the controls from the /MACT/ packet or the base-year inventory controls; otherwise, the control will be applied in addition to the controls from the /MACT/ packet or the base-year inventory controls. When the controls are replaced, the default behaviour of **Cntlmat** is to back out the existing controls and apply the replacement controls. Usually, users want to do this only when the replacement controls are more stringent (i.e., a greater reduction) than the /MACT/ packet or base-year controls - so this is the default behaviour of **Cntlmat**. This default behaviour can be changed by setting the value of COMPARE_REPLACE_CONTROL to "N" in your run script. In this case, the replacement controls will be applied regardless of the existing controls from the base inventory or the /MACT/ packet, which could result in increased emissions.

When an “additive” entry is matched to a source, the /CONTROL/ packet factor ($Fac_{CONTROL}$) the control packet information is applied in addition to the existing controls, which further reduce the remaining emissions.

For “additive” control packet entries, the control factors are calculated from the control efficiency, rule effectiveness, and rule penetration values provided in the /CONTROL/ packet entry as follows:

$$Fac_{CONTROL} = (1 - C_{eff} [packet] \times R_{eff} [packet] \times R_{pen} [packet])$$

A cumulative control factor Fac_{result} is then calculated by multiplying $Fac_{Existing} \times Fac_{CONTROL}$.

In the case of “additive” controls only, The overall reduction factor is then used to calculate an overall new control efficiency to be put in any resulting inventory files as: $C_{eff} [result] = 1 - Fac_{result}$. The final Rule Penetration and Rule Effectiveness values are then set to 100%.

For “replacement” entries, **Cntlmat** first “backs out” the existing controls provided in the inventory from the control values provided in the /CONTROL/ packet entry as follows:

$$D = (1 - C_{eff} [inventory] \times R_{eff} [inventory] \times R_{pen} [inventory])$$

If $D = 0.0$, then the backout value, B, is equal to 0; otherwise, $B = 1/D$. Using this backout value, the /CONTROL/ factor is calculated as

$$Fac_{CONTROL} = B \times (1 - C_{eff} [packet] \times R_{eff} [packet] \times R_{pen} [packet])$$

Unlike “additive” entries, the $Fac_{CONTROL}$ value for “replacement” entries replaces the factor calculated from the /MACT/ packet or base year inventory (if any). The /CONTROL/ packet can be applied to stationary area/nonpoint, nonroad, on-road mobile, and point sources. On-road mobile source inventories do not include control efficiency, rule effectiveness, or rule penetration fields. However, the /CONTROL/ packet can still be used to apply adjustment factors to mobile sources. In this case, B in the above formula will be 1 when computing factor $Fac_{CONTROL}$ that is applied to the emissions.

4.2.1.1.3. /CTG/ packet

The /CTG/ packet is processed next, as follows. The emission value (after application of /MACT/, /CONTROL/, and/or /EMS CONTROL/) is compared to the cutoff value specified as part of the /CTG/ packet record. If the emission value exceeds the cutoff value, then the control technology factor is applied to the emissions. If the resulting emissions value still exceeds the cutoff value, then either the MACT or the

RACT factor is used. The MACT factor is used if it is defined (i.e., greater than zero); if it is not defined (less than or equal to zero), then the RACT factor is used. If neither the MACT nor RACT are defined, but the emissions are still greater than the cutoff, then the emissions are set to the cutoff value.

4.2.1.1.4. /ALLOWABLE/ packet

Finally, the /ALLOWABLE/ packet is processed. The entries in this packet override the /MACT/, /CONTROL/, /EMS CONTROL/, and /CTG/ packets. The way this packet is applied depends on whether or not the Cap and Replace values in the packet are defined (greater than zero).

- If the Cap value is defined, **Cntlmat** compares the inventory emissions value to the Cap value, and sets a control factor, using the following procedure: If both the Cap and Replace values are defined, this control factor is the Replace value divided by the original emissions value. If only the Cap value is defined, the factor is the Cap value divided by the original emissions value.
- If the Cap value is not defined, then the factor is the Replace value divided by the original emissions value.
- If neither the Cap nor Replace values are defined, the packet entry is invalid and is ignored.

4.2.1.2. Source Matching Hierarchy

To match each sources with the appropriate control packet entry, **Cntlmat** uses a hierarchy of source characteristics, trying to match each source to the most specific control packet entry. Note that not all combinations are applicable to all control packets (for example, there is no MACT code associated with the /PROJECTION/ packet). “Left x of SCC” refers to an 8- or 10-digit SCC with all digits except the first x set to 0. “Left 2 of SIC code” refers to a 4-digit SIC code with the third and fourth digits set to 0. The maximum field width in SMOKE and its input files for SCC is 20 characters as of SMOKE v4.0. The 8 or 10 digit SCC are still supported, but if the SCC is greater than 10 digits the SCC hierarchial approach will not be supported. The SIC may also be up to 20 characters in length, but if the SIC is larger than 4 characters then the hierarchial approach will not be used.

For point sources, the following hierarchy is used, in order of most specific to least specific. (NOTE: only for SCC less than or equal to 10 characters and SIC less than or equal to 4 characters)

4.2.2. Processing Order

Smkinven must be executed before **Cntlmat**.

Cntlmat must be executed before **Smkmerge**. **Cntlmat** also needs to be run prior to the **Grwinven** program, which requires at least one growth or control matrix to be run.

Cntlmat is an optional program that needs to be run only when controlled emissions are needed for the AQM.

Figure 4.2. Cntlmat input and output files

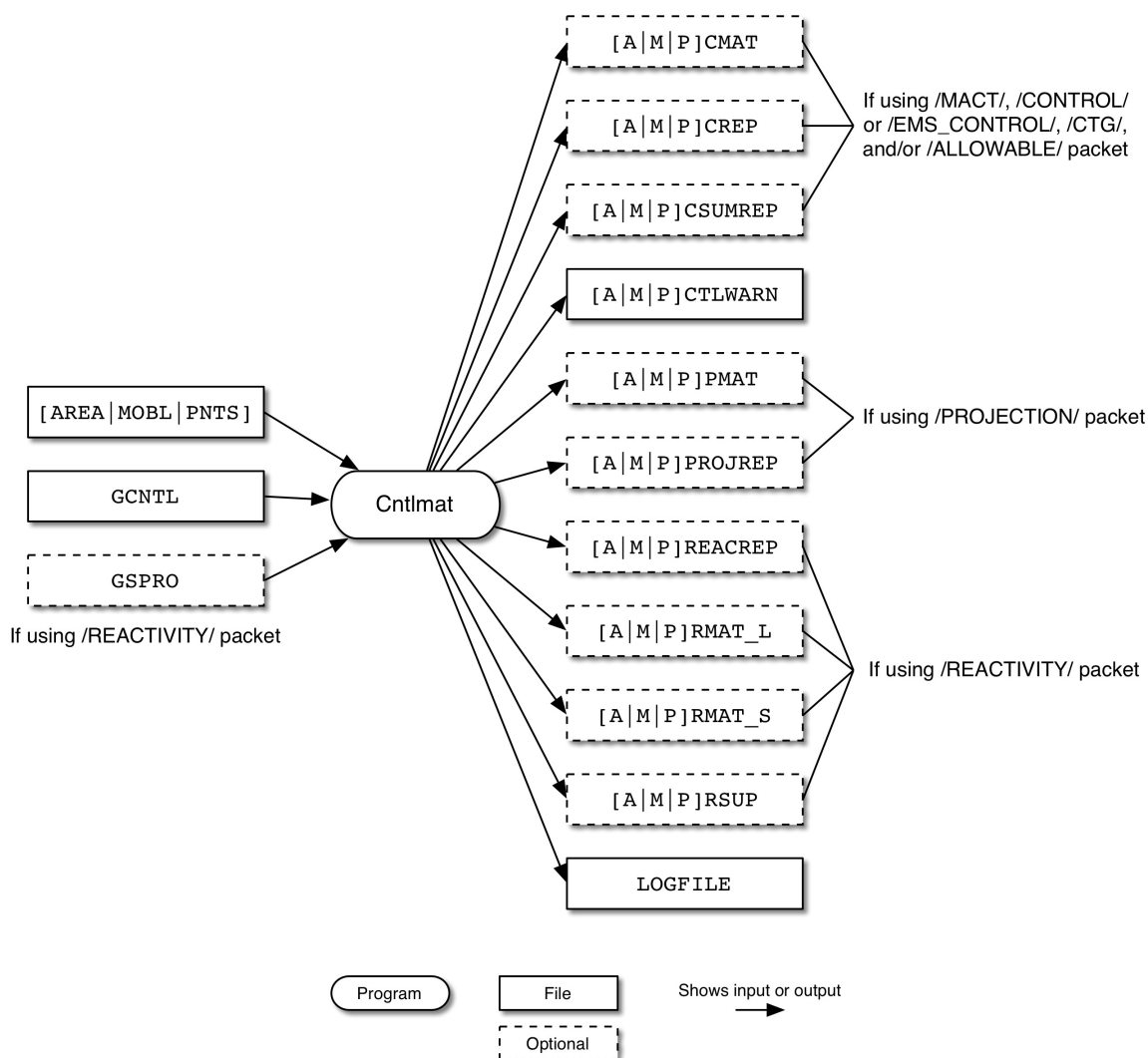


Figure 4.2, “**Cntlmat** input and output files” [136] shows the input and output files for the **Cntlmat** program. The input files are the inventory file output from **Smkinven** (either AREA, MOBL, or PNTS), the control packets file (GCNTL), and the speciation profiles file (GSPRO) if there are reactivity controls (using the /REACTIVITY/ packet).

If the GCNTL file contains /MACT/, /CONTROL/ or /EMS_CONTROL/, /CTG/, and/or /ALLOWABLE/ packets, **Cntlmat** outputs a multiplicative control matrix file (ACMAT, MCMAT, or PCMAT), a report of multiplicative controls (ACREP, MCREP, or PCREP), and a report of all multiplicative controls applied to the inventory (ACSUMREP, MCSUMREP, or PCSUMREP). **Cntlmat** also outputs a warning file (ACTLWARN, MCTLWARN, or PCTLWARN) regardless of which packets are used.

If the GCNTL file contains a /PROJECTION/ packet, **Cntlmat** outputs a growth matrix file (APMAT, MPMAT, or PPMAT) and a growth report (APROJREP, MPROJREP, or PPROJREP).

If the GCNTL file contains a /REACTIVITY/ packet, **Cntlmat** outputs mole and mass-based reactivity matrix files (either ARMAT_L and ARMAT_S, MRMAT_L and MRMAT_S, or PRMAT_L and PRMAT_S), a reactivity matrix supplement file (ARSUP, MRSUP, or PRSUP), and a report of reactivity controls (AREACREP, MREACREP, or PREACREP). Finally, **Cntlmat** writes the LOGFILE detailing the program's execution.

The physical file name of the input file GCNTL file is typically overridden by the environment that is running **Cntlmat**. For example, when running SMOKE from scripts using the Assigns file, the projection factor inputs are available as the [A | M | P] PROJ files. So, for instance, the script must set GCNTL as APROJ (or area-source processing) after the Assigns file has been invoked by the script, but before the **Cntlmat** program is actually run.

4.2.3.2. Input Environment Variables

- COMPARE_REPLACE_CONTROL : [default: Y]

Controls the way a replacement control is applied.

- Y: When set to Y, Cntlmat compares the overall percent reductions ($CEFF * RPEN * REFF$) from a replacement control in the CONTROL packet against existing percent reductions (either from the base inventory or from a just-applied /MACT/ packet). If the packet's reduction is more control (greater reduction) than the existing controls, then it is applied. Otherwise, it is not applied.
- N: When set to N, Cntlmat applies replacement controls even if the control is less control than an existing control, which may result in an increase in emissions

- FULLSCC_ONLY : [default: N]

Disables any sub-SCC cross-reference assignments that would otherwise be included in the cross-reference hierarchy. For example, the left-7, left-4, and left-2 levels of nonpoint and mobile SCCs would never be used. This is useful when zeros are a natural part of the SCC that the user does not want to assume are present for cross-reference hierarchy purposes. This option affects all Cntlmat input packets that use SCC assignments as part of their hierarchy.

- PROJECTION_YR_SPEC : [default: Y]

Sets whether or not entries in the /PROJECTION/ packet are in year-specific format.

- Y: Year-specific format in use
- N: Year-specific format not in use

- **REACTIVITY_POL:** [default: VOC]
Sets the pollutant name to use in computing the reactivity matrix.
- **REPORT_DEFAULTS:** [default: Y]
Defines whether or not the program reports when a source uses the default cross-reference.

4.3. Elevpoint

4.3.1. Description

Processing categories: point

The **Elevpoint** program is used to select elevated point sources and to prepare certain input files for special elevated source or PinG processing. **Elevpoint** selects the major point source (MPS) and major elevated point source emissions (MEPSE) records using a variety of criteria, such as stack parameters, emissions, and analytical plume rise calculations. (Note that MEPSE is another name for a PinG source.)

Elevpoint distinguishes PinG sources from non-PinG elevated sources based on emission thresholds, highest day-specific emissions rank compared to other sources, analytical plume rise, and/or stack parameters such as height. **Elevpoint** flags sources as either elevated or PinG based on instructions given in an input configuration file, the PELVCONFIG file. **Elevpoint** also permits grouping of stacks at the same facility if the stack parameters are similar, within tolerances you specify with the PELVCONFIG file; the result is call a “stack group”. For more information on selecting and grouping elevated and PinG sources, refer to Section 6.9.3.1, “PELVCONFIG: Elevated source selection file” [357].

Elevpoint can also be used to calculate plume rise using the “cutoff” method. This is the method traditionally used to prepare input files to the air quality models UAM-IV, UAM-V and CAM_x, which require a separate

model-ready input file containing emissions for elevated point sources. Below, we refer to this path as the “UAM style” of emissions processing.

For the cutoff method, the **Elepoint** program uses the stack parameters of the point sources and estimates the plume rise for each source using a Briggs analytical solution (but not actual gridded meteorology data); the details of this process are given in Section 4.3.1.1, “Plume rise calculation” [140]. **Elepoint** then records all of the sources that have an estimated plume rise greater than a specified cutoff as defined in the PELVCONFIG file using the “RISE” instruction. Using the PELVCONFIG file, this cutoff method can be combined with selection of elevated sources based on stack parameters and/or emissions values.

When emissions values are part of these selection criteria, **Elepoint** computes the maximum daily emissions using one or more PTMP files. **Elepoint** computes the maximum daily value of any pollutant used as a selection criterion across all of the days that you input. You have the option of providing either a list of paths and file names of one or more PTMP files, or a single PTMP file. The day or days that **Elepoint** uses to compute each source’s maximum depends on the time zone in which the source resides, based on the county and the COSTCY file setting for the time zone (the time zone is stored in the PNTS file output from **Smkinven**). When using emissions values as a selection criterion, **Elepoint** only considers sources that are within the grid domain.

Elepoint also creates a report file that contains all SMOKE sources that have been selected as elevated, their source characteristics (including stack parameters), emissions values used as selection criteria, stack-group numbers, status as either elevated or PinG, and which selection criteria were used to assign the status to the source. The report does not include any low-level sources. This report is in semicolon-delimited format for easier reading into a spreadsheet for sorting, review, and making charts.

The **Elepoint** program is not needed if the environment variables SMK_PING_METHOD and SMK_ELEV_METHOD are both set to 0.

4.3.1.1. Plume rise calculation

The Briggs solution is documented in the following:

1. Briggs, Gary A., 1971: Some Recent Analyses of Plume Rise Observation, pp. 1029-1032 in *Proceedings of the Second International Clean Air Congress*, edited by H. M. Englund and W. T. Beery. Academic Press, New York.

The following formula is used in **Elepoint**:

$$F = 0.25 \times G \times V_S \times D_S^2 \times (T_S - T)/T_S$$

For F less than 55,

$$\text{Plume rise} = H_S + 21.31311057 \times F^{0.75}/U$$

Otherwise,

$$\text{Plume rise} = H_S + 38.87776061 \times F^{0.6}/U$$

where

- F = Bouyancy flux (m^4/s^3)
- G = Mean gravitational acceleration (9.80665 m/s^2)

- V_S = Stack gas exit velocity (m/s)
- D_S = Inside stack diameter (m)
- T_S = Stack gas temperature (K)
- T = Default ambient air temperature (293 K)
- U = Default wind speed (2 m/s)
- H_S = Physical stack height (m)

This represents an improved algorithm over the original so that the discontinuity at $F = 55$ no longer exists. Now, the second term in the plume rise formula approaches 595 as F approaches 55 from either side.

4.3.1.2. Summary

In summary, **Elevpoint** permits the following combinations of source selection and processing:

- Identify MEPSE/PinG sources for outputting to special PinG files only (all other point sources will be treated as potentially elevated by **Laypoint**).
- Identify elevated sources (MPSs) with the PELVCONFIG file, which might include using the cutoff method alone or in combination with other criteria.
- Identify elevated sources (MPSs) and MEPSE/PinG sources with the PELVCONFIG file with cutoff method (**Laypoint** not used) and identify MEPSE/PinG sources with the PSPLIT file for outputting to special PinG files.

4.3.2. Processing Order

Smkinven must be run for point sources before **Elevpoint**. If the PELVCONFIG file uses emissions as a source-grouping or source-selection criterion, then **Temporal** must be run before **Elevpoint**.

Elevpoint must be run before **Laypoint**.

Elevpoint must be run before **Smkmerge** if elevated sources are to be used.

Elevpoint is an optional program that is not needed if all of the following criteria are met:

1. A UAM-style model (e.g., UAM, CAM_X) is not being used.
2. No MEPSE/PinG source processing is required.
3. You are willing to run **Laypoint** for all point sources and treat all as “potentially elevated”. In this case, sources that rise above layer 1 will be “elevated” for reporting purposes in **Smkreport**, but these sources may sometimes be within layer 1 if the plume rise algorithm in **Laypoint** computes it that way.

Figure 4.3. Elevpoint input and output files

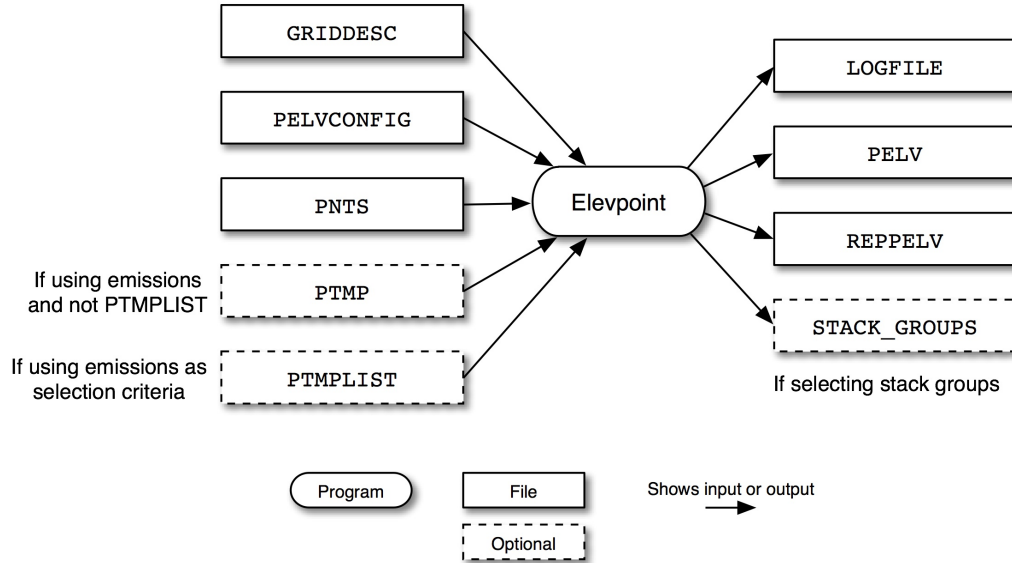


Figure 4.3, “**Elevpoint** input and output files” [142] shows the input and output files for the **Elevpoint** program. The input files are the grid description file (GRIDDESC), an elevated source configuration file (PELVCONFIG), the point-source inventory file output from **Smkinven** (PNTS), and, if the PELVCONFIG file selects sources by emissions value or rank, either a list of hourly emissions files output by **Temporal** (PTMPLIST) or an individual hourly emissions file (PTMP).

Elevpoint outputs a log file (LOGFILE), an elevated point source identification file (PELV), an elevated and PinG source report (REPPELV), and a stack parameters file (STACK_GROUPS) if the PELVCONFIG file is configured to select stack groups.

This environment variable can also be used to set custom spheroid representations. See the I/O API documentation [<http://www.baronams.com/products/ioapi/SETSPHERE.html>] for more information.

- `SMK_ELEV_METHOD`: [default: 0]

Defines the method to use in SMOKE for determining and processing elevated point sources. The setting chosen depends on the model output format needed from SMOKE. All PinG sources determined based on `SMK_PING_METHOD` will automatically be considered elevated sources (as defined specifically for the model for which you are creating emissions).

- 0: Treat all sources as potentially elevated, and let the **Laypoint** program determine which sources are elevated and which are not. This approach is appropriate only for SMOKE output for the CMAQ model.
- 1: Use the “Elevated” section of the `PELVCONFIG` configuration file to select specific sources. This approach can be used for any of the model output formats - CMAQ and UAM-style.

For UAM-style emissions processing, this environment variable must be set to 1 and the `PELVCONFIG` file will be used to select specific sources. This method of processing is needed for UAM and `CAMx` because they require use of the cutoff method discussed earlier. In rare cases of a very small inventory, it might be acceptable to specify 0 for this setting in UAM-style emissions processing, provided that you are sure that treating all sources as elevated sources in UAM-style models is acceptable. We do not recommend such an approach for typical SMOKE applications for UAM-style models.

- 2: Use the “Elevated” section of the `PELVCONFIG` configuration file to select specific sources. This approach can be used for in-line plume rise in CMAQ. Must set `SMK_PING_METHOD = 0`.

For in-line plume rise processing in CMAQ, this environment variable must be set to 2 and the `PELVCONFIG` file will be used to select specific sources. To reduce the total number of plume rise calculations that would be done in the CMAQ in-line plume rise module, **Elevpoint** needs to group sources with nearly identical stack parameters. **Elevpoint** outputs stack group file that identifies elevated source locations and stack parameters for in-line plume rise calculation in CMAQ.

When using **Smkmerge** for in-line plume rise processing, `MRG_LAYERS_YN` must set to N to create hourly speciated 2-D surface layer emissions file. If `SMKMERGE_CUSTOM_OUTPUT` is set to Y, the output file for the in-line emissions is called `INLNST_L`.

- `SMK_PING_METHOD`: [default: 0]

Defines the method to use in determining PinG point sources.

- 0: No PinG sources
- 1: Use PinG section of `PELVCONFIG` configuration file

For all models that SMOKE supports use of PinG sources is optional. Some models may have limitations on the number of PinG sources supported, and you must make sure that these limitations are met; SMOKE does not automatically compare with these limitations, if any.

For CMAQ, SMOKE will output a `STACK_GROUPS` file from the **Elevpoint** program and a `PINGTS_[S|L]` file from the **Smkmerge** program to support PinG. For UAM-style processing, SMOKE will flag PinG sources in the ASCII elevated file created by **Smkmerge**, and should be used with the `SMK_ASCII_ELEV_YN` option set to Y to create this ASCII elevated file.

- `SMK_SOURCE`: See description in Section 4.2.3.2, “Input Environment Variables” [137]

4.4. Grdmat

4.4.1. Description

Processing categories: area, mobile, point

The **Grdmat** program produces the matrix that contains the factors for spatially allocating the emission sources to the modeling domain.

For pre-gridded inventory data, `grdmat` is used to convert the data from the input data grid (e.g. lat-lon for EDGAR/RCP/HTAP) to the output modeling grid when the user sets `IMPORT_GRDNETCDF_YN` to Y. Spatial surrogates (AGPRO or MGPRO) are not needed for processing gridded inventory data with SMOKE. The input modeling domain information is obtained from the `GRIDMASK` input file and the output grid is defined by the `IOAPI_GRIDNAME_1` environment variable in the `GRID_CRO_2D` file.

For inventory data that is not already pre-gridded, point sources are assigned to grid cells using the geographic coordinates that are stored in each point-source record. For area and mobile sources, a cross-reference file matches the gridding surrogates to the source-level emissions. When the gridding cross-reference files are applied, the most-specific matches always override the less-specific ones.

For the current version of SMOKE, a gridding surrogates file must be created for the specific grid of interest. This can be accomplished in a variety of ways:

- ArcInfo (or other GIS) processing by an expert in creating gridding surrogates.
- Using the MIMS Spatial Allocation Tool.
- Extracting surrogate data from a larger gridding surrogates file. National 4-km surrogates are available from the EPA at <http://www.epa.gov/ttn/chief/emch/spatial/newsurrogate.html>. To use these data for your modeling, you must use the same grid projection as was used to create the gridding surrogates.

For area sources, the gridding cross-reference file provides the following possible combinations, ordered from most specific to least specific:

1. Country/state/county code and 10-digit SCC
2. Country/state/county code and 7-digit SCC

3. Country/state code and 10-digit SCC
4. Country/state code and 7-digit SCC
5. 10-digit SCC
6. 7-digit SCC
7. Country/state/county code
8. Country/state code
9. Ultimate default (country/state/county code = 0, SCC = 0)

For mobile sources, the available combinations and their order are:

1. Country/state/county code, and 10-digit SCC
2. Country/state code and 10-digit SCC
3. Country/state/county code
4. Country/state code
5. 10-digit SCC
6. Ultimate default (country/state/county code = 0, SCC = 0)

4.4.2. Processing Order

Smkinven must be run before **Grdmat**.

Grdmat must be run before gridded emissions may be produced using **Smkmerge**.

4.4.3. Files and Environment Variables

Figure 4.4. Grdmat input and output files

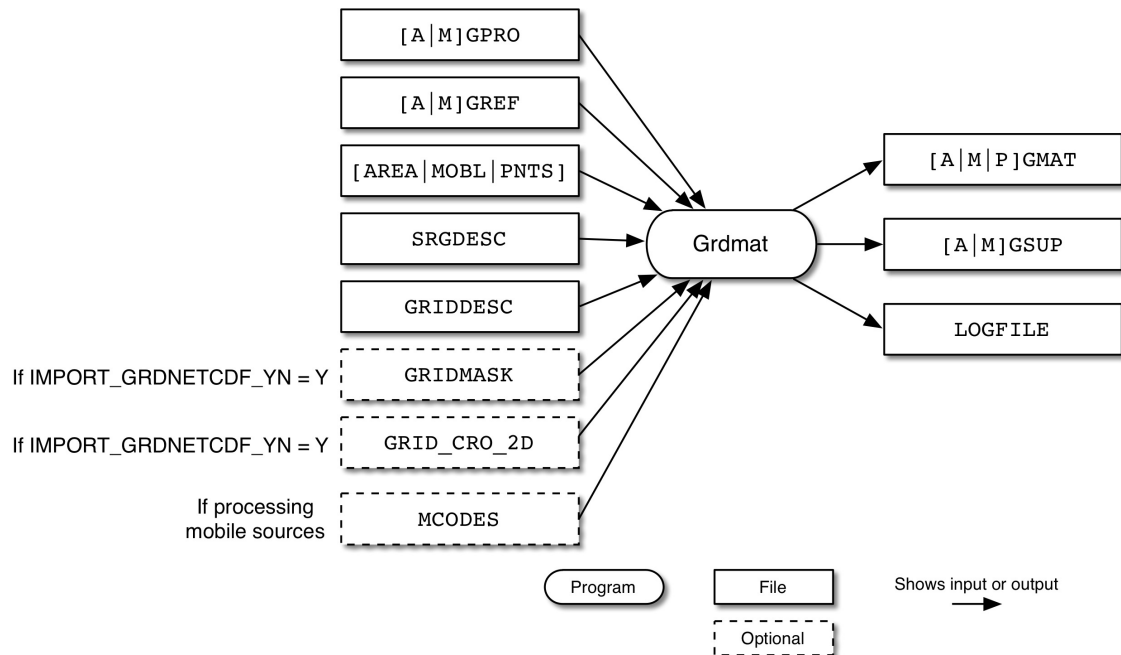


Figure 4.4, “**Grdmat** input and output files” [146] shows the input and output files for the **Grdmat** program. The input files are the spatial surrogates file (AGPRO or MGPRO), the spatial cross-reference file (AGREF

or MGRES), the inventory file output from **Smkinven** (AREA, MOBL, or PNTS), the surrogate description file (SRGDESC), and the grid description file (GRIDDESC).

Grdmat outputs a gridding matrix file (AGMAT, MGMT, or PGMAT) used by other SMOKE programs, and a supplemental gridding file (AGSUP or MGSUP) that includes all of the spatial surrogate codes assigned to each source. Like all SMOKE programs, **Grdmat** writes a program log (LOGFILE).

4.5. Grwinven

4.5.1. Description

Processing categories: area, mobile, point

The **Grwinven** program grows and controls inventory emissions and activity data into the past/future by merging a SMOKE inventory file (AREA, MOBL, or PNTS) with its respective growth and control matrices. This optional program need not be used if these projections have been made outside of SMOKE. **Grwinven** outputs new SMOKE I/O API inventory files, but not the corresponding inventory ASCII files (because the program changes the data only in the I/O API inventory files, so there is no need to output the same ASCII files). The program can also output data in ORL format, or be used as a converter from SMOKE to ORL format. **Grwinven** does not merge the SMOKE inventory with reactivity matrices; this functionality is handled by **Smkmerge**.

The **Grwinven** program writes out temporary emissions files when creating an ORL-formatted inventory. You can set the directory to which these temporary files go by setting the `SMK_TMPDIR` environment variable. These files can be quite large; at least 100 MB should be available on the disk to which this environment variable is set.

4.5.2. Processing Order

Smkinven and **Cntlmat** must be run before **Grwinven**.

After running **Grwinven**, the output can be used similarly to the output from **Smkinven**. If **Spcmat** or **Grdmat** have already been run for a given inventory, these programs do not need to be rerun after running **Grwinven** because the number and order of the sources in the grown emissions files are the same as in the base case.

Figure 4.5. Grwinven input and output files

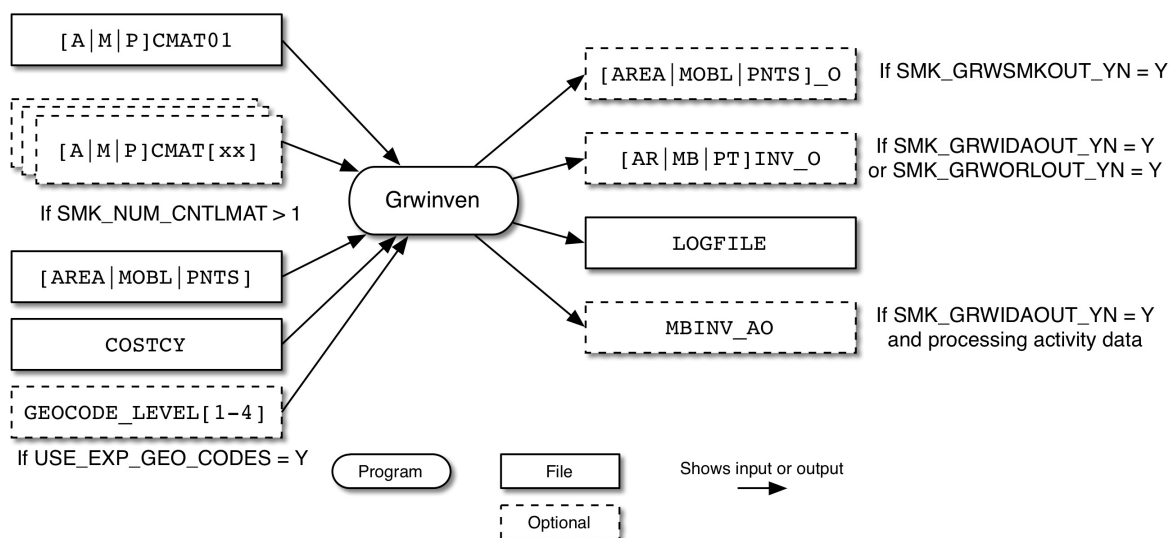


Figure 4.5, “**Grwinven** input and output files” [149] shows the input and output files for the **Grwinven** program. The input files include at least one growth or control matrix output from **Cntlmat** (ACMAT01, MCMAT01, or PCMAT01). If you are applying more than one growth or control matrix (i.e. `SMK_NUM_CNTLMAT` is greater than one), **Cntlmat** will open additional matrices as needed (ACMAT[xx], MCMAT[xx], or PCMAT[xx]). **Cntlmat** also uses the inventory file output from **Smkinven** (AREA, MOBL, or PNTS) and the country, state and county file (COSTCY).

Grwinven outputs new SMOKE intermediate inventory files (AREA_O, MOBL_O, or PNTS_O) that have been controlled and/or grown into the past or future. Note that the suffix _O is used to distinguish the **Grwinven** output files from the input files. You can also choose to output ASCII inventory files in ORL format (ARINV_O, MBINV_O, or PTINV_O). **Grwinven** also writes a log file (LOGFILE) and can create an ASCII inventory file for activity data (MBINV_AO).

4.6. Laypoint

4.6.1. Description

Processing categories: point

The **Laypoint** program uses the SMOKE point-source inventory file with gridded and hourly meteorology data to compute hourly plume rise for all point sources. The plume rise is expressed in terms of layer fractions for each source.

Laypoint is run only for the CMAQ styles of processing, in which all of the plume rise calculations are done prior to input to the AQM. In **Laypoint**, meteorological data are used to calculate the plume rise for all point sources. Then, the plume is distributed into the vertical layers that the plume intersects based on the pressure in each layer. Only these fractions are stored (not the emissions in each layer), until the SMOKE merge step (**Smkmerge**). Therefore, the plume rise calculations do not need to be repeated for each control strategy or grid. The **Laypoint** program calculates the plume rise for all days of each meteorological scenario.

4.6.1.1. Plume rise calculation for fires

Regardless whether the heat flux for wildfires is precomputed or internally computed, the Pouliot-Godowitch plume rise algorithm (<http://www.epa.gov/ttn/chief/conference/ei14/session12/pouliot.pdf>) converts the heat flux (Q) to a buoyancy flux (F) for use in the plume rise calculation (Equation 1). Hourly heat flux (Q) can be estimated based upon daily area burned, fuel loading, material burned and a constant default heat content (8000 BTU/lb).

To account for a smoldering fraction of the fire emissions, fire plumes are distributed into both the model layers below the plume bottom and into the model layers between the plume top and bottom. The smoldering fraction of the total fire emissions is distributed into the model layer below the plume bottom. The remaining part of emissions are distributed into the model layers between the plume bottom and top.

Equation 2 estimates the plume buoyant efficiency (BE) which is the portion of heat release from a fire that produces buoyancy, using the fire size in acres. The smoldering fraction (S_{fraction}) of the fire plume is calculated from the BE (Equation 3). All the fire emissions are allocated to the model layers using a weighting based on the hourly sigma-pressure vertical coordinate. These equations are used in **Laypoint** when the variable `FIRE_PLUME_YN` is set to Y.

Fire-specific plume rise equations are following:

1. $F = 0.00000258 \times Q$
2. $BE_{\text{size}} = 0.0703 \times \ln(\text{acres}) + 0.3$
3. $S_{\text{fraction}} = 1 - BE_{\text{size}}$

where

- F = Buoyancy flux (m^4/s^3)
- Q = Heat flux for fires (BTU/hr)
- BE_{size} = buoyant efficiency
- acres = fire size in acres

- S_{fraction} = smoldering fraction

4.6.2. Processing Order

For elevated point sources, **Smkinven** and **Elevpoint** must be run before **Laypoint** if using PinG and/or specific major point sources.

Laypoint must be run before elevated sources can be processed using **Smkmerge**.

Figure 4.6. Laypoint input and output files

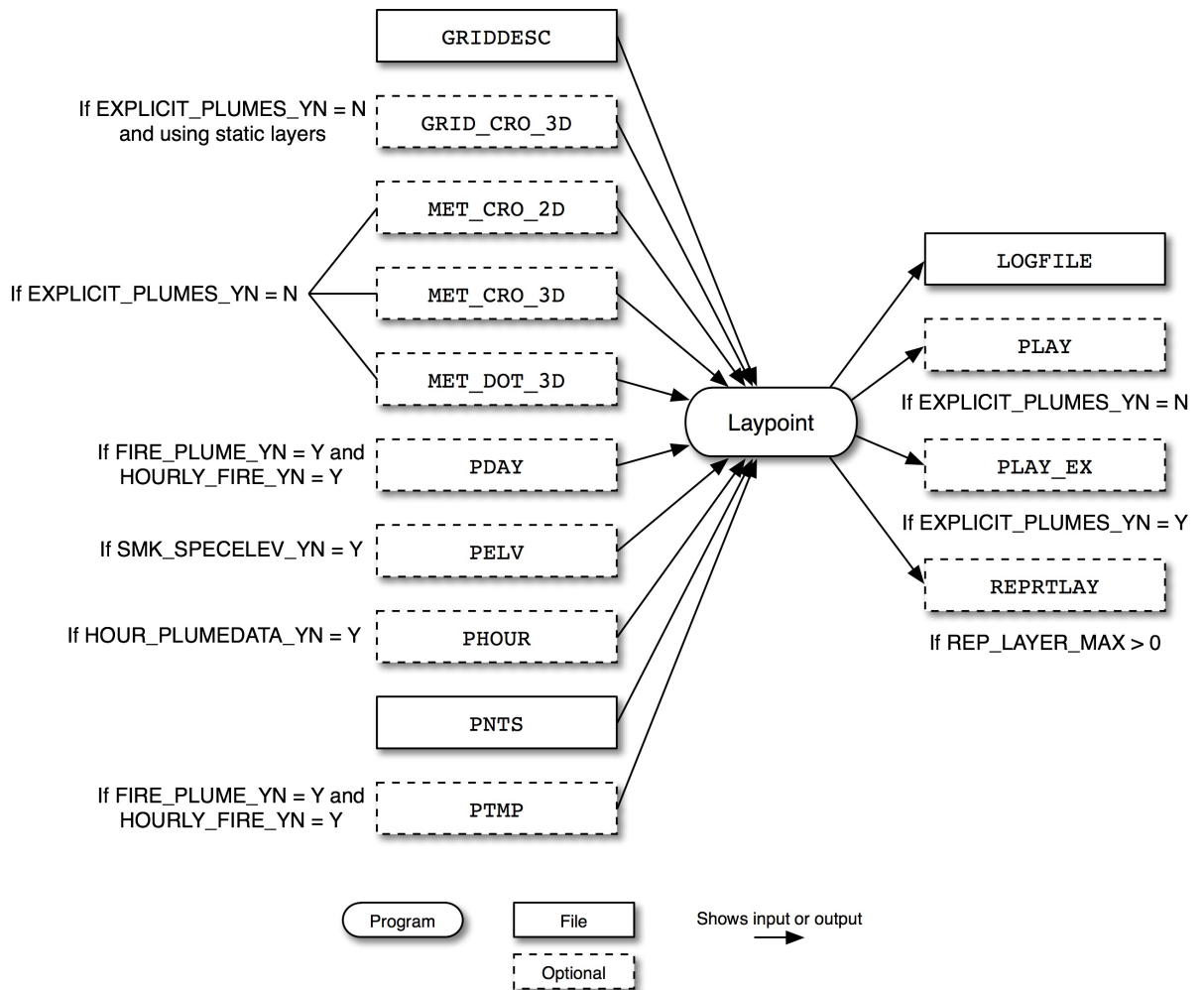


Figure 4.6, “**Laypoint** input and output files” [152] shows the input and output files for the **Laypoint** program. The input files include the grid description file (GRIDDESC) and meteorology files created by the meteorology preprocessor (GRID_CRO_3D, MET_CRO_2D, MET_CRO_3D, and MET_DOT_3D). If elevated sources have been selected, **Laypoint** uses the the elevated point source identification file output from **Elevpoint** (PELV). Hourly plume data can be read from the PHOUR hourly inventory file and annual inventory data is read from the PNTS file, both output from **Smkinven**. When processing fire sources, the PDAY file created by **Smkinven** and the PTMP file created by **Temporal** may be used.

Laypoint outputs a log file (LOGFILE), hourly plume rise layer fractions for all sources (PLAY) or optionally only for explicit sources (PLAY_EX), and a report file REPRTLAY if reporting is turned on using the REP_LAYER_MAX setting.

4.7. Met4moves

4.7.1. Description

Processing categories: mobile

The **Met4moves** is a meteorological processor that prepares temperature and relative humidity (RH) data for use by both MOVES and SMOKE. **Met4moves** produces specific meteorological metrics for the representative county(s) for MOVES and additional meteorological metrics for all inventory counties in the county group for SMOKE

4.7.1.1. Definition of a “day”

Met4moves seeks to obtain 24 hours’ worth of meteorology data for a source for each day, which is necessary for generating emission factors. However, the definition of a “day” differs for sources in different time zones. By default, **Met4moves** uses each source’s time zone to determine a day for that time zone. To instead use the same day-start-time for all sources, the UNIFORM_STIME environment variable can be used.

If the inventory covers multiple time zones, all sources will not have the same coverage of days. **Met4moves** will use meteorology data from previous or subsequent days to fill in missing data. If appropriate data are not available, the program will quit with an error and you must provide additional meteorology data to cover the time period of interest. Currently, **Met4moves** does not consider Daylight Saving time in its determination of “day”.

4.7.2. Processing Order

Met4moves must be run prior to MOVES processing scripts. The SMOKE Utility program, **Metcombine**, needs to be run prior to **Met4moves**. **Metcombine** allows the user to combine ambient temperature, pressure and mixing ratio variables from two different MCIP files (METCRO_2D and METCRO_3D) that are needed to compute Relative Humidity (RH) in **Met4moves**.

Figure 4.7. Met4moves input and output files

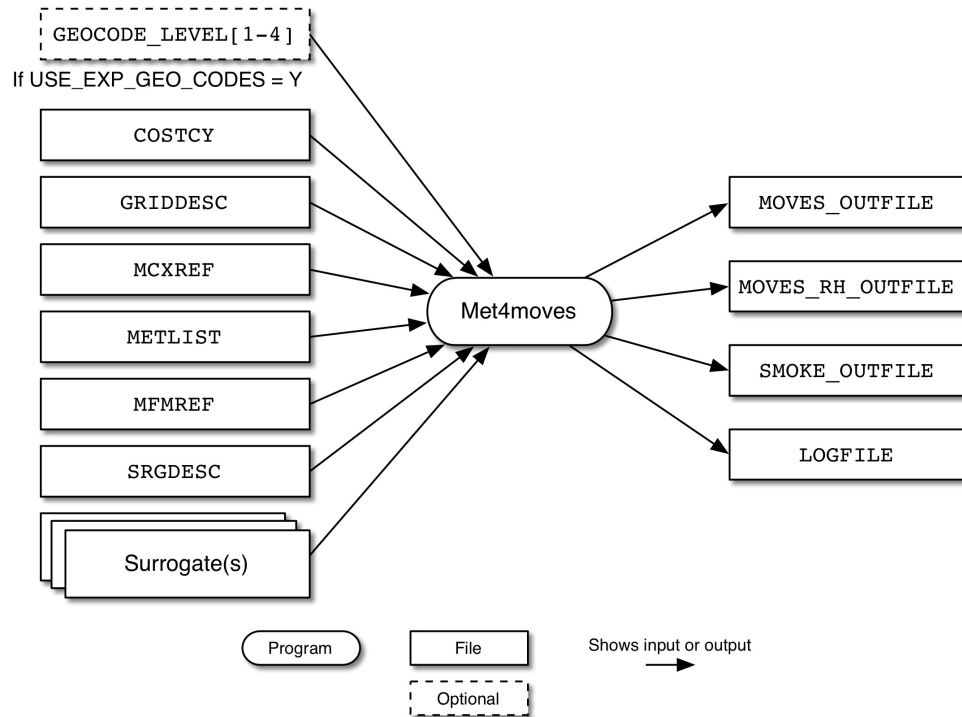


Figure 4.7, “**Met4moves** input and output files” [156] shows the input and output files for the **Met4moves** program. The input files are the Grid Description File from MCIP (GRIDDESC), the Surrogate Description file (SRGDESC), the MCIP List of Meteorology File (METLIST), and the representative county cross-reference file (MCXREF).

Met4moves outputs datasets for SMOKE that contain the daily gridded min/max temperatures and averaged RH. **Met4moves** outputs for MOVES datasets that provide all (min/max) temperature combinations for a representative county, reflecting all min/max combinations for all inventory counties in that county group. The associated RH values are also included in these datasets. In addition, the datasets include the 24-h diurnal profiles needed for the RPP emission process, and contain user-specified temperature increments for use by MOVES.

4.8. Movesmrg

4.8.1. Description

Processing categories: mobile

Movesmrg is a mobile-sources-only program, loosely based on the SMOKE program **Smkmerge**, that combines the intermediate files produced by the other SMOKE programs (i.e., **SmkInven**, **Grdmat**, **Spemat**, **Temporal**). The **movesmrg** program is discussed in detail in Section 4.8, “**Movesmrg**” [158]. Similar to **Smkmerge**, the main goal of **Movesmrg** is to create (1) gridded, speciated, hourly air quality model-ready input files and (2) county-level SCC summaries. The primary difference between **Movesmrg** and **Smkmerge** is that **Movesmrg** uses the SMOKE Formatted MOVES emission rate lookup tables to compute emissions on the fly, by multiplying the emissions factors by hourly VMT (for RatePerDistance [RPD]), annual or monthly hotelling hours (for RatePerHour [RPH]), annual or monthly vehicle engine starts (for RatePerStart [RPS]), or by monthly or annual vehicle populations (for RatePerVehicle [RPV] or RatePerProfile [RPP]).

Movesmrg must be run four times to compute on-roadway and off-network (including vapor venting) emissions processes individually, since the emission rate calculation methods in SMOKE for these categories are quite different. Once all three emissions processes have been computed, the emission output files can be merged (optionally along with other 2D sectors separate from onroad) using **Mrgrid**, which combines any number of 2D or 3D hourly, gridded, and speciated emission data files. See the section Section 4.10, “**Mrgrid**” [168] for more details on the above programs.

- **RPD, RPH, RPHO, RPV and RPS Emission Calculations**

For its RPD, RPH, RPHO, RPS and RPV lookup table calculations, **Movesmrg** uses the gridded hourly temperatures in GMT, and then adjusts the hour of the RPD, RPH, RPHO, and RPS and RPV lookup tables from local time to GMT to get the emission rates for the representative county for the appropriate month. The key lookup fields for the factors are hourly temperature and average speed for the RPD lookup table calculation, hourly temperature for the RPH and RPHO lookup table calculation, and hourly temperature and hour of the day in local time for the RPS and RPV table calculation.

- **RPP Emission Calculations**

For the RPP lookup table calculations, **Movesmrg** uses the RPP lookup table as an input file for the emission rates that depend not on the gridded hourly temperatures, but on the temperature profiles output by the **Met4moves** program. The emissions estimates based on the RPP table are computed for the temporal averaging period specified for the temperature profiles, rather than using hourly gridded meteorology.

4.8.2. Processing Order

Movesmrg must be run after **Met4moves** and MOVES and before **Mrgrid**.

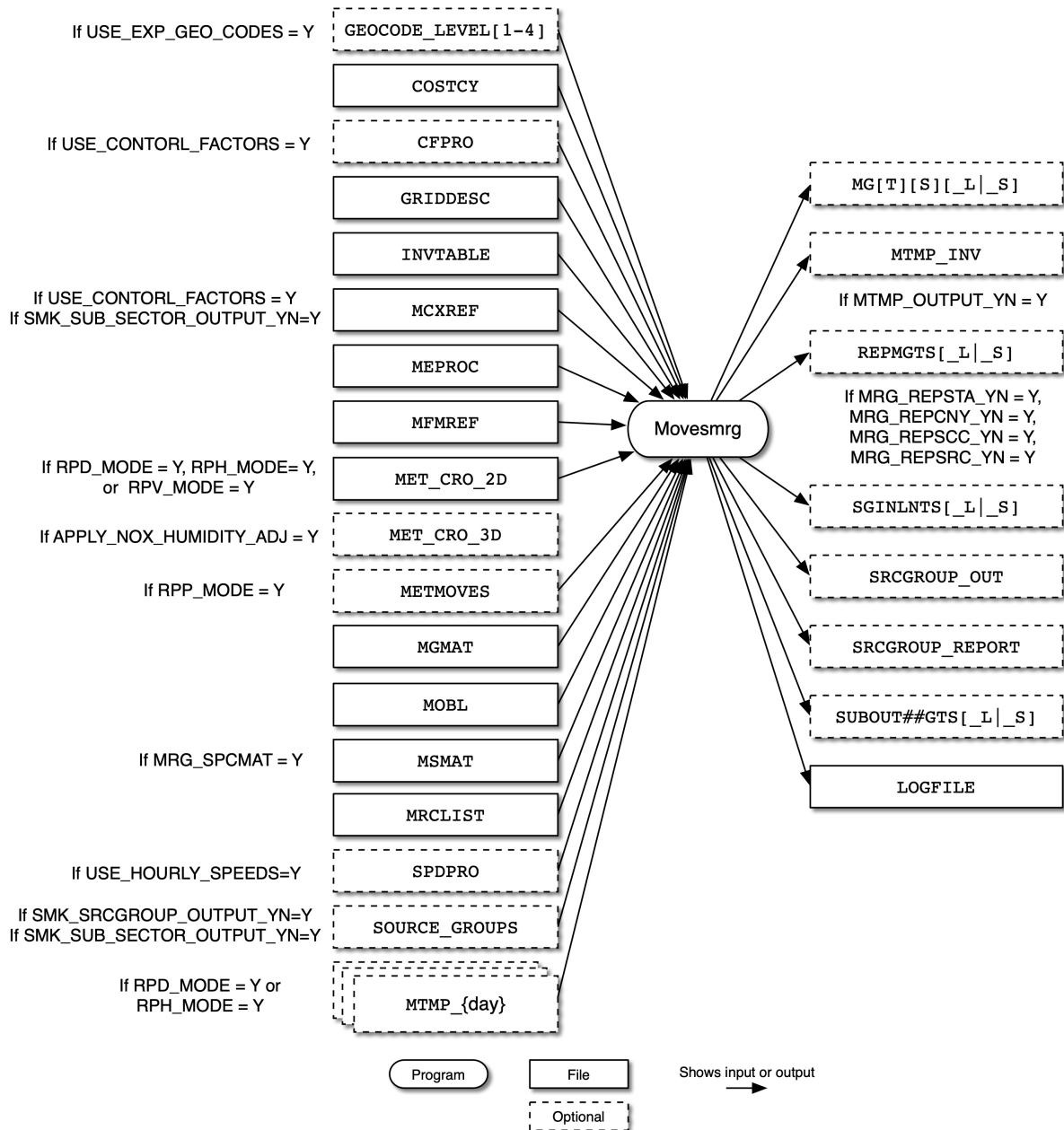


Figure 4.8, “**Movesmrg** input and output files” [160] shows the input and output files for the **Movesmrg** program. The input files are the country, state, and county codes file (**COSTCY**), the grid description file (**GRIDDESC**), the inventory data table (**INVTABLE**), the representative county fuel month file (**MFMREF**), the list of emission process and associated pollutants file (**MEPROC**), the representative county cross-reference file (**MCXREF**), the list of emission factors files by representative county file (**MRCLIST**), the meteorology files (**MET_CRO_2D**), the gridding matrix from **Grdmat** (**MGMAT**), the inventory file output from **Smkinven** (**MOBL**), the speciation matrix from **Spcmat** (**MSMAT_L** or **MSMAT_S**), the **Met4moves** output file for

4.9. Mrgelev

4.9.1. Description

Processing categories: point

The **Mrgelev** merges multiple ASCII elevated files created by **Smkmerge**. The program can also output a binary elevated file needed by CAMx and UAM models. **Mrgelev** also handles matching PinG sources from different inputs, ensuring that only the top 300 emission sources are marked as PinG sources in the final merged output. For PinG matching, **Mrgelev** uses PELV files output by **Elevpoin**t. **Mrgelev** uses the environment variable `MRG_DIFF_DAYS` to merge files from different days into a single file.

4.9.2. Processing Order

Mrgelev is used to merge ASCII elevated files created by **Smkmerge**. If PinG matching is desired, then output files from **Elevpoin**t are required.

The output binary elevated file from **Mrgelev** is used when running CAMx or UAM models.

Figure 4.9. Mrgelev input and output files

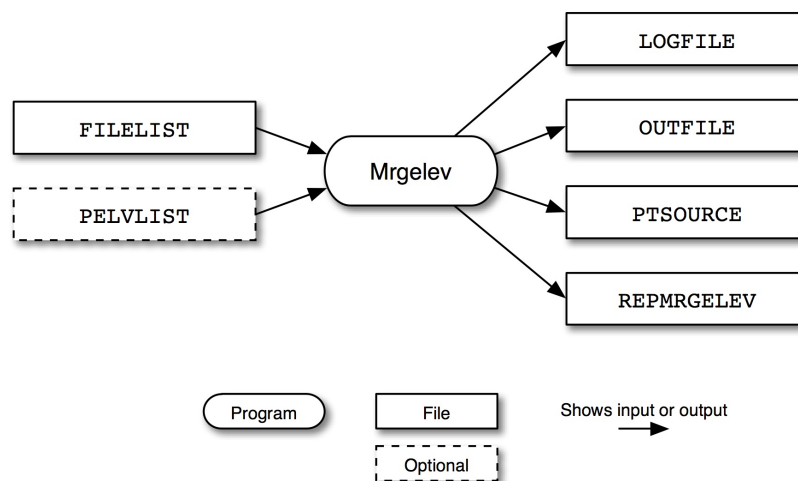


Figure 4.9, “**Mrgelev** input and output files” [167] shows the input and output files for the **Mrgelev** program. The input files are a list of the ASCII elevated files (`FILELIST`) and optionally a list of PELV files created by **Elevpoin**t (`PELVLIST`). In both files, the complete file name including path must be provided. When using the `PELVLIST` file, each file must match the corresponding ASCII elevated file. The program outputs a log file (`LOGFILE`), a merged ASCII elevated file (`OUTFILE`), a merged binary elevated file (`PT-SOURCE`), and a report file (`REPMRGELEV`).

4.10. Mrgrid

4.10.1. Description

Processing categories: all

The purpose of the **Mrgrid** program is to combine gridded emission data files, which can be speciated or nonspeciated, and hourly or time-independent. It can combine any number of 3-D emissions files with any number of 2-D emissions files. In fact, this program will work with any I/O API NetCDF gridded files and need not be used only for emissions files. The program merges whatever data variables are in the input files. These files can each have different sets of data variables; **Mrgrid** will sum values only for each variable that is common to two or more files.

Mrgrid checks several features of the input files to ensure that the data in these files are appropriate to be merged together. All input files must have use the same time step. **Mrgrid** compares the units of the variables with the same name and it creates an error message when the units are not identical. It is not sufficient to have units that are the same in meaning but different in syntax. For example, although tons/hour

and tons/hr represent the same units, **Mrgrid** will not recognize this because of the different syntax. The user must resolve unit discrepancies before running the program. In addition, **Mrgrid** compares the horizontal grid settings across all 2-D and 3-D files, and these settings must be identical in all respects (e.g., number of cells, grid cell size, grid projection). Finally, **Mrgrid** checks the layer structures across multiple 3-D files. The 3-D files can have a different number of layers, as long as any layer common to two or more files has the same thickness in each of the files; **Mrgrid** also checks the I/O API type of vertical structures and top height, and these must be identical across all 3-D files.

4.10.2. Processing Order

Mrgrid can be used with any gridded output files from **Smkmerge**. It can also be used with other I/O API NetCDF gridded files produced outside of SMOKE.

Output files from **Mrgrid** are usually model-ready input files that will be used in running an AQM.

Figure 4.10. Mrgrid input and output files

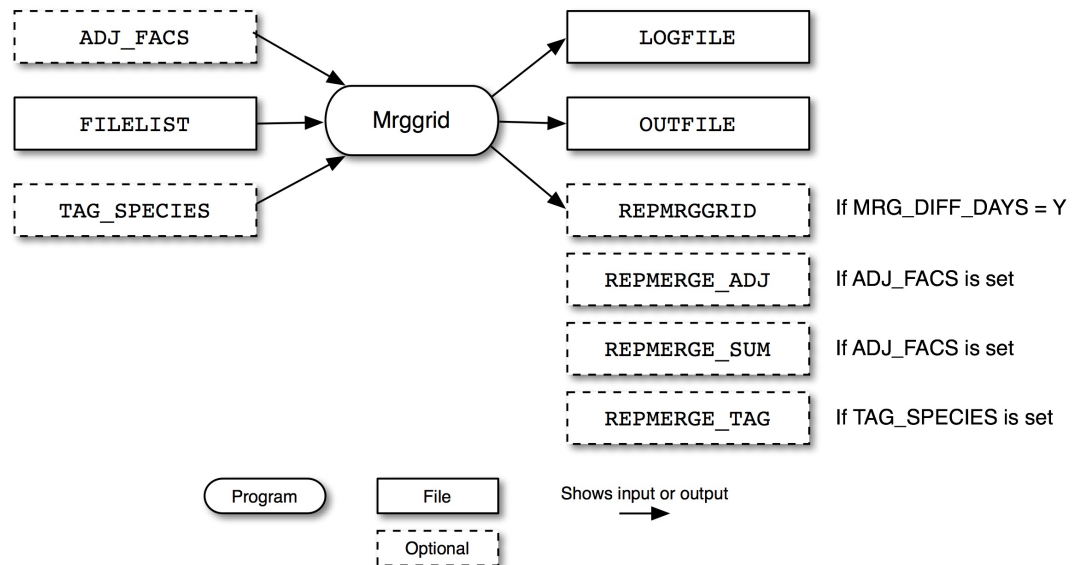


Figure 4.10, “**Mrgrid** input and output files” [169] shows the input and output files for the **Mrgrid** program. The input file is simply a list of the logical file names for the files to be merged (**FILELIST**). The program outputs a log file (**LOGFILE**), a gridded, optionally layered, optionally hourly emissions file (**OUTFILE**), and if merging different days, a report file (**REPMRGRID**).

All input files must have use the same time step. **Mrgpt** compares the units of the variables with the same name and it creates an error message when the units are not identical. It is not sufficient to have units that are the same in meaning but different in syntax. For example, although tons/hour and tons/hr represent the same units, **Mrggrid** will not recognize this because of the different syntax. The user must resolve unit discrepancies before running the program.

Mrgpt can be used with any hourly speciated emissions from **Smkmerge** and any ASCII elevated output files from **Elevpoint**.

Figure 4.11. Mrgpt input and output files

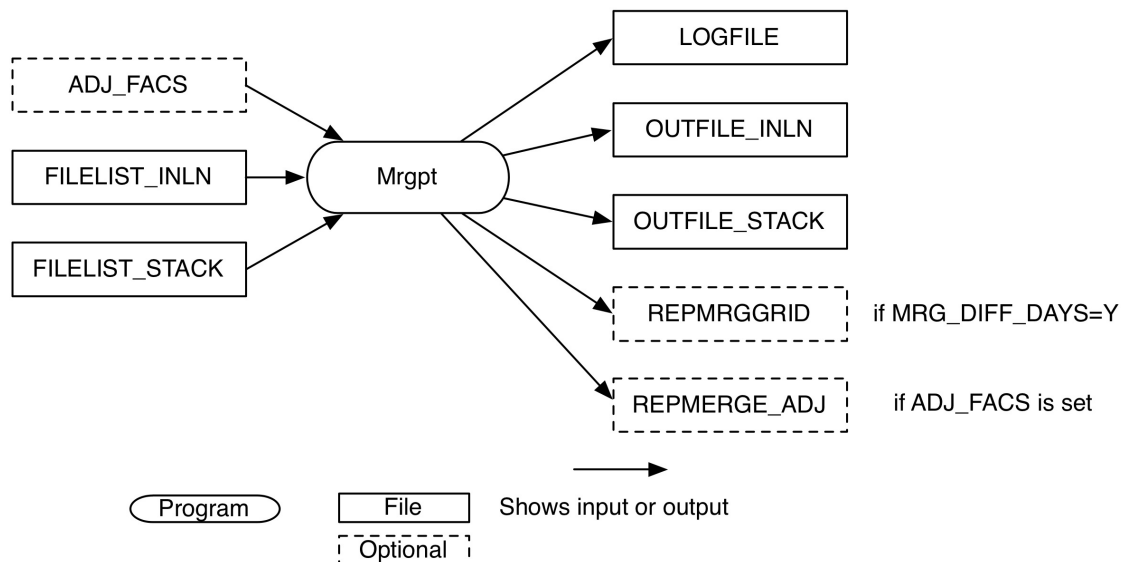


Figure 4.11, “**Mrgpt** input and output files” [172] shows the input and output files for the **Mrgpt** program. The input files are a list of the logical file names for the speciated hourly emissions files from **Smkmerge** to be merged (`FILELIST_INLN`) and a list of the logical file names for the ASCII elevated output files from **Elepoint** to be merged (`FILELIST_STACK`). The program outputs a log file (`LOGFILE`), a merged speciated hourly emissions file (`OUTFILE_INLN`), a merged ASCII elevated output file (`OUTFILE_STACK`), and if merging different days, a report file (`REPMRGGRID`).

4.12. Normbeis3

4.12.1. Description

Processing categories: biogenic

Normbeis3 reads gridded land use data and emissions factors and produces gridded normalized biogenic emissions. **Normbeis3** is the first program in the SMOKE-BEIS3 model. The gridded land use includes various number of land use types. Emissions factors are provided for each land use type. The output gridded domain is the same as the input domain for the land use data. Emission fluxes are normalized to 30 °C, and isoprene and methyl-butenol fluxes are also normalized to a photosynthetic active radiation (PAR) of 1000 $\mu\text{mol}/\text{m}^2\text{s}$. **Normbeis3** also computes normalized emissions for winter months, using a winter factor read in from the emissions factor table.

For BEIS version 3.14 and 3.60, **Normbeis3** outputs winter and summer normalized emissions for the 35 species/compounds (including 14 monoterpenes and 1 sesquiterpene) listed below, as well as winter and summer leaf area indices (LAI). The output units for NO are grams of nitrogen per hour; the output units for LAI are meters squared per meters squared; the units for all other species/compounds are grams of carbon per hour.

Figure 4.12. Normbeis3 input and output files for BEIS v3.14

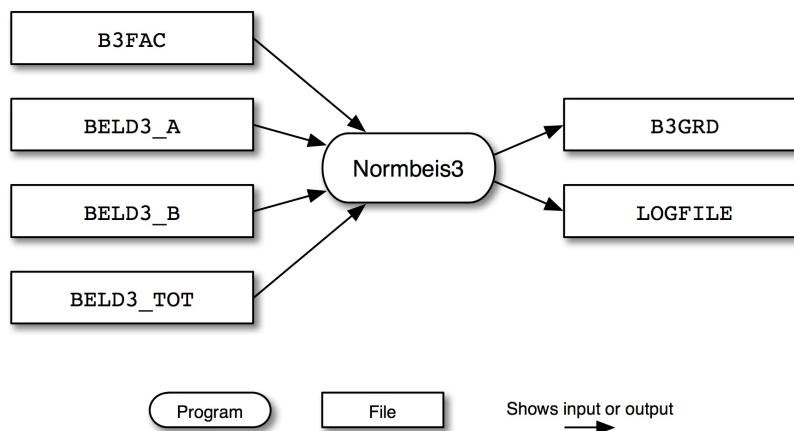


Figure 4.12, “**Normbeis3** input and output files for BEIS v3.14” [175] shows the input and output files for the **Normbeis3** program for BEIS v3.14. The input files are the emission factors file (B3FAC), the gridded land use file for the first 120 land use types (BELD3_A), the gridded land use types for the next 110 types (BELD3_B), and the land use totals data file (BELD3_TOT).

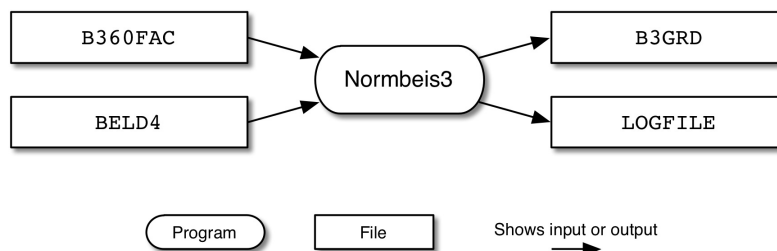
Figure 4.13. Normbeis3 input and output files for BEIS v3.61

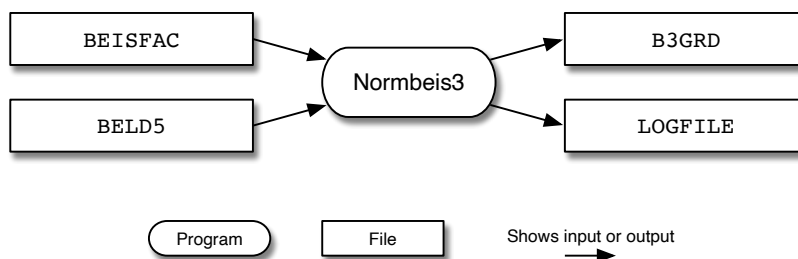
Figure 4.14. Normbeis3 input and output files for BEIS v3.7 or later version

Normbeis3 outputs a gridded, normalized biogenic emissions file (B3GRD) and a log file (LOGFILE).

Gridded land use data can be created using GIS software, such as ArcInfo. Another tool that can be used to generate gridded land use data is the SMOKE Tool in Models-3 (see Models-3 documentation). The typical database used to generate the BELD3_A, BELD3_B, and BELD3_TOT files is the BELD3. Future versions of SMOKE may include a method for creating land use files for use with **Normbeis3**.

4.13. Normbeis4

4.13.1. Description

Processing categories: biogenic

Normbeis4 reads gridded land use data, gridded biomass data, and emissions factors and produces gridded normalized biogenic emissions. **Normbeis4** is the first program in the SMOKE-BEIS4 model. The gridded land use includes various number of land use types. Emissions factors are provided for each land use type. The output gridded domain is the same as the input domain for the land use data. Emission fluxes are normalized to 30 °C, and isoprene and methyl-butenol fluxes are also normalized to a photosynthetic active radiation (PAR) of 1000 $\mu\text{mol}/\text{m}^2\text{s}$. **Normbeis4** also computes normalized emissions for winter months, using a winter factor read in from the emissions factor table.

For BEIS version 4, **Normbeis4** outputs winter and summer normalized emissions for the 35 species/compounds (including 14 monoterpenes and 1 sesquiterpene) listed below. The output units for NO are grams of nitrogen per hour; the units for all other species/compounds are grams of carbon per hour.

4.14. Smkinven

4.14.1. Description

Processing categories: area, mobile, point

Smkinven reads in the raw input data, sorts the records, and creates the SMOKE inventory files that are required by most of the SMOKE programs. The program is run separately for area-, mobile-, and point-source processing. **Smkinven** reads annual, average-day, day-specific, and hour-specific inventory files. The annual and average-day inventory data are combined into a single inventory. The output also indicates whether the data started out as annual or average-day data; such “temporal origin” information is needed by the **Temporal** program to determine whether to apply monthly adjustments. **Smkinven** can also import gridded one-layer annual or average-day emissions in I/O API NetCDF or CF-compliant NetCDF format as an area source.

Smkinven writes several SMOKE inventory files for each source category: an ASCII file containing all character-string fields from the inventory, individual I/O API NetCDF files containing emissions data for each output pollutant, and an ASCII map file listing the names and locations of each file. The character string fields cannot be stored in the I/O API NetCDF file because of limitations of the I/O API library. When day-specific and hour-specific data are available (this applies only for point sources), **Smkinven** can also read these data, and produce separate I/O API NetCDF files for each data type (day-specific or hour-specific).

Smkinven supports the following input file formats and source categories:

- SMOKE one-record-per-line (ORL) format for nonpoint, nonroad mobile, on-road mobile, and point sources
- SMOKE one-record-per-line (ORL) format for fire point sources (modified to support wildfires and prescribed fires characteristics and pollutants)
- Special mobile link format
- FF10 (Flat File 10) format for many different source categories including day-specific, hour-specific, monthly and annual for nonpoint, nonroad mobile, on-road mobile, and point sources (comma or semicolon delimited)
- ASCII Continuous Emissions Monitoring (CEM) format (hour-specific point-source emissions)
- List format (for combining multiple files of the same or compatible formats) for area, mobile, and point
- LIST GRID format (for reading multiple gridded one-layer annual CF-compliant NetCDF inventory data) as area sources
- Gridded one-layer annual or average-day NetCDF I/O API or CF-compliant NetCDF emissions data (must be treated as an area source)

It is not possible to import only day- or hour-specific data from FF10 input files. If only such data are to be used, mock annual files must be created; see Section 6.2.6, “PTDAY: Point source day-specific emissions” [278] and Section 6.2.7, “PTHOUR: Point source hour-specific emissions” [280] for more information on the required formats.

The list format is simply a list of file names with paths with a special format identifier that allows all files in the list to be processed together. To use a list format, all input files must have the same or compatible formats.

The list grid format is simply a list of CF-compliant NetCDF file names with paths with a special format identifier that allows all files in the list to be processed together. To use a list grid format, all input files must have the same or compatible formats with inventory data from the same year.

When using CEM data, you are encouraged to preprocess your data to prepare them down to the dates and/or sources in the domain. The sources in the grid will be selected based on matching to the inventory (if the inventory is for only states within the modeling grid) and/or by the **Grdmat** program, which will remove sources outside the grid from the model-ready results.

Smkinven also can process the hourly CEM data in a more sophisticated way. Hourly heat input from the CEM data are used to allocate annual emissions to hourly emission data. More information are available at (Section 3.3.3, “**CEMScan**” [104]) and (Section 2.8, “Inventory import” [47])

If new sources are added to the input files or sources are removed, **Smkinven** must be rerun for that type of source. However, **Smkinven** does not need to be rerun when processing additional control scenarios, growth projections, speciation profiles, or modeling grids.

By default, **Smkinven** will fill in missing average-day data with annual data when possible. To fill in missing annual data with average-day data, use the `FILL_ANNUAL` setting.

4.14.2. Processing Order

Smkinven must be run for a given processing type (i.e., area, mobile, point) before any other SMOKE programs for that processing type can be run.

When processing CEM data, the utility program **CEMScan** must be run before **Smkinven**.

Figure 4.18. **Smkinven** input and output files for area sources

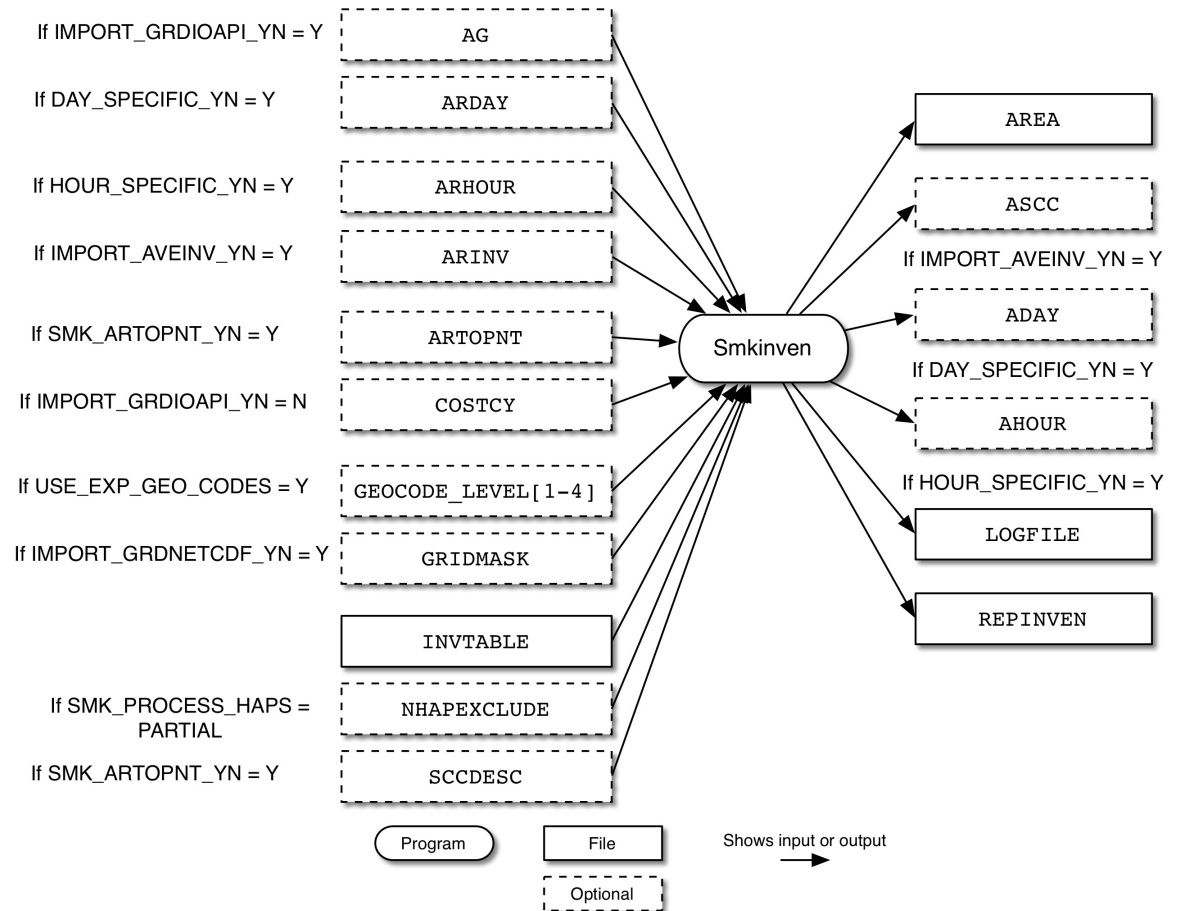


Figure 4.18, “**Smkinven** input and output files for area sources” [181] shows the input and output files for **Smkinven** for area sources. If importing gridded data, **Smkinven** reads the AG file; for the annual inventory, **Smkinven** reads the ARINV file. The ARTOPNT file is used to assign point-source locations to area sources, and either the COSTCY or GEOCODE_LEVEL4 file is used to assign time zones to the annual inventory data. **Smkinven** also uses the inventory data table (INVTABLE), the optional NONHAP exclusions file (NHAPEXCLUDE), and the SCC description file (SCCDESC) if processing area-to-point sources.

Smkinven outputs an annual and average-day inventory emissions file (AREA), a file listing the inventory SCCs (ASCC), a log file (LOGFILE), and a report containing various information about the processed inventory (REPINVEN).

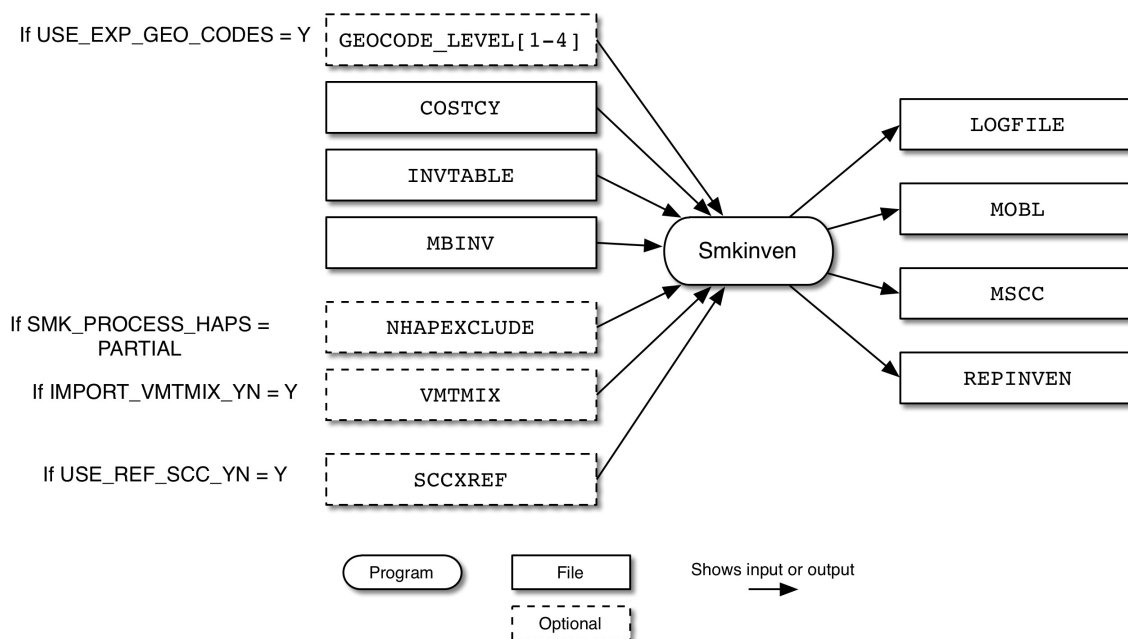
Figure 4.19. Smkinven input and output files for mobile sources

Smkinven outputs a log file (**LOGFILE**), an annual and average-day inventory emissions file (**MOBL**), a file listing the inventory SCCs (**MSCC**), and a report containing various information about the processed inventory (**REPINVEN**).

Figure 4.20. Smkinven input and output files for point sources

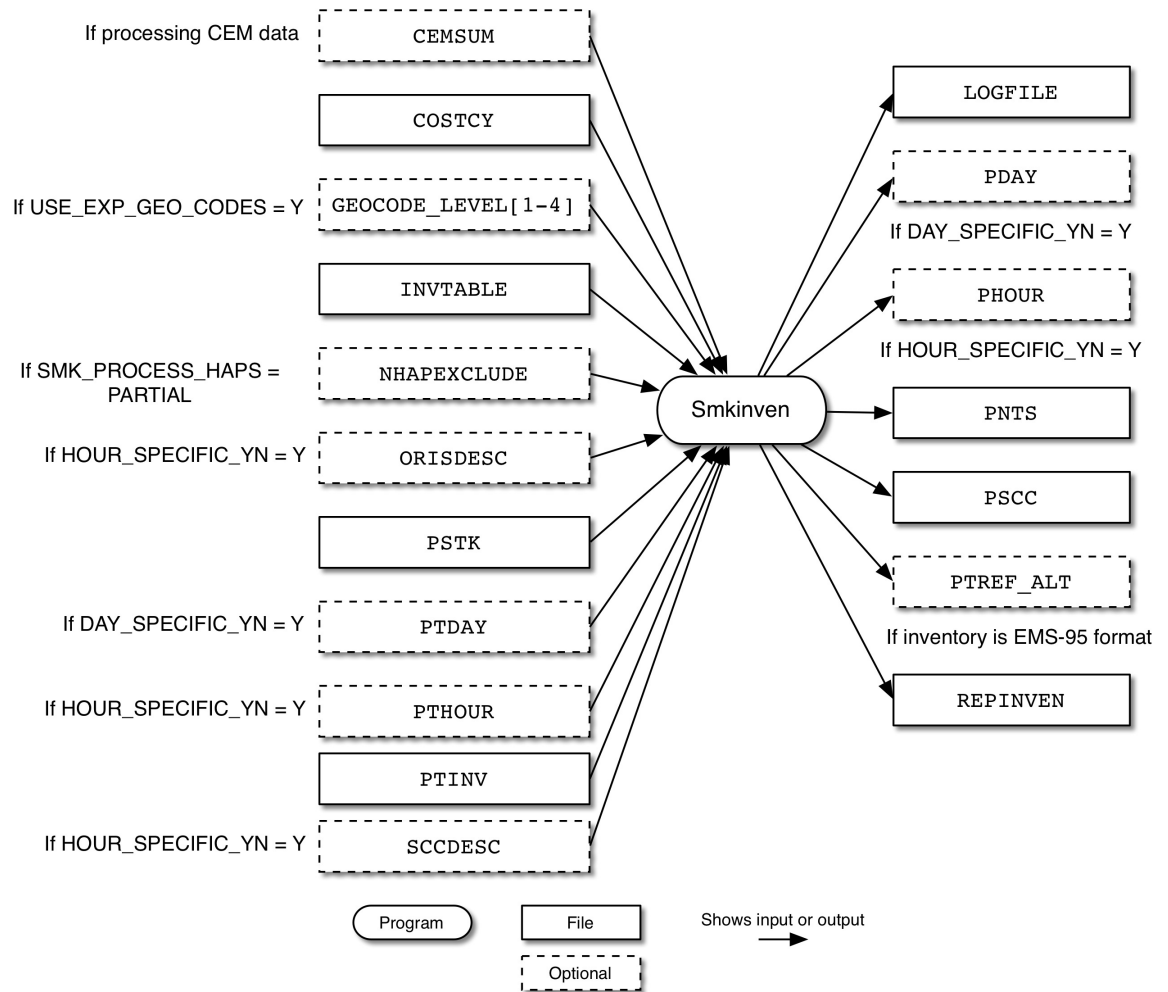


Figure 4.20, “**Smkinven** input and output files for point sources” [183] shows the input and output files for **Smkinven** for point sources. The input files include the optional CEM summary file (**CEMSUM**) created by **CEMScan**, the country, state and county codes file (**COSTCY**), the inventory data table (**INVTABLE**), and the optional NONHAP exclusions file (**NHAPEXCLUDE**). If importing hour-specific data, the **ORIS** facility description file **ORISDESC** is used. The **PSTK** file provides replacement stack parameters. Day-specific data is read from the **PTDAY** file, while hour-specific data comes from the **PTHOUR** file; the **PTINV** file provides the raw inventory data. For hour-specific data, the **SCC** description file (**SCCDESC**) is also needed.

Smkinven outputs a log file (**LOGFILE**), and optional day-specific inventory (**PDAY**), and an optional hour-specific inventory (**PHOUR**). The annual and average-day inventory emissions are stored in the **PNTS** file and the **PSCC** file lists the inventory SCCs. Finally, the **REPINVEN** report contains various information about the processed inventory.

The pollutant units are taken from the first variable in each formula. The variables used as input in the formula will still be output to the SMOKE inventory file. If the formula is not set, no additional variables will be written to the SMOKE inventory file. An output from one formula may not be used as an input to another formula. In the OUTPUT pollutant name is the same as an INPUT pollutant name from the inventory file, Smkinven will give an error indicating that the second pollutant could not be written (e.g. if computing PMC when PMC is already in the raw inventory data). If INPUT2 is omitted, an error will also occur. Formulas using multiplication and division are not yet implemented.

- SMKINVEN_MONTH: [default: 0]

Defines the number of month to process. The integer month number will allow users to pick monthly total inventory data in area FF10-formatted inventory data listed at Table 6.15, “FF10 Format for AR-INV” [268].

4.15. Smkmerge

4.15.1. Description

Processing categories: area, biogenic, mobile, point

The **Smkmerge** program combines the matrices produced by the other SMOKE programs to produce the emissions files for input to the AQM. The **Smkmerge** program may be run on any combination of source types and may incorporate temporal, speciation, projection, and spatial processing.

If **Smkmerge** is run to produce the input files to the AQM, all the other SMOKE programs must already have been run. However, you can also run **Smkmerge** to produce specialized reports. In that instance, only the required subset of SMOKE programs must have been run prior to **Smkmerge**.

Smkmerge can be used to create 2-D or 3-D gridded, hourly, speciated files. It also outputs the hourly emissions file for PinG sources needed by CMAQ. Finally, it outputs an ASCII elevated point sources file, suitable for postprocessing with the Ptsrce program of EPS2.0/EPS2.5. If PinG sources have been selected and an ASCII elevated sources file is output, then SMOKE will set the stack diameters to negative values for the PinG sources.

4.15.1.1. By-day processing

Smkmerge can use a by-day processing approach, to read in one-day hourly files for each day of the week. When the `MRG_BYDAY` environment variable is set to A, M, P, or any combination of those letters, **Smkmerge** reads a different logical file name for each day of the week for the hourly emission input files for the indicated sources.

For example, if the `MRG_SOURCE` environment variable is set to AMBP, **Smkmerge** will expect the following hourly input files: `ATMP`, `BGTS_[S|L]`, `MTMP`, and `PTMP`, for area, biogenic, mobile, and point source types respectively. If, in addition, `MRG_BYDAY` is set to “A”, then the hourly input files expected by **Smkmerge** for area sources would be the `ATMP_{day}` files. The files for the other source types would remain the same.

The `MRG_BYDAY` option is useful for implementing a Monday-weekday-Saturday-Sunday (MWSS) approach to save processing time for long episodes. This approach is applicable when weekly temporal profiles used by an inventory do not have variation between the five weekdays. In the MWSS approach, Monday is processed separately, because time zone differences across a large domain cause some Sunday emissions for some time zones to be in the Monday file. Additional environment variables other than the defaults in the `Assigns` file need to be set when this option is applied. **Smkmerge** will prompt for a different file for each day of the week, but the logical file names for Tuesday through Friday can be defined as the same file when implementing the MWSS approach.

4.15.2. Processing Order

All other SMOKE core programs except the optional program **Mrggrid** prepare input for the **Smkmerge** program. **Smkmerge** is the last nonoptional SMOKE program to be run.

Individual output files from **Smkmerge** can be merged using **Mrggrid** if desired.

4.15.3. Files and Environment Variables

Figure 4.21. Smkmerge input and output files for area sources

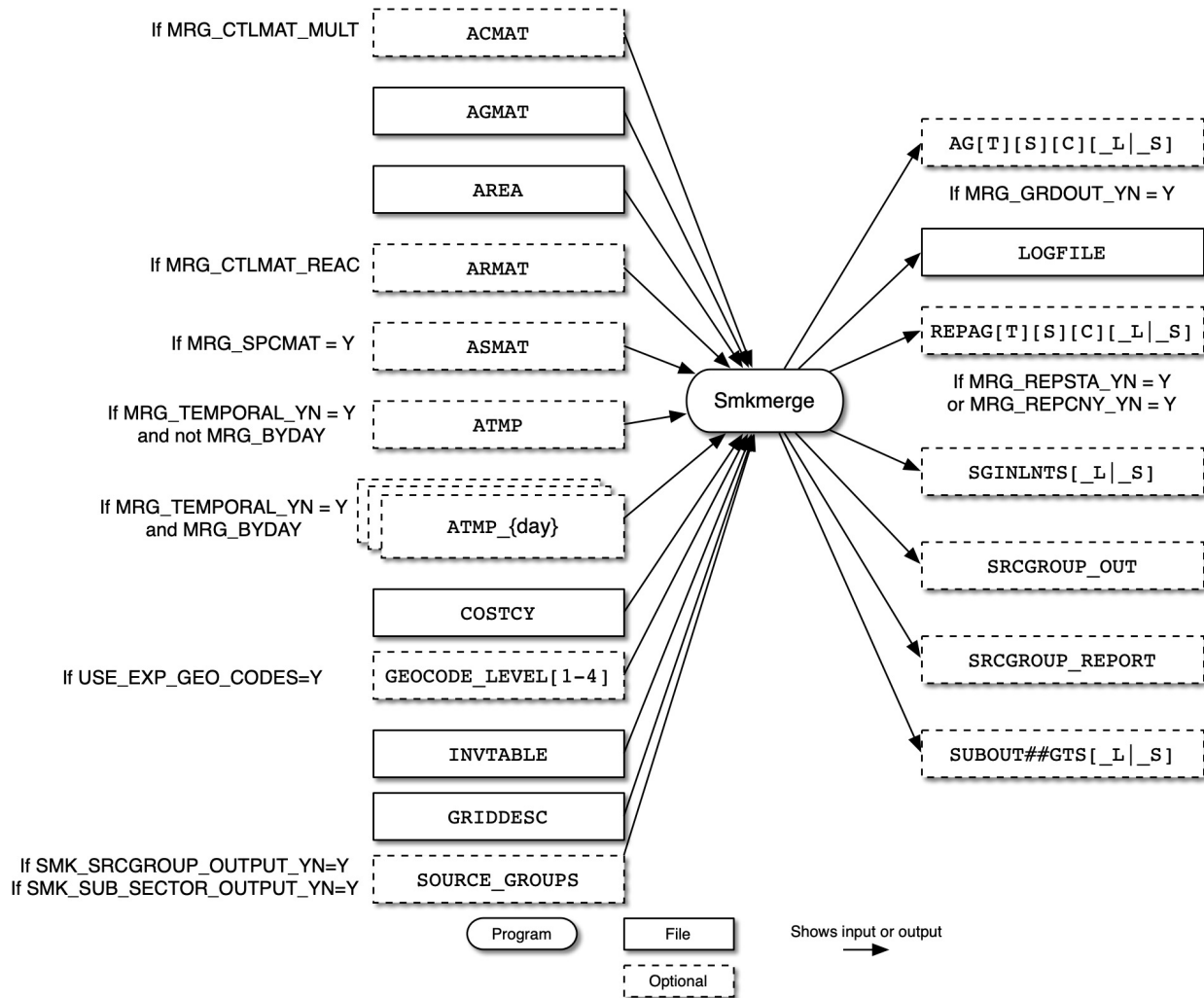


Figure 4.21, “**Smkmerge** input and output files for area sources” [193] shows the input and output files for the **Smkmerge** program for area sources. The inputs include the optional multiplicative control matrix from **Cntlmat** (ACMAT), the gridding matrix from **Grdmat** (AGMAT), the inventory file output from **Smkinven** (AREA), the optional reactivity matrix from **Cntlmat** (ARMAT), and the optional speciation matrix from **Spcmat** (ASMAT). **Smkmerge** can also use hourly emissions from **Temporal**, either a single file (PTMP) or hourly emissions for each day of the week (ATMP_{day}). The last three input files are the country, state, and county codes file (COSTCY), the inventory data table (INVTABLE), and the grid description file (GRIDDESC).

Smkmerge outputs a data file that is determined by the inputs and can be a model-ready emissions file (AG[T][S][C]_L or AG[T][S][C]_S), a log file (LOGFILE), and an optional report file (REPAG[T][S][C]_L or REPAG[T][S][C]_S).

When using source apportionment, **Smkmerge** will also read the source grouping file (`SOURCE_GROUPS`) and output the source group information `SRCGROUPS_OUT`, the emissions for each source group `SGINLNTS_L` or `SGINLNTS_S`, and a source group report file `SRCGRP_REPORT`.

Smkmerge outputs either a mole-based emissions file (`BGTS_L_O`) or a mass-based emissions file (`BGTS_S_O`). Note that `_O` is appended to the output file name to distinguish it from the input file. The program also writes a log file (`LOGFILE`) and an optional report file (`REPBGTS_L` or `REPBGTS_S`).

When using source apportionment, **Smkmerge** will also read the source grouping file (`SOURCE_GROUPS`) and output the source group information `SRCGROUPS_OUT`, the emissions for each source group `SGINLNTS_L` or `SGINLNTS_S`, and a source group report file `SRCGRP_REPORT`.

Figure 4.23. Smkmerge input and output files for mobile sources

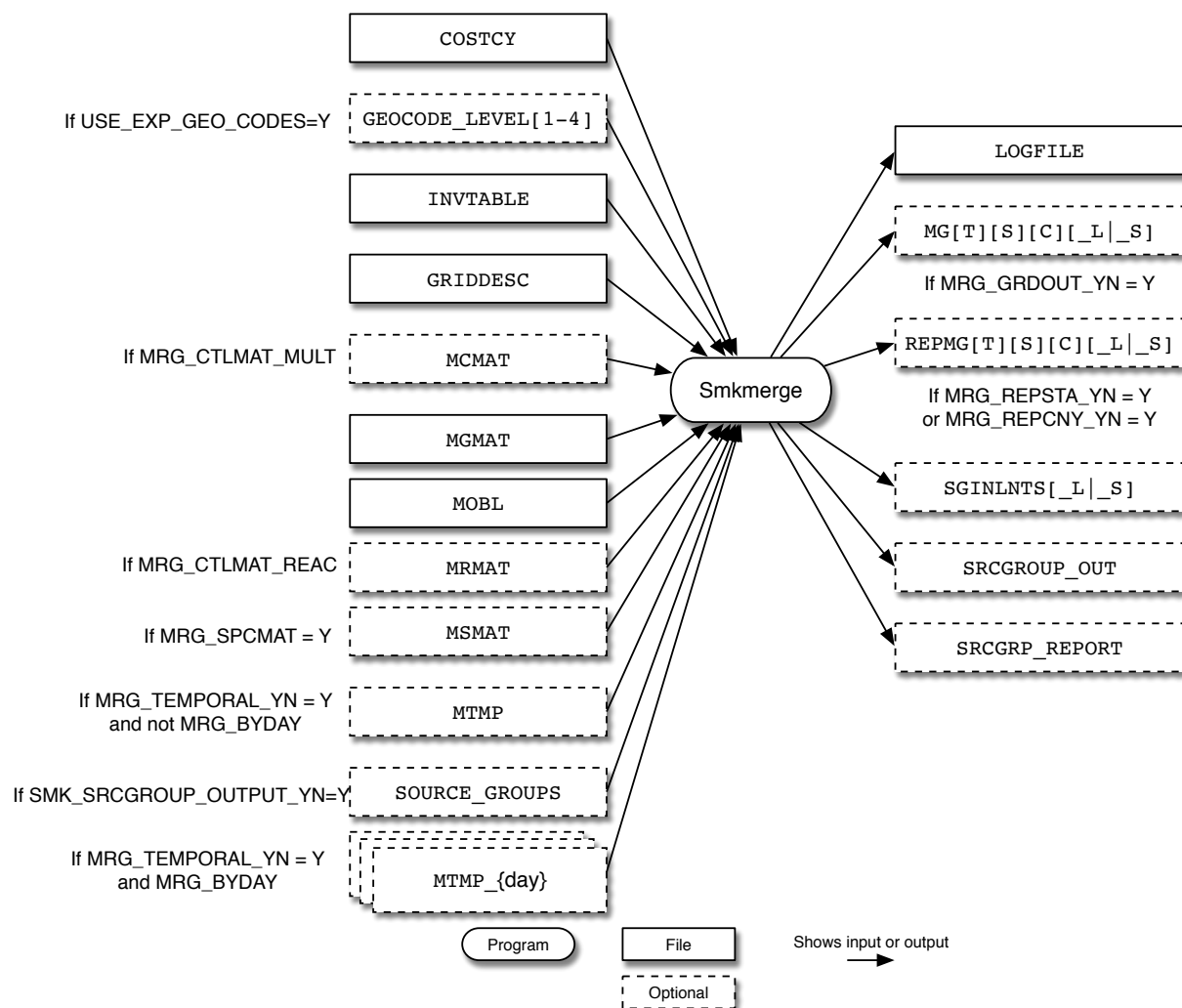


Figure 4.23, “**Smkmerge** input and output files for mobile sources” [195] shows the input and output files for the **Smkmerge** program for mobile sources. The inputs include the country, state and county codes file (COSTCY), the inventory data table (INVTABLE), and the grid description file (GRIDDESC). **Smkmerge** also reads the optional multiplicative control matrix from **Cntlmat** (MCMAT), the gridding matrix from **Grdmat** (MGMAT), the inventory file output from **Smkinven** (MOBL), the optional reactivity matrix from **Cntlmat** (MRMAT), and the optional speciation matrix from **Specmat** (MSMAT_L or MSMAT_S). Hourly emissions can be input either as a single file (MTMP) or as hourly emissions for each day of the week (MTMP_{day}).

Smkmerge outputs a log file (LOGFILE), a data file that is determined by the inputs and can be a model-ready emissions file (MG[T][S][C]_L or MG[T][S][C]_S), and an optional report file (REPMG[T][S][C]_L or REPMG[T][S][C]_S).

When using source apportionment, **Smkmerge** will also read the source grouping file (SOURCE_GROUPS) and output the source group information SRCGROUPS_OUT, the emissions for each source group SGINLNTS_L or SGINLNTS_S, and a source group report file SRCGRP_REPORT.

Figure 4.24. Smkmerge input and output files for point sources

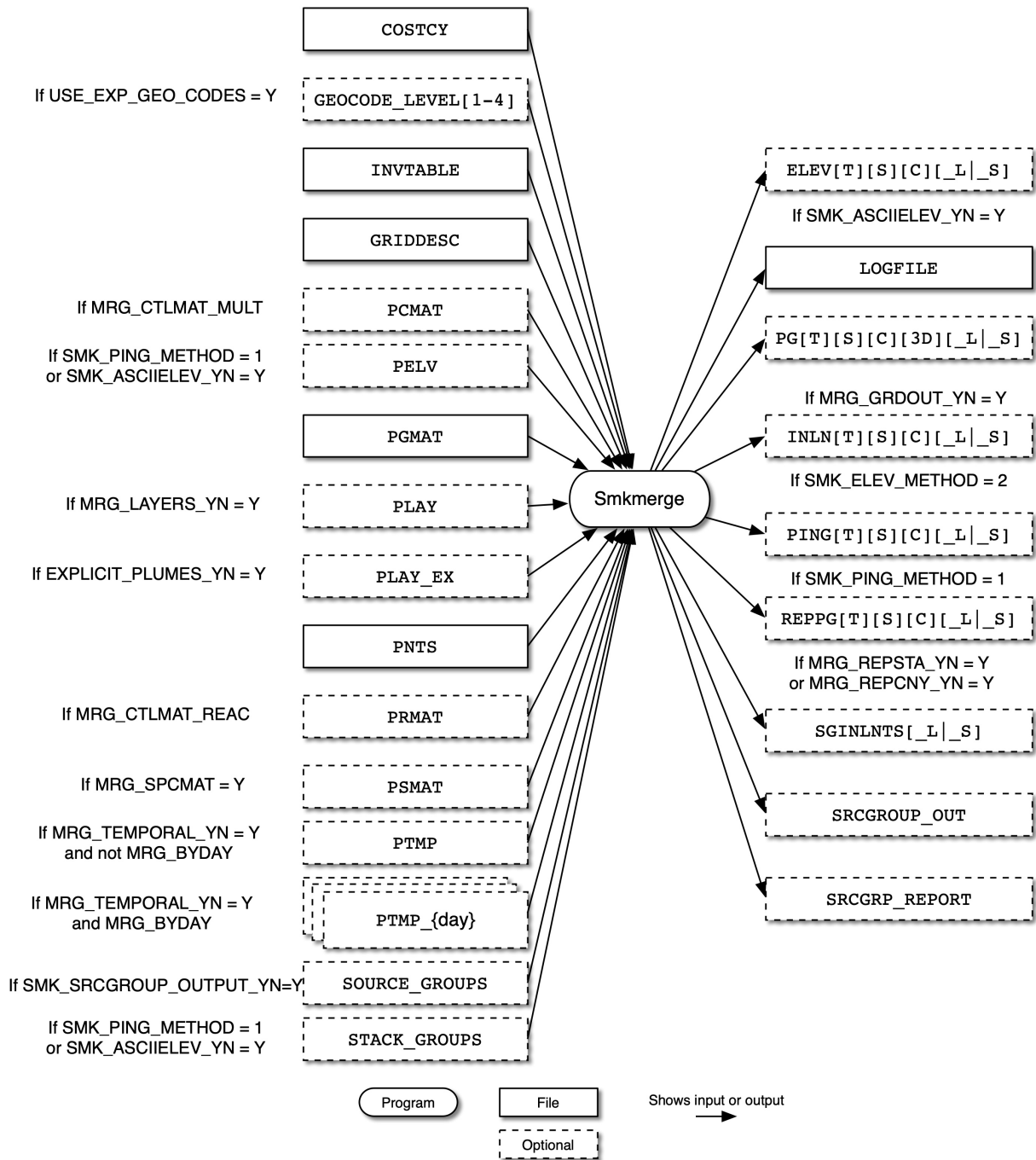


Figure 4.24, “**Smkmerge** input and output files for point sources” [196] shows the input and output files for the **Smkmerge** program for point sources. The inputs include the country, state, and county codes file (**COSTCY**), the inventory data table (**INVTABLE**), the grid description file (**GRIDDESC**), and the optional multiplicative control matrix from **Cntlmat** (**PCMAT**). If using PinG or elevated sources, the **PELV** file is used. **Smkmerge** reads the gridding matrix output from **Grdmat** (**PGMAT**). The **PLAY** file is used to merge layer fractions, while the **PLAY_EX** file is used for explicit plumes. Other **Smkmerge** input files include the inventory file output from **Smkinven** (**PNTS**), the optional reactivity matrix from **Cntlmat** (**PRMAT**), and the optional speciation matrix from **Spmat** (**PSMAT**). The hourly emissions from **Temporal** are

provided either as the PTMP file or as hourly emissions for each day of the week (PTMP_{day}). Finally, **Smkmerge** can read the optional elevated stack groups file (STACK_GROUPS).

Smkmerge can output an elevated sources file (ELEV[T]S[_S|_L]) if requested. Like all other SMOKE programs, **Smkmerge** outputs a log file (LOGFILE) detailing the program's execution. The main data file is determined by the inputs and can include a model-ready emissions file (PG[T][S][C][3D]_L or PG[T][S][C][3D]_S). Other output files can be a PinG file (PING[T][S][C][_S][_L]) and a report file (REPPG[T][S][C]_L or REPPG[T][S][C]_S).

When using source apportionment, **Smkmerge** will also read the source grouping file (SOURCE_GROUPS) and the stack groups file (STACK_GROUPS), and output the source group information SRCGROUPS_OUT, the emissions for each source group SGINLNTS_L or SGINLNTS_S, and a source group report file SRCGRP_REPORT.

Figure 4.25. Smkmerge input and output files for all source categories

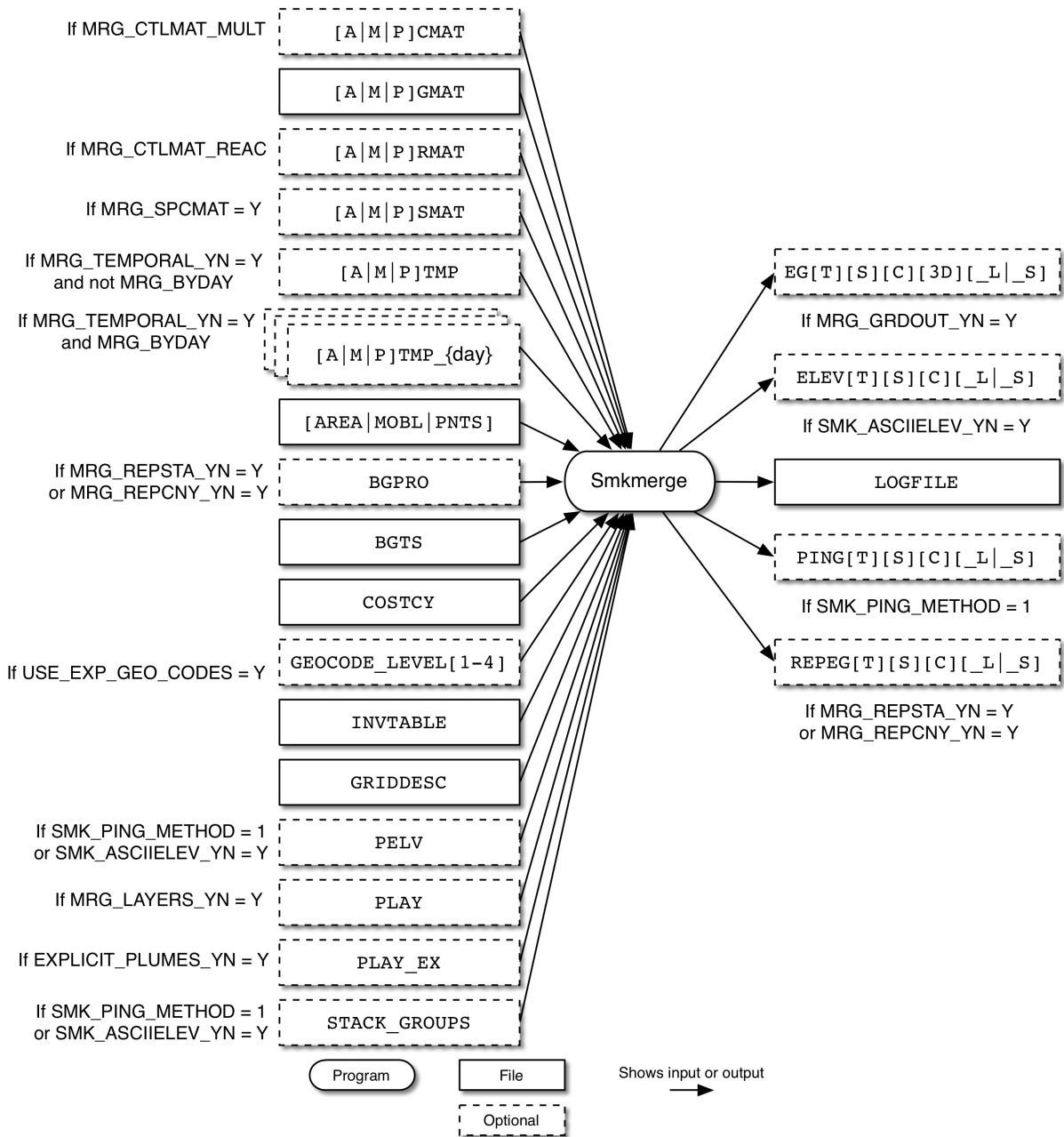


Figure 4.25, “**Smkmerge** input and output files for all source categories” [198] shows the input and output files for the **Smkmerge** program for all sources. The input and output files are a combination of those found in the previous four figures.

4.15.3.1. Input Files

The input files needed depend upon the input environment variables that are set for this program. For example, if only area sources are being merged, then only area-source-related inputs are required. Similarly, if **Smkmerge** is being executed to produce speciated, gridded, temporally allocated area and point sources,

then all area- and point-related inputs for area and point sources, speciation matrices, gridding matrices, and temporal matrices are required.

4.16. Spcmat

4.16.1. Description

Processing categories: area, mobile, point

An emission inventory is built and reported for a variety of compounds or chemical classes such as CO, NO_x, VOC, PM₁₀, and SO₂. However, AQM photochemical mechanisms (e.g., CB6, SAPRC) contain a simplified set of equations that use representative “model species” to represent atmospheric chemistry. Therefore, factors are needed to convert the emissions from the chemical classes in the emission inventory

to the species in the intended photochemical mechanism. The **Spcmat** program produces matrices that contain the factors for performing this conversion.

The speciation factors are provided to **Spcmat** using "speciation profiles", which are applied to the inventory's sources using a "speciation cross-reference". For inventories that contain VOC mass, an additional factor is needed that converts the VOC mass to Total Organic Gases (TOG) mass, since the profiles used for VOC are actually computed based on TOG. The TOG profiles are used (instead of VOC profiles) since some of the TOG mass gets assigned to model species. Using VOC-only profiles would underestimate the volatile mass being emitted. Historically in SMOKE, the VOC-to-TOG conversion factors have been assigned by SCC or FIPS and SCC. Starting with SMOKE version 2.3, however, these factors can optionally be assigned by speciation profile ID codes. In fact, since the VOC-to-TOG factors come directly from the raw data used to create speciation profile factors (such as the SPECIATE4.0 database), the most consistent way to assign these factors is actually by speciation profile ID. SMOKE version 2.3 is backward compatible with existing GSCNV file formats.

Spcmat outputs both mass-based and mole-based speciation factors for all sources. Previous systems have assumed that the average molecular weight of the model species was sufficient to represent the molecular weight of a species emitted by a specific source. In fact, the actual molecular weight of a model species is different for different types of emission processes. To represent the mass values more accurately, the mass and mole factors are input, applied, and output separately by Spcmat.

The speciation cross-reference file input to **Spcmat** specifies the speciation profile to be used for transforming the inventory pollutants to the model species for each source or type of source. **Spcmat** permits profiles to be assigned based on the country, state, and county code, the SCC, and other source characteristics. In the hierarchical system used to apply the profiles, the most specific assignments are applied first, followed by the next most specific, and so on. This system ensures that the most-specific matches override the less-specific ones.

For stationary area/nonpoint sources, the available combinations and their order are the following, starting with the most specific. "Left x of SCC" refers to an 8- or 10-digit SCC with all digits except the first x set to 0. "Left 2 of SIC code" refers to a 4-digit SIC code with the third and fourth digits set to 0. The maximum field width in SMOKE and its input files for SCC is 20 characters as of SMOKE v4.0. The 8 or 10 digit SCC are still supported, but if the SCC is greater than 10 digits the SCC hierarchical approach will not be supported. The SIC may also be up to 20 characters in length, but if the SIC is larger than 4 characters then the hierarchical approach will not be used. (NOTE: only for SCC less than or equal to 10 characters and SIC less than or equal to 4 characters)

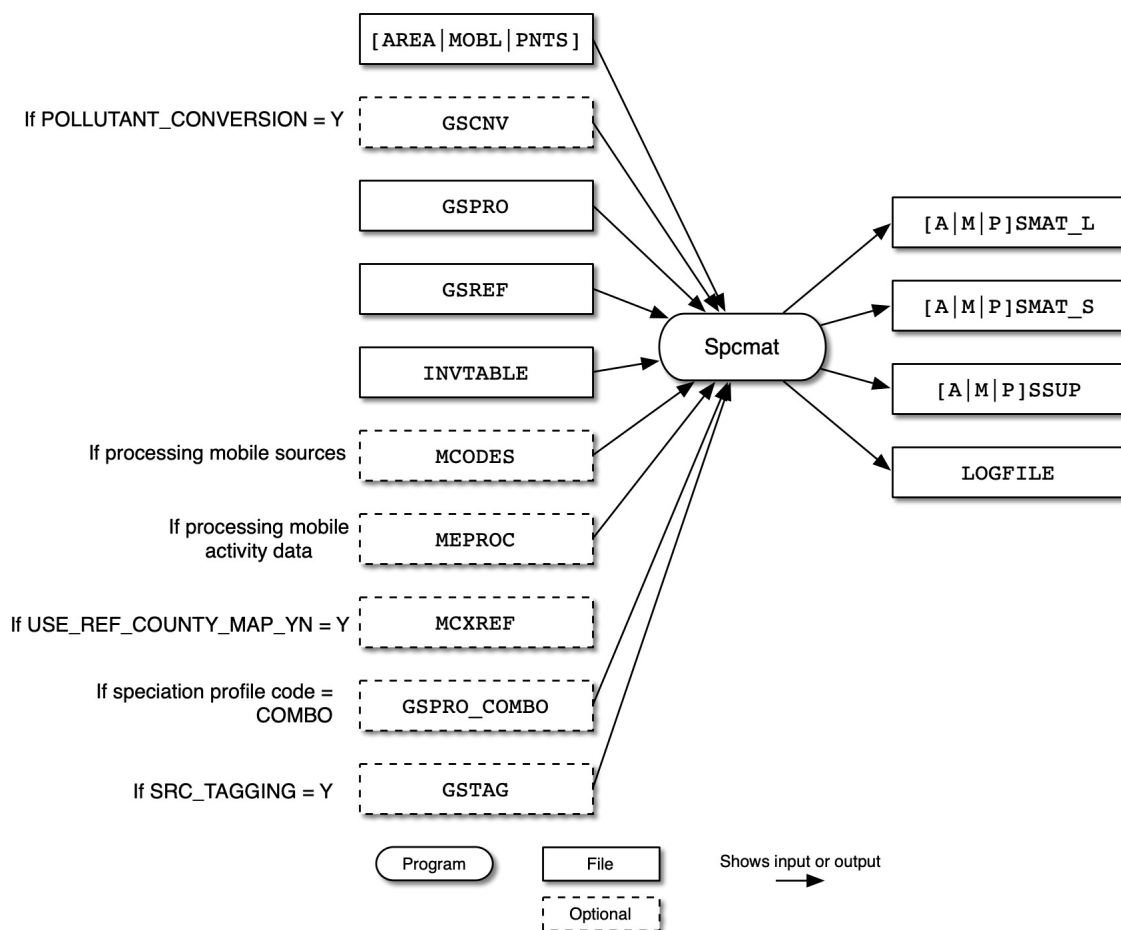


Figure 4.26, “**Spcmat** input and output files” [209] shows the input and output files for the **Spcmat** program. The input files include the inventory file output from **Smkinven** (AREA, MOBL, or PNTS), the optional pollutant conversion file (GSCNV), the speciation profiles file (GSPRO), the speciation cross-reference file (GSREF), the combination speciation profiles file (GSPRO_COMBO), and the inventory data table (INVTABLE). For mobile sources only, **Spcmat** uses the mobile emission processes file (MEPROC). More information of GSPRO_COMBO file is available at Section 6.5.4, “GSPRO_COMBO: Combination speciation profiles file” [306].

4.17. Temporal

4.17.1. Description

Processing categories: area, mobile, point

The **Temporal** program produces a file with hourly inventory pollutant emissions. Unlike the SMOKE matrices produced by **Cntlmat**, **Grdmat**, and **Spcmat**, the output file from **Temporal** contains the actual emissions data. For all source categories, it uses temporal profiles, temporal cross-references, and the time zone of each source to create the hourly emissions output file. It can also read in day-specific and hour-specific inventory data in SMOKE format, and it uses the most detailed data it can when multiple types of data are available for the same source. For example, if a source had annual, day-specific, and hour-specific

data, **Temporal** would use the hour-specific emissions. The program can also apply source-specific hourly profiles from the hour-specific data file, and it can override all temporal profiles and use temporally uniform profiles for all sources.

Temporal treats the temporal profiles as *local* profiles. In other words, the profile applied to the source is adjusted based on the difference between the time zone of the source (determined by the *COSTCY* file) and the output time zone (determined by the *OUTZONE* environment variable). *SMOKE* automatically considers Daylight Saving time when converting from a region's standard time zone to the output time zone, and *SMOKE* can exclude regions that never use Daylight Saving time based on the *COSTCY* file. Note that **Temporal** has been tested for time zones in the Western Hemisphere, but we have not tested it for time zones in the Eastern Hemisphere.

Within the **Temporal** program, the processing occurs as follows:

- Temporal profiles are assigned for all sources.
- Monthly (year-to-month) temporal profiles can be applied.
- Daily (month-to-day) temporal profiles can be applied.
- Weekly (month-to-weekly) temporal profiles can be applied.
- Day-of-week specific hourly diurnal temporal profiles (Monday,,Sunday, Weekday, Weekend, or All days) are applied.
- Date-specific hourly diurnal temporal profiles (year-to-hour, month-to-hour or day-to-hour) can be applied.
- Day-specific emissions or activities are read in and used to overwrite daily emissions for the appropriate sources
- Hour-specific emissions or activities are read in and used to overwrite hourly emissions for the appropriate sources.

Hourly temporal profiles can be applied for weekdays and weekend days by default in the system. By breaking up the processing into different periods, you can apply different temporal profiles for different days of the week. A future version of *SMOKE* will permit different hourly profiles for every day of the week in a single run of the **Temporal** program.

A special holidays file should be provided so that holidays can receive special treatment. This file specifies which daily profiles should be applied to holidays.

A many-step hierarchy is used in applying the temporal cross-referencing. *SMOKE* preferentially matches each source to the most specific line in the cross-reference file. When there are missing entries in the cross-reference file, **Temporal** first looks for cross-reference entries for other species at the same level in the search hierarchy before descending to the next level in the hierarchy. For example, if a source has a temporal cross-reference entry for CO but not for NO_x, **Temporal** uses the source-specific CO temporal cross reference entry for allocating NO_x from that source in preference to using a default NO_x temporal profile.

For area sources, the available combinations are the following, starting with the most specific. "7-digit SCC" means a 10-digit SCC with the last three digits set to zero. The maximum field width in *SMOKE* and its input files for SCC is 20 characters as of *SMOKE* v4.0. The 8 or 10 digit SCC are still supported, but if the SCC is greater than 10 digits the SCC hierarchial approach will not be supported. The SIC may also be up to 20 characters in length, but if the SIC is larger than 4 characters then the hierarchial approach will not be used. (NOTE: only for SCC less than or equal to 10 characters and SIC less than or equal to 4 characters)

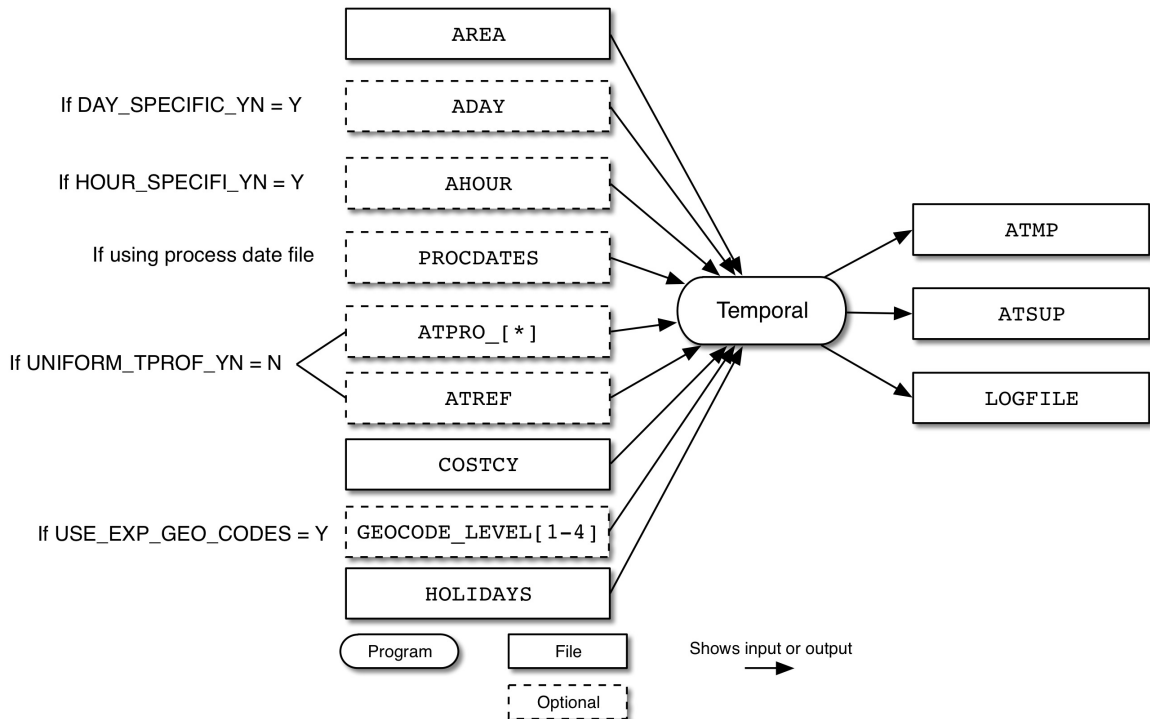


Figure 4.27, “**Temporal** input and output files for area sources” [214] shows the input and output files for the **Temporal** program for area sources. The input files include the inventory file output from **Smkinven** (AREA), the temporal profiles file (ATPRO), the temporal cross-reference file (ATREF), the country, state, and county codes file (COSTCY), the holidays file HOLIDAYS), and optional process date file (PROCDATES).

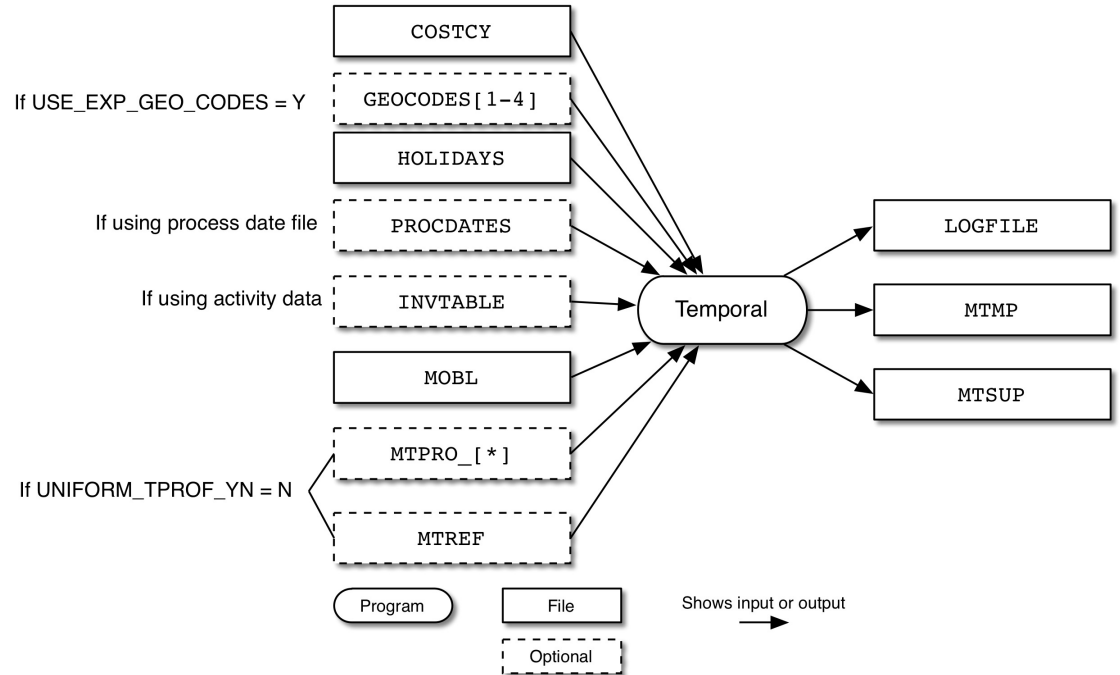
Figure 4.28. Temporal input and output files for mobile sources

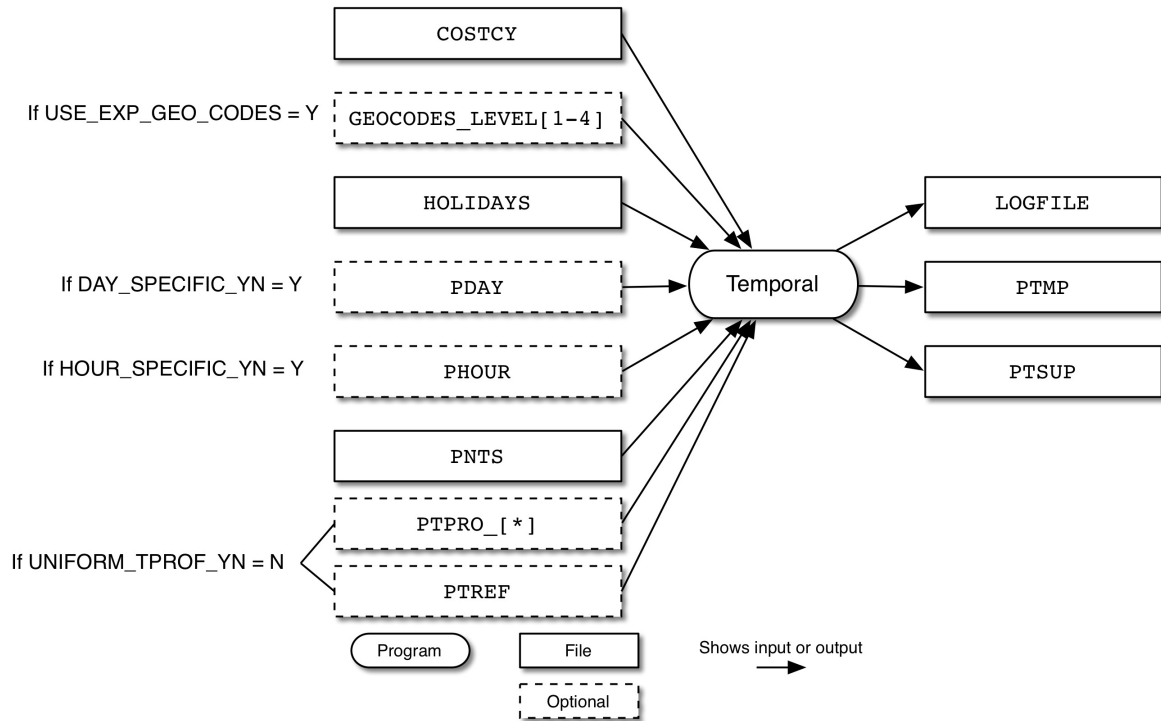
Figure 4.29. Temporal input and output files for point sources

Defines whether the program processes daily/hourly inventories in local time or not.

Table 2.9, “Example OUTZONE settings and their associated time zones” [61] provides allowed values for OUTZONE. The CMAQ model expects OUTZONE to be 0, while other models such as UAM-IV, UAM-V and CAM_x often use time zone 5. All models expect that the emissions and the meteorology data provided to the model will have a consistent time zone. SMOKE expects that the meteorology data will be in GMT.

Note that SMOKE expects OUTZONE to be set as a positive number for time zones in the Western Hemisphere, although standard notation would list these as negative values. For example, Eastern Standard Time is -5:00 hours from GMT, but OUTZONE for EST in SMOKE is 5.

4.18. Tmpbeis3

4.18.1. Description

Processing categories: biogenic

Tmpbeis3 uses version 3.14 or version 3.60 of the BEIS3 model. **Tmpbeis3** reads the gridded, normalized emissions file B3GRD and meteorological data from MET_FILE1 and optionally MET_FILE2 (these files may be either MET_CRO_2D or MET_CRO_3D). Note that **Tmpbeis3** uses temperature and surface pressure data that must be in MET_FILE1, and radiation/cloud data that may be in MET_FILE1 or MET_FILE2. Within **Tmpbeis3**, speciation profiles are used to speciate biogenic pollutants for appropriate chemical mechanisms. Various speciation profiles for the CB6, and SAPRC mechanisms are available for BEIS3 modeling. The normalized emissions and meteorological data are used to produce gridded, speciated, hourly biogenic emissions. Additionally, an optional seasonal switch file, BIOSEASON, can be used to determine when and where to use summer or winter normalized emissions data on a daily basis.

4.18.2. Processing Order

The **Normbeis3** program must be executed before **Tmpbeis3**.

If you are using the seasonal switch option, the seasonal switch file (BIOSEASON) must be created using the utility program **Metscan** before running **Tmpbeis3**.

Tmpbeis3 must be executed before biogenic emissions can be used in **Smkmerge**.

Figure 4.30. **Tmpbeis3** input and output files

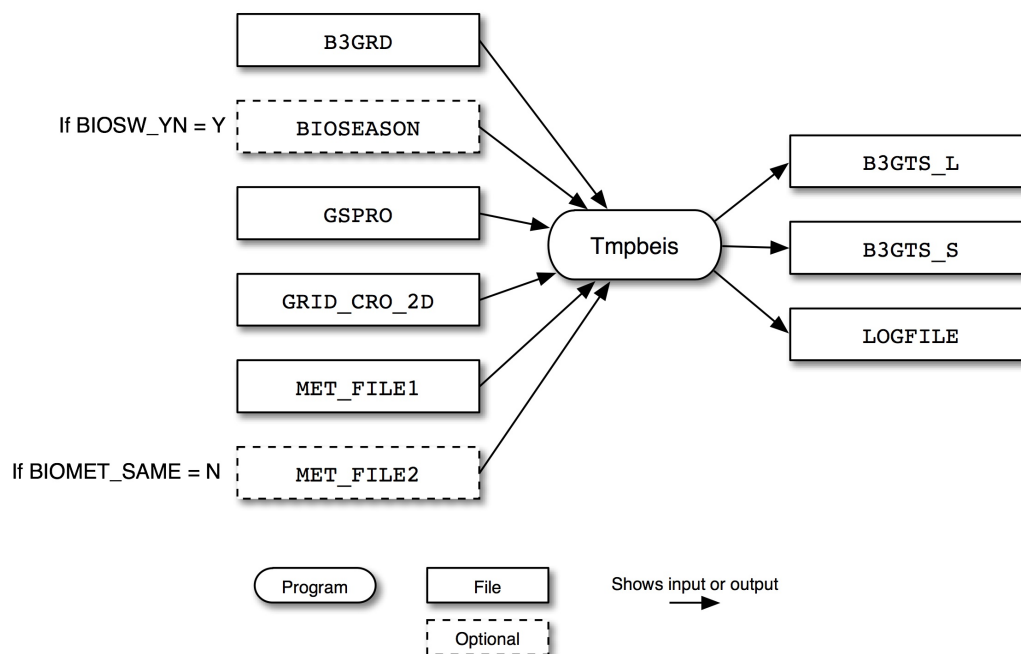


Figure 4.30, “**Tmpbeis3** input and output files” [220] shows the input and output files for the **Tmpbeis3** program. The input files include the gridded, normalized biogenic emissions from **Normbeis3** (B3GRD) and, if BIOSW_YN = Y, then a gridded, seasonal switch file output from **Metscan** is required (BIOSEASON). The biogenic speciation profiles are read from the GSPRO file and the GRID_CRO_2D contains the latitude and longitude for each grid cell. **Tmpbeis3** reads surface pressure and radiation/cloud data from MET_FILE1 and optionally from MET_FILE2 if BIOMET_SAME = N.

Tmpbeis3 outputs gridded, speciated, hourly biogenic emissions files in moles/hour (B3GTS_L) and tons/hour (B3GTS_S). The program also outputs an execution log file (LOGFILE).

Within **Tmpbeis4**, speciation profiles are used to speciate biogenic pollutants for appropriate chemical mechanisms. Various speciation profiles for the CB6, and SAPRC mechanisms are available for BEIS modeling. The normalized emissions and meteorological data are used to produce gridded, speciated, hourly biogenic emissions. Additionally, an optional seasonal switch file, BIOSEASON, can be used to determine when and where to use summer or winter normalized emissions data on a daily basis.

5.1. Introduction

This chapter provides documentation on SMOKE’s quality assurance (QA) capabilities. Quality assurance of emissions modeling results is a very important component of using SMOKE. Because emission modeling is a complex procedure that includes many disparate data sets and many processing steps, it is critical that quality assurance be performed on the emissions modeling results prior to using the model-ready emissions in air quality modeling. Failure to quality assure the results will almost surely result in undesirable errors in SMOKE’s output caused by factors such as user inexperience, file formatting errors, misunderstanding of software capabilities, and software bugs. It is far preferable to catch emissions modeling problems during emissions modeling rather than after the emissions results have already been used and policy decisions made based on them.

SMOKE quality assurance consists of at least the following components:

- Setting up SMOKE using available documentation (this manual) on file formats.
- Reviewing log files for errors and warnings, then resolving any problems.
- Reviewing reports generated by SMOKE core programs (e.g., reports from the **Cntlmat** program indicating which controls were applied and the changes made to the inventory emissions).
- Reviewing and customizing reports generated by the **Smkreport** program, and comparing these to one another and to totals from the emission inventory.

In this chapter, we provide documentation on the **Smkreport** program (Section 5.2, “**Smkreport** Program” [229]), on its main input file REPCONFIG (Section 5.3, “REPCONFIG Input File” [232]), and on the **Smkreport** output reports (Section 5.4, “Reports Created by **Smkreport**” [251]).

5.2. Smkreport Program

5.2.1. Description

Smkreport uses the SMOKE intermediate files generated by other SMOKE programs to create a large variety of emissions and activity data totals to be used for QA of the emissions data. This QA is in addition to the QA performed by other SMOKE programs for checking file formats and input quality, and it focuses on analysis of the emissions values processed and output by SMOKE. **Smkreport** operates on one source category (area, mobile, or point) in a given run, though it does not operate on biogenic emissions because biogenic does not have the same structure of intermediate files that **Smkreport** uses for inputs. Each run of **Smkreport** is also limited to one speciation scenario, one grid projection and resolution, and one hourly emissions file. **Smkreport** can also read in growth or multiplicative control matrices, but not reactivity

control matrices. All of these component datasets are optional, however, and their use is controlled by the settings in the Report Configuration File (REPCONFIG), described in Section 5.3, “REPCONFIG Input File” [232]. Analysis of multiple source categories (area/mobile/point) in the same report is a postprocessing step in which the user can import multiple reports from different source categories and analyze across multiple source categories.

The most important input file to **Smkreport** is the REPCONFIG file. Through this file, you have a tremendous amount of flexibility in generating different types of reports. Options are invoked by using reporting “instructions”, which you prepares before using **Smkreport**. See the REPCONFIG documentation in Section 5.3, “REPCONFIG Input File” [232] for more information on the reporting options. Additionally, in Section 1, “Quality Assurance Methods” [?] we provide some guidance on the types of analyses you can perform using reports created by **Smkreport**, and reasons why you might want to use those analyses.

Smkreport can generate multiple reports with a single run of the program. Multiple report writing is helpful, because a large part of the time that the program takes to run is reading in the SMOKE intermediate files. Note that the multiple reports are all for a single source category for one run of **Smkreport**. As described in the Section 5.4, “Reports Created by **Smkreport**” [251], the report output names are configured by the REPCONFIG file. You may specify either physical file names (including the path) in REPCONFIG, or you may specify logical file names and then make sure your script sets the logical file names to physical file names.

5.2.2. Processing Order

Smkreport can only be used after *at least* **Smkinven** (for inventory import) has been run. Depending on the reporting options selected in the REPCONFIG input file, other processing steps may need to have been run. For example, to create a report of county total emissions after gridding, the **Grdmat** (for spatial allocation) program must have been run already to create the gridding matrix. **Smkreport** can use output files from the following programs: **Smkinven**, **Temporal** (for temporal allocation), **Spmat** (for chemical speciation), **Grdmat**, **Elevpoint** (for elevated source selection), **Laypoint** (for plume rise calculations), and **Cntlmat**.

5.2.3. Files and Environment Variables

5.2.3.1. Input Files

The input files depend upon the SMK_SOURCE input instruction in the REPCONFIG input file setting when the program is started. With the exception of the SMOKE intermediate inventory file (AREA, MOBL, PNTS), whether a file is optional or not depends on the settings in REPCONFIG. If **Smkreport** is being executed to produce speciated, gridded, temporally allocated area sources, for instance, then the area-source inventory, speciation matrix, gridding matrix, and hourly emissions are required. Also, the source category of the input file depends on the REPCONFIG file setting for SMK_SOURCE. For example, if only area sources are being merged (SMK_SOURCE is set to A), then only area-source-related inputs are required.

5.2.3.2. Input Environment Variables

- USE_EXP_GEO_CODES: [default: N]

If set to Y, this variable is used to specify the use of expanded 12-character geographic codes contained in the **GEOCODE_LEVEL[1-4]** input files. For **Smkreport**, it controls which ASCII GEOCODE file to use. The user can select the data extraction summary format in the REPCONFIG file. If the REPCONFIG file contains CARB_QADEF setting, then **Smkreport** creates reports in the CARB QA Data Extraction Format. If the REPCONFIG file contains the BY GEOCODE_LEVEL1[NAME] or BY GEOCODE_LEVEL2[NAME] or BY GEOCODE_LEVEL3[NAME] or BY GEOCODE_LEVEL4[NAME] then **Smkreport** creates reports at each geographic level with its description and local time zone.

- MRG_GRDOUT_UNIT: [default: blank]

This variable is the same one used to control the **Smkmerge** output units. For **Smkreport**, it controls which ASCII elevated file to use, when the ASCIIELEV instruction is included in the REPCONFIG file. If the first letter of this setting is an “m” (for mole), then **Smkreport** opens the ELEVTS_L file to use in the report; otherwise, **Smkreport** opens and uses the ELEVTS_S file. This setting does not do anything to the behavior of **Smkreport** unless the ASCIIELEV setting is included in the REPCONFIG file. The default setting of MRG_GRDOUT_UNIT results in the ELEVTS_S file being used by **Smkreport**.

- REPORT_ZERO_VALUES: [default: N]

Determines if **Smkreport** should keep report entries whose data values are all zero

- Y: Print entries whose values are zero
- N: Do not print entries whose values are zero

5.2.3.3. Output Files

5.3. REPCONFIG Input File

The REPCONFIG file is used to control the **Smkreport** program. As noted earlier, each run of **Smkreport** is constrained to a single source category (area, mobile, or point), at most one speciation scenario, at most one grid, and at most one hourly emissions file. All of these component datasets are optional, however, and their use is controlled by the settings in REPCONFIG. This file also controls the number and types of reports created by **Smkreport**, which can create an unlimited number of reports in each program run.

The file works on the principles of “packets” and “instructions”. Packets are groups of instructions or a single action that have been predefined by the `REPCONFIG` file format to control the **Smkreport** outputs; instructions are settings that tell **Smkreport** what to do. Some types of packets must appear in one of three sections, while other packets can appear anywhere in the `REPCONFIG` file. The three sections are: “One-time” (see Section 5.3.1, “One-time section” [233]), “Define-group” (see Section 5.3.2, “Define-group section” [234]), and “Create-report” (see Section 5.3.3, “Create-report Section” [236]); each file section has a large number of options. In this section of the chapter, we first provide details on these three file sections and their packets, and then we describe four additional packets that can appear between other packets at any point in the `REPCONFIG` file.

The full list of packets that one can use in the `REPCONFIG` input file are as follows:

One-time section (Section 5.3.1, “One-time section” [233])

- `SMK_SOURCE`

Define-group section (Section 5.3.2, “Define-group section” [234])

- `/DEFINE GROUP REGION/`
- `/DEFINE SUBGRID/`

Create-report section (Section 5.3.3, “Create-report Section” [236])

- `/CREATE REPORT/`

Packets that can appear anywhere in the file

- `/DELIMITER/` (Section 5.3.4, “The `/DELIMITER/` packet” [249])
- `/AVEDAY/` (Section 5.3.7, “The `/AVEDAY/` packet” [250])
- `/REPORT TIME/` (Section 5.3.6, “The `/REPORT TIME/` packet” [250])
- `/NEWFILE/` (Section 5.3.8, “The `/NEWFILE/` packet” [250])
- `/SET LABEL/` (Section 5.3.5, “The `/SET LABEL/` packet” [249])

Comments can be put in the file using a pound sign (`#`) at the first column of a line, or a double pound sign (`##`) anywhere else on a line. The double pound can appear after packet labels or instructions in the file.

Finally, note that the maximum number of characters that can be read on any line in this file is 300. This can be important in particular for the `SELECT DATA` instruction.

5.3.1. One-time section

The first section of the file is the One-time section, and it is a required section. This section is used for setting the environment variables that control **Smkreport** for all reports in a given run. The variables are set by listing the environment variable as an instruction, followed by its value. No `setenv` command (used in the C shell) is needed, because `SMOKE` is interpreting these values directly. At this time, the one instruction available in the One-time section is the `SMK_SOURCE` variable:

`SMK_SOURCE`: Set as “A”, “M”, or “P”, for area-source reporting, mobile-source reporting, and point-source reporting, respectively.

An example of the way this setting would appear in the `REPCONFIG` file is the following:

SMK_SOURCE A

5.3.2. Define-group section

The second section of the REPCONFIG file is the Define-group section. This optional section is used for defining groups of source characteristics for use later in the Create-reports section. The Define-group section uses packets for defining groups. There are currently two types of groupings, and therefore two packet types for this section: regions and subgrids.

5.3.2.1. /DEFINE GROUP REGION/ packet

The /DEFINE GROUP REGION/ packet is used for defining groups by the country, state, and county codes in the inventory. The packet contains the following entries.

- /DEFINE GROUP REGION/ <Label>

Must appear to start the packet. A label (see below) is required for naming the group.

- INCLUDE and/or EXCLUDE instruction(s) (see below). These are optional.

Country, state, and county codes in format NSSCCC, where N is the country number, SS is the state code, and CCC is the county code. Zeros can be used in place of CCC to select all counties in a state, or in place of SSSCC to select all counties and states in a country.

- /END/

Must appear to end the packet.

5.3.2.2. /DEFINE SUBGRID/ packet

The /DEFINE SUBGRID/ packet is used for defining subdomains based on cell numbers from the full grid being applied using the gridding matrices. The packet contains the following entries.

- /DEFINE SUBGRID/ <Label>

Must appear to start the packet. A label (see below) is required for naming the subgrid.

- INCLUDE and/or EXCLUDE instruction(s) (see below) These are optional.

(X cell, Y cell):

Cell numbers should appear for all cells in the subgrid. The count (i.e. the x-cell count and the y-cell count) of the cells depends on the grid defined by the gridding matrix being used by **Smkreport**. A range can be given with the following syntax:

(X cell, Y cell) TO (X cell, Y cell)

If only one cell is to be specified, the range must still appear, with both entries indicating the same cell.

Smkreport is not very sensitive to the spacing of this instruction, and additional spaces or no spaces may be placed between the parentheses, the cell numbers, and the commas. Spaces around the "TO" are recommended.

The maximum width of these lines is 100 characters. Multiple entries of this type may appear in the packet, allowing for the grouping of spatially unconnected cells/regions or non-rectangular regions.

- /END/

Must appear to end the packet.

5.3.2.3. Group labels

Group labels, denoted above by <Label>, are used to name a group for identification when creating a report in the Create-report section. The text appearing in the placeholder <Label> can be any alphanumeric combination of characters up to 200 characters, including intervening blanks. The text string (less trailing blanks) that occurs after /DEFINE .../ and before a comment (indicated with ##), is treated as the group label. References to the group label in the Create-report section do not have to be consistent in the case of the text; SMOKE will ignore the case of the text, treating lower- and uppercase characters as if they were the same.

5.3.2.4. INCLUDE and EXCLUDE instructions

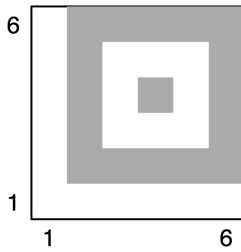
The INCLUDE and EXCLUDE instructions are used for defining the meaning of the entries in the packet. If the INCLUDE instruction appears, then **Smkreport** interprets the subsequent entries in the packet as identifying records to *include* in the output report(s). On the other hand, if the EXCLUDE instruction appears, then **Smkreport** interprets the subsequent entries in the packet as identifying records to *exclude* from the output report(s). The INCLUDE and EXCLUDE instructions may appear in both the /DEFINE GROUP REGION/ and /DEFINE SUBGRID/ packets. These instructions act as toggle switches, and **Smkreport** will give a warning if a county previously included is later excluded. All packet entries after an instruction will be interpreted according to the instruction, until another instruction is given, or until the packet ends. The INCLUDE instruction is the default, so if neither instruction is given, SMOKE will assume that the records in the packet are those to be only in the report.

The ordering of INCLUDE or EXCLUDE instructions in a group definition can change the meaning of the group definition. If INCLUDE is given first, **Smkreport** will initialize the group to exclude all grid cells and then proceed with interpreting the instructions. On the other hand, if EXCLUDE is given first, **Smkreport** will initialize the group to include all grid cells. Here is an example for a small 6-cell by 6-cell grid, which shows how the order of the INCLUDE and EXCLUDE statements changes the meaning of a group definition.

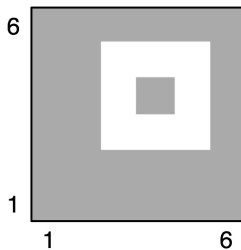
If the instructions are

```
/DEFINE SUBGRID/ Example subgrid
  INCLUDE
    ( 2,2) TO ( 6,6)
  EXCLUDE
    ( 3,3) TO ( 5,5)
  INCLUDE
    ( 4,4) TO ( 4,4)
/END/
```

then the following cells (shown in gray) will be selected:



If the instructions were rearranged to have the EXCLUDE statement first, then the initialized status for all cells would be INCLUDE. The additional INCLUDE statements are therefore unneeded, and the definition of the group changes to the following:



5.3.2.5. Future grouping options

As noted above, the REPCONFIG file currently can have only two possible groups in the Define-group section (regions and subgrids) In the future, other types of groups could be permitted if a need for them is identified:

- /DEFINE GROUP SCC/: Permits user-defined SCC groups
- /DEFINE GROUP PLANT/ Permits user-defined groups by country/state/county code and plant ID
- /DEFINE GROUP STACK/ Permits user-define groups by country/state/county code, plant ID, and stack ID
- /DEFINE GROUP POINT/ / Permits user-define groups by country/state/county code, plant ID, stack ID, and point ID
- /DEFINE GROUP SOURCE/: Permits user-defined source groups by SMOKE source ID
- /DEFINE GROUP HOURS/: Permits user-defined hour groupings

5.3.3. Create-report Section

The third section of the REPCONFIG file is called the Create-report section. It is responsible for providing instructions to **Smkreport** for generating the reports. The /CREATE REPORT/ packet is used in this section. This packet uses the following types of instructions (listed in alphabetical order):

- ARRANGE
- ASCIIELEV

- BY
- CONTROL
- GRIDDING
- LAYFRAC
- NORMALIZE
- NUMBER
- PROJECTION
- SELECT
- SPECIATION
- TEMPORAL
- TITLE
- UNITS

By using these instructions (some of which have a number of different options), many different types of outputs can be achieved by **Smkreport**. The ordering of the instructions in the packet is not important, *with one exception*: if multiple titles are used, they will be printed to the report in the order in which they appear in the packet. The remainder of this subsection provides descriptions of each of these instructions.

5.3.3.1. AERMOD instruction

The AERMOD instruction causes **Smkreport** to generate the customized summary reports for SMOKE4AERMOD post-processing scripts [<https://github.com/CEMPD/SMOKE/tree/master/scripts/aermod>] that create AERMOD helper input files. The report includes daily total emissions by the grid cell, states, counties, SCC, temporal profiles assignments, grid cell coordinates, and so on. The list of output contents varies by the type of inventory source. For stationary point sources, it will include a few additional variables, such as point source facility ID, unit ID, release point ID, process ID, and stack parameters (stack height, stack diameter, exit gas temperature and exit gas velocity).

The syntax of the AERMOD instruction is:

```
AERMOD <option 1> <option 2>
```

with the following valid options:

- option 1: There are two options. One is for stationary point sources [POINT] and the other is for area sources [NONPOINT].
- option 2: This option 2 is only applicable when option 1 is defined as [POINT]. PTEGU is designed for point sources with hourly CEM inventory dataset, and PTNONIPM is for the rest of stationary point sources.

See the example:

- AERMOD [POINT | NONPOINT] [PTEGU | PTNONIPM]

5.3.3.2. ARRANGE instruction

The ARRANGE instruction controls the arrangement of variables and files for a single report. This instruction sets how many variables are included in a report or a section of a report, and can set the number of sections that a report will have. It also permits a database format that includes an emissions data value for each record in the report.

If no ARRANGE instruction is provided for a report, **Smkreport** will attempt to write all of the variables requested in the report to the same file and section. If too many variables are requested in the report, this could cause **Smkreport** to abort with an error. *In general, if you have more than 20 variables that will be written to a given report, you should consider using the ARRANGE instruction.*

The syntax of the ARRANGE instruction is:

```
ARRANGE <option>
```

with the following valid options:

- **MULTIFILE** [*number of variables*]: Writes the report into multiple output files. This is different from the **Smkreport** capability of creating multiple reports: the instruction applies to a single report and indicates that the report should be output as multiple files. The file names in this case are created automatically by **Smkreport** based on the file name set by the associated NEWFILE instruction (explained in Section 5.3.8, “The /NEWFILE/ packet” [250]), by appending a “_1”, “_2”, “_3”, and so forth to the file name that would otherwise be output by **Smkreport**. For example, if the output report setting REPORT1 is defined as /outdir/test/report1.myfile.txt, but that report requires two files, then the actual files that would be written would be /outdir/test/report1.myfile.txt_1 and /outdir/test/report1.myfile.txt_2.

The *number of variables* option controls the number of variables written to each file of the report. For example, if the report will include 100 variables and the number of variables is set to 15, then **Smkreport** will create a report using seven separate files, six that include 15 variables (taking care of the first 90 variables) and a seventh file that has the remaining 10 variables. *Smkreport allows a maximum of 30 variables per file using the MULTIFILE instruction.*

- **ONEFILE** [*number of variables*]: Writes the report into a single output file with multiple sections. Like the MULTIFILE option, this is different from the **Smkreport** capability of creating multiple reports: the instruction applies to a single report, but permits multiple sections of the report to be written to the same file.

The *number of variables* option controls the number of variables written to each section of the report. The number of sections is set automatically by dividing the number of data variables selected for the report by the number of variables.

- **DATABASE**: Writes the report one variable at a time, with only one data variable on each row of the report. The attributes of the row are repeated for all variables, and all entries are written for one variable before the next variable is written. For example, if a report BY SCC10 is requested for the variables NOX and SO2, the report will list all SCCs with the NOX emissions as a data variable, followed by all SCCs again with SO2 emissions. Without the DATABASE instruction, the NOX and SO2 values would be written to the same line of the report and the SCC codes would be written only once.

5.3.3.3. ASCIIELEV instruction

The ASCIIELEV instruction causes **Smkreport** to use the elevated ASCII emissions file (ELEVTS_L or ELEVTS_S) written by **Smkmerge** as the sole source for emissions information in the report. This option can be used only for point sources (SMK_SOURCE is set to P). When this option is included in a REPCON-

FIG file, all other reports in the REPCONFIG file must also include the ASCIIELEV instruction, or **Smkreport** will produce an error.

Using this instruction, **Smkreport** will use the emissions in the ELEVTS_S or ELEVTS_L file as the sole source of emissions and inventory information. These files include information about the states, counties, plants, stacks, stack parameters, hour, cell number, and speciated emissions. Therefore, only certain instructions may be used with the ASCIIELEV instruction, or else a warning will be printed to the log file and the unusable instruction will be ignored. The following subset of /CREATE REPORT/ instructions can be used with the ASCIIELEV instruction:

- ARRANGE
- BY <COUNTRY | STATE | COUNTY | CELL | ELEVSTAT | HOUR | PLANT | SOURCE | STACK>; other BY options will be ignored
- NORMALIZE
- NUMBER
- SELECT
- TITLE
- UNITS

The following instructions are implied by the ASCIIELEV instruction:

- CONTROL (implied only if the emissions in the elevated ASCII file are controlled)
- GRIDDING
- PROJECTION (implied only if the emissions in the elevated ASCII file are grown)
- SPECIATION [MASS|MOLE] (which option is used depends on the MRG_GRDOUT_UNIT setting, described below)
- TEMPORAL

5.3.3.4. BY instruction

The BY instruction controls what columns in addition to data columns will be printed in the output report. Multiple BY commands may appear in the same /CREATE REPORT/ packet, but not all combinations make sense. The BY instructions tell the program the basis on which to sum the emissions or activity values. The syntax of the BY instruction is:

BY <option>

with the following valid options:

- BOILER [NAME]: Records are printed by ORIS boiler code. NAME can be appended to the option to additionally output the ORIS facility description (from the ORISDESC file).
- CELL: Records are printed by cell. This option requires the GRIDDING instruction, so **Smkreport** automatically adds the GRIDDING instruction when the BY CELL instruction is used (even if it is not actually in the REPCONFIG file).

- **COUNTRY [NAME]**: Records are printed by country total. This option invokes use of the **COSTCY** file. **NAME** can be appended to the option to additionally output the country name instead of only the country number.
- **COUNTY [NAME]**: Records are printed by county total. This option invokes use of the **COSTCY** file. **NAME** can be appended to the option to additionally output the county name instead of only the county number.
- **DOMCODE**: Records are printed by Day of Month profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.
- **ELEVSTAT [STACKGROUP]**: Records include the status of sources as elevated (E), plume-in-grid (P), and low-level (L). All elevated statuses could appear in the same report, depending on the inventory and elevated source selection criteria. **STACKGROUP** can be appended to the option to additionally output stack group number from **PELV**. This instruction can be used for point sources only.
- **FACILITY [NAME]**: For point sources, emissions can be printed at the **FACILITY** level, replicating the existing **PLANT** option. **NAME** can be appended to the option to additional output the name of the facility.
- **FRICODE**: Records are printed by Friday diurnal profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.
- **GEOCODE_LEVEL1**: Records are printed by the Country-level geographic code.
- **GEOCODE_LEVEL2**: Records are printed by the State-level geographic code.
- **GEOCODE_LEVEL3**: Records are printed by the County-level geographic code.
- **GEOCODE_LEVEL4**: Records are printed by the Tribal-level geographic code.
- **HOURL**: Records are printed by hour total for each day. This option implies the **TEMPORAL** instruction, so **Smkreport** automatically adds that instruction even if it was not included in the input.
- **INTEGRATE**: Records are printed by the integration status of sources. “Y” will appear for the integrated sources that were used to calculate the **NONHAP[VOC|TOG]** inventory pollutant.
- **LAYER**: For point sources, daily emissions are printed by vertical layer. This option implies the **LAYFRAC** option (discussed later) that requires input of the **PLAY SMOKE** intermediate file. In the report, records are written first for one layer, then the next, and so on. Only records with nonzero emissions in a layer are written. When used to together with the **HOURL** instruction (above), emissions will be written by hour as well as by layer. Since the number of records the report when using **HOURL** instruction is very large, we recommend that a source group be used to subselect the inventory records when appropriate.
- **MACT [NAME]**: Records are printed by **MACT** code. **NAME** can be appended to the option to additionally output the **MACT** code description (from the **MACTDESC** file) instead of only the **MACT** code.
- **MATBURNED**: For wildfire point sources, records are printed by **MATBURNED** code.
- **METCODE**: Records are printed by Meteorology-based hourly profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.
- **MONCODE**: Records are printed by Mothly profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.

- **MNDCODE**: Records are printed by Monday diurnal profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.
- **NFDRSCODE**: For wildfire point sources, records are printed by NFDRSCODE code.
- **NAICS [NAME]**: Records are printed by NAICS code. NAME can be appended to the option to additional output the NAICS code description (from the NAICSDESC file) instead of only the NAICS code.
- **ORIS [NAME]**: Records are printed by ORIS facility code. NAME can be appended to the option to additionally output the ORIS facility description (from the ORISDESC file).
- **PLANT [NAME]**: For point sources, emissions are printed by plant total. This option cannot be used in conjunction with the BY SOURCE option; if the REPCONFIG file contains both instructions, SMOKE will ignore the BY PLANT instruction.

When the NAME option is included, the plant name will be included in the report. Otherwise, only the plant number will be included.

- **ROADCLASS**: Records are printed by road class total. This option can only be used for mobile sources.
- **SATCODE**: Records are printed by Saturday diurnal profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.
- **SCC [N] [NAME]**: Records are printed and summed by all or part of the SCC, depending on the value of N, which can be set to 1, 2, 3, or 4. These numbers correspond to the SCC levels described in Section 2.2.5, “Source Classification Codes” [11]. When N = 4, the full SCC is used. When N = 1, 2, or 3, the records are summed and reported by the corresponding SCC level. Differences between point and nonpoint/mobile SCCs are handled as described by the SCC structures. If no value is given, N is assumed to be 4 by default.

The NAME option can be used for any N value. The SCC description is truncated assuming that semicolons separate the different parts of the SCC descriptions. If there are more than 3 semicolons in an SCC description (dividing into 4 parts), then all of the SCC sections after part 3 are put into part 4. The SCC description written by **Smkreport** will match the value of N by including all parts of the SCC description up to and including the value of N.

- **SCC10 [NAME]**: This option maintains backward compatibility with previous versions of **Smkreport**. It is the same as the option "SCC 4 [NAME]".
- **SIC [NAME]**: Records are printed by SIC totals.

When the “NAME” option is included, the SIC name will be included in the report. Otherwise, only the SIC code will be included. As with the BY SCC10 NAME instruction, the BY SIC NAME instruction will change the column delimiter from a semi-colon to the pipe symbol (“|”). The SIC name will also be enclosed in double quotes.

- **SOURCE [STACKPARAM] [NAME] [LATLON]**: Records are printed by source totals. Source characteristics are printed as well:
 - Point: country/state/county code, plant ID, stack ID, point ID, segment ID, SCC, and SIC
 - Area: country/state/county code and SCC
 - Mobile: country/state/county code, road type code, vehicle type code, link ID, and SCC

For area and mobile sources, the SCC descriptions will automatically be included in the report. This is the same as adding the “BY SCC10 NAME” instruction to the report instructions. There is no way to turn off this feature.

For point sources, STACKPARAM can be appended to the option to also output the stack parameters (height, diameter, exit velocity, exit temperature). Also for point sources, NAME can be appended to the option to get the facility names in the output file. LATLON can be appended to the option to print each source’s x- and y-coordinates.

- SPCCODE <POLLUTANT>: Records are printed by speciation profile codes assigned to sources by the speciation cross-reference file. *Only one pollutant can appear with this command throughout the entire REPCONFIG file.* The pollutant should be one that is in the inventory file and that was processed as part of the chemical speciation file run. This BY option does not imply the SPECIATION instruction (see below), and it can be used without included speciated emissions in the report. For example, the BY SPCCODE instruction may be used to indicate which speciation profiles were assigned to total VOC emissions (without reporting speciated VOC emissions). **NOTE: this BY SPCCODE option can't be used more than once in a REPCONFIG file.**
- SRCTYPE: Records are printed by source type code.
- SRGCODE [FALLBACK]: Records are printed by surrogate codes assigned to sources by the gridding cross-reference file. If no option is used, both primary and fallback surrogate codes are included in the output report. If the FALLBACK option is used, only the fallback surrogate codes are included in the output report, and a zero is used for all records that did not use a fallback surrogate (i.e., their primary surrogate did not cause emissions to go to zero). This BY option does not imply the GRIDDING instruction (see below); therefore, it can be used without applying the gridding matrix in the report. A value of -9 is used for fallback surrogate IDs in the resulting report.
- STATE [NAME]: Records are printed by state totals. This option invokes the use of the COSTCY file. NAME can be appended to the option to additionally output the state name instead of only the state number.
- SUNCODE: Records are printed by Sunday diurnal profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.
- STACK [NAME]: For point sources only, records are printed as facility and stack totals. NAME can be appended to the option to get the facility names in the output file.
- THUCODE: Records are printed by Thursday diurnal profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.
- TUECODE: Records are printed by Tuesday diurnal profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.
- UNIT [NAME]: For point sources, emissions are printed by facility and unit total. This option cannot be used in conjunction with the BY SOURCE option; if the REPCONFIG file contains both instructions, SMOKE will ignore the BY UNIT instruction. When the NAME option is included, the facility name will be included in the report. Otherwise, only the facility and unit IDs will be included.
- WEKCODE: Records are printed by Weekly profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant. Note that this option spelling is *not* WEEKCODE.
- WEDCODE: Records are printed by Wednesday diurnal profile code. This option will work correctly only when monthly temporal profiles have not been applied by pollutant.

The most detailed BY instruction will determine the resolution of the emissions and activity totals. For example, the COUNTRY, STATE, and COUNTY options can be used in the same report to affect the column headers, but the data output will not be different because the emissions totals will be at the finest resolution specified. In other words, if the instructs are to report BY COUNTY and BY STATE, the emission totals in that report will be by county, and the BY STATE instruction will merely add the state code to the columns printed. Another example is that the BY SCC10 instruction will override the resolution of BY ROADCLASS.

Future versions of the BY command may support the following options, if a need for them is identified by SMOKE users:

- POINT [NAME]: For point sources only, records are printed as facility, stack, and point totals. NAME can be appended to the option to get the facility names in the output file.
- VTYPE: For mobile sources only, records are printed as vehicle-type totals.
- GROUP <option>: Records are printed based on the user-defined groups, with the following options:
 - REGION: Rows in report are user-defined region groups.
 - SCC: Rows in report are user-defined SCC groups.
 - SOURCE: Rows in report are user-defined source groups, by SMOKE record number.
 - HOURS: Rows in report are user-defined hour groups.

5.3.3.5. CONTROL instruction

The CONTROL instruction applies the multiplicative control matrix to all pollutants and species requested in the report. This instruction does not limit the options available for resolution of the report, so reports that have the CONTROL instruction can also include any combination of BY instructions. **Smkreport** is unable to apply the reactivity control matrix at this time.

5.3.3.6. CROSSWALK instruction

The CROSSWALK instruction allows users to generate the crosswalk output file that maps how the point inventory sources are grouped into the output source for a single report. This option is only limited to stationary point sources (SMK_SOURCE is set to P). The file names in this case are created automatically by **Smkreport** based on the file name set by the associated NEWFILE instruction (explained in Section 5.3.8, “The /NEWFILE/ packet” [250]), by appending a “_crosswalk”.

5.3.3.7. GRIDDING instruction

The GRIDDING instruction controls whether or not the gridding matrix is used by **Smkreport**. When the instruction is present, the gridding matrix is used in generating the report; the matrix is applied to the emissions before the totals are made. The gridding matrix file name is determined by the environment variables set at run time. One use of the GRIDDING instruction would be the following: a report could be generated without GRIDDING to see emission totals before gridding, and another report could be generated with GRIDDING to see the totals after gridding. The totals from the two reports could be compared to see if any emissions were lost because of the gridding step.

The GRIDDING instruction is assumed when any of the following other instructions appear in the packet:

- SELECT SUBGRID

- BY CELL
- NORMALIZE CELLAREA

5.3.3.8. LAYFRAC instruction

The LAYFRAC instruction controls whether or not the point source layer fractions file (PLAY) from the **Laypoint** program is used in determining elevated and low-level sources. If the PLAY file is not used for determining elevated sources, the PELV file from the **Elevpoint** program will be required.

5.3.3.9. NORMALIZE instruction

The NORMALIZE instruction controls whether or not the emission values will be normalized using some other data value. Two normalize options are currently supported; CELLAREA and POPULATION. Emissions normalization can provide additional insight to the inventory, more than can be obtained by simply summarizing emissions values.

The syntax of the NORMALIZE instruction is:

NORMALIZE <option>

with the following valid options:

- **CELLAREA**: Normalize emissions based on grid cell area. When the emissions are normalized by cell area, they are divided by the area of each cell (or just the cells selected, if a subgrid is used). Normalizing by grid cell area is useful for comparing emission reports from grids at different resolutions, including nested grids, to ensure that a consistent emissions density is maintained across the multiple grid resolutions.

For Lambert and UTM grids, the cell areas are computed using the formula:

$$DX * DY$$

where

- *DX* is the cell x-direction size in meters
- *DY* is the cell y-direction size in meters

For lat-lon grids, the area of the lat-lon cell are estimated using the formula:

$$(\cos Y) * (\pi * DX * R / 180) * (\pi * DY * R / 180)$$

where

- *DX* is the cell x-direction size in degrees longitude
- *DY* is the cell y-direction size in degrees latitude
- *Y* is the cell center in degrees latitude
- *R* is the radius of the earth in meters

The NORMALIZE CELLAREA command cannot be used with polar stereographic grids at this time.

This instruction requires that the GRIDDING instruction also be used, because the gridding information is needed in order to normalize the emissions by grid area. If the GRIDDING instruction is left out of the report instructions, **Smkreport** will add it to the report and continue.

- **POPULATION**: Normalize emission based on county population. Emissions in the report are divided by county population, regardless of whether the BY COUNTY instruction has been used in the report instructions.

This option requires that the COSTCY input file to **Smkreport** include an additional field and a #POPULATION header (as is described in the COSTCY documentation in Chapter 6, *SMOKE Input Files* [261]).

Future versions of the NORMALIZE instruction may support the following option, if a need for this option is identified by SMOKE users:

- **NORMALIZE COUNTYAREA**: Normalize emissions based on county area.

5.3.3.10. NUMBER instruction

The NUMBER instruction controls the format used to display *data values* in the report. The argument for the number instruction applies to all data values that are written to the report, and the structure of the argument is simply the formats supported by Fortran. The data values in the reports are rounded to the nearest value allowed based on the format selected. A value of 5 is rounded up to the next decimal place, when such rounded is needed.

The syntax of the NUMBER instruction is simply:

NUMBER <format>

where <format> is the Fortran format specification. The common formats you might use are the following:

- Float format: F<x>.<y>: where <x> is the number of digits for the number, including the decimal place, and <y> is the number of digits shown after the decimal place.
- Exponential format: E<x>.<y>: where <x> is the complete width of the value, including five characters for “E+00” and the decimal, and <y> is the number of significant figures.

If the NUMBER instruction does not appear in the report instructions, the E8.3 format is used.

5.3.3.11. PROJECTION instruction

The PROJECTION instruction will apply the growth matrix to all pollutants and species requested in the report. This instruction does not limit the options available for resolution of the report, so reports that have the PROJECTION instruction can also include any combination of BY instructions.

5.3.3.12. SELECT instruction

The SELECT instruction controls which records in the inventory are used in generating the report. It allows the user to extract particular records from the inventory, for inclusion in the report. This instruction also permits references to the groups defined in the Define-groups section of the REPCONFIG file. If no SELECT instruction is used, then the other report instructions will be applied to all records in the inventory. Only one SELECT statement of each type is permitted in per report; for example, only one SELECT REGION statement and one SELECT SUBGRID statement could be used for a single report. Of course, different SELECT REGION or SELECT SUBGRID instructions could be used for different reports in the same output file.

The syntax of the command is:

```
SELECT <options> <label>
```

where <label> is an optional field, depending on the <option> selected. The following options are available for the SELECT instruction:

- **DATA <label>**: Selects data values to include in the report. When no SELECT DATA instruction is used, all pollutants, activities, or species found in the input file(s) are reported. When species are being reported, the corresponding pollutants in the inventory or hourly emissions file are reported as well as the speciated emission values. The <label> must be a space-delimited list of pollutant, activity, or species names. Do not include the pollutant names in the list when species are listed, as these will be included by default.

To specify a species value when the species name is the same as the pollutant name, an “S” and a hyphen can be inserted before the species name. You can also use this method for specifying the sum of post-speciated emissions. For instance, to specify carbon monoxide after speciation, the SELECT instruction should be:

```
SELECT DATA S-CO
```

To specify the sum of VOC emissions after speciation, the SELECT instruction should be:

```
SELECT DATA S-VOC
```

*Note that **Smkreport** does not determine whether the summation makes sense, and does not correct for species molecular weights. You must ensure that the data you request makes sense.*

Also note that the maximum number of characters that can be read on any line in this file is 1024. This can limit the number of pollutants that you can specifically request in a SELECT DATA statement.

- **ELEVATED [PING]**: Selects all elevated point sources (recognized for point sources only). If no elevated sources are found (after applying all other selection criteria), the report will contain a warning to that effect. If the PING option appears, only plume-in-grid sources will be selected. When the ELEVATED instruction is used by any report, the PELV file (from **Elevpoint**) or PLAY file (from **Laypoint**) will be required to determine which sources are elevated. The latter will be used when the LAYFRAC instruction is also included in the report instructions. If the PING option is used, the PELV file will be required in all cases, although the LAYFRAC instruction can still be used to set the elevated source status based on the layer fractions.
- **NOELEVATED**: Selects all low-level point sources (recognized for point sources only). If both the ELEVATED and NOELEVATED commands appear in the same report, a warning will be given, and the latter setting will be used to generate the report. If no low-level sources are found (after applying all other selection criteria), the report will contain a warning to this effect. The same rules apply for use of the PELV or PLAY files as described for the ELEVATED option.
- **REGION <label>**: Selects a region using the country/state/county code or a region group. For this option, <label> must be either a country/state/county code in NSSCCC format, or a region group label from the Define-group section of the REPCONFIG file.
- **SUBGRID <label>**: Selects a subgrid using the grid cell numbers or a subgrid group label. For this option, <label> must be either a range of grid cells, or a subgrid label from the Define-group Section of the file. When the <label> defines the cell range, you should use the same syntax that was specified above for the /DEFINE SUBGRID/ packet. However, the INCLUDE setting is assumed, and **Smkreport** will not understand the INCLUDE and EXCLUDE commands as part of the <label>.

For the REGION and SUBGRID options, the value of <label> must either match a group or subgrid label or match characteristics of the inventory or grid. Also, the <label> for the REGION and SUBGRID options must be 200 characters or fewer.

Future versions of **Smkreport** may support the following additional options, if a need is identified:

- SCC <label>: Select a single SCC or SCC group for reporting.
- PLANT <label>: Select a single point source plant, or a plant group for reporting.
- STACK <label>: Select a single point source stack, or a stack group for reporting.
- POINT <label>: Select a single point source point, or a point group for reporting.
- HOURS <label>: Select a single hour or hour group for reporting.
- SOURCE <label>: Select a single source or source group for reporting.

5.3.3.13. SPECIATION instruction

The SPECIATION instruction controls whether the speciation matrix is used by the program. This option controls the columns of data that will be printed in the output file. When the SPECIATION instruction is in the report instructions, the columns in the output file will include speciated emissions values as well as inventory emissions from the SMOKE inventory or hourly emissions file (depending on whether or not the TEMPORAL instruction is used). When the SPECIATION instruction is not used, the columns in the output file will be inventory emissions and/or activities.

The syntax of the SPECIATION instruction is:

SPECIATION <option>

where the following options are supported

- MOLE: Uses the mole-based speciation matrix.
- MASS: Uses the mass-based speciation matrix.

5.3.3.14. TEMPORAL instruction

The TEMPORAL instruction controls whether or not emission values are used from the hourly emission files ATMP, MTMP, or PTMP. When this instruction is used, the default behavior of **Smkreport** is to sum up the emissions by day and report emissions as daily totals. To override this behavior, the BY HOUR instruction must be used.

When dates and times are given in the report, the hours are reported in the time zone from the ATMP, MTMP, or PTMP file. Hours are reported as *standard* time values for the time zone stored in the header of the hourly emissions file; hours are never reported as *daylight* time values.

The TEMPORAL instruction is assumed when either of the following options appear in the report instructions:

- SELECT HOURS
- BY HOUR

In the future, we may be able to enhance this instruction to permit the reported hour values to be labeled with a different time zone than is in the hourly emissions file.

5.3.3.15. TITLE instruction

The TITLE instruction allows one or more titles to be added to a report. The titles are printed into the report in the order in which they appear in the packet. Quotes are *not* needed in titles with blank spaces. The title will be ended at the last character on the line, or at a double pound sign (**##**), whichever appears first on the line. Double pound signs cannot be printed in the titles of reports. It is recommended that titles be 80 characters wide. The maximum title width is 300 characters. The syntax of the TITLE instruction is the following:

```
TITLE <title text>
```

5.3.3.16. UNITS instruction

The UNITS instruction allows you to control the units of the output data. The current version of **Smkreport** does not permit you to vary the units by data value; instead, the same units must be used for all data values, or the default units will be used. Future versions of **Smkreport** may permit control of the units by data variable.

All unit conversions that *can* be done, will be done. For example, if the inventory is stored in tons/hour, and the output is requested in fathoms/day, the hour-to-day conversion will be made, while the impossible tons-to-fathoms conversion will not be made. The syntax of the UNITS instruction is the following:

```
UNITS ALL <units>
```

Valid values for the <units> option numerator are the following:

- ton(s)
- g, gm(s), gram(s)
- kg(s)
- mole(s), gm mole(s)

Valid values for the <units> option denominator are the following:

- year(s), yr(s)
- day
- hour(s), hr(s)
- min(s)
- day(s)
- s, sec(s)

No quotes are needed around the unit labels, and they must be 30 characters or fewer. Some examples of the units instruction are the following:


```
UNITS ALL gm moles/s
UNITS ALL tons/hr
UNITS ALL kg/year
```

5.3.4. The /DELIMITER/ packet

The /DELIMITER/ packet can be used to change the column delimiter used in the output reports from **Smkreport**. The default delimiter is a semicolon (;). You can change the delimiter to any single-character value to suit your needs, although using a space as a delimiter may result in slightly misformatted reports. Some reasons to change the delimiter from the default are:

- You are reporting “BY SOURCE” and including the source name, and it has semicolons included in one or more of the names. This would prevent those records in the output report from being read into another program using semicolon as the delimiter.
- Software you want to use to read the **Smkreport** output report does not support semi-colons for delimiters.
- You prefer a different appearance in the reports; you can select another delimiter that does not conflict with other fields in your report.

The syntax of this instruction is the following:

```
/DELIMITER/ ,
```

This example results in a comma (,) being used as the delimiter for columns of any results from /CREATE REPORT/ instructions that followed this instruction in the REPCONFIG file.

5.3.5. The /SET LABEL/ packet

The /SET LABEL/ packet can be used to set a label to include on every row of every subsequent report defined in the REPCONFIG file. The label text can be either the text that appears in the packet, or the label can be defined by an environment variable. This feature facilitates combining multiple reports from separate SMOKE runs into a single report more easily. For example, if the packet is used to create state reports for all sectors run through SMOKE, then those state reports could be concatenated, the file headers removed (except for the first header), and the individual sectors would be identified by the labels on the rows.

The syntax for the packet is as follows:

```
/SET LABEL/ <label>
```

where <label> is limited to 200 characters and is one of the following:

- a string of text that will appear near the beginning of every data line of the report. The only invalid string is the word "OFF" in capital letters.

Example: /SET LABEL/ NonEGU Point

In this example, all subsequent reports will contain a new column called "Label" and every value in the entire report will be "NonEGU Point".

- an environment variable designated by <label> starting with a dollar sign.

Example: /SET LABEL/ \$RUN_ID

In this example, **Smkreport** will attempt to evaluate the environment variable `RUN_ID` from the shell running **Smkreport**. If `RUN_ID` is a defined environment variable (e.g., the shell had set `RUN_ID` to "oarea"), then all subsequent reports will contain a new column called "Label" and every value in the entire report will be "oarea".

If the environment variable is not defined, set to blank, or otherwise invalid, the instruction will behave like the `/SET LABEL/ OFF` case below.

- the word "OFF".

Example: `/SET LABEL/ OFF`

This syntax turns off use of the label in all subsequent reports until a new valid `/SET LABEL/` packet is found.

5.3.6. The /REPORT TIME/ packet

The `/REPORT TIME/` packet can be used to change the hour value for which daily-total hourly emissions are output. The syntax of this instruction is the following:

```
/REPORT TIME/ <HHMMSS>
```

The setting uses HHMMSS format, in which HH is the hour and MMSS is 0000. The time specified is in the time zone of the input hourly data file. This setting is ignored when hourly data are not input to **Smkreport**. The default behavior of **Smkreport** is to report at the last hour of the day, hour 23 (hours are counted from 0 to 23). This setting must be consistent with the SMOKE intermediate files, which use hour numbers 0 through 23 because they are based on the I/O API. However, these hour numbers are different from those included in the report because of the "BY HOUR" instruction, which numbers the hours 1 through 24.

5.3.7. The /AVEDAY/ packet

The `/AVEDAY/` packet can be used to toggle on or off the use of the average-day emissions from the SMOKE inventory file. The syntax of the command is the following:

```
/AVEDAY/ <option>
```

The `<option>` field can be set to Y or N. The default behavior of the program (if no `/AVEDAY/` packet appears) is to *not* use the average-day emissions in the reports. This packet only affects the program *only* when the inventory emission are being reported. If the TEMPORAL instruction is given, the output report will contain whatever emission values were used to create the hourly emissions file.

5.3.8. The /NEWFILE/ packet

The `/NEWFILE/` packet can be used before or between any `/CREATE REPORT/` packets to cause **Smkreport** to write out the subsequent reports to a different report file. The syntax of the command is the following:

```
/NEWFILE/ <Filename>
```

The placeholder `<Filename>` is replaced by either:

1. A physical file name, including the path.

2. A logical file name.

Smkreport will detect whether the file is a physical or logical file name by checking to see if the <Filename> value is defined with a nonblank value in the run-time environment. If it is, then **Smkreport** assumes the value is a logical file name, and opens a file using the value found from the environment.

If no information is given for <Filename>, the output files will be named by their automatic logical file names, REPORT[#], where [#] is replaced by the number of the report file in order of its associated /NEWFILE/ packet.

5.4. Reports Created by Smkreport

As described in Section 5.2, “**Smkreport** Program” [229], the **Smkreport** program creates user-defined reports and summaries for QA purposes based on the SMOKE intermediate files (e.g., SMOKE inventory files, hourly emissions, speciation matrix, gridding matrix). The reports that are created by **Smkreport** can easily be imported into a spreadsheet program or into a database because the ASCII output format is delimited. Note that report files larger than about 60,000 lines will not import into Excel because of limitations of that software.

Because **Smkreport** is very flexible, there are a large number of reports that you can generate. The “File Format(s)” section below describes the guidelines that **Smkreport** uses in building the output reports, based on the instructions the user provides to **Smkreport**. This section is followed by a large number of example reports, to help you understand the possible format options.

5.4.1. File format(s)

5.4.1.1. Multiple reports in one file

Each file output by **Smkreport** can contain multiple reports. The user has control over how many reports are included in each file (please see the REPCONFIG file documentation above for more information on using the /CREATE REPORT/ and /NEWFILE/ packets). The reports in a file are separated by a row of pound signs (#). If having multiple reports in a single file causes problems for importing the data into other software, then you should create a REPCONFIG file that specifies a new file for each report.

5.4.1.2. Basic report structure

The reports in an output file use columns and rows to structure the information. The reports are structured to permit the user to import a report into spreadsheet or database software, or some other data-processing tool for further analysis. The columns in the reports are semicolon delimited (though the delimiter can be set by the user), have labels, and have units. Where possible, we have also tried to make sure that the text versions of the reports can be viewed easily. The width of the widest entry in a column is used to set the width for the column, thereby making fixed-file format transfer to other software possible.

5.4.1.3. Advanced report structures

Using the ARRANGE instruction in the **Smkreport** REPCONFIG input file, you can also create reports with more advanced structures: a single report that is composed of multiple physical files; a report that is single physical file but has multiple sections; or a report that uses a “database” format of one data value (e.g., emissions value) per line. Use of these formats is described in the REPCONFIG file documentation in Section 5.3, “REPCONFIG Input File” [232].

5.4.1.4. Structure template

The following is a general template for the **Smkreport** output files. It consists of a REPORTS section and a METADATA section. These two sections are discussed in detail below the template.

```

5.4.1.5. Elements of the REPORTS section

5.4.1.5.1. User titles

The first section of each report is a title section. The first title entries in the report are any titles specified in the /CREATE REPORT/ packets in the REPCONFIG file, created by the user. They are listed in the same order as those provided in the input packets for the report. It is recommended that user titles be no more than 80 characters wide (to more easily fit on printed documents), although they can have up to 300 characters.

5.4.1.5.2. Automatic titles

Automatic titles are inserted by **Smkreport** to indicate the operations that were done by **Smkreport** to generate the requested report. This helps the report be self-describing. The automatic titles are formatted to be no larger than 80 characters wide, in order to permit easier viewing as text files. The following automatic titles are applied, where applicable:

- The source category processed
- The year of the base inventory
- The year of the grown inventory (only if a grown inventory file is input to **Smkreport**)
- Whether growth factors were applied, and if so, for what year
- Whether multiplicative control factors were applied, and if so, for what year

- Whether a gridding matrix was applied, and if so, the grid name
- Whether a speciation matrix was applied, and if so, whether it was mole-based or mass-based
- Whether annual, average-day, or hourly data from SMOKE intermediate files are the basis of the emissions in the report
- If hourly data were input, the time period processed with dates, hours, and time zones
- Whether annual or average-day data were the basis for the report
- Whether the emissions are divided by grid cell area (NORMALIZE CELLAREA instruction)
- Whether the emissions are divided by population (NORMALIZE POPULATION instruction)
- The name of the group used to select the data, if any (the group definition will be listed in the METADATA section)
- The name of the subgrid used to select the data, if any (the subgrid definition will be listed in the METADATA section)

5.4.1.5.3. Data columns written

The particular columns of data that are written to a report are determined by the BY instructions in the /CREATE REPORT/ packet. Typically, one column is created for each BY instruction, which corresponds to the name of the BY instruction. The exceptions to this rule are the following:

- The BY COUNTRY, BY STATE, and BY COUNTY instructions, which output the country, state, and county codes, and optionally the country, state, and county names, respectively (if NAME is included at the end of the instruction).
- The BY SOURCE instruction, which outputs columns for all source characteristics (point sources: country/state/county, plant, char1, char2, char3, char4, char5, SIC; area sources: country/state/county, SCC; mobile sources: country/state/county, road class, vehicle type, SCC). For point sources, the BY SOURCE instruction can also output four additional columns for stack parameters, and another additional column for facility name.

In addition to the columns specified by the BY instructions, the emissions and/or activity data are written out to the report. If no speciation option is used (i.e., the SPECIATION instruction is not given), then the other data columns are the emissions and activities from the SMOKE inventory file (e.g., NOX, VOC, PM10, VMT). If the speciation option *is* used, then the other data columns are the speciated emissions data (e.g., NO, NO2, ALD, PAR, ISOP). The SELECT DATA instruction determines which inventory data and speciated emissions data are written to the reports. When speciated data are output, the columns for the corresponding inventory pollutants are written as well (as explained more fully in the input file description of the SELECT DATA instruction, earlier).

The order of the columns of data values is taken from the order of the data in the SMOKE intermediate files. The orders of pollutants and activities are controlled by the INVTABLE file when **Smkinven** is run to create the SMOKE inventory files. Species are arranged by **Spmat** based on the order of the pollutants, and then alphabetically for species coming for the same pollutant, and this order is used to create the speciation matrix.

5.4.1.5.4. Column delimiters

The default column delimiter in most cases is a semicolon (;). However, if you select the “BY SCC10 NAME” or “BY SIC NAME” instruction, the SCC or SIC description will be included in the report and

the default delimiter will be a pipe symbol (|). This is because the SCC and SIC descriptions can include semicolons. In either case, you can use the /DELIMITER/ packet to manually set your choice of delimiter, if desired.

5.4.1.5.5. Column headers

Each column of data is labeled with a header name. Where applicable, the columns also are labeled with units (discussed below), as set by the UNITS instruction or by the default units for the data used by the program. For the emissions and activity data, the header names are simply the names of the pollutants or activity variables input to SMOKE. For columns generated by the BY instructions, the following possible column headers are used by SMOKE. These are listed in the order in which they would appear.

- Date (values of MM/DD/YYYY)
- Hour (integer values from 1 through 24)
- Layer number (integer values >0)
- X cell (integer values >0)
- Y cell (integer values >0)
- Source ID (SMOKE record number, integer values >0)
- Co/St/Cy (Country, state, and county code; values of NSSCCC, with SS and/or CCC replaced by zeros as necessary, depending on the BY option used)
- Country (value is name; optional when country, state, and county code is output)
- State (value is name; optional when country, state, and county code is output)
- County (value is name; optional when country, state, and county code is output)
- SCC (10-character values, with 2 leading zeros for 8-character SCCs)
- SIC (4-character values)
- NAICS (6-character values)
- MACT (6-character values)
- ORIS ID (6-character values)
- Primary Srg (primary surrogate ID code; for area or mobile sources only)
- Fallbk Srg (fallback surrogate ID code; for area or mobile sources only)
- Monthly Prf (monthly temporal profile code)
- Weekly Prf (weekly temporal profile code)
- Diurnal Prf (diurnal temporal profile code)
- Spec Prf (speciation profile code)
- Plant ID (for ORL) or Facility ID (for FF10)

- Char 1 point-source stack ID (for ORL) or ?? (for FF10)
- Char 2 Stack ID (for ORL) or Release Point ID (for FF10)
- Char 3 Segment ID (for ORL) or Process ID (for FF10)
- Char 4 (for point sources only; may or may not be defined)
- Char 5 (for point sources only; may or may not be defined)
- Stk Ht (stack height; for point sources only)
- Stk Dm (stack diameter; for point sources only)
- Stk Tmp (stack exit temperature; for point sources only)
- Stk Vel (stack exit velocity; for point sources only)
- Elevstat (E= elevated, P= Plume-in-grid, L= low-level; for point sources only)
- Plt Name (facility name with quotes around it; for point sources only)
- SCC Description (in quotes)
- SIC Description (in quotes)
- NAICS Description (in quotes)
- MACT Description (in quotes)
- ORIS Description (in quotes)

5.4.1.5.6. Header units

The units used in the header for each column depend on (1) the units in the input files, (2) the units set as output units in the report instructions, and (3) any normalization used. **Smkreport** starts with the units obtained from the input files and application of any matrices of interest. Then all unit conversions that can be made, are made. The conversions are done separately on the numerator and the denominator, but one or both of the conversions will not be done if **Smkreport** has not been configured for the conversions. If this is the case, a note will appear to this effect in the log file. Last, the units are converted to 1/m² if the NORMALIZE CELLAREA instruction has been given.

Below the header units, a line of minus signs will appear in the reports.

5.4.1.5.7. Data rows

The rows of data (i.e., emissions totals or activity totals) are listed sequentially, without spaces between the rows, in sorted order according to the BY instructions, and based on the order listed in the file (just explained above). Data-value-based sorting is not done by **Smkreport**, but rather left for a postprocessing step of other data manipulation software. Unlike the title rows, the length of the data rows constrained only by the maximum number of characters up to 3500 per ASCII line, which varies based on the platform you are using. The ARRANGE instruction can be used to improve the arrangement of data rows when the lines are too large or the program is not working properly because of the large number of data values requested in a report.

The data values in the rows are formatted based on the NUMBER instruction for the report.

The resolution of the data values (e.g., summed by SCC) depends on the BY instructions for the report. The inventory records included in the totals (i.e., which sources are included in the reported emissions) depend on the SELECT instructions for the report. More description of these instructions and how they affect the output is provided with the REPCONFIG file format information given earlier.

5.4.1.6. Elements of the METADATA section

Note: this section is not yet implemented in SMOKE. Once implemented, this section of the reports will begin by a line with the word METADATA on it.

5.4.1.6.1. Input files

In this part of the METADATA section, all of the input files used in running the program are provided, one on each line. The full path and file name will be provided.

5.4.1.6.2. Echoed group definitions

The group definitions from the REPCONFIG file used to generate the file will be listed in this section. The definitions will be merely copied directly from the input file to this section of the output report.

5.4.1.6.3. Echoed report instructions

The report instructions from the REPCONFIG file used for creating each report in the file will be listed in this section. The instructions will be merely copied directly from the input file.

5.4.2. Example reports

Given below are just a few examples of the many types of reports **Smkreport** can generate. Note that no actual emission data values are given in these examples (and sometimes the emission values are not even listed). Also, no example is given with two reports in a single file. When we created these examples, we pretended that the inventory used to generate the reports had only CO and NOx available. Also, we have not provided the entire reports, but rather a sampling of what each report looks like, without showing all states, SCCs, etc.

6.1. Overview

This chapter contains format information for all input files used by SMOKE. Chapter 7, *SMOKE Intermediate Files* [379] and Chapter 8, *SMOKE Output Files* [403] provide documentation on SMOKE’s intermediate and output file formats.

In this overview section, we first provide a few important notes about file formats (Section 6.1.1, “General notes about file formats” [262], and then discuss where to put SMOKE input files (Section 1, “Where to put SMOKE input files” [?]). Section 2, “SMOKE input file list” [?] summarizes all the input files needed by SMOKE, organized by function.

The remaining sections in this chapter are broken down as follows:

- Inventory files used by **Smkinven** (Section 6.2, “Inventory Files” [262])
- Temporal allocation files used by **Temporal** (Section 6.3, “Temporal Allocation Files” [294])
- Spatial allocation files used by **Grdmat**, **Normbeis3**, **Normbeis4**, and **Smkmerge** (Section 6.4, “Spatial Allocation Files” [300])
- Chemical speciation files used by **Spcmat** (Section 6.5, “Chemical speciation” [303])
- Growth and controls files used by **Cntlmat** (Section 6.6, “Growth and Controls Files” [310])
- Special merging files used by **Mrggrid** (Section 6.7, “Special Merging Files” [317])
- Meteorology files used by **Tmpbeis3**, **Tmpbeis4**, **Met4moves**, and **Laypoint** (Section 6.8, “Meteorology Files” [318])
- Source-specific files for biogenics, mobile, and point source processing (Section 6.9, “Source-Specific files” [321])
- Support files used by various programs (Section 6.10, “Other Support Files” [362])

6.1.1. General notes about file formats

- In the tables used to describe the file format for each file, the “Position” column lists a single number or a range of numbers.

When there is a letter or a single number in the “Position” column, this indicates that the file must be list-directed, and therefore the fields on each line need to be delimited by a space, comma, or semicolon. If there are fields that have embedded spaces, commas, or semicolons in a list-directed file, these entries must be surrounded by single or double quotation marks to prevent SMOKE from treating those characters as delimiters.

When a range of numbers is listed in the “Position” column, ie. (1-3), this indicates that the file is column-specific, which means that the entry must be placed exactly within the columns listed.

- For all cross-reference files (e.g. AGREF, MGRES, GSRES), all of the source-characteristic fields are optional. For example, it is permissible to provide only the SCC for use in matching a profile to a source.

For list-directed files, if there are source characteristic fields that will not be used (such as country/state/county code) that come *before* the required fields in the file, these must be filled in with a zero or -9. If there are unused fields that come *after* the required fields in the file, they can be left blank.

For column-specific formats, the optional entries can be left blank or set to -9 when they are not used.

- Nearly all input files support full-line and trailing comments. If the first character on a line is a pound sign (#) then the line is treated as a comment. Any characters after an exclamation point (!) are treated as a comment.

6.2. Inventory Files

The directories where the inventory files should be stored are listed in Table 6.1, “Inventory File Locations” [?]. The table also lists the programs that use each input file.

6.2.1. Overview

6.2.1.1. Inventory list files

Area-, mobile-, and point-source inventories are provided to SMOKE as ASCII text files using the logical file names ARINV, MBINV, and PTINV, respectively. These files may either contain the actual inventory data (i.e. source characteristics, emissions data, and other information) or they can contain a list of file names with full paths (i.e. /apps/smoke/data/inventory/nei02/area/arinv.txt); in the latter case, we call the file a “list file”. When the inventory is a list file, SMOKE will open and read the data in each of the listed files and combine the data into one inventory. You may also choose to separate your data into multiple files, splitting the data by country or into EGU versus nonEGU point sources, or to reduce the individual file sizes. Some inventory formats require that a list file is used; this will be noted in the format descriptions.

6.2.1.2. File format header

All area-, mobile-, and point-source inventory files must include information specifying the file format being used. This is accomplished using a header entry, either in each individual inventory file or in the list file, if one is being used. Valid format options are:

- #CEM indicates that the file is in CEM format
- #LIST indicates that the file is a list file
- #LIST GRID indicates that the file is a list of global gridded emission inventory files
- #FF10 indicates that the file is in FF10 (Flat File 10) format is shared between different source categories for annual/monthly or daily/hourly and point/nonpoint/nonroad/onroad data. The user specifies the data provided using this command in the header: FF10_[HOURLY|DAILY]_[NONPOINT|POINT|NONROAD|ONROAD].
- #ORL indicates that the file is in ORL format (usually used for toxics inventories)
- #ORL NONPOINT indicates that the file is in ORL format for nonpoint sources
- #ORL FIRE indicates that the file is in ORL format for fires sources
- #ORL FIREEMIS indicates that the file is in ORL format for day-specific fires sources

6.2.1.3. Required and optional fields

Inventory files can include both required and optional fields. In the format tables for each file, required fields are labeled “required”; optional fields are labeled either “recommended”, “optional”, or “not used by SMOKE”. For column-specific file formats, you may leave blank the fields that are optional. List-directed files, on the other hand, must have a default value (usually -9) for these fields.

6.2.1.4. Header records

The ORL and FF10 formats used for the area-, mobile-, and point-source inventories require a set of header records at the beginning of each file. The general format of the header records is:

The *command* field starts in the first column of the row. The remainder of the line is list-directed, with each field separated by blanks. The specific header commands vary by source category and format and are listed in Table 6.12, “Inventory header commands for ORL, and FF10 formats” [264].

6.2.2. ARDAY: Area source day-specific emissions

6.2.2.1. FF10 Format

The user specifies the data provided using this command in the header: FF10_DAILY_[NONPOINT|POINT|NONROAD|ONROAD].

This FF10 format uses the header described in Section 6.2.1.4, “Header records” [263]. Sample header records for daily nonpoint sources are shown below:

6.2.3. ARHOUR: Area source hour-specific emissions

6.2.3.1. FF10 Format

The user specifies the data provided using this command in the header: FF10_HOURLY_[NON-POINT|POINT|NONPOINT|ONROAD].

This FF10 format uses the header described in Section 6.2.1.4, “Header records” [263]. Sample header records for daily nonpoint sources are shown below:

The SMOKE requires that the sources in the day-specific fires inventory format (#ORL FIREEMIS) PTDAY file also be in the PTINV file described in Section 6.2.8.3, “ORL FIRE Format” [294]. The values of the fields that are common to the day-specific data and the master (annual) data from PTINV are used to match exactly by country/state/county code, fire identification, location identification, and SCC. Default daily ACRESBURNED and FUEL_LOAD input are required to internally estimate heat flux for the fire-specific plume-rise computation. Fire duration information, such as BEGHOUR and ENDEHOUR are used to adjust the hourly temporal profile.

The file must be a list file (see Section 6.2.1.1, “Inventory list files” [262]) and the files listed in the PTHOUR file must be in Continuous Emissions Monitoring (CEM) format when processing hourly CEM inventory data files with a format identifier (#CEM) or the format can be specified in the PTHOUR list file (#LIST CEM). In addition, these files can have a #COUNTRY entry to set the country code (see Section 6.2.1.4, “Header records” [263]). The default country code is 0, which corresponds to the United States in the default COSTCY file.

6.2.7.1. Date range setting

The PTHOUR file may optionally contain a packet to control the range of dates for which **Smkinven** will read data. When this feature is needed, the following entry should appear on the first line of the PTHOUR file.

```
DATERANGE MMDD(start) MMDD(end)
```

where MMDD is the two-digit month and day of the month at the start and end of the period of interest. For example, to request July 10th through 12th, the first line of the file should read:

```
DATERANGE 0710 0712
```


The year is implied by the data themselves; note that the files can only contain data for a single year. As an alternative to using the DATERANGE packet, you can manually break the year up into smaller periods in separate files, and only list the files of interest in the PTHOUR file. Note that reading in the whole year of data and extracting just a few days will take much more time than manually editing the file to contain just the days of interest. Also note that if you choose the manual editing option, you must select days that fully cover the modeling episode after accounting for time zone differences between the facility's time zone and the modeling time zone (set by the OUTZONE option).

6.2.7.2. CEM hour-specific format

SMOKE uses the CEM ORIS ID and Boiler ID fields to match sources in the CEM hour-specific inventory to those in the annual inventory. Note that the CEM data hours are in standard local time (no daylight saving time adjustment). The format of the CEM hour-specific data is shown in Table 6.22, "CEM Format for individual hour-specific data files" [281].

6.2.7.4. EMS-95 Format and EMS-95 Wider Format

For EMS-95 formatted data, SMOKE requires that the sources in the PTHOUR file also be in the PTINV file. The values of the fields that are common to the hour-specific data and the annual data need to match exactly. These fields are Facility ID, Stack ID, Device ID, and Process ID. These fields are treated as text fields (not numeric) in SMOKE, so leading zeros need to be consistent between the hour-specific and annual or average-day inventory files.

There are two types of EMS-95 format available for hour-specific data. The traditional EMS-95 format is shown in Table 6.24, “EMS-95 Format for individual hour-specific files” [284] and the wider EMS-95 format is shown in Table 6.25, “EMS-95 Wider Format for individual hour-specific files” [285]. The traditional EMS-95 format has 7 columns available for the emissions values instead of 12 columns in the EMS-95 wider format. For some air pollutant values, the 7 columns was not big enough to capture the low

precision unless scientific notation is used. To use the EMS-95 wider format, the optional environmental variable HOURLY_WIDE_FMT needs to be set to Y.

To process pollutant names greater than 5 characters, you need to add the new field of inventory pollutant code known as CAS number from column 261 to 276. If this new field is filled, the POLID is not used. If the new field is not filled, the POLID is required to use the inventory data name. The CAS number will be used to distinguish which chemical compound or inventory pollutant is provided on each line of the file. **Smkinven** matches these numbers with the CAS numbers from an inventory table (INVTABLE) file, described in Section 6.10.4, “INVTABLE: Inventory table” [368]. The CAS number does not necessarily have to be a valid CAS number; it can be any number as long as there is a match between the numbers in the SMOKE ORL file and the inventory table.

6.2.8.3. ORL FIRE Format

The ORL inventory file for fires (#ORL FIRE) is one of the required input files to provide wildfire and prescribed fire data that are being treated as point sources to SMOKE. This file includes the fire characteristics, such as country/state/county code, fire identification, fire name, location identification, location coordinates, SCC (flaming or smoldering), material burned, vegetation types and heat content. Some of characteristics that are common to this master (annual) inventory file PTINV and the day-specific inventory file PTDAY shown in Section 6.2.6.2, “ORL FIREEMIS Emission Format” [279] need to match exactly by country/state/county code, fire ID, location ID, location coordinates, and SCC.

NOTE: Although inventory pollutants are not listed, user needs to list all inventory pollutant names available from the day-specific inventory file PTDAY using a header record #DATA. Sample header records are shown below:

6.3.2. [A | M | P] TREF: Temporal cross-reference file

The ATREF, MTREF, and PTREF files contain the area-, mobile-, and point-source cross-reference records for assigning the temporal profiles to the sources. If needed, the same file can be used for area-, mobile-, or point-source categories, but more fields are used for mobile than for area, and more fields are used for point than for mobile. Section 4.17, “**Temporal**” [211] provides a list of the matching hierarchies that SMOKE uses when applying the file to an inventory. If a field is blank, it must be set to -9.

Between weekly and daily temporal profiles, daily Profiles will take precedence weekly profiles. Within hourly diurnal profiles, the processing occurs as follows (1) day-to-hour hourly profiles (i.e., Monday,,,,,Sunday), (2) Weekday/Weekend hourly profiles, and (3) All days (Monday-Sunday) hourly profiles. However, date-specific houlry temporal profiles from [A | M | P] TPRO_HOURLY_NCF input file will take precedence any types of temporal profiles. This date-specific hourly temporal profiles NetCDF input file contains annual total (ANNTOT), monthly total (MONTHTOT), daily total (DAYTOT) and hourly total (HRLTOT) to compute year-to-hour, month-to-hour, day-to-hour profiles to calculate hourly total depending on types of inventory data (annual, monthly or daily inventory). If inventory is annual total, year-to-hour profiles will be used to convert annual total to hourly total emissions. If inventory is monthly total, month-to-hour profiles will be used to compute hourly total from monthly total inventory.

Within the **Temporal** program, the processing occurs as follows:

- Temporal profiles are assigned for all sources.
- Monthly (year-to-month) temporal profiles can be applied.
- Daily (month-to-day) temporal profiles can be applied.
- Weekly (month-to-weekly) temporal profiles can be applied.
- Day-of-week specific hourly diurnal temporal profiles (Monday,,,Sunday, Weekday, Weekend, or All days) are applied.
- Date-specific hourly diurnal temporal profiles (year-to-hour, month-to-hour or day-to-hour) can be applied.
- Day-specific emissions or activities are read in and used to overwrite daily emissions for the appropriate sources
- Hour-specific emissions or activities are read in and used to overwrite hourly emissions for the appropriate sources.

NOTE: Date-specific houlry diurnal temporal profiles require FIPS and SCC specific entries in [A | M | P] TREF input file.

The pollutant field allows the user to assign a different temporal profile for each pollutant associated with a given source. This is an optional approach; if you do not want to use pollutant as a characteristic in assigning temporal profiles, you can put a “-9” in the pollutant field. In that case, all pollutants for a given source will be assigned that temporal profile.

The country/state/county code is defined as follows:

6.4. Spatial Allocation Files

All spatial allocation (gridding) inputs need to be consistent. Each file has a header to indicate the grid projection, location, dimensions, and resolution; SMOKE uses these headers to ensure consistency across all inputs. SMOKE also requires that any meteorology data inputs be consistent with these gridded data. Most programs in SMOKE are capable of processing a modeling grid that is a subgrid of the input data (i.e. spatial surrogates, meteorology data).

Several options are available for creating the spatial surrogate and biogenic land use inputs.

- The MIMS Spatial Allocator can create surrogates and prepare BELD inputs files for any modeling grid.
- Several national surrogate data sets are available online at EPA’s Clearinghouse for Inventories and Emissions Factors [<http://www.epa.gov/ttn/chief/emch/spatial/>]. These data sets are at 36-, 12-, and 4-km resolutions.
- The gridding surrogates and land use data can be prepared using a GIS program.

The directories where the spatial allocation files should be stored are listed in Table 6.3, “Spatial Allocation Input File Locations” [?]. The table also lists the programs that use each input file.

6.4.1. SRGDESC: Surrogate Designation, Description and Surrogate profile filename.

The Surrogate Description file is used to designate the regional location of the surrogate, the surrogate code number, a brief description of the code number and the Area and Mobile spatial surrogate file in which surrogate profile can be found. 6.4.4. BELD3_A, BELD3_B, BELD3_TOT: BELD3 land use data files

BELD3_A, BELD3_B, and BELD3_TOT files are I/O API netCDF files that contain gridded BELD3 data. The BELD3 data comprise 230 land use types. Because the I/O API limit on the number of variables in one netCDF file is 120, the gridded BELD3 data is broken up into two files (BELD_A and BELD_B). The BELD_TOT file contains additional information on the BELD3 data for the same grid as the BELD3_A and BELD3_B files. The BELD3_TOT file contains the following variable and description:

- FOREST: Percentage of forest area in each grid cell

6.4.5. BELD6 and BIOMASS: BELD land use data files

BELD6 and BIOMASS files are I/O API netCDF files that contain gridded BELD6 data.

6.4.6. BGPRO: Biogenic spatial surrogate file

The BGPRO file must be provided to SMOKE when using county land use data, in order to provide a means of converting county land use to gridded land use. The format for the BGPRO file is the same as for the Area and Mobile spatial surrogate files (see Section 6.4.2, “Area and Mobile Spatial Surrogates Files” [301]).

6.4.7. GRIDDESC: Grids and projection information

The GRIDDESC file is used to provide grid and projection information to SMOKE and can contain data for many different projections and many different grids. The format of the GRIDDESC file is available in the I/O API documentation at <http://www.baronams.com/products/ioapi/GRIDDESC.html>.

6.5. Chemical speciation

6.5.1. GSCNV: Pollutant-to-pollutant conversion file

The pollutant-to-pollutant conversion factors file is required when there is a mismatch between the pollutant in the inventory and the pollutant for which the speciation profiles have been developed. The typical example

is when the inventory has VOC (or ROG), but the speciation profiles are developed for TOG. SMOKE permits such a factor to be applied to any pollutant. The same format is used by all source categories.

These factors can be applied to the inventory using one of two assignment approaches: either by FIPS/SCC or by Speciation Profile ID. The same approach must be used for all sources in a single run of Spemat. Historically in SMOKE, the FIPS/SCC approach has been used; however, starting with SMOKE version 2.3, users may instead apply these factors by Speciation Profile ID. For assignment of factors using the state/county FIPS and SCC codes, the available combinations and hierarchies for applying the factors are the same as for the speciation cross-reference (see Section 4.16, “**Spemat**” [206]), with the exception of the plant ID and other more specific source characteristics for point sources. For assignment of the factors using Speciation Profile ID, there is no assignment hierarchy - whatever profile was assigned to a source by the GSREF file will be used to choose the factor to apply from the GSCNV file, for the appropriate pollutants. To assign these factors by Speciation Profile ID, a special header line is needed, as described below. SMOKE version 2.3 is backward compatible with previous GSCNV files used with earlier versions.

The GSCNV file is not needed if there is no mismatch between the inventory and the pollutants in the speciation profiles file. The **Spemat** program will input and use this file only when the POLLUTANT_CONVERSION environment variable is set to Y.

If emissions types (emission process/pollutant combinations) are being used, as with mobile source processing using the **Movesmrg** program (see Section 2.7.4.9, “MOVES Emission Processes by Emission Rate Tables” [36]), the emission type must be listed instead of the pollutant. For example, if exhaust running VOC emissions were being converted to exhaust TOG, then EXR__VOC and EXR__TOG would need to appear in their respective columns on the header line (line 1 in the "old" format below or in the first and second columns in the "new" format). It would not be correct to put only VOC and TOG. All emission types must be listed, or the conversion factor that will be applied is 1. This approach permits conversion factors that are specific to each emission process (e.g., different conversions for EXR and EXS).

The format of the GSCNV file for Speciation Profile ID assignments is shown in Table 6.40, “Format for GSCNV (using Speciation Profile ID assignments)” [304]. The format is consistent with the format created by the Emission Modeling Framework Speciation Tool.

6.5.2. GSPRO: Speciation profile file

The speciation profile file, GSPRO, contains the factors that are used to separate aggregated inventory pollutant emissions totals into emissions of model species required by the AQM. In traditional ozone air quality modeling, this file contained split factors only for VOC. In SMOKE, all inventory pollutants need to be represented in this file, even if it is only to indicate that a pollutant is not split into any model species (e.g., CO emissions would have a “split factor” of 1.0). The format of the GSPRO file is shown in Table 6.41, “Format for GSPRO” [305].

For support of combining criteria and toxic VOC using the NONHAPVOC calculation feature of SMOKE, the GSPRO file (starting in version 2.3 of SMOKE) includes a special header that defines the meaning of NONHAPVOC. This is the new #NHAP header, described below. This header keyword will be treated as a comment line by previous versions of SMOKE. The header lines define NONHAPVOC (and/or NONHAPTOG) by listing all of the VOC compounds that were assumed to be removed from VOC (or TOG) when the speciation profile factors for NONHAPVOC (or NONHAPTOG) were calculated. When using this file, Spemat compares this list with the list from the Inventory Table ("VOC or TOG Component" field = V or T and "Explicit in Mechanism = "N"). This new header is included in this file so that the file is self-describing with respect to the definition of NONHAPVOC and NONHAPTOG.

The format supports header lines (using a # symbol in position 1 of any line) in any part of the file.

The columns are used by SMOKE as follows:

- The speciation profile number is matched with the number in the GSREF file. This "number" is treated as a character string, so leading zeros must be the same in both the GSPRO and GSREF files.
- The pollutant ID must match the pollutant names in the SMOKE inventory file (AREA, MOBL, or PNTS). These names are set by the #POLID or #DATA headers in the **Smkinven** input files.
- The species IDs are the names of the model species needed by the AQM for which SMOKE is being used. These depend on the requirements of that model. The example SMOKE inputs will not be correct for all AQMs.
- The split factor is the numerator in the factor computed for the mole-based speciation matrix.
- The divisor is the denominator in the factor computed for the mole-based speciation matrix.
- The mass fraction is the value put in the mass-based speciation matrix. The ratio of the mass fraction and the split factor is the average molecular weight for the species and profile, if the divisor is 1.

The combination speciation profiles file (GSPRO_COMBO) contains a combination of multiple speciation profiles that combine multiple speciation profiles with a weight for each profile to support a mixture of fuel profiles to specific counties, when users have information to provide about market penetration of each fuel and have speciation profiles for each of these fuels available. 6.5.5. GSREF: Speciation cross-reference file

The speciation cross-reference file is used to match the emission sources with the speciation profiles in the GSPRO file. The GSREF file uses a header to define the point-source unique characteristics. The same file can be used for all source categories; the SMOKE programs use only the applicable entries in the file. The way that the file is applied in SMOKE ensures that the most-specific matches override the less-specific ones. A description of how the speciation cross-reference is applied to the inventory is provided in Section 4.16, “**Spmat**” [206].

When the special keyword “COMBO” is placed in the speciation profile code column, all sources matching the cross-reference entry should use a combination speciation profile provided in Section 6.5.4, “GSPRO_COMBO: Combination speciation profiles file” [306]. Using the profiles listed in the GSPRO_COMBO file, **Spmat** can use the fractions and the information from the GSPRO and GSCNV for the profiles provided to create weighted profiles for the matching source.

As of SMOKE version 4.5, the chemical speciation profile split factor column M is added into the Table 6.45, “Format for point-source GSREF” [309] for users to apply multiple speciation profiles to a single inventory source. Unlike GSPRO_COMBO approach, this approach can be used to an individual stationary point source level.

6.5.5.1. Area- and mobile-source speciation cross-reference file entries

When emission type are used (as with mobile source processing using the **Movesmrg** program), column C must contain the emission types instead of the pollutants. For example, if the MEPROC file contained processes EXR (exhaust running), EPM (evaporative permeation), and CXR (crankcase running exhaust), then in order to use pollutant-specific entries in the GSREF file for mobile sources, records would need to be added to the file that use the emission types EXR__TOG, EPM__TOG, and CXR__TOG in column C. Note that the separator within these process-pollutant combinations must be a double underscore. The format of the GSREF file for area and mobile sources is shown in Table 6.44, “Format for area- and mobile-source GSREF” [308].

6.5.6. GSTAG: Speciation tagging cross-reference file

The speciation tagging cross-reference file allows **Spmat** to tag existing model species based on the match between the source characteristics listed in the GSTAG file and source characteristics for each source in the inventory. The **Spmat** program will append the characters of the tag label specified in the GSTAG file. Note that this approach will not address raw inventory pollutants (VOC, NOX, PM2_5 and PM10) or

any other model species from biogenic sources from the BEIS model. When the environment variable SRC_TAGGING is set to “Y”, **Spcmat** will look for the GSTAG file. The default setting for the SRC_TAGGING variable is “N” to support back-ward comparability. If an invalid character appears in a tag label in the GSTAG file, such as “#” or “+” is used, SMOKE will return an error.

SMOKE uses growth and control packets to get the information needed for growth and control of emissions. A packet is a group of inputs used to apply specific types of controls. A single control file containing a series of packets can be shared by area, mobile, and point sources and the packets that do not apply to a given source category will be ignored. The following packets are recognized by the SMOKE control programs:

- `/ALLOWABLE/` contains county-specific, SIC-specific, SCC-specific controls, caps, and replacement emissions. Contributes to the multiplicative control matrix. Section 6.6.1.1, “`/ALLOWABLE/ Packet`” [311]
- `/CONTROL/` contains settings for control efficiency, rule effectiveness, and rule penetration. Contributes to the multiplicative control matrix. Section 6.6.1.2, “`/CONTROL/ Packet`” [312]
- `/CTG/` contains settings for CTG, MACT, and RACT controls. Contributes to the multiplicative control matrix. Section 6.6.1.3, “`/CTG/ Packet`” [313]
- `/MACT/` contains settings to support the primary MACT controls needed for toxics processing. Contributes to the multiplicative control matrix. Section 6.6.1.4, “`/MACT/ Packet`” [314]
- `/PROJECTION/` contains settings to permit growth of emission values into the past or future. Creates a growth matrix for each pollutant and/or activity. Section 6.6.1.5, “`/PROJECTION/ Packet`” [315]
- `/REACTIVITY/` contains settings needed for reactivity-based controls. Creates the reactivity control matrix. Section 6.6.1.6, “`/REACTIVITY/ Packet`” [316]

This file can be created using the **Metscan** utility program. The BIOSEASON file is time-dependent and usually contains data for an entire year (365 or 366 days). It uses one variable, SEASON, which is either 0 (grid cell should use winter factors for current day) or 1 (grid cell should use summer factors for current day).

6.9.1.2. BEISFAC: Biogenic emissions factors file for BEIS v3.7 or later version

The BEISFAC file for BEIS version 3.7 or later version contains LAI, dry leaf biomass, winter biomass factor, indicator of specific leaf weight, and normalized emission fluxes for various species/compounds listed in Table 6.56, “Format for BEISFAC, BEIS version 3.7 or later version.” [322]. As of BEIS version 3.7, BEISFAC is designed for Section 6.9.1.7, “BELD5: Landuse input file for BEIS v3.7 or later version” [331].

6.9.3.1. PELVCONFIG: Elevated source selection file

The PELVCONFIG is optionally used by the **Elevpoin**t program. It permits users to provide SMOKE criteria for grouping stacks and for selecting elevated and PinG point sources. “Stack groups” are groups of stacks from the same facility that are treated by SMOKE and the AQM as a single stack when computing plume rise and/or processing the stack as a PinG source. They have the effect of reducing the number of elevated and PinG stacks which makes for faster processing, particularly in the case of PinG sources in the AQM. Users can specify stack groups regardless of whether elevated or PinG sources are also being specified.

All emissions in a stack group are summed for the purposes of comparing against the elevated source criteria and PinG source criteria. In short, the grouped sources are treated as a single source for all SMOKE features regarding elevated source selection and special outputs. The grouped sources can still have different temporal profiles and chemical speciation profiles. For more information on how the emissions are computed for source selection, see Section 4.3, “**Elevpoin**t” [139].

The PELVCONFIG file has four sections: (1) source category selection, (2) source grouping, (3) PinG source selection, and (4) elevated source selection. Sections 2, 3, and 4 are optional, but **Elevpoin**t will not run if all three sections are missing, because in that case the file would be instructing it to do nothing. The sections need not appear in any particular order, but each section is permitted only once. Comments may also be used in the file. The following subsections explain these major input features.

6.9.3.1.1. Using comments

Comments can be put in the file using a pound sign (#) in the first column of a line or a double pound sign (##) anywhere else in a line. For example, the double pound can appear after packet labels or instructions in the file.

6.9.3.1.2. Source category selection

This section is used to tell **Elevpoin**t which source category to process. Since **Elevpoin**t is designed only for point sources, this is very simple. This section needs to appear as follows:

SMK_SOURCE P

6.9.3.1.3. Source grouping

The /SPECIFY ELEV GROUPS/ packet is used for defining source groups based on source criteria. The packet contains the following entries:

- /SPECIFY ELEV GROUPS/

Must appear to start the packet. Only one packet of this type is permitted.

- <Source grouping criteria, explained next>
- /END/

Must appear to end the packet.

The *source grouping criteria* can be as many lines as you want. Each line contains at least three parts: (1) variable (explained in Section 6.9.3.1.3.1, “/SPECIFY ELEV GROUPS/ variables” [358]), (2) type of criterion (explained in Section 6.9.3.1.3.2, “/SPECIFIC ELEV GROUPS/ grouping criteria” [359]), and (3) value for criterion, in the following structure:

<variable> <type of criterion> <value for criterion>

For example, the following source grouping criterion groups all inventory sources at the same facility that have stack heights within ± 2 meters of weighted average stack height:

```
HT +/- 2.0
```

The fact that sources are grouped by facility is implicit to the **Elepoint** program, since we assumed when creating **Elepoint** that grouping at a coarser level of detail was not desirable. The packet supports boolean OR and AND conditions. Each separate line of the packet is an OR condition. The AND conditions must appear on a single line. Any number of lines are permitted in this packet, as are any number of AND conditions or AND/OR combinations. However, each line has a maximum length of 300 characters.

The following example will help illustrate. To indicate that one group should consist of sources with stack heights within ± 2 meters of weighted average stack height that also have diameters within ± 1 meter of weighted average diameter, and that a second group should consist of sources with exit velocities below 10 m/s, the packet would be:

6.9.3.1.3.1. /SPECIFY ELEV GROUPS/ variables

The elevated groups packet supports the following variables:

- HT: stack height (m)
- DM: stack diameter (m)
- TK: stack gas exit temperature (K)
- VE: stack gas exit velocity (m/s)

- FL: stack gas exit flow rate (m³/s)
- <pollutant name>: whatever pollutant names are in the inventory (e.g., NOX). We do not know why a user might want this type of grouping, but SMOKE does not prevent it.

6.9.3.1.3.2. /SPECIFIC ELEV GROUPS/ grouping criteria

- +/- or -/+: variable values must be within plus or minus <value for criterion> for the variable given

- <: variable values must be less than <value for criterion> for the variable given
- <= or =<: variable values must be less than or equal to <value for criterion> for the variable given
- = or ==: variable values must be equal to <value for criterion> for the variable given
- %: variable values must be less than plus or minus <value for criterion> percent different for the variable given

6.9.3.1.4. Plume-in-grid source selection

The /SPECIFY PING/ packet is used for selecting plume-in-grid sources based on source criteria. The packet contains the following entries:

- /SPECIFY PING/

Must appear to start the packet. Only one packet of this type is permitted.

- <Source selection criteria, explained next>
- /END/

Must appear to end the packet.

The *source selection criteria* can be as many lines as you want. Each line contains at least three parts: (1) variable (explained in Section 6.9.3.1.4.1, “/SPECIFY PING/ variables” [359]), (2) type of criterion (explained in Section 6.9.3.1.4.2, “/SPECIFY PING/ selection criteria” [360]), and (3) value for criterion in the following structure:

<variable> <type of criterion> <value for criterion>

This structure is the same as that of the /SPECIFY ELEV GROUPS/ packet, and the description of the PinG source selection criteria is the same as that of the source grouping criteria (see Section 6.9.3.1.3, “Source grouping” [358]).

6.9.3.1.4.1. /SPECIFY PING/ variables

The PinG packet supports the same variables as the /SPECIFY ELEV GROUPS/ packet (see Section 6.9.3.1.3.1, “/SPECIFY ELEV GROUPS/ variables” [358]) and the following additional variables:

- **RISE**: The plume rise as computed by the Briggs algorithm documented with the **Elevpoint** program (see Section 4.3, “**Elevpoint**” [139]). The <value for criterion> must be provided in meters. To select all sources with plume rise greater than or equal to 75 meters, you would input:

```
RISE >= 75 .
```

- **SOURCE**: Source number from the intermediate inventory file output by **Smkinven**. This variable permits selection of specific **SMOKE** sources as PinG sources.
- **PLANT**: Plant ID code from the intermediate inventory file output by **Smkinven**. The “**PLANT**” variable can only be paired with the “**IS**” criterion type (below); no other criterion types (such as “<” or “=”) are permitted. It is recommended that this variable be used in addition to the **FIPS** variable (below) to allow selection of all records at specific plants. It can also be combined with stack parameter variables.
- **FIPS**: Country/state/county region code. This can be used with the “**PLANT**” variable or other variables to specific PinG sources by region. It is not recommended that this variable be used alone for specifying PinG sources, because that would result in insignificant sources being prepared for the AQM as PinG sources. It does not make sense to process such sources as PinG sources in AQMs.

6.9.3.1.4.2. /SPECIFY PING/ selection criteria

The PinG packet supports the same types of criteria as the /SPECIFY ELEV GROUPS/ packet (see Section 6.9.3.1.3.2, “/SPECIFIC ELEV GROUPS/ grouping criteria” [359]) and the following additional criteria types:

- **TOP**: This criterion type permits users to select sources with the largest values of the variable given. The <value for criterion> is the number of sources that will be selected based on the value given. This criterion type is permitted only when using a pollutant name as the <variable>.
- **IS**: This criterion type must be used to assign a value to the “**PLANT**” variable.

The following example illustrates a PinG packet that uses several of the variables and criterion types. In the following section is a further example that demonstrates using the rest of the variables and criterion types.

6.9.3.1.5. Elevated source selection

The /SPECIFY ELEV/ packet is used for selecting elevated sources based on source criteria. The packet contains the following entries:

Must appear to start the packet. Only one packet of this type is permitted.

- <Source selection criteria, explained above>

- /END/

Must appear to end the packet.

All of the source selection criteria for elevated sources are the same as the PinG selection criteria at this time (see Section 6.9.3.1.4, “Plume-in-grid source selection” [359]). To use the “cutoff” method for UAM-style processing, only the “RISE” variable should be used; the packet should not contain any other selection criteria. The “cutoff” method is the traditional approach for elevated-source selection for UAM, UAM-V, and CAM_X; you can decide if you want to use this traditional approach or a more complex set of criteria.

The following example illustrates using all of the different source selection variables and criterion types listed in the previous sections.

6.10.1. ARTOPNT: Area-to-point conversions file

The ARTOPNT file provides the point-source locations to assign to stationary area and nonroad mobile sources. The file is separated into sections. Each section starts with a header that contains the SCCs that will receive the point-source locations and allocation factors contained in that section. Within the section, the content and format are similar to the EMS-HAP airport allocation factor files (e.g., `ap_af1.sas7bdat`).

Each section of the file starts with the following packet:

6.10.4. INVTABLE: Inventory table

The INVTABLE file replaces the SIPOLS and ACTVNAMS files previously used by SMOKE. **Smkinven** uses the inventory table to select the inventory pollutants that will be output by **Smkinven**. The valid pollutants are again checked at the end of SMOKE processing by **Smkmerge**, to ensure that the program knows about all of the pollutants and also to set the order of the output variables (output species are sorted by the order of the pollutants in the inventory table and for multiple species per pollutant, by alphabetical order). You can use the INVTABLE to drop inventory pollutants in **Smkinven** without having to modify the inventory files, simply by modifying INVTABLE. The units used in the SMOKE intermediate files are listed in this file. The SMOKE programs **Spemat**, and **Movesmrg** use this file to determine which pollutants should be included in the NONHAPVOC or NONHAPTOG calculation.

The inventory table also provides a way to assign the SPECIATE4 species ID to any pollutant that is a Hazardous Air Pollutant (HAP) VOC. This assignment is not used directly by SMOKE, but rather is used by the Speciation Tool when creating VOC speciation profiles. This is used only when creating speciation profiles to support SMOKE runs that will combine criteria VOC and HAP VOC emissions, using the NHAPEXCLUDE file in the **Smkinven** program. More specifically, this can be done for the purpose of using VOC HAP emissions to augment VOC speciation profiles. Since the Inventory Table provides information to the Speciation Tool, this field is not used by SMOKE, but is included for continued integration of SMOKE inputs with the Speciation Tool.

As described in the **Smkinven** documentation in Chapter 6, **Smkinven** in some cases will create "no-integrate" (NOI) HAP pollutant emissions from the inventory data by renaming the pollutant with a "_NOI" suffix applied to the end of the Inventory Data Name from the Inventory Table for such pollutants. Similarly, **Smkinven** will automatically add all possibly needed "_NOI" pollutant names to the internal master list of valid pollutant names. This list would otherwise be limited to the contents of the INVTABLE file entries where the Keep column contains an "Y". **Smkinven** inserts these names in the master list such that the "_NOI" version of the pollutant name appears in the list just after the pollutant on which the name is based. The inserted entries that include "_NOI" are made when the following values are included for the pollutant in the INVTABLE file.

- A "Y" appears in the "Keep" field
- A "V" or "T" appears in the "VOC or TOG component" field
- A "Y" appears in the "Model species" field
- Something other than "Y" appears in the "Explicit in mechanism" field (e.g., "N" or blank)

It is possible for a user to choose two pollutants that result in double counting the emissions from the inventory. For example, you may want to model both benzo(a)pyrene and 7-PAH which, would result in the emissions associated with CAS number 205992 (for benzo(a)pyrene) to be duplicated. The user is responsible for the choices made and the resulting changes in inventory mass.

The columns in the INVTABLE are used as follows:

- Inventory data name: Unique name for pollutant or activity that will be stored and processed by SMOKE. Because of I/O API restrictions, these names can only include alphanumeric characters and underscores, and the first character must be a letter. In addition, because SMOKE uses double-underscore as a separator when appending to variable names, no double-underscores are permitted in these names.
- Mode: This three-letter code represents the emissions mode that SMOKE uses to augment the pollutant names. Emissions mode usually refers to the on-road or nonroad mobile exhaust or evaporative emissions. If present in a record of the Inventory Table, SMOKE will combine the Mode field with the Inventory Data Name field using a double underscore. So, if the Inventory Data Name is "VOC" and the Mode is "EXH", then the pollutant name in SMOKE intermediate files will be stored as "EXH__VOC".
- Inventory Pollutant Code: This code represents the pollutant that is provided in the inventory file input into SMOKE, and is sometimes the Chemical Abstracts Service (CAS) number when the inventory uses CAS numbers to identify pollutants. **Smkinven** matches this code to a ORL-formatted inventory file to assign the combination of Mode and Inventory Data Name (columns 2 and 1 as described in the previous bullet), which is used in all subsequent SMOKE intermediate files and reports. This code is not used by SMOKE in any other way.
- SPECIATE4 ID: The SPECIATE4 ID is the unique species identifier in SPECIATE4 (the "ID" field in the SPECIES_PROPERTIES table). This code is not used by SMOKE, but rather is used during import of the Inventory Table to the Speciation Tool.
- Reactivity group: The reactivity group for the ASPEN model. It is not used in SMOKE.

- **Keep:** Indicates whether SMOKE should keep the CAS number associated with this inventory data name. SMOKE will keep any inventory data with at least one CAS number with a Y.
- **Factor:** The adjustment factor to use in splitting the emissions associated with a CAS number into different inventory data names, or reducing the mass of a metal compound associated with a CAS number to account for the metal mass only.
- **VOC or TOG component:** A “V” should be entered if the CAS number is part of VOC emissions or TOG emissions. A “T” should be entered if the CAS number is part of TOG emissions only. An “N” should be entered if the CAS number is part of neither VOC or TOG. Any other value other than “V” or “T” will be treated as an “N”.
- **Model species:** A “Y” should be entered if the pollutant is also a VOC model species for the AQM being targeted for the run. Any other values will be treated as an “N”.
- **Explicit in mechanism:** A “Y” should be entered if (1) the pollutant is a VOC species (the model-species column must be “Y” as well), and (2) that model-species is explicitly treated in the AQM’s chemical mechanism. The pollutant can be an explicit species in the chemical mechanism only when the GSPRO file definitions of the lumped VOC species have been adjusted to account for the pollutants/species that are explicit in the mechanism. The current explicit-in-mechanism species being used in the toxics CB6 mechanism for CMAQ are formaldehyde, acetaldehyde, acrolein and 1,3 butadiene.
- **Activity:** A “Y” should be entered if the inventory data name is a type of activity instead of emissions. Any other values will be treated as an “N”.
- **NTI:** Code identifying a HAP on the Clean Air Act HAP list (list of 188 HAPs). Not currently used by SMOKE; will be used in the future for growing HAP emissions to future years.
- **Units:** The units to store the data in the SMOKE intermediate files. This should be “short tons/year” for emissions values, “miles/year” for VMT, and “miles/hr” for speed. Although this is provided as an input field to allow possible future changes, these values should *not* be changed by the user and are unrelated to the units of the emissions in the input files.
- **Inventory data descriptions:** This is the description of the inventory data name listed in columns 1-11.
- **CAS pollutant description:** Describes the pollutant that is coming from the inventory that is being input into SMOKE.

6.10.7. NHAPEXCLUDE: NonHAP VOC calculation inclusions/exclusions file

The NHAPEXCLUDE file provides a way to exclude sources from the NONHAPVOC or NONHAPTOG calculation. For SMOKE versions 2.6 and higher, a new special header in the NHAPEXCLUDE file to allow **Smkinven** to either include or exclude sources from NONHAPVOC or NONHAPTOG calculation. When the header is defined as /INCLUDE/, **Smkinven** will treat selected sources as integrated sources; **Smkinven** will use the toxics pollutants from the selected sources to compute NONHAPVOC or NONHAPTOG. The toxic emissions will be retained or dropped by **Smkinven**, depending on the status of the pollutants in the INVTABLE file (see Section 6.10.4, “INVTABLE: Inventory table” [368]). If the pollutant is a model species and an explicit species, then the toxic emissions will not be dropped. If the pollutant is only a model species but not an explicit species, it will be renamed by appending “_NOI” to the species name. If it is neither a model species nor an explicit species, the toxics mass will be dropped to prevent double counting of the inventory mass. When the header is defined as /EXCLUDE/ which is the default setting, **Smkinven** will exclude the selected sources from the HAP-CAP integratoin approach. All other inventory sources will be used to compute NONHAPVOC or NONHAPTOG.

The NHAPEXCLUDE file is only used when SMK_PROCESS_HAPS is set to PARTIAL. If SMK_PROCESS_HAPS is set to ALL or NONE, the NHAPEXCLUDE file is not required (Section 4.14.3.2, “Input Environment Variables” [184]). Once integration/non-integration processing is done, **Smkreport** can create a report that separates integrated and non-integrated sources using the BY INTEGRATE instruction (Section 5.3.3, “Create-report Section” [236]).

NOTE: Whenever SMK_PROCESS_HAPS is set to process HAPs, a new inventory pollutant, “VOC_INV” or “TOG_INV”, will be created to retain the original VOC or TOG values for the purpose of creating quality assurance reports with **Smkreport**.

The NHAPEXCLUDE file contains the country/state/county and SCC codes of those sources that SMOKE will include or exclude from the NONHAP calculation. The file format is shown in Table 6.94, “Format for NHAPEXCLUDE” [372].

6.10.13. SOURCE_GROUPS: Source apportionment groups

The SOURCE_GROUPS file is used to define groups of sources when processing emissions for source apportionment. **Movesmrg** and **Smkmerge** read this file when **SMK_SRCGROUP_OUTPUT_YN** is set to **Y**.

When reading the SOURCE_GROUPS file, SMOKE will skip lines with data that doesn't apply to the current source category. Lines that contain a plant ID or point ID will be skipped when processing area, biogenic, or mobile sources. Lines containing an SCC will be skipped when processing biogenic sources.

If SMOKE encounters lines with duplicate grouping information (i.e. FIPS, SCC, point source characteristics), an error will be printed to the log and the program will quit.

Multiple grouping criteria can be assigned to the same source group ID by using additional lines. In the example below, all sources with SCCs 2102001000, 2102002000, and 2102004000 will be assigned to source group 1.

For BEIS version 3.14, **Normbeis3** calculates normalized emissions for both the summer and winter seasons. For nitric acid (NO) calculations, however, emissions depend on a given grid cell’s land use category (or categories). For agricultural land use portions of a grid cell, a determination is made of whether the given day is in the growing season or the non-growing season. The appropriate emissions factor is then applied to the NO emissions calculations. The agricultural land use categories USGS Cropprass (a cropland/grassland mosaic) and USGS Cropwoodland (a cropland/woodland mosaic) represent grid cells with mixed vegetation and only half the area is assumed to be covered by crops. Accordingly, the corresponding emissions factors for these two categories are multiplied by 0.5 for NO calculations. (Note that the USGS Drycrop and USGS Irrcrop land use categories assume the vegetation is all crop.) For the non-growing season in agricultural areas, the emissions factor for the USGS Grassland land use category is used for NO emission calculations. Finally, for non-agricultural areas, the USGS Grassland emissions factor is used all year round. Table 9.21b contains the names and descriptions of variables in the B3GRD output file from **Normbeis3**, BEIS version 3.14

For BEIS version 4.0, **Normbeis4** calculates normalized emissions for both the summer and winter seasons. For nitric acid (NO) calculations, however, emissions depend on a given grid cell’s land use category (or categories). For agricultural land use portions of a grid cell, a determination is made of whether the given day is in the growing season or the non-growing season. The appropriate emissions factor is then applied to the NO emissions calculations. The agricultural land use categories USGS Cropgrass (a cropland/grassland mosaic) and USGS Cropwoodland (a cropland/woodland mosaic) represent grid cells with mixed vegetation and only half the area is assumed to be covered by crops. Accordingly, the corresponding emissions factors for these two categories are multiplied by 0.5 for NO calculations. (Note that the USGS Drycrop and USGS Irrcrop land use categories assume the vegetation is all crop.) For the non-growing season in agricultural areas, the emissions factor for the USGS Grassland land use category is used for NO emission calculations. Finally, for non-agricultural areas, the USGS Grassland emissions factor is used all year round.

8.1. Introduction

An output file is a file that is output from a SMOKE program and not used as input to any other SMOKE programs. This include the model-ready emissions files and various reports. Files that are used as input to other SMOKE programs are considered intermediate files and are documented in Chapter 7, *SMOKE Intermediate Files* [379].

In this chapter, the output files are organized under headings named for the SMOKE programs that create the files; the files are listed alphabetically within each program section. The order of the programs within the chapter is also alphabetical. Please note that some file types have multiple file names, one per source category. For example, the multiplicative control report file name is ACREP, MCREP, or PCREP, depending on whether the area, mobile, or point source category is being processed by **Cntlmat**. In these cases of multiple names for a single file type, the file description is listed one time for all output files.

8.2. Cntlmat

The **Cntlmat** program is responsible for creating the growth and control matrices. **Cntlmat** creates the following output files:

- Multiplicative control report: Section 8.2.1, “ACREP, MCREP, and PCREP” [403]
- Growth factors report: Section 8.2.2, “APROJREP, MPROJREP, and PPROJREP” [404]
- Reactivity controls report: Section 8.2.3, “AREACREP, MREACREP, and PREACREP” [404]
- Summary of controls report: Section 8.2.4, “ACSUMREP, MCSUMREP, and PCSUMREP” [405]

8.2.1. ACREP, MCREP, and PCREP

Type: ASCII - list-directed

Summary: This file contains the report for the multiplicative control matrix. It includes the inventory pollutant emissions before and after application of the multiplicative control matrix factors. For area and mobile sources, the report resolution is by state and SCC code. For point sources, the report is by state/county and plant code. The individual factors applied (e.g., /ALLOWABLE/ and /CONTROL/ packet factors) by

source are provided in the *CSUMREP file described in Section 8.2.4, “ACSUMREP, MCSUMREP, and PCSUMREP” [405].

The file header and output format are similar to what is output by the **Smkreport** program (see Section 5.4, “Reports Created by **Smkreport**” [251]). The headers include information about:

- The source category (area, mobile, or point sources) for the report
- The base year or projected year of the inventory input file
- Which control packets were applied
- Whether the emissions in the report are based on ozone-season or annual total emissions
- The inventory pollutants controlled by the packets
- The units

The columns of the report include:

- State ID (area and mobile); state/county ID (point)
- SCC (area and mobile); plant (point)
- Input emissions in tons/day for each controlled pollutant
- Output emissions in tons/day for each controlled pollutant

8.2.2. APROJREP, MPROJREP, and PPROJREP

Type: ASCII - list-directed

Summary: This file contains the report for the /PROJECTION/ packet applied during the **Cntlmat** run. It includes the growth matrix factors applied to the inventory pollutant emissions. For all sources, the resolution of the report is the source level. For area and mobile sources, this means that the report resolution is by county code and SCC. Mobile sources may additionally have link-detail information if links are included in the inventory. For point sources, the resolution includes the state/county code, plant ID, SCC, and other source identifiers such as segment and point.

The file header and output format are somewhat similar to that output by the **Smkreport** program (see Section 5.4, “Reports Created by **Smkreport**” [251]), but less so than the *CREP file (see Section 8.2.1, “ACREP, MCREP, and PCREP” [403]). The headers include information about:

- The source category (area, mobile, or point sources) for the report
- The base year of the inventory
- The growth year for the packets being applied
- The fact that all pollutants receive factors uniformly.

The columns of the report include:

- State ID (area and mobile); state/county ID (point)
- SCC (area and mobile); plant (point)
- Growth factor

8.2.3. AREACREP, MREACREP, and PREACREP

Summary: This file contains the report for the reactivity packet applied during the **Cntlmat** run. It contains the reactivity packet contents applied for any source in the inventory that gets a reactivity control. For all sources, the resolution of the report is the source level, as described for the [A|M|P]PROJREP files in Section 8.2.2, “APROJREP, MPROJREP, and PPROJREP” [404].

The file header and output format are the same as that output by the **Smkreport** program (see Section 5.4, “Reports Created by **Smkreport**” [251]). The headers in include information about:

- The source category (area, mobile, or point sources) for the report
- The base year of the inventory (or the projected year if applicable)
- The projected year in the reactivity packet
- The pollutant name (e.g., ROG) for which the reactivity controls were applied.
- Whether the emissions in the report are based on average-day or annual total emissions.
- The column names and units

The columns in the report include:

- SMOKE source number
- State/county code
- Base-year SCC
- Base-year emissions
- New base-year emissions
- Projection factor
- Projected-year SCC
- Projected-year speciation profile
- Market penetration rate

8.2.4. ACSUMREP, MCSUMREP, and PCSUMREP

The structure of this file is not amenable for import into a spreadsheet, because all control information applied to each source is listed underneath each source (not on the same line). Appendix A. Glossary

A

Air quality model	A model that predicts ambient air quality that accounts for impacts of meteorology, manmade emissions sources, and biogenic emissions sources. It simulates physical components such as advection, dispersion, clouds, dry and wet precipitation, air chemistry, particulate formation, to provide ambient air quality estimates of a variety of pollutants (such as ozone) and other chemical constituents.
Anthropogenic sources	Manmade sources of emissions. All inventory source categories besides biogenic sources are considered to be anthropogenic sources.
Area source	An anthropogenic source category that is represented as a 2-d source, typically a county. In SMOKE, the term area source more specifically refers to a collection of source categories types that are not point sources and are not on-road mobile sources. SMOKE area sources are defined by country, state, and county codes and by source category codes (SCCs). Area sources are also referred to as stationary area sources and, in SMOKE, include nonroad mobile sources.

B

Base year	Year for which an air quality modeling episode will be evaluated for model performance. Air quality modeling typically involves modeling a base year and comparing the model run to observational data. Once the meteorology and emissions data in the base year have been improved enough for adequate model performance, the emissions are grown to a future year and the model is run in the future with and without a control strategy.
Biogenic source	A natural source, or one that is not manmade. In SMOKE, biogenic sources include VOC emissions from vegetation and nitrous oxide emissions from soil. Volcanoes and other geothermal emissions, water emissions, and other biogenic sources are not included in SMOKE biogenic emissions components.

C

Chemical mechanism	A set of chemical species and their interactions used to represent air chemistry (e.g., carbon bond 6 [CB6], Statewide Air Pollution Research Center [SAPRC]).
Chemical speciation	Convert the inventory pollutant data to the chemical species needed by the air quality model (e.g., VOC gets split to PAR, OLE, XYL, TOL, ISOP, and more).
Cross-reference file	A dataset used for matching sources in the emissions inventory with profile data based on the source characteristics. Typically there can be thousands of records in a cross-reference file and tens or hundreds

of thousands of records in an emissions inventory. The cross-reference file facilitates assigning conversion factors for emissions processing to records in the emissions inventory.

E

Elevated source	A point source in which emissions are higher than the first model layer because of plume rise.
Emission inventory	<p>An emission inventory is an accounting of the amount of air pollutants discharged into the atmosphere. It is generally characterized by the following factors:</p> <ul style="list-style-type: none">• the chemical or physical identity of the pollutants included,• the geographic area covered,• the institutional entities covered,• the time period over which emissions are estimated, and• the types of activities that cause emissions. <p>Emission inventories are developed for a variety of purposes. Inventories of natural and anthropogenic emissions are used by scientists as inputs to air quality models, by policy makers to develop strategies and policies or track progress of standards, and by facilities and regulatory agencies to establish compliance records with allowable emission rates. A well constructed inventory should include enough documentation and other data to allow readers to understand the underlying assumptions and to reconstruct the calculations for each of the estimates included.</p>
Emissions processing	<p>Converting the resolution of emissions inventories (e.g. area, biogenic, mobile, and point sources) to the resolution needed by an air quality model (e.g., hourly, grid-cell, data of model species). It may also include growing data from one year to another year and applying emissions controls on the inventory. This process requires a large number of supplementary data files include gridding surrogates, cross-reference files, and factor profiles for chemical speciation and temporal allocation. It includes combining all source categories and ensuring that the emissions are in the format needed by a specific air quality model. Emissions processing typically includes quality assurance to increase user confidence that the data were converted as intended.</p>
Environment variable	<p>Environment variables are how SMOKE communicates with its operating environment. There are several different uses for environment variables including assigning file names, setting options, and setting operating parameters.</p> <p>An environment variable in the UNIX environment C-shell is defined using the setenv command. For example, to define the FILENAME environment variable to the file <code>testfile.txt</code> in the <code>/home/user/</code> directory, the following command is used:</p> <pre>setenv FILENAME /home/user/testfile.txt</pre>

F

Fuel month	The concept of a fuel month is used to indicate when a particular set of fuel properties should be used in a MOVES simulation. The fuel month reduces the computational time of MOVES by using a single month to represent a set of months. To determine the fuel month and which months it is similar to, the user should review the State-provided fuel supply data in the MOVES database for each representative county. If the fuel supply data change throughout the year, then group the months by fuel parameters. For example, if the grams/mile exhaust emission rates in January are identical to February's rates for a given representative county, then use a single fuel month to represent January and February. (Only one of the months needs to be modeled through MOVES)
Future year	A year after the base year.

G

Grid	See Model grid.
Grid projection	See Map projection.
Gridding	See Spatial allocation.
Gridding surrogate	A dataset developed from data at a finer resolution than the emissions, used to spatially allocate the emissions to the grid cells (e.g., population, housing, agricultural regions).

I

Inventory pollutant	A compound or group of compounds emitted into the atmosphere by anthropogenic and biogenic sources defined for record-keeping and regulatory purposes (e.g. carbon monoxide [CO], nitrogen oxides [NO _x], volatile organic compounds [VOC], particulate matter 10 microns or less [PM ₁₀]).

L

Lambert conformal	A type of map projection.
Latitude/longitude (lat/lon)	A spherical reference system used to measure locations on the Earth's surface. Latitude and longitude are angles measured from the Earth's center to locations on the Earth's surface. Latitude measures angles in a north-south direction. Longitude measures angles in the east-west direction. In SMOKE, lat/lon refers to a map projection.
Layer	See Model layers.
Logical file names	Environment variables that programs use to access files are called logical file names. In the Environment variable [412], FILENAME is the logical file name for the physical file /home/user/test-file.txt. The I/O API is based on logical file names, and since

SMOKE uses the I/O API for accessing all of its files, it too uses logical file names. The benefit of logical file names is that the programs do not require that the physical files always have the same name. Instead, the logical file names can be defined each time a program is run to use whatever physical file names the user would like. In Chapter 6, *SMOKE Input Files* [261], Chapter 7, *SMOKE Intermediate Files* [379], and Chapter 8, *SMOKE Output Files* [403], the logical file names are used to reference the files, their associations with programs, and their formats.

Low-level point source

A point source in the first model layer. A source that is not elevated.

M

Map projection

A mathematical model that transforms the locations of features on the Earth's surface to locations on a two-dimensional surface. Because the Earth is three-dimensional, some method must be used to depict a map in two dimensions. Some projections preserve shape; others preserve accuracy of area, distance, or direction. Map projections project the Earth's surface onto a flat plane. However, any such representation distorts some parameter of the Earth's surface be it distance, area, shape, or direction.

Merging

In SMOKE, merging can refer to two steps. One, it can refer to combining the SMOKE processes for a single source category, such as combining the gridding information, the inventory, the temporal allocation, and the chemical speciation information to create model-ready emissions. Two, it can refer to combining all source categories together into a single model-ready file.

Meteorology data

Simulated weather data required by SMOKE for biogenic sources, some mobile source processing, and some point source processing.

Mobile source

In the most general sense, a mobile source is simply a non-stationary source such as an on road vehicle, a construction vehicle, or a lawn mower. In SMOKE, the term mobile source more specifically refers to on-road vehicles. SMOKE mobile sources are defined by country, state, and county codes, by source category codes (SCCs) that include a road class code and a vehicle type code, and optionally by a link identification code. For SMOKE, mobile sources include only on-road mobile sources and NOT nonroad sources (which are treated as area sources).

Model domain

The grid on which a model will be run.

Model grid

A 2-d grid based on a map projection, defined by starting coordinates, number of grid cells in each direction, and the physical size of the grid cells.

Model layers

Vertical spatial divisions defined by an air quality model because the atmosphere has varied characteristics in the vertical direction.

Model species

A compound or group of compounds defined as part of the estimation of air chemistry in an air quality model (e.g., CO, nitrogen oxide [NO],

nitrogen dioxide [NO₂], paraffins [PAR], elemental carbon, coarse [ECC]). Model species can be an actual chemical compound, ion, or group of compounds. Air quality models typically input emissions data for a subset of model species from a larger number of species in a full chemical mechanism.

N

Nonroad mobile sources See Area source.

O

On-road mobile source See Mobile source.

P

Past year A year prior to a base year.

Plume rise The rising of the exhaust from point sources due to the velocity and temperature of the exhaust gases.

Plume-in-grid (PinG) A special treatment of elevated sources by which the plume rise is modeled with extra detail by the air quality model. The acronym for plume-in-grid is PinG or sometimes PIG.

Point source A point source is an emissions source that can be represented by a point in space, relative to the modeling domain. In SMOKE, a point source is defined by a country, state, and county code, a plant identification code, 1 to 5 additional user-defined attributes (such as stack code, process codes, and a source category code [SCC]). Point sources have other required attributes such as stack parameters.

Polar stereographic A type of map projection.

Profile data Factors used for disaggregating emissions data as is done during chemical speciation or temporal allocation.

Projection (grid) See Map projection.

Projection (temporal) Estimating past-year or future-year emissions from a base-year value and other factors.

R

Representative County Representative county is used to represent a set of counties that have the a constant set of fuel parameters (distribution of fuels over the year), fleet age distribution, inspection/maintenance (I/M) programs, similar community characteristics (e.g. urban vs rural) and similar meteorological conditions (e.g. temperature and relative humidity). Variables that can vary within the counties represented by a representative county include vehicle miles traveled (VMT), source type vehicle population, roadway speed and grid cell temperatures. By specifying

a representative county the user is able to reduce the computational time of MOVES by using a single county to represent a set of counties.

S

Source category	A general classification of emission sources for both emission inventory development and emissions modeling. The major source categories in SMOKE are area, biogenic, mobile, and point. Other source categories that are sometimes treated separately are offshore point sources, non-road area sources, and Continuous Emissions Monitoring (CEM) sources. See Also Area source, Biogenic source, Mobile source, Point source.
Source classification code (SCC)	A code used in emission inventories to label emission sources as being part of a specific industrial, chemical, or natural processes of generating emissions.
Sparse Matrix Operator Kernel Emissions (SMOKE)	A emissions data modeling system that prepares emissions data for use in air quality models. It converts the resolution of area, biogenic, mobile, and point source inventories into the hourly, gridded, model-species resolution needed by air quality models.
Spatial allocation	Convert the source spatial extent to the grid cell resolution needed by the air quality model. For area sources, this process requires gridding surrogate data. For mobile link sources (line sources), this requires determining the cells intersected by the link and the fractions of the link in each cell. For point sources, this requires determining in which cell the point source falls.
Spatial surrogate	See Gridding surrogate.
Speciation	See Chemical speciation.
Species	See Model species.
Stack parameters	Attributes of point sources including stack height, stack diameter at the top (the point where exit gases flow from the stack), exit gas temperature at the top, exit gas velocity at the top, and exit gas flow at the top.

T

Temporal allocation	Convert the inventory temporal resolution to the hourly temporal resolution needed by the air quality model.
Time zone	A region on the Earth assigned a specific zone relative to Greenwich Mean Time, defined as time zone 0.

U

Universal Transverse Mercator	Military grid projection based on the transverse Mercator projection, applied to maps of the Earth's surface extending from the Equator to 84 degrees north and 80 degrees south latitudes.
